## RESOLUTION

Providing for consideration of the bill (H.R. 4821) making appropriations for the Department of the Interior, environment, and related agencies for the fiscal year ending September 30, 2024, and for other purposes; providing for consideration of the bill (H.R. 4820) making appropriations for the Departments of Transportation, and Housing and Urban Development, and related agencies

for the fiscal year ending September 30, 2024, and for other purposes; and providing for consideration of the bill (H.R. 6126) making emergency supplemental appropriations to respond to the attacks in Israel for the fiscal year ending September 30, 2024, and for other purposes.

1       *Resolved*, That at any time after adoption of this reso-  
2 lution the Speaker may, pursuant to clause 2(b) of rule  
3 XVIII, declare the House resolved into the Committee of  
4 the Whole House on the state of the Union for consider-  
5 ation of the bill (H.R. 4821) making appropriations for  
6 the Department of the Interior, environment, and related  
7 agencies for the fiscal year ending September 30, 2024,  
8 and for other purposes. The first reading of the bill shall  
9 be dispensed with. All points of order against consider-  
10 ation of the bill are waived. General debate shall be con-  
11 fined to the bill and shall not exceed one hour equally di-  
12 vided and controlled by the chair and ranking minority  
13 member of the Committee on Appropriations or their re-  
14 spective designees. After general debate the bill shall be  
15 considered for amendment under the five-minute rule. The  
16 bill shall be considered as read. All points of order against  
17 provisions in the bill are waived.

18       SEC. 2. (a) No amendment to H.R. 4821 shall be in  
19 order except those printed in part A of the report of the  
20 Committee on Rules accompanying this resolution, amend-

1 ments en bloc described in section 3 of this resolution, and  
2 pro forma amendments described in section 4 of this reso-  
3 lution.

4 (b) Each amendment printed in part A of the report  
5 of the Committee on Rules shall be considered only in the  
6 order printed in the report, may be offered only by a Mem-  
7 ber designated in the report, shall be considered as read,  
8 shall be debatable for the time specified in the report  
9 equally divided and controlled by the proponent and an  
10 opponent, shall not be subject to amendment except as  
11 provided by section 4 of this resolution, and shall not be  
12 subject to a demand for division of the question in the  
13 House or in the Committee of the Whole.

14 (c) All points of order against amendments printed  
15 in part A of the report of the Committee on Rules or  
16 against amendments en bloc described in section 3 of this  
17 resolution are waived.

18 SEC. 3. It shall be in order at any time for the chair  
19 of the Committee on Appropriations or her designee to  
20 offer amendments en bloc consisting of amendments print-  
21 ed in part A of the report of the Committee on Rules ac-  
22 companying this resolution not earlier disposed of. Amend-  
23 ments en bloc offered pursuant to this section shall be con-  
24 sidered as read, shall be debatable for 20 minutes equally  
25 divided and controlled by the chair and ranking minority

1 member of the Committee on Appropriations or their re-  
2 spective designees, shall not be subject to amendment ex-  
3 cept as provided by section 4 of this resolution, and shall  
4 not be subject to a demand for division of the question  
5 in the House or in the Committee of the Whole.

6       SEC. 4. During consideration of H.R. 4821 for  
7 amendment, the chair and ranking minority member of  
8 the Committee on Appropriations or their respective des-  
9 ignees may offer up to 10 pro forma amendments each  
10 at any point for the purpose of debate.

11       SEC. 5. At the conclusion of consideration of H.R.  
12 4821 for amendment the Committee shall rise and report  
13 the bill to the House with such amendments as may have  
14 been adopted. The previous question shall be considered  
15 as ordered on the bill and amendments thereto to final  
16 passage without intervening motion except one motion to  
17 recommit.

18       SEC. 6. At any time after adoption of this resolution  
19 the Speaker may, pursuant to clause 2(b) of rule XVIII,  
20 declare the House resolved into the Committee of the  
21 Whole House on the state of the Union for consideration  
22 of the bill (H.R. 4820) making appropriations for the De-  
23 partments of Transportation, and Housing and Urban De-  
24 velopment, and related agencies for the fiscal year ending  
25 September 30, 2024, and for other purposes. The first

1 reading of the bill shall be dispensed with. All points of  
2 order against consideration of the bill are waived. General  
3 debate shall be confined to the bill and shall not exceed  
4 one hour equally divided and controlled by the chair and  
5 ranking minority member of the Committee on Appropria-  
6 tions or their respective designees. After general debate  
7 the bill shall be considered for amendment under the five-  
8 minute rule. The bill shall be considered as read. All points  
9 of order against provisions in the bill are waived.

10       SEC. 7. (a) No amendment to H.R. 4820 shall be in  
11 order except those printed in part B of the report of the  
12 Committee on Rules accompanying this resolution, amend-  
13 ments en bloc described in section 8 of this resolution, and  
14 pro forma amendments described in section 9 of this reso-  
15 lution.

16       (b) Each amendment printed in part B of the report  
17 of the Committee on Rules shall be considered only in the  
18 order printed in the report, may be offered only by a Mem-  
19 ber designated in the report, shall be considered as read,  
20 shall be debatable for the time specified in the report  
21 equally divided and controlled by the proponent and an  
22 opponent, shall not be subject to amendment except as  
23 provided by section 9 of this resolution, and shall not be  
24 subject to a demand for division of the question in the  
25 House or in the Committee of the Whole.

1 (c) All points of order against amendments printed  
2 in part B of the report of the Committee on Rules or  
3 against amendments en bloc described in section 8 of this  
4 resolution are waived.

5 SEC. 8. It shall be in order at any time for the chair  
6 of the Committee on Appropriations or her designee to  
7 offer amendments en bloc consisting of amendments print-  
8 ed in part B of the report of the Committee on Rules ac-  
9 companying this resolution not earlier disposed of. Amend-  
10 ments en bloc offered pursuant to this section shall be con-  
11 sidered as read, shall be debatable for 20 minutes equally  
12 divided and controlled by the chair and ranking minority  
13 member of the Committee on Appropriations or their re-  
14 spective designees, shall not be subject to amendment ex-  
15 cept as provided by section 9 of this resolution, and shall  
16 not be subject to a demand for division of the question  
17 in the House or in the Committee of the Whole.

18 SEC. 9. During consideration of H.R. 4820 for  
19 amendment, the chair and ranking minority member of  
20 the Committee on Appropriations or their respective des-  
21 ignees may offer up to 10 pro forma amendments each  
22 at any point for the purpose of debate.

23 SEC. 10. At the conclusion of consideration of H.R.  
24 4820 for amendment the Committee shall rise and report  
25 the bill to the House with such amendments as may have

1 been adopted. The previous question shall be considered  
2 as ordered on the bill and amendments thereto to final  
3 passage without intervening motion except one motion to  
4 recommit.

5       SEC. 11. Upon adoption of this resolution it shall be  
6 in order to consider in the House the bill (H.R. 6126)  
7 making emergency supplemental appropriations to re-  
8 spond to the attacks in Israel for the fiscal year ending  
9 September 30, 2024, and for other purposes. All points  
10 of order against consideration of the bill are waived. The  
11 bill shall be considered as read. All points of order against  
12 provisions in the bill are waived. The previous question  
13 shall be considered as ordered on the bill and on any  
14 amendment thereto to final passage without intervening  
15 motion except: (1) one hour of debate equally divided and  
16 controlled by the chair and ranking minority member of  
17 the Committee on Appropriations or their respective des-  
18 ignees; and (2) one motion to recommit.
