## **RESOLUTION**

Providing for consideration of the bill (H.R. 4664) making appropriations for financial services and general government for the fiscal year ending September 30, 2024, and for other purposes.

- 1 Resolved, That at any time after adoption of this reso-
- 2 lution the Speaker may, pursuant to clause 2(b) of rule
- 3 XVIII, declare the House resolved into the Committee of
- 4 the Whole House on the state of the Union for consider-
- 5 ation of the bill (H.R. 4664) making appropriations for
- 6 financial services and general government for the fiscal

- 1 year ending September 30, 2024, and for other purposes.
- 2 The first reading of the bill shall be dispensed with. All
- 3 points of order against consideration of the bill are waived.
- 4 General debate shall be confined to the bill and shall not
- 5 exceed one hour equally divided and controlled by the chair
- 6 and ranking minority member of the Committee on Appro-
- 7 priations or their respective designees. After general de-
- 8 bate the bill shall be considered for amendment under the
- 9 five-minute rule. The amendment printed in part A of the
- 10 report of the Committee on Rules accompanying this reso-
- 11 lution shall be considered as adopted in the House and
- 12 in the Committee of the Whole. The bill, as amended, shall
- 13 be considered as read. All points of order against provi-
- 14 sions in the bill, as amended, are waived.
- 15 Sec. 2. (a) No further amendment to H.R. 4664, as
- 16 amended, shall be in order except those printed in part
- 17 B of the report of the Committee on Rules accompanying
- 18 this resolution, amendments en bloc described in section
- 19 3 of this resolution, and pro forma amendments described
- 20 in section 4 of this resolution.
- 21 (b) Each further amendment printed in part B of the
- 22 report of the Committee on Rules shall be considered only
- 23 in the order printed in the report, may be offered only
- 24 by a Member designated in the report, shall be considered
- 25 as read, shall be debatable for the time specified in the

- 1 report equally divided and controlled by the proponent and
- 2 an opponent, shall not be subject to amendment except
- 3 as provided by section 4 of this resolution, and shall not
- 4 be subject to a demand for division of the question in the
- 5 House or in the Committee of the Whole.
- 6 (c) All points of order against further amendments
- 7 printed in part B of the report of the Committee on Rules
- 8 or against amendments en bloc described in section 3 of
- 9 this resolution are waived.
- 10 Sec. 3. It shall be in order at any time for the chair
- 11 of the Committee on Appropriations or her designee to
- 12 offer amendments en bloc consisting of further amend-
- 13 ments printed in part B of the report of the Committee
- 14 on Rules accompanying this resolution not earlier disposed
- 15 of. Amendments en bloc offered pursuant to this section
- 16 shall be considered as read, shall be debatable for 20 min-
- 17 utes equally divided and controlled by the chair and rank-
- 18 ing minority member of the Committee on Appropriations
- 19 or their respective designees, shall not be subject to
- 20 amendment except as provided by section 4 of this resolu-
- 21 tion, and shall not be subject to a demand for division
- 22 of the question in the House or in the Committee of the
- 23 Whole.
- Sec. 4. During consideration of H.R. 4664 for
- 25 amendment, the chair and ranking minority member of

- 1 the Committee on Appropriations or their respective des-
- 2 ignees may offer up to 10 pro forma amendments each
- 3 at any point for the purpose of debate.
- 4 Sec. 5. At the conclusion of consideration of H.R.
- 5 4664 for amendment the Committee shall rise and report
- 6 the bill, as amended, to the House with such further
- 7 amendments as may have been adopted. The previous
- 8 question shall be considered as ordered on the bill, as
- 9 amended, and on any further amendment thereto to final
- 10 passage without intervening motion except one motion to
- 11 recommit.
