

House Votes on Bills and Amendments in the 110th and 11th Congress to Curtail Oil and Gas Tax Subsidies

1/18/2007 – Passage of H.R. 6, The CLEAN Energy Act of 2007, passage: 264 – 163, Included 199 reform for all oil and gas companies regardless of size, and repeal of geological and geophysical expensing, passage 230-195 (no Republican support):

8/4/2007 - Passage of H.R. 2776, Renewable Energy and Energy Conservation Tax Act of 2007, passage: 221 – 189 (9 Republicans supported), Included 199 reform, geological and geophysical expensing, foreign oil and gas extraction income deductions:

8/4/2007 - Final Passage of H.R. 3221, New Direction for Energy Independence, National Security, and Consumer Protection Act' and the 'Renewable Energy and Energy Conservation Tax Act of 2007, final passage 241-172 (26 Republicans supported). Included 199 reform, repeal of geological and geophysical expensing, foreign oil and gas extraction income deductions:

10/3/2008 - House agreeing to the Senate amendments to H.R.1424, The Paul Wellstone Mental Health and Addiction Equity Act of 2007, note: Division C is the Tax Extenders and Alternative Minimum Tax Relief Act of 2008, passage 263 – 171 (91 Republicans supported). Included limitation of the deduction for income attributable to domestic production of oil and gas under Section 199 and the elimination of the different treatment of foreign oil and gas extraction income and foreign oil related income under the foreign tax credit. **Became public law:**
