Amending the Rules of the House of Representatives...

1 Resolved,

2 SECTION 1. PROHIBITING APPROPRIATIONS BILLS FROM 3 BEING CONSIDERED UNDER CLOSED RULE.

4 Clause 6 of rule XIII of the Rules of the House of5 Representatives is amended by adding at the end the fol-6 lowing new paragraph:

"(h) The Committee on Rules may not report
a rule or order that would provide for the consideration of any appropriation measure or joint resolution under a closed rule. This paragraph may not be
waived except by an affirmative vote of two-thirds of
the Members voting, a quorum being present.".

1 SEC. ____. REQUIRING TWO-THIRDS APPROVAL FOR 2 CLOSED RULES.

Clause 6 of rule XIII of the Rules of the House of
Representatives is amended by adding at the end the following new paragraph:

6 "(h) The House may not adopt a rule or order 7 reported by the Committee on Rules that would pro-8 vide for the consideration of any bill or joint resolu-9 tion under a closed rule except by an affirmative 10 vote of two-thirds of the Members voting, a quorum 11 being present.".

1 SEC. _____. ELECTION OF CHAIRS OF COMMITTEES BY COM 2 MITTEE MEMBERS.

Clause 5(c)(1) of rule X of the Rules of the House
of Representatives is amended by striking "by the House,
on the nomination of the majority party caucus or conference," and inserting "by the members of the committee".

1 SEC. ____. PROHIBITING CHAIRS OF COMMITTEES FROM 2 SERVING FOR MORE THAN TWO CONSECU 3 TIVE CONGRESSES.

4 Clause 5(c)(2) of rule X of the Rules of the House
5 of Representatives is amended by striking "more than
6 three consecutive Congresses" and inserting "more than
7 two consecutive Congresses".

1 SEC. ____. PERMITTING PROXY VOTING IN COMMITTEES.

- 2 Clause 2 of rule XI of the Rules of the House of Rep-
- 3 resentatives is amended by striking paragraph (f).

SEC. ____. POINT OF ORDER AGAINST BILL AUTHORIZING
 OR APPROPRIATING FUNDS AFTER APRIL 15
 IF A BUDGET RESOLUTION HAS NOT PASSED
 THE HOUSE.

5 Rule XXI of the Rules of the House of Representa6 tives is amended by adding at the end the following new
7 clause:

8 "13.(a) It shall not be in order to consider a bill or 9 joint resolution authorizing or appropriating funds after 10 April 15 of a calendar year if a concurrent resolution on 11 the budget for the fiscal year beginning on October 1 of 12 that calendar year has not passed the House.

13 "(b) Paragraph (a) may only be waived by an affirm14 ative vote of two thirds of the Members voting, a quorum
15 being present.".

1 SEC. ____. OVERSIGHT RESPONSIBILITY OF INDIVIDUAL 2 MEMBERS.

Rule XXIII of the Rules of the House of Representa-3 tives is amended by redesignating clause 18 as clause 19 4 and by inserting after clause 18 the following new clause: 5 "18. A Member, Delegate, or Resident Commissioner 6 shall have the duty and responsibility to actively engage 7 in the oversight of programs and agencies within the juris-8 diction of the committees upon which such individual 9 10 serves.".

1 SEC. ____. CHALLENGING THE VALIDITY OF ANY CONSTITU 2 TIONAL AUTHORITY STATEMENT.

Clause 7(c) of rule XII of the Rules of the House
of Representatives is amended by adding at the end the
following new subparagraph:

6 "(3) Upon the consideration of any bill or joint reso7 lution for which a constitutional authority statement ap8 peared in the Record, any Member may make a point of
9 order against the validity of such statement.".

1 SEC. ____. READING OF THE BILL.

Clause 8 of rule XVI of the Rules of the House of
Representatives is amended by inserting "(a)" after "8.",
by redesignating paragraphs (a), (b), and (c), as subparagraphs (1), (2), and (3), and by adding at the end the
following new paragraph:

7 "(b) It shall not be in order to waive the first, second,
8 or third reading of a bill unless such waiver has been ap9 proved by a roll call vote with and affirmative vote of at
10 least two thirds of the Members voting, a quorum being
11 present.".

1 SEC. ____. CBO ESTIMATES.

Clause 3(c)(3) of rule XIII of the Rules of the House
of Representatives is amended by adding at the end the
following new sentence: "Any such estimate provided by
the Director shall, to the extent practicable, provide a
range of estimates based on economic variables instead of
one definitive estimate.".

1 SEC. ____. SUSPENSION OF THE RULES.

2 Clause 1 of rule XV of the Rules of the House of3 Representatives is amended by adding at the end the fol-4 lowing new paragraph:

5 "(d) A rule may not be suspended for any bill or joint
6 resolution if a cost estimate for that bill has not been pro7 vided by the Director of the Congressional Budget Office
8 or if that estimate indicates that such measure costs over
9 \$10,000,000.".
