Mr. BYRNE, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for further consideration of the bill (H.R. 5293) making appropriations for the Department of Defense for the fiscal year ending September 30, 2017, and for other purposes.

1 *Resolved*, That at any time after adoption of this reso-
2 lution the Speaker may, pursuant to clause 2(b) of rule
3 XVIII, declare the House resolved into the Committee of
4 the Whole House on the state of the Union for further
5 consideration of the bill (H.R. 5293) making appropria-
6 tions for the Department of Defense for the fiscal year

1 ending September 30, 2017, and for other purposes. No
2 further general debate shall be in order.

3 SEC. 2. (a) The bill shall be considered for amend-
4 ment under the five-minute rule. The bill shall be consid-
5 ered as read through page 170, line 7. Points of order
6 against provisions in the bill for failure to comply with
7 clause 2 of rule XXI are waived.

8 (b) No amendment to the bill shall be in order except
9 those printed in the report of the Committee on Rules ac-
10 companying this resolution, amendments en bloc described
11 in section 3 of this resolution, and pro forma amendments
12 described in section 4 of this resolution.

13 (c) Each amendment printed in the report of the
14 Committee on Rules shall be considered only in the order
15 printed in the report, may be offered only by a Member
16 designated in the report, shall be considered as read, shall
17 be debatable for the time specified in the report equally
18 divided and controlled by the proponent and an opponent,
19 shall not be subject to amendment except as provided by
20 section 4 of this resolution, and shall not be subject to
21 a demand for division of the question in the House or in
22 the Committee of the Whole.

23 (d) All points of order against amendments printed
24 in the report of the Committee on Rules or against amend-

1 ments en bloc described in section 3 of this resolution are
2 waived.

3 SEC. 3. It shall be in order at any time for the chair
4 of the Committee on Appropriations or his designee to
5 offer amendments en bloc consisting of amendments print-
6 ed in the report of the Committee on Rules accompanying
7 this resolution not earlier disposed of. Amendments en
8 bloc offered pursuant to this section shall be considered
9 as read, shall be debatable for 20 minutes equally divided
10 and controlled by the chair and ranking minority member
11 of the Committee on Appropriations or their respective
12 designees, shall not be subject to amendment except as
13 provided by section 4 of this resolution, and shall not be
14 subject to a demand for division of the question in the
15 House or in the Committee of the Whole.

16 SEC. 4. During consideration of the bill for amend-
17 ment, the chair and ranking minority member of the Com-
18 mittee on Appropriations or their respective designees may
19 offer up to 10 pro forma amendments each at any point
20 for the purpose of debate.

21 SEC. 5. At the conclusion of consideration of the bill
22 for amendment the Committee shall rise and report the
23 bill to the House with such amendments as may have been
24 adopted. The previous question shall be considered as or-
25 dered on the bill and amendments thereto to final passage

1 without intervening motion except one motion to recommit
2 with or without instructions.

3 SEC. 6. It shall be in order at any time on the legisla-
4 tive day of June 16, 2016, for the Speaker to entertain
5 motions that the House suspend the rules as though under
6 clause 1 of rule XV. The Speaker or his designee shall
7 consult with the Minority Leader or her designee on the
8 designation of any matter for consideration pursuant to
9 this section.
