(a) IN GENERAL.—The Weather Research and Forecasting Innovation Act of 2017 (15 U.S.C. 8501 et seq.)
is amended by adding at the end the following:

13 "TITLE VI—IMPROVING FED14 ERAL PRECIPITATION INFOR15 MATION

16 "SEC. 601. STUDY ON PRECIPITATION ESTIMATION.

17 "(a) IN GENERAL.—Not later than 90 days after the
18 date of enactment of the PRECIP Act, the Administrator,
19 in consultation with other Federal agencies as appropriate,
20 shall seek to enter an agreement with the National Acad21 emies—

"(1) to conduct a study on the state of practice
and research needs for precipitation estimation, including probable maximum precipitation estimation;
and

1	((2) to submit, not later than 24 months after
2	the date on which such agreement is finalized, to the
3	Committee on Science, Space, and Technology of the
4	House of Representatives and the Committee on
5	Commerce, Science, and Transportation of the Sen-
6	ate, and make publicly available on a website, a re-
7	port on the results of the study under paragraph
8	(1).
9	"(b) Study.—The report under subsection (a) shall
10	include the following:
11	"(1) An examination of the current state of
12	practice for precipitation estimation at scales appro-
13	priate for decisionmaker needs, and rationale for
14	further evolution of this field.
15	((2) An evaluation of best practices for precipi-
16	tation estimation that are based on the best-avail-
17	able science, include considerations of non-
18	stationarity, and can be utilized by the user commu-
19	nity.
20	"(3) A framework for—
21	"(A) the development of a National Guid-
22	ance Document for estimating extreme precipi-
23	tation in future conditions; and
24	"(B) evaluation of the strengths and chal-
25	lenges of the full spectrum of approaches, in-

cluding for probable maximum precipitation
 studies.

3 "(4) A description of existing research needs in
4 the field of precipitation estimation in order to mod5 ernize current methodologies and consider non6 stationarity.

7 "(5) A description of in-situ, airborne, and 8 space-based observation requirements, that could en-9 hance precipitation estimation and development of 10 models, including an examination of the use of geo-11 graphic information systems and geospatial tech-12 nology for integration, analysis, and visualization of 13 precipitation data.

"(6) A recommended plan for a Federal research and development program, including specifications for costs, timeframes, and responsible agencies for addressing identified research needs.

"(7) An analysis of the respective roles in precipitation estimation of various Federal agencies,
academia, State, tribal, territorial, and local governments, and other public and private stakeholders.

"(8) Recommendations for data management to
promote long-term needs such as enabling retrospective analyses and data discoverability, interoperability, and reuse.

"(9) Recommendations for how data and serv ices from the entire enterprise can be best leveraged
 by the Federal Government.

4 "(10) A description of non-Federal precipitation
5 data, its accessibility by the Federal Government,
6 and ways for National Oceanic and Atmospheric Ad7 ministration to improve or expand such datasets.

8 "(c) AUTHORIZATION OF APPROPRIATIONS.—There
9 is authorized \$1,500,000 to the National Oceanic and At10 mospheric Administration to carry out this study.

11 "SEC. 602. IMPROVING PROBABLE MAXIMUM PRECIPITA12 TION ESTIMATES.

13 "(a) IN GENERAL.—Not later than 90 days after the 14 date on which the National Academies makes public the 15 report under section 601, the Administrator, in consider-16 ation of the report recommendations, shall consult with 17 relevant partners, including users of the data, on the de-18 velopment of a plan to—

"(1) not later than 6 years after the completion
of such report and not less than every 10 years
thereafter, update probable maximum precipitation
estimates for the United States, such that each update considers non-stationarity;

24 "(2) coordinate with partners to conduct re-25 search in the field of extreme precipitation esti-

mation, in accordance with the research needs iden tified in such report;

3 "(3) make publicly available, in a searchable, 4 interoperable format, all probable maximum precipi-5 tation studies developed by the National Oceanic and 6 Atmospheric Administration that the Administrator 7 has the legal right to redistribute and deemed to be 8 at an appropriate state of development on an inter-9 net website of the National Oceanic and Atmos-10 pheric Administration; and

"(4) ensure all probable maximum precipitation
estimate data, products, and supporting documentation and metadata developed by the National Oceanic and Atmospheric Administration are preserved,
curated, and served by the National Oceanic and Atmospheric Administration, as appropriate.

17 "(b) NATIONAL GUIDANCE DOCUMENT FOR THE DE18 VELOPMENT OF PROBABLE MAXIMUM PRECIPITATION
19 ESTIMATES.—The Administrator, in collaboration with
20 Federal agencies, State, territorial, Tribal and local gov21 ernments, academia, and other partners the Administrator
22 deems appropriate, shall develop a National Guidance
23 Document that—

24 "(1) provides best practices that can be fol-25 lowed by Federal and State regulatory agencies, pri-

1	vate meteorological consultants, and other users that
2	perform probable maximum precipitation studies;
3	((2) considers the recommendations provided in
4	the National Academies study under section 601;
5	"(3) facilitates review of probable maximum
6	precipitation studies by regulatory agencies; and
7	"(4) provides confidence in regional and site-
8	specific probable maximum precipitation estimates.
9	"(c) PUBLICATION.—Not later than 2 years after the
10	date on which the National Academies makes public the
11	report under section 601, the Administrator shall make
12	publicly available the National Guidance Document under
13	subsection (b) on an internet website of the National Oce-
14	anic and Atmospheric Administration.
15	"(d) UPDATES.—The Administrator shall update the
16	National Guidance Document not less than once every 10
17	years after the publication of the National Guidance Docu-
18	ment under subsection (c) and publish such updates in
19	accordance with such subsection.
20	"SEC. 603. DEFINITIONS.
21	" In this title:
22	"(1) Administrator.—The term 'Adminis-
23	trator' means the Under Secretary of Commerce for
24	Oceans and Atmosphere and Administrator of the

25 National Oceanic and Atmospheric Administration.

"(2) NATIONAL ACADEMIES.—The term 'Na tional Academies' means the National Academies of
 Sciences, Engineering, and Medicine.

(3)4 UNITED STATES.—The term 'United 5 States' means, collectively, each State of the United 6 States, the District of Columbia, the Commonwealth 7 of Puerto Rico, American Samoa, Guam, the Com-8 monwealth of the Northern Mariana Islands, the 9 Virgin Islands of the United States, and any other 10 territory or possession of the United States.".
