RESOLUTION

Providing for consideration of the Senate amendment to the House amendment to the Senate amendment to the bill (H.R. 4346) making appropriations for the Legislative Branch for the fiscal year ending September 30, 2022, and for other purposes, and providing for proceedings during the period from August 1, 2022, through September 12, 2022.

Branch for the fiscal year ending September 30, 2022, 1 2 and for other purposes, with the Senate amendment to 3 the House amendment to the Senate amendment thereto, 4 and to consider in the House, without intervention of any 5 point of order, a motion offered by the chair of the Committee on Science, Space, and Technology or her designee 6 7 that the House concur in the Senate amendment to the 8 House amendment to the Senate amendment. The Senate 9 amendment and the motion shall be considered as read. 10 The motion shall be debatable for one hour equally divided and controlled by the chair and ranking minority member 11 12 of the Committee on Science, Space, and Technology or 13 their respective designees. The previous question shall be considered as ordered on the motion to its adoption with-14 15 out intervening motion.

SEC. 2. On any legislative day during the period from
August 1, 2022, through September 12, 2022, the Journal
of the proceedings of the previous day shall be considered
as approved.

SEC. 3. The Speaker may appoint Members to perform the duties of the Chair for the duration of the period
addressed by section 2 of this resolution as though under
clause 8(a) of rule I.

SEC. 4. Each day during the period addressed by sec-tion 2 of this resolution shall not constitute a calendar

day for purposes of section 7 of the War Powers Resolu tion (50 U.S.C. 1546).

- 3 SEC. 5. Each day during the period addressed by sec4 tion 2 of this resolution shall not constitute a legislative
 5 day for purposes of clause 7 of rule XIII.
- 6 SEC. 6. Each day during the period addressed by sec7 tion 2 of this resolution shall not constitute a calendar
 8 or legislative day for purposes of clause 7(c)(1) of rule
 9 XXII.

SEC. 7. Each day during the period addressed by section 2 of this resolution shall not constitute a legislative
day for purposes of clause 7 of rule XV.
