Mr. BURGESS, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 347) to require the Executive Office of the President to provide an inflation estimate with respect to Executive orders with a significant effect on the annual gross budget, and for other purposes, and providing for consideration of the joint resolution (H.J. Res. 30) providing for congressional disapproval under chapter 8 of title 5, United States Code, of the rule submitted by the Department

of Labor relating to “Prudence and Loyalty in Selecting Plan Investments and Exercising Shareholder Rights”.

1 *Resolved*, That at any time after adoption of this reso-
2 lution the Speaker may, pursuant to clause 2(b) of rule
3 XVIII, declare the House resolved into the Committee of
4 the Whole House on the state of the Union for consider-
5 ation of the bill (H.R. 347) to require the Executive Office
6 of the President to provide an inflation estimate with re-
7 spect to Executive orders with a significant effect on the
8 annual gross budget, and for other purposes. The first
9 reading of the bill shall be dispensed with. All points of
10 order against consideration of the bill are waived. General
11 debate shall be confined to the bill and shall not exceed
12 one hour equally divided and controlled by the chair and
13 ranking minority member of the Committee on Oversight
14 and Accountability or their respective designees. After
15 general debate the bill shall be considered for amendment
16 under the five-minute rule. The bill shall be considered
17 as read. All points of order against provisions in the bill
18 are waived. No amendment to the bill shall be in order
19 except those printed in the report of the Committee on
20 Rules accompanying this resolution. Each such amend-
21 ment may be offered only in the order printed in the re-
22 port, may be offered only by a Member designated in the
23 report, shall be considered as read, shall be debatable for
24 the time specified in the report equally divided and con-

1 trolled by the proponent and an opponent, shall not be
2 subject to amendment, and shall not be subject to a de-
3 mand for division of the question in the House or in the
4 Committee of the Whole. All points of order against such
5 amendments are waived. At the conclusion of consider-
6 ation of the bill for amendment the Committee shall rise
7 and report the bill to the House with such amendments
8 as may have been adopted. The previous question shall
9 be considered as ordered on the bill and amendments
10 thereto to final passage without intervening motion except
11 one motion to recommit.

12 SEC. 2. Upon adoption of this resolution it shall be
13 in order to consider in the House the joint resolution (H.J.
14 Res. 30) providing for congressional disapproval under
15 chapter 8 of title 5, United States Code, of the rule sub-
16 mitted by the Department of Labor relating to “Prudence
17 and Loyalty in Selecting Plan Investments and Exercising
18 Shareholder Rights”. All points of order against consider-
19 ation of the joint resolution are waived. The joint resolu-
20 tion shall be considered as read. All points of order against
21 provisions in the joint resolution are waived. The previous
22 question shall be considered as ordered on the joint resolu-
23 tion and on any amendment thereto to final passage with-
24 out intervening motion except: (1) one hour of debate
25 equally divided and controlled by the chair and ranking

1 minority member of the Committee on Education and the
2 Workforce or their respective designees; and (2) one mo-
3 tion to recommit.
