1 That the following sums are appropriated, out of any 2 money in the Treasury not otherwise appropriated, for the 3 Department of Homeland Security for the fiscal year end-4 ing September 30, 2025, and for other purposes, namely: 5 TITLE I DEPARTMENTAL INTEL-6 MANAGEMENT, 7 LIGENCE, SITUATIONAL AWARENESS, AND **OVERSIGHT** 8 9 OFFICE OF THE SECRETARY AND EXECUTIVE 10 MANAGEMENT 11 **OPERATIONS AND SUPPORT** 12 For necessary expenses of the Office of the Secretary 13 and for executive management for operations and support, \$281,358,000, of which \$22,151,000 shall remain avail-14 15 able until September 30, 2026: Provided, That \$5,000,000 shall be withheld from obligation until the Secretary sub-16 17 mits, to the Committees on Appropriations of the House  $\mathbf{2}$ 

of Representatives and the Senate, responses to all ques tions for the record for each hearing on the fiscal year
 2026 budget submission for the Department of Homeland
 Security held by such Committees prior to July 1: *Pro- vided further*, That not to exceed \$30,000 shall be for offi cial reception and representation expenses.

7 MANAGEMENT DIRECTORATE8 OPERATIONS AND SUPPORT

9 For necessary expenses of the Management Direc-10 torate for operations and support, \$1,637,290,000: *Pro-*11 *vided*, That not to exceed \$2,000 shall be for official recep-12 tion and representation expenses.

13 PROCUREMENT, CONSTRUCTION, AND IMPROVEMENTS

For necessary expenses of the Management Directorate for procurement, construction, and improvements,
\$54,337,000, to remain available until September 30,

Not later than 30 days after the last day of each month, the Chief Financial Officer of the Depart-11 12 ment of Homeland Security shall submit to the Commit-13 tees on Appropriations of the House of Representatives and the Senate a monthly budget and staffing report that 14 15 includes total obligations of the Department for that month and for the fiscal year at the appropriation and 16 17 program, project, and activity levels, by the source year 18 of the appropriation.

SEC. 103. (a) The Secretary of Homeland Security,
in consultation with the Secretary of the Treasury, shall
notify the Committees on Appropriations of the House of
Representatives and the Senate of any proposed transfers
of funds available under section 9705(g)(4)(B) of title 31,
United States Code, from the Department of the Treasury

Forfeiture Fund to any agency within the Department of
 Homeland Security.

SEC. 104. All official costs associated with the use

made available for the Office of the Secretary.

12 SEC. 105. (a) The Under Secretary for Management 13 shall brief the Committees on Appropriations of the House of Representatives and the Senate not later than 45 days 14 15 after the end of each fiscal quarter on all Level 1 and Level 2 acquisition programs on the Master Acquisition 16 Oversight list between Acquisition Decision Event and 17 Full Operational Capability, including programs that have 18 been removed from such list during the preceding quarter. 19 20 (b) For each such program, the briefing described in 21 subsection (a) shall include—

(1) a description of the purpose of the program,
including the capabilities being acquired and the
component(s) sponsoring the acquisition;

22	(C) a breakout of the estimate for the
23	prior five years, the current year, and the budg-
24	et year;

8	pendent verification and validation of the items to be
9	acquired or an explanation for why no such
10	verification and validation has been performed;
11	(7) a table displaying the obligation of all pro-
12	gram funds by prior fiscal year, the estimated obli-
13	gation of funds for the current fiscal year, and an
14	estimate for the planned carryover of funds into the
15	subsequent fiscal year;
16	(8) a listing of prime contractors and major
17	subcontractors; and
18	(9) narrative descriptions of risks to cost,
19	schedule, or performance that could result in a pro-
20	gram breach if not successfully mitigated.
21	(c) The Under Secretary for Management shall sub-
22	mit each approved Acquisition Decision Memorandum for
23	programs described in this section to the Committees on
24	Appropriations of the House of Representatives and the
25	Senate not later than five business days after the date of

approval of such memorandum by the Under Secretary for
 Management or the designee of the Under Secretary for
 Management.

4 SEC. 106. (a) None of the funds made available to 5 the Department of Homeland Security in this Act or prior 6 appropriations Acts may be obligated for any new pilot 7 or demonstration unless the component or office carrying 8 out such pilot or demonstration has documented the infor-9 mation described in subsection (c).

10 (b) Prior to the obligation of any such funds made 11 available for "Operations and Support" for a new pilot 12 or demonstration, the Under Secretary for Management 13 shall provide a report to the Committees on Appropria-14 tions of the House of Representatives and the Senate on 15 the information described in subsection (c).

16 (c) The information required under subsections (a)
17 and (b) for a pilot or demonstration shall include the fol18 lowing—

19 (1) documented objectives that are well-defined20 and measurable;

21 (2) an assessment methodology that details—

22 (A) the type and source of assessment23 data;

24 (B) the methods for, and frequency of, collecting such data; and

(C) how such data will be analyzed; and
 (3) an implementation plan, including mile stones, cost estimates, and implementation sched ules, including a projected end date.

5 (d) Not later than 90 days after the date of completion of a pilot or demonstration described in subsection 6 7 (e), the Under Secretary for Management shall provide a 8 report to the Committees on Appropriations of the House 9 of Representatives and the Senate detailing lessons learned, actual costs, any planned expansion or continu-10 11 ation of the pilot or demonstration, and any planned tran-12 sition of such pilot or demonstration into an enduring pro-13 gram or operation.

(e) For the purposes of this section, a pilot or dem15 onstration program is a study, demonstration, experi16 mental program, or trial that—

(1) is a small-scale, short-term experiment conducted in order to evaluate feasibility, duration,
costs, or adverse events, and improve upon the design of an effort prior to implementation of a larger
scale effort; and

(2) uses more than 10 full-time equivalents or
obligates, or proposes to obligate, \$5,000,000 or
more, but does not include congressionally directed
programs or enhancements and does not include pro-

grams that were in operation as of the date of the
 enactment of this Act.

3 (f) For the purposes of this section, a pilot or dem4 onstration does not include any testing, evaluation, or ini5 tial deployment phase executed under a procurement con6 tract for the acquisition of information technology services
7 or systems, or any pilot or demonstration carried out by
8 a non-Federal recipient under any financial assistance
9 agreement funded by the Department.

3 For necessary expenses of the United States Secret 4 Service for operations and support, including purchase of 5 not to exceed 652 vehicles for police-type use; hire of pas-6 senger motor vehicles; purchase of motorcycles made in 7 the United States: hire of aircraft; rental of buildings in 8 the District of Columbia; fencing, lighting, guard booths, 9 and other facilities on private or other property not in 10 Government ownership or control, as may be necessary to perform protective functions; conduct of and participation 11 12 in firearms matches; presentation of awards; conduct of 13 behavioral research in support of protective intelligence 14 and operations; payment in advance for commercial ac-15 commodations as may be necessary to perform protective 16 functions; and payment, without regard to section 5702 17 of title 5, United States Code, of subsistence expenses of 18 employees who are on protective missions, whether at or 19 away from their duty stations; \$3,017,524,000; of which 20 \$80,041,000 shall remain available until September 30, 21 2026, and of which \$6,000,000 shall be for a grant for 22 activities related to investigations of missing and exploited 23 children; and of which up to \$24,000,000 may be for cal-24 endar year 2024 premium pay in excess of the annual equivalent of the limitation on the rate of pay contained 25

in section 5547(a) of title 5, United States Code, pursuant 1 to section 2 of the Overtime Pay for Protective Services 2 3 Act of 2016 (5 U.S.C. 5547 note), as last amended by 4 Public Law 118–38: *Provided*, That not to exceed \$19,125 5 shall be for official reception and representation expenses: *Provided further*, That not to exceed \$100,000 shall be to 6 7 provide technical assistance and equipment to foreign law 8 enforcement organizations in criminal investigations with-9 in the jurisdiction of the United States Secret Service.

limitations, shall apply with respect to funds made available in this Act in the same manner as such section ap-

plied to funds made available in that Act, except that "fis cal year 2025" shall be substituted for "fiscal year 2018".

3 SEC. 202. Funding made available under the head-4 ings "U.S. Customs and Border Protection—Operations and Support" and "U.S. Customs and Border Protec-5 tion—Procurement, Construction, and Improvements" 6 7 shall be available for customs expenses when necessary to 8 maintain operations and prevent adverse personnel actions 9 in Puerto Rico and the U.S. Virgin Islands, in addition 10 to funding provided by sections 740 and 1406i of title 48, 11 United States Code.

12 SEC. 203. As authorized by section 601(b) of the 13 United States-Colombia Trade Promotion Agreement Im-14 plementation Act (Public Law 112–42), fees collected 15 from passengers arriving from Canada, Mexico, or an ad-16 jacent island pursuant to section 13031(a)(5) of the Con-17 solidated Omnibus Budget Reconciliation Act of 1985 (19 18 U.S.C. 58c(a)(5)) shall be available until expended.

19 SEC. 204. (a) For an additional amount for "U.S. 20 Customs and Border Protection—Operations and Sup-21 port", \$31,000,000, to remain available until expended, 22 to be reduced by amounts collected and credited to this 23 appropriation in fiscal year 2025 from amounts authorized 24 to be collected by section 286(i) of the Immigration and 25 Nationality Act (8 U.S.C. 1356(i)), section 10412 of the

Farm Security and Rural Investment Act of 2002 (7
 U.S.C. 8311), and section 817 of the Trade Facilitation
 and Trade Enforcement Act of 2015 (Public Law 114–
 125), or other such authorizing language.

5 (b) To the extent that amounts realized from such 6 collections exceed \$31,000,000, those amounts in excess 7 of \$31,000,000 shall be credited to this appropriation, to 8 remain available until expended.

9 SEC. 205. None of the funds made available in this 10 Act for U.S. Customs and Border Protection may be used to prevent an individual not in the business of importing 11 a prescription drug (within the meaning of section 801(g) 12 13 of the Federal Food, Drug, and Cosmetic Act) from importing a prescription drug from Canada that complies 14 with the Federal Food, Drug, and Cosmetic Act: Provided, 15 That this section shall apply only to individuals trans-16 porting on their person a personal-use quantity of the pre-17 18 scription drug, not to exceed a 90-day supply: *Provided* 19 *further*, That the prescription drug may not be—

20 (1) a controlled substance, as defined in section
21 102 of the Controlled Substances Act (21 U.S.C.
22 802); or

23 (2) a biological product, as defined in section
24 351 of the Public Health Service Act (42 U.S.C.
25 262).

1 SEC. 206. (a) Notwithstanding any other provision 2 of law, none of the funds provided in this or any other 3 Act shall be used to approve a waiver of the navigation 4 and vessel-inspection laws pursuant to section 501(b) of 5 title 46, United States Code, for the transportation of crude oil distributed from and to the Strategic Petroleum 6 7 Reserve until the Secretary of Homeland Security, after 8 consultation with the Secretaries of the Departments of 9 Energy and Transportation and representatives from the 10 United States flag maritime industry, takes adequate measures to ensure the use of United States flag vessels. 11

12 (b) The Secretary shall notify the Committees on Ap-13 propriations of the House of Representatives and the Senate, the Committee on Transportation and Infrastructure 14 15 of the House of Representatives, and the Committee on Commerce, Science, and Transportation of the Senate 16 within 2 business days of any request for waivers of navi-17 gation and vessel-inspection laws pursuant to section 18 501(b) of title 46, United States Code, with respect to 19 20such transportation, and the disposition of such requests. 21 SEC. 207. (a) Beginning on the date of enactment 22 of this Act, the Secretary of Homeland Security shall 23 not-

24 (1) establish, collect, or otherwise impose any25 new border crossing fee on individuals crossing the

Southern border or the Northern border at a land
 port of entry; or

3 (2) conduct any study relating to the imposition4 of a border crossing fee.

5 (b) In this section, the term "border crossing fee"
6 means a fee that every pedestrian, cyclist, and driver and
7 passenger of a private motor vehicle is required to pay

None of the funds appropriated or otherwise made available by this Act may be made available 6 7 to admit an alien into the United States at a port of entry 8 on an F or M visa if the college, university, or other insti-9 tution of higher learning that the student will attend is 10 not accredited by a nationally recognized accrediting agency or association recognized by the Secretary of Education 11 pursuant to part H of title IV of the Higher Education 12 13 Act of 1965 (20 U.S.C. 1099a et seq.).

14 SEC. 216. None of the funds appropriated or other-15 wise made available by this Act may be made available 16 to parole into the Commonwealth of the Northern Mariana 17 Islands, for the purpose of temporary visit for business 18 or pleasure without a visa, an alien who is a national of 19 the People's Republic of China.

SEC. 217. (a) None of the funds appropriated or otherwise made available by this Act may be used by U.S.

produced or manufactured in a foreign adversary country.

(b) The term "foreign adversary country" means a
 country specified in section 4872(d)(2) of title 10, United
 States Code.

4 SEC. 218. None of the funds appropriated or other-5 wise made available by this Act may be made available 6 to reduce participation in or substantively diminish the 7 delegation of law enforcement authority authorized under 8 section 287(g) of the Immigration and Nationality Act (8 9 U.S.C. 1357(g)), except as provided in section 219 of this 10 Act.

11 SEC. 219. None of the funds provided under the 12 heading "U.S. Immigration and Customs Enforcement— Operations and Support" may be used to continue a dele-13 gation of law enforcement authority authorized under sec-14 15 tion 287(g) of the Immigration and Nationality Act (8) U.S.C. 1357(g)) if the Department of Homeland Security 16 Inspector General determines that the terms of the agree-17 ment governing the delegation of authority have been ma-18 19 terially violated.

SEC. 220. (a) None of the funds provided under the heading "U.S. Immigration and Customs Enforcement— Operations and Support" may be used to continue any contract for the provision of detention services if the two most recent overall performance evaluations received by the contracted facility are less than "adequate" or the

equivalent median score in any subsequent performance
 evaluation system.

3 (b) The performance evaluations referenced in sub4 section (a) shall be conducted by the U.S. Immigration
5 and Customs Enforcement Office of Professional Respon6 sibility.

SEC. 221. Without regard to the limitation as to time

14 SEC. 225. (a) None of the funds provided by this Act, provided by previous appropriations Acts to the compo-6 7 nents in or transferred to the Department of Homeland 8 Security that remain available for obligation or expendi-9 ture in fiscal year 2025, or provided from any accounts 10 in the Treasury of the United States derived by the collection of fees available to the components funded by this 11 12 Act, shall be available for obligation or expenditure through a reprogramming of funds that— 13

- (1) creates or eliminates a program, project, or
  activity, or increases funds for any program, project,
  or activity for which funds have been denied or restricted by the Congress;
- (2) contracts out any function or activity presently performed by Federal employees or any new
  function or activity proposed to be performed by
  Federal employees in the President's budget proposal for fiscal year 2025 for the Department of
  Homeland Security;

(3) augments funding for existing programs,
 projects, or activities in excess of \$5,000,000 or 10
 percent, whichever is less;

8 sources, as applicable; and

9 (5) other information as determined by the Sec-10 retary.

11 SEC. 534. Within 60 days of any budget submission 12 for the Department of Homeland Security for fiscal year 13 2026 that assumes revenues or proposes a reduction from the previous year based on user fees proposals that have 14 15 not been enacted into law prior to the submission of the budget, the Secretary of Homeland Security shall provide 16 the Committees on Appropriations of the House of Rep-17 18 resentatives and the Senate specific reductions in proposed 19 discretionary budget authority commensurate with the 20revenues assumed in such proposals in the event that they 21 are not enacted prior to October 1, 2025.

SEC. 535. None of the funds made available by this
Act may be obligated or expended to implement the Arms
Trade Treaty until the Senate approves a resolution of
ratification for the Treaty.

1 SEC. 536. No Federal funds made available to the 2 Department of Homeland Security may be used to enter 3 into a procurement contract, memorandum of under-4 standing, or cooperative agreement with, or make a grant 5 to, or provide a loan or guarantee to, any entity identified under section 1260H of the William M. (Mac) Thornberry 6 7 National Defense Authorization Act for Fiscal Year 2021 8 (Public Law 116–283) or any subsidiary of such entity. 9 SEC. 537. None of the funds appropriated or other-10 wise made available in this or any other Act may be used to transfer, release, or assist in the transfer or release to 11 12 or within the United States, its territories, or possessions 13 Khalid Sheikh Mohammed or any other detainee who— 14 (1) is not a United States citizen or a member 15 of the Armed Forces of the United States; and 16 (2) is or was held on or after June 24, 2009, 17 at the United States Naval Station, Guantanamo 18 Bay, Cuba, by the Department of Defense. 19 SEC. 538. (a) The Secretary of Homeland Security 20 (in this section referred to as the "Secretary") shall, on 21 a bimonthly basis beginning immediately after the date of 22 enactment of this Act, develop estimates of the number 23 of aliens anticipated to arrive at the southwest border of the United States. 24

1	(b) The Secretary shall ensure that, at a minimum,

9 (iii) a description and quantification 10 of the anticipated workload and require-11 ments resulting from such estimates; and 12 (iv) a confirmation as to whether the 13 budget requests for impacted agencies were

(c) The Secretary shall share the bimonthly estimates
developed pursuant to subsection (a) with the Secretary
of Health and Human Services, the Attorney General, the
Secretary of State, and the Committees on Appropriations
of the House of Representatives and the Senate.

(d) If the bimonthly estimates described in subsection
(b) are not provided for the purposes described, the reprogramming and transfer authority provided in section
503 of this Act shall be suspended until such time as the

SEC. 540. Funds made available in this Act or any
 other Act for Operations and Support may be used for
 the necessary expenses of providing an employee emer gency back-up care program.

SEC. 541. (a) Not less than \$5,000,000 made available in this Act shall be transferred to "U.S. Immigration
and Customs Enforcement—Operations and Support" to
support and conduct necessary operations of the Blue
Campaign for fiscal year 2025.

(b) Prior to the obligation of funds made available
by subsection (a), notification shall be submitted to the
Committees on Appropriations of the House of Representatives and the Senate.

14 SEC. 542. (a) None of the funds appropriated or oth-15 erwise made available by this Act or any other Act shall be used to execute an inspection of a detention facility that 16 is in a contractual agreement with U.S. Immigration and 17 Customs Enforcement for the provision of detention serv-18 ices and that is subject to the terms, conditions, and 19 20standards found within the National Detention Standards 21 for Non-Dedicated Facilities, as revised in 2019 for U.S. 22 Immigration and Customs Enforcement, except solely for 23 compliance with the terms, conditions, and standards 24 found within the National Detention Standards for Non-Dedicated Facilities, as revised in 2019. 25

(b) Executions of inspections described in subsection
 (a) shall not occur within six months of a previous inspec tion of such facility, except with respect to inspections exe cuted by the Office of Inspector General.

5 SEC. 543. None of the funds appropriated or other6 wise made available by this Act may be made available
7 to implement, administer, or enforce the rule entitled
8 "Circumvention of Lawful Pathways" (88 Fed. Reg.
9 11704).

10 SEC. 544. None of the funds appropriated or other-11 wise made available by this Act may be made available 12 to establish or support the activities of a Disinformation 13 Governance Board at the Department of Homeland Secu-14 rity, or any other similar entity carrying out activities re-15 lating to disinformation in a similar manner or to a similar 16 extent to such a Board.

17 SEC. 545. None of the funds appropriated or other-18 wise made available by this Act may be made available19 to:

20 (a) classify or facilitate the classification of any com21 munications by a United States person as mis-, dis-, or
22 mal-information; or

(b) partner with or fund nonprofit or other organizations that pressure or recommend private companies to
censor lawful and constitutionally protected speech of

United States persons, including recommending the cen soring or removal of content on social media platforms.
 (c) Any officer or employee of the Federal Govern ment whose salary is funded by this Act and who conducts
 any activity described in (a) or (b) shall be removed from

6 the Federal service.

7 SEC. 546. None of the funds appropriated or other-8 wise made available by this Act may be made available 9 to implement, administer, apply, enforce, or carry out the 10 Equity Action Plan of the Department of Homeland Security, or Executive Order No. 13985 of January 20, 2021 11 12 (86 Fed. Reg. 7009, relating to advancing racial equity 13 and support for underserved communities through the federal government), Executive Order No. 14035 of June 25, 14 15 2021 (86 Fed. Reg. 34593, relating to diversity, equity, inclusion, and accessibility in the federal workforce), Exec-16 utive Order No. 14091 of February 16, 2023 (88 Fed. 17 Reg. 10825 relating to further advancing racial equity and 18 19 support for underserved communities through the federal government) or any program, project, or activity that pro-20 21 motes or advances Critical Race Theory or any concept 22 associated with Critical Race Theory.

SEC. 547. (a) In general.—Notwithstanding section
7 of title 1, United States Code, section 1738C of title
28, United States Code, or any other provision of law,

1 none of the funds provided by this Act, or previous appro2 priations Acts, shall be used in whole or in part to take
3 any discriminatory action against a person, wholly or par4 tially, on the basis that such person speaks, or acts, in
5 accordance with a sincerely held religious belief, or moral
6 conviction, that marriage is, or should be recognized as,
7 a union of one man and one woman.

8 (b) Discriminatory action defined.—As used in sub9 section (a), a discriminatory action means any action
10 taken by the Federal Government to—

(1) alter in any way the Federal tax treatment
of, or cause any tax, penalty, or payment to be assessed against, or deny, delay, or revoke an exemption from taxation under section 501(a) of the Internal Revenue Code of 1986 of, any person referred to
in subsection (a);

17 (2) disallow a deduction for Federal tax pur18 poses of any charitable contribution made to or by
19 such person;

20 (3) withhold, reduce the amount or funding for,
21 exclude, terminate, or otherwise make unavailable or
22 deny, any Federal grant, contract, subcontract, co23 operative agreement, guarantee, loan, scholarship, li24 cense, certification, accreditation, employment, or

other similar position or status from or to such per son;

3 (4) withhold, reduce, exclude, terminate, or oth4 erwise make unavailable or deny, any entitlement or
5 benefit under a Federal benefit program, including
6 admission to, equal treatment in, or eligibility for a
7 degree from an educational program, from or to
8 such person; or

9 (5) withhold, reduce, exclude, terminate, or oth-10 erwise make unavailable or deny access or an entitle-11 ment to Federal property, facilities, educational in-12 stitutions, speech fora (including traditional, limited, 13 and nonpublic fora), or charitable fundraising cam-14 paigns from or to such person.

15 (c) Accreditation; Licensure; Certification.—The Federal Government shall consider accredited, licensed, or 16 17 certified for purposes of Federal law any person that 18 would be accredited, licensed, or certified, respectively, for 19 such purposes but for a determination against such person wholly or partially on the basis that the person speaks, 20 21 or acts, in accordance with a sincerely held religious belief 22 or moral conviction described in subsection (a).

SEC. 548. (a) None of the funds appropriated or otherwise made available in this or any other Act may be used
to license, facilitate, coordinate, or otherwise allow officials

of a country designated as a state sponsor of terrorism
 within the past three fiscal years, to, in their capacity as
 an official, observe, tour, visit, or confer with the employ ees of the Department of Homeland Security.

5 (b) The term "state sponsor of terrorism" means a country the government of which the Secretary of State 6 7 determines has repeatedly provided support for inter-8 national terrorism pursuant to section 1754(c)(1)(A) of 9 the Export Control Reform Act of 2018 (50 U.S.C. 10 4813(c)(1)(A); section 620A of the Foreign Assistance Act of 1961 (22 U.S.C. 2371); section 40 of the Arms 11 Export Control Act (22 U.S.C. 2780); or any other provi-12 sion of law. 13

SEC. 549. None of the funds made available by this
Act may be used to obligate or award funds to a political
subdivision of a State that—

(a) has in effect any law, policy, or procedure, whether written or communicated orally, in contravention of, or
which substantially limits compliance with, subsection (a)
or (b) of section 642 of the Illegal Immigration Reform
and Immigration Responsibility Act of 1996 (8 U.S.C.
1373); or

(b) has in effect any law, policy, or procedure, wheth-er written or communicated orally, the result of which

hinders the federal government from enforcing the immi gration laws as defined by 8 U.S.C. 101(a)(17).

3 (RESCISSIONS OF FUNDS)

4 SEC. 550. Of the funds appropriated to the Depart-5 ment of Homeland Security, the following funds are hereby rescinded from the following accounts and programs 6 7 in the specified amounts: *Provided*, That no amounts may 8 be rescinded from amounts that were designated by the 9 Congress as an emergency requirement pursuant to a con-10 current resolution on the budget or the Balanced Budget 11 and Emergency Deficit Control Act of 1985:

(1) \$600,000,000 from the unobligated balances available under the heading "U.S. Customs
and Border Protection—Procurement, Construction,
and Improvements" of the amounts provided by
Public Law 116–260 for the construction of barrier
system along the southwest border.

18 SEC. 551. Of the unobligated balances in the "De19 partment of Homeland Security Nonrecurring Expenses
20 Fund" established in section 538 of division F of Public
21 Law 117–103, \$154,000,000 are hereby rescinded.
