A BILL

Making consolidated appropriations for the fiscal year ending September 30, 2026, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Commerce, Justice,
5 Science; Energy and Water Development; and Interior and
6 Environment Appropriations Act, 2026”.

1 SEC. 3. REFERENCES.

2 Except as expressly provided otherwise, any reference
3 to “this Act” contained in any division of this Act shall
4 be treated as referring only to the provisions of that divi-
5 sion.

6 SEC. 4. EXPLANATORY STATEMENT.

7 The explanatory statement regarding this Act, print-
8 ed in the House section of the Congressional Record on
9 or about January 7, 2026, and submitted by the chair of
10 the Committee on Appropriations of the House, shall have
11 the same effect with respect to the allocation of funds and
12 implementation of divisions A through C of this Act as
13 if it were a joint explanatory statement of a committee
14 of conference.

1 SEC. 5. STATEMENT OF APPROPRIATIONS.

2 The following sums in this Act are appropriated, out
3 of any money in the Treasury not otherwise appropriated,
4 for the fiscal year ending September 30, 2026.

1 **DIVISION A—COMMERCE, JUSTICE,**
2 **SCIENCE, AND RELATED AGENCIES**
3 **APPROPRIATIONS ACT, 2026**

4 TITLE I

5 DEPARTMENT OF COMMERCE

6 INTERNATIONAL TRADE ADMINISTRATION

7 OPERATIONS AND ADMINISTRATION

8 For necessary expenses for international trade activi-
9 ties of the Department of Commerce provided for by law,
10 to carry out activities associated with facilitating, attract-
11 ing, and retaining business investment in the United
12 States, to carry out activities associated with title VI of
13 division BB of the Consolidated Appropriations Act, 2023
14 (Public Law 117–328), and for engaging in trade pro-
15 motional activities abroad, including expenses of grants
16 and cooperative agreements for the purpose of promoting
17 exports of United States firms, without regard to sections
18 3702 and 3703 of title 44, United States Code; full med-
19 ical coverage for dependent members of immediate fami-
20 lies of employees stationed overseas and employees tempo-
21 rarily posted overseas; travel and transportation of em-
22 ployees of the International Trade Administration between
23 two points abroad, without regard to section 40118 of title
24 49, United States Code; employment of citizens of the
25 United States and aliens by contract for services; recog-

1 nizing contributions to export expansion pursuant to Exec-
2 utive Order 10978; rental of space abroad for periods not
3 exceeding 10 years, and expenses of alteration, repair, or
4 improvement; purchase or construction of temporary de-
5 mountable exhibition structures for use abroad; payment
6 of tort claims, in the manner authorized in the first para-
7 graph of section 2672 of title 28, United States Code,
8 when such claims arise in foreign countries; not to exceed
9 \$294,300 for official representation expenses abroad; pur-
10 chase of passenger motor vehicles for official use abroad,
11 not to exceed \$65,000 per vehicle; not to exceed \$350,000
12 for purchase of armored vehicles without regard to the
13 general purchase price limitations; obtaining insurance on
14 official motor vehicles; and rental of tie lines,
15 \$582,000,000, of which \$94,000,000 shall remain avail-
16 able until September 30, 2027: *Provided*, That
17 \$20,000,000 is to be derived from fees to be retained and
18 used by the International Trade Administration, notwith-
19 standing section 3302 of title 31, United States Code: *Pro-*
20 *vided further*, That, of amounts provided under this head-
21 ing, not less than \$16,400,000 shall be for China anti-
22 dumping and countervailing duty enforcement and compli-
23 ance activities: *Provided further*, That the provisions of the
24 first sentence of section 105(f) and all of section 108(c)
25 of the Mutual Educational and Cultural Exchange Act of

1 1961 (22 U.S.C. 2455(f) and 2458(c)) shall apply in car-
2 rying out these activities; and that for the purpose of this
3 Act, contributions under the provisions of the Mutual
4 Educational and Cultural Exchange Act of 1961 shall in-
5 clude payment for assessments for services provided as
6 part of these activities.

7 BUREAU OF INDUSTRY AND SECURITY

8 OPERATIONS AND ADMINISTRATION

9 For necessary expenses for export administration and
10 national security activities of the Department of Com-
11 merce, including costs associated with the performance of
12 export administration field activities both domestically and
13 abroad; full medical coverage for dependent members of
14 immediate families of employees stationed overseas; em-
15 ployment of citizens of the United States and aliens by
16 contract for services abroad; payment of tort claims, in
17 the manner authorized in the first paragraph of section
18 2672 of title 28, United States Code, when such claims
19 arise in foreign countries; not to exceed \$13,500 for offi-
20 cial representation expenses abroad; awards of compensa-
21 tion to informers under the Export Control Reform Act
22 of 2018 (subtitle B of title XVII of the John S. McCain
23 National Defense Authorization Act for Fiscal Year 2019;
24 Public Law 115–232; 132 Stat. 2208; 50 U.S.C. 4801 et
25 seq.), and as authorized by section 1(b) of the Act of June

1 15, 1917 (40 Stat. 223; 22 U.S.C. 401(b)); and purchase
2 of passenger motor vehicles for official use and motor vehi-
3 cles for law enforcement use with special requirement vehi-
4 cles eligible for purchase without regard to any price limi-
5 tation otherwise established by law, \$235,000,000, of
6 which \$94,000,000 shall remain available until expended:
7 *Provided*, That the provisions of the first sentence of sec-
8 tion 105(f) and all of section 108(c) of the Mutual Edu-
9 cational and Cultural Exchange Act of 1961 (22 U.S.C.
10 2455(f) and 2458(c)) shall apply in carrying out these ac-
11 tivities: *Provided further*, That payments and contribu-
12 tions collected and accepted for materials or services pro-
13 vided as part of such activities may be retained for use
14 in covering the cost of such activities, and for providing
15 information to the public with respect to the export admin-
16 istration and national security activities of the Depart-
17 ment of Commerce and other export control programs of
18 the United States and other governments.

19 ECONOMIC DEVELOPMENT ADMINISTRATION

20 ECONOMIC DEVELOPMENT ASSISTANCE PROGRAMS

21 For economic development assistance as provided by
22 the Public Works and Economic Development Act of
23 1965, including provision of assistance under section
24 207(b) of such Act, for trade adjustment assistance, and
25 for programs authorized by the Stevenson-Wydler Tech-

1 nology Innovation Act of 1980, as amended, \$400,000,000
2 to remain available until expended, which shall be for the
3 purposes and in the amounts specified in the table titled
4 “Economic Development Assistance Programs” in the ex-
5 planatory statement described in section 4 (in the matter
6 preceding division A of this consolidated Act).

7 SALARIES AND EXPENSES

8 For necessary expenses of administering the eco-
9 nomic development assistance programs as provided for by
10 law, \$66,000,000: *Provided*, That funds provided under
11 this heading may be used to monitor projects approved
12 pursuant to title I of the Public Works Employment Act
13 of 1976; title II of the Trade Act of 1974; sections 27
14 through 30 of the Stevenson-Wydler Technology Innova-
15 tion Act of 1980 (15 U.S.C. 3722–3723), as amended; and
16 the Community Emergency Drought Relief Act of 1977.

17 MINORITY BUSINESS DEVELOPMENT AGENCY

18 MINORITY BUSINESS DEVELOPMENT

19 For necessary expenses of the Minority Business De-
20 velopment Agency in fostering, promoting, and developing
21 minority business enterprises, as authorized by law,
22 \$50,000,000.

1 ECONOMIC AND STATISTICAL ANALYSIS

2 SALARIES AND EXPENSES

3 For necessary expenses, as authorized by law, of eco-
4 nomic and statistical analysis programs of the Department
5 of Commerce, \$118,000,000, to remain available until
6 September 30, 2027.

7 BUREAU OF THE CENSUS

8 CURRENT SURVEYS AND PROGRAMS

9 For necessary expenses for collecting, compiling, ana-
10 lyzing, preparing, and publishing statistics, provided for
11 by law, \$318,500,000: *Provided*, That, from amounts pro-
12 vided herein, funds may be used for promotion, outreach,
13 and marketing activities.

14 PERIODIC CENSUSES AND PROGRAMS

15 For necessary expenses for collecting, compiling, ana-
16 lyzing, preparing, and publishing statistics for periodic
17 censuses and programs provided for by law,
18 \$1,171,849,000, to remain available until September 30,
19 2027: *Provided*, That, from amounts provided herein,
20 funds may be used for promotion, outreach, and mar-
21 keting activities.

1 NATIONAL TELECOMMUNICATIONS AND INFORMATION
2 ADMINISTRATION
3 SALARIES AND EXPENSES

4 For necessary expenses, as provided for by law, of
5 the National Telecommunications and Information Ad-
6 ministration (NTIA), \$50,000,000, to remain available
7 until September 30, 2027: *Provided*, That, notwith-
8 standing 31 U.S.C. 1535(d), the Secretary of Commerce
9 shall charge Federal agencies for costs incurred in spec-
10 trum management, analysis, operations, and related serv-
11 ices, and such fees shall be retained and used as offsetting
12 collections for costs of such spectrum services, to remain
13 available until expended: *Provided further*, That the Sec-
14 retary of Commerce is authorized to retain and use as off-
15 setting collections all funds transferred, or previously
16 transferred, from other Government agencies for all costs
17 incurred in telecommunications research, engineering, and
18 related activities by the Institute for Telecommunication
19 Sciences of NTIA, in furtherance of its assigned functions
20 under this paragraph, and such funds received from other
21 Government agencies shall remain available until ex-
22 pended.

23 FACILITIES MANAGEMENT AND CONSTRUCTION

24 For necessary expenses for the design, construction,
25 alteration, improvement, maintenance, and repair of build-

1 ings and facilities managed by the National Telecommuni-
2 cations and Information Administration, not otherwise
3 provided for, \$1,000,000, to remain available until ex-
4 pended.

5 UNITED STATES PATENT AND TRADEMARK OFFICE

6 SALARIES AND EXPENSES

7 (INCLUDING TRANSFERS OF FUNDS)

8 For necessary expenses of the United States Patent
9 and Trademark Office (USPTO) provided for by law, in-
10 cluding defense of suits instituted against the Under Sec-
11 retary of Commerce for Intellectual Property and Director
12 of the USPTO, \$4,956,000,000, to remain available until
13 expended: *Provided*, That the sum herein appropriated
14 from the general fund shall be reduced as offsetting collec-
15 tions of fees and surcharges assessed and collected by the
16 USPTO under any law are received during fiscal year
17 2026, so as to result in a fiscal year 2026 appropriation
18 from the general fund estimated at \$0: *Provided further*,
19 That during fiscal year 2026, should the total amount of
20 such offsetting collections be less than \$4,956,000,000,
21 this amount shall be reduced accordingly: *Provided further*,
22 That any amount received in excess of \$4,956,000,000 in
23 fiscal year 2026 and deposited in the Patent and Trade-
24 mark Fee Reserve Fund shall remain available until ex-
25 pended: *Provided further*, That the Director of USPTO

1 shall submit a spending plan to the Committees on Appro-
2 priations of the House of Representatives and the Senate
3 for any amounts made available by the preceding proviso
4 and such spending plan shall be treated as a reprogram-
5 ming under section 505 of this Act and shall not be avail-
6 able for obligation or expenditure except in compliance
7 with the procedures set forth in that section: *Provided fur-*
8 *ther*, That any amounts reprogrammed in accordance with
9 the preceding proviso shall be transferred to the United
10 States Patent and Trademark Office “Salaries and Ex-
11 penses” account: *Provided further*, That the budget of the
12 President submitted for fiscal year 2027 under section
13 1105 of title 31, United States Code, shall include within
14 amounts provided under this heading for necessary ex-
15 penses of the USPTO any increases that are expected to
16 result from an increase promulgated through rule or regu-
17 lation in offsetting collections of fees and surcharges as-
18 sessed and collected by the USPTO under any law in ei-
19 ther fiscal year 2026 or fiscal year 2027: *Provided further*,
20 That from amounts provided herein, not to exceed
21 \$13,500 shall be made available in fiscal year 2026 for
22 official reception and representation expenses: *Provided*
23 *further*, That in fiscal year 2026 from the amounts made
24 available for “Salaries and Expenses” for the USPTO, the
25 amounts necessary to pay (1) the difference between the

1 percentage of basic pay contributed by the USPTO and
2 employees under section 8334(a) of title 5, United States
3 Code, and the normal cost percentage (as defined by sec-
4 tion 8331(17) of that title) as provided by the Office of
5 Personnel Management (OPM) for USPTO's specific use,
6 of basic pay, of employees subject to subchapter III of
7 chapter 83 of that title, and (2) the present value of the
8 otherwise unfunded accruing costs, as determined by OPM
9 for USPTO's specific use of post-retirement life insurance
10 and post-retirement health benefits coverage for all
11 USPTO employees who are enrolled in Federal Employees
12 Health Benefits (FEHB) and Federal Employees Group
13 Life Insurance (FEGLI), shall be transferred to the Civil
14 Service Retirement and Disability Fund, the FEGLI
15 Fund, and the Employees FEHB Fund, as appropriate,
16 and shall be available for the authorized purposes of those
17 accounts: *Provided further*, That any differences between
18 the present value factors published in OPM's yearly 300
19 series benefit letters and the factors that OPM provides
20 for USPTO's specific use shall be recognized as an im-
21 puted cost on USPTO's financial statements, where appli-
22 cable: *Provided further*, That, notwithstanding any other
23 provision of law, all fees and surcharges assessed and col-
24 lected by USPTO are available for USPTO only pursuant
25 to section 42(c) of title 35, United States Code, as amend-

1 ed by section 22 of the Leahy-Smith America Invents Act
2 (Public Law 112–29): *Provided further*, That within the
3 amounts appropriated, \$2,450,000 shall be transferred to
4 the “Office of Inspector General” account for activities as-
5 sociated with carrying out investigations and audits re-
6 lated to the USPTO.

7 NATIONAL INSTITUTE OF STANDARDS AND TECHNOLOGY
8 SCIENTIFIC AND TECHNICAL RESEARCH AND SERVICES
9 (INCLUDING TRANSFER OF FUNDS)

10 For necessary expenses of the National Institute of
11 Standards and Technology (NIST), \$1,249,239,000, to
12 remain available until expended, of which not to exceed
13 \$9,000,000 may be transferred to the “Working Capital
14 Fund”: *Provided*, That of the amounts appropriated under
15 this heading, \$405,331,366 shall be made available for the
16 NIST—STRS projects, and in the amounts, specified in
17 the table titled “Community Project Funding/Congres-
18 sionally Directed Spending” included for this division in
19 the explanatory statement described in section 4 (in the
20 matter preceding division A of this consolidated Act): *Pro-*
21 *vided further*, That the amounts made available for the
22 projects referenced in the preceding proviso may not be
23 transferred for any other purpose: *Provided further*, That
24 not to exceed \$5,000 shall be for official reception and
25 representation expenses: *Provided further*, That NIST may

1 provide local transportation for summer undergraduate re-
2 search fellowship program participants.

3 INDUSTRIAL TECHNOLOGY SERVICES

4 For necessary expenses for industrial technology
5 services, \$212,000,000, to remain available until ex-
6 pended, of which \$175,000,000 shall be for the Hollings
7 Manufacturing Extension Partnership, and of which
8 \$37,000,000 shall be for the Manufacturing USA Pro-
9 gram.

10 CONSTRUCTION OF RESEARCH FACILITIES

11 For construction of new research facilities, including
12 architectural and engineering design, and for renovation
13 and maintenance of existing facilities, not otherwise pro-
14 vided for the National Institute of Standards and Tech-
15 nology, as authorized by sections 13 through 15 of the
16 National Institute of Standards and Technology Act (15
17 U.S.C. 278c–278e), \$385,897,000, to remain available
18 until expended: *Provided*, That of the amounts appro-
19 priated under this heading, \$257,897,000 shall be made
20 available for the NIST—Construction projects, and in the
21 amounts, specified in the table titled “Community Project
22 Funding/Congressionally Directed Spending” included for
23 this division in the explanatory statement described in sec-
24 tion 4 (in the matter preceding division A of this consoli-
25 dated Act): *Provided further*, That up to one percent of

1 amounts made available for the projects referenced in the
2 preceding proviso may be used for the administrative costs
3 of such projects: *Provided further*, That the Director of
4 the National Institute of Standards and Technology shall
5 submit a spending plan to the Committees on Appropria-
6 tions of the House of Representatives and the Senate for
7 any amounts made available by the preceding proviso and
8 such spending plan shall be treated as a reprogramming
9 under section 505 of this Act and shall not be available
10 for obligation or expenditure except in compliance with the
11 procedures set forth in that section: *Provided further*, That
12 the Secretary of Commerce shall include in the budget jus-
13 tification materials for fiscal year 2027 that the Secretary
14 submits to Congress in support of the Department of
15 Commerce budget (as submitted with the budget of the
16 President under section 1105(a) of title 31, United States
17 Code) an estimate for each National Institute of Stand-
18 ards and Technology construction project having a total
19 multi-year program cost of more than \$5,000,000, and si-
20 multaneously the budget justification materials shall in-
21 clude an estimate of the budgetary requirements for each
22 such project for each of the 5 subsequent fiscal years.

1 NATIONAL OCEANIC AND ATMOSPHERIC
2 ADMINISTRATION
3 OPERATIONS, RESEARCH, AND FACILITIES
4 (INCLUDING TRANSFER OF FUNDS)

5 For necessary expenses of activities authorized by law
6 for the National Oceanic and Atmospheric Administration
7 (NOAA), including maintenance, operation, and hire of
8 aircraft and vessels; pilot programs for State-led fisheries
9 management, notwithstanding any other provision of law;
10 grants, contracts, or other payments to nonprofit organi-
11 zations for the purposes of conducting activities pursuant
12 to cooperative agreements; and relocation of facilities,
13 \$4,540,392,000, to remain available until September 30,
14 2027: *Provided*, That fees and donations received by the
15 National Ocean Service for the management of national
16 marine sanctuaries may be retained and used for the sala-
17 ries and expenses associated with those activities, notwith-
18 standing section 3302 of title 31, United States Code: *Pro-*
19 *vided further*, That in addition, \$399,644,000 shall be de-
20 rived by transfer from the fund entitled “Promote and De-
21 velop Fishery Products and Research Pertaining to Amer-
22 ican Fisheries”, which shall only be used for fishery activi-
23 ties related to the Saltonstall-Kennedy Grant Program;
24 Fisheries Data Collections, Surveys, and Assessments; Ob-
25 servers and Training; Fisheries Management Programs

1 and Services; and Interjurisdictional Fisheries Grants:
2 *Provided further*, That in addition \$28,000,000 is derived
3 from recoveries of prior year obligations: *Provided further*,
4 That of the amounts provided under this heading, includ-
5 ing the amounts in the clause preceding the first proviso
6 and in the second and third provisos, \$4,862,168,110 shall
7 be for the purposes and in the amounts specified in the
8 tables under this heading in the explanatory statement de-
9 scribed in section 4 (in the matter preceding division A
10 of this Act): *Provided further*, That of the amounts pro-
11 vided under this heading, including the amounts in the
12 clause preceding the first proviso and in the second and
13 third provisos, \$105,867,890 shall be made available for
14 the NOAA—CZM and NOAA—ORF projects, and in the
15 amounts, specified in the table titled “Community Project
16 Funding/Congressionally Directed Spending” included for
17 this division in the explanatory statement described in sec-
18 tion 4 (in the matter preceding division A of this consoli-
19 dated Act): *Provided further*, That the amounts made
20 available for the projects referenced in the preceding pro-
21 viso may not be transferred for any other purpose: *Pro-*
22 *vided further*, That not to exceed \$71,299,000 shall be for
23 payment to the “Department of Commerce Working Cap-
24 ital Fund”: *Provided further*, That any use of deobligated
25 balances of funds provided under this heading in previous

1 years shall be subject to the procedures set forth in section
2 505 of this Act: *Provided further*, That in addition, for
3 necessary retired pay expenses under the Retired Service-
4 man's Family Protection and Survivor Benefits Plan, and
5 for payments for the medical care of retired personnel and
6 their dependents under the Dependents' Medical Care Act
7 (10 U.S.C. ch. 55), such sums as may be necessary.

8 PROCUREMENT, ACQUISITION AND CONSTRUCTION

9 For procurement, acquisition and construction of
10 capital assets, including alteration and modification costs,
11 of the National Oceanic and Atmospheric Administration,
12 \$1,576,899,000, to remain available until September 30,
13 2028, except that funds provided for acquisition and con-
14 struction of satellites, vessels, aircraft, and construction
15 of facilities shall remain available until expended: *Pro-*
16 *vided*, That in addition \$13,000,000 is provided from re-
17 coveries of prior year obligations: *Provided further*, That
18 the amounts provided under this heading, including the
19 amounts in the clause preceding the first proviso and in
20 the first proviso, shall be for the purposes and in the
21 amounts specified in the tables under this heading in the
22 explanatory statement described in section 4 (in the mat-
23 ter preceding division A of this Act): *Provided further*,
24 That any use of deobligated balances of funds provided
25 under this heading in previous years shall be subject to

1 the procedures set forth in section 505 of this Act: *Pro-*
2 *vided further*, That the Secretary of Commerce shall in-
3 clude in budget justification materials for fiscal year 2027
4 that the Secretary submits to Congress in support of the
5 Department of Commerce budget (as submitted with the
6 budget of the President under section 1105(a) of title 31,
7 United States Code) an estimate for each National Oce-
8 anic and Atmospheric Administration procurement, acqui-
9 sition or construction project having a total of more than
10 \$5,000,000 and simultaneously the budget justification
11 shall include an estimate of the budgetary requirements
12 for each such project for each of the 5 subsequent fiscal
13 years.

14 PACIFIC COASTAL SALMON RECOVERY

15 For necessary expenses associated with the restora-
16 tion of Pacific salmon populations, \$65,000,000, to re-
17 main available until September 30, 2027: *Provided*, That,
18 of the funds provided herein, the Secretary of Commerce
19 may issue grants to the States of Washington, Oregon,
20 Idaho, Nevada, California, and Alaska, and to the feder-
21 ally recognized Tribes of the Columbia River and Pacific
22 Coast (including Alaska), for projects necessary for con-
23 servation of salmon and steelhead populations that are
24 listed as threatened or endangered, or that are identified
25 by a State as at-risk to be so listed, for maintaining popu-

1 lations necessary for exercise of Tribal treaty fishing
2 rights or native subsistence fishing, or for conservation of
3 Pacific coastal salmon and steelhead habitat, based on
4 guidelines to be developed by the Secretary of Commerce:
5 *Provided further*, That all funds shall be allocated based
6 on scientific and other merit principles and shall not be
7 available for marketing activities: *Provided further*, That
8 funds disbursed to States shall be subject to a matching
9 requirement of funds or documented in-kind contributions
10 of at least 33 percent of the Federal funds.

11 FISHERIES DISASTER ASSISTANCE

12 For necessary expenses of administering the fishery
13 disaster assistance programs authorized by the Magnuson-
14 Stevens Fishery Conservation and Management Act (Pub-
15 lic Law 94–265) and the Interjurisdictional Fisheries Act
16 (title III of Public Law 99–659), \$300,000.

17 FISHERMEN’S CONTINGENCY FUND

18 For carrying out the provisions of title IV of Public
19 Law 95–372, not to exceed \$349,000, to be derived from
20 receipts collected pursuant to that Act, to remain available
21 until expended.

22 FISHERIES FINANCE PROGRAM ACCOUNT

23 Subject to section 502 of the Congressional Budget
24 Act of 1974, during fiscal year 2026, obligations of direct
25 loans may not exceed \$24,000,000 for Individual Fishing

1 Quota loans and not to exceed \$150,000,000 for tradi-
2 tional direct loans as authorized by the Merchant Marine
3 Act of 1936.

4 RECREATIONAL QUOTA ENTITY FUND

5 For carrying out the provisions of section 106 of the
6 Driftnet Modernization and Bycatch Reduction Act (title
7 I of division S of the Consolidated Appropriations Act,
8 2023 (Public Law 117–328)), the National Oceanic and
9 Atmospheric Administration may assess and collect fees
10 pursuant to such section, which shall be credited to this
11 account, to remain available until expended, for the pur-
12 poses specified in subsection (b) of such section, in addi-
13 tion to amounts otherwise available for such purposes.

14 DEPARTMENTAL MANAGEMENT

15 SALARIES AND EXPENSES

16 For necessary expenses for the management of the
17 Department of Commerce provided for by law, including
18 not to exceed \$4,500 for official reception and representa-
19 tion, \$92,500,000: *Provided*, That no employee of the De-
20 partment of Commerce may be detailed or assigned from
21 a bureau or office funded by this Act or any other Act
22 to offices within the Office of the Secretary of the Depart-
23 ment of Commerce for more than 180 days in a fiscal year
24 unless the individual's employing bureau or office is fully
25 reimbursed for the salary and expenses of the employee

1 Secretary of Commerce that such payments are in the
2 public interest.

3 SEC. 102. During the current fiscal year, appropria-
4 tions made available to the Department of Commerce by
5 this Act for salaries and expenses shall be available for
6 hire of passenger motor vehicles as authorized by 31
7 U.S.C. 1343 and 1344; services as authorized by 5 U.S.C.
8 3109; and uniforms or allowances therefor, as authorized
9 by law (5 U.S.C. 5901–5902).

10 SEC. 103. Not to exceed 5 percent of any appropria-
11 tion made available for the current fiscal year for the De-
12 partment of Commerce in this Act may be transferred be-
13 tween such appropriations, but no such appropriation shall
14 be increased by more than 10 percent by any such trans-
15 fers: *Provided*, That any transfer pursuant to this section
16 shall be treated as a reprogramming of funds under sec-
17 tion 505 of this Act and shall not be available for obliga-
18 tion or expenditure except in compliance with the proce-
19 dures set forth in that section: *Provided further*, That the
20 Secretary of Commerce shall notify the Committees on Ap-
21 propriations at least 15 days in advance of the acquisition
22 or disposal of any capital asset (including land, structures,
23 and equipment) not specifically provided for in this Act
24 or any other law appropriating funds for the Department
25 of Commerce.

1 SEC. 104. The requirements set forth by section 105
2 of the Commerce, Justice, Science, and Related Agencies
3 Appropriations Act, 2012 (Public Law 112–55), as
4 amended by section 105 of title I of division B of Public
5 Law 113–6, are hereby adopted by reference and made
6 applicable with respect to fiscal year 2026: *Provided*, That
7 the life cycle cost for the Joint Polar Satellite System is
8 \$11,322,125,000, the life cycle cost of the Polar Follow
9 On Program is \$6,837,900,000, the life cycle cost for the
10 Geostationary Operational Environmental Satellite R-Se-
11 ries Program is \$11,700,100,000, and the life cycle cost
12 for the Space Weather Follow On Program is
13 \$692,800,000.

14 SEC. 105. Notwithstanding any other provision of
15 law, the Secretary of Commerce may furnish services (in-
16 cluding but not limited to utilities, telecommunications,
17 and security services) necessary to support the operation,
18 maintenance, and improvement of space that persons,
19 firms, or organizations are authorized, pursuant to the
20 Public Buildings Cooperative Use Act of 1976 or other
21 authority, to use or occupy in the Herbert C. Hoover
22 Building, Washington, DC, or other buildings, the mainte-
23 nance, operation, and protection of which has been dele-
24 gated to the Secretary from the Administrator of General
25 Services pursuant to the Federal Property and Adminis-

1 trative Services Act of 1949 on a reimbursable or non-
2 reimbursable basis. Amounts received as reimbursement
3 for services provided under this section or the authority
4 under which the use or occupancy of the space is author-
5 ized, up to \$200,000, shall be credited to the appropria-
6 tion or fund which initially bears the costs of such services.

7 SEC. 106. Nothing in this title shall be construed to
8 prevent a grant recipient from deterring child pornog-
9 raphy, copyright infringement, or any other unlawful ac-
10 tivity over its networks.

11 SEC. 107. The Administrator of the National Oceanic
12 and Atmospheric Administration is authorized to use, with
13 their consent, with reimbursement and subject to the lim-
14 its of available appropriations, the land, services, equip-
15 ment, personnel, and facilities of any department, agency,
16 or instrumentality of the United States, or of any State,
17 local government, Indian Tribal government, Territory, or
18 possession, or of any political subdivision thereof, or of
19 any foreign government or international organization, for
20 purposes related to carrying out the responsibilities of any
21 statute administered by the National Oceanic and Atmos-
22 pheric Administration.

23 SEC. 108. The National Technical Information Serv-
24 ice shall not charge any customer for a copy of any report
25 or document generated by the Legislative Branch unless

1 the Service has provided information to the customer on
2 how an electronic copy of such report or document may
3 be accessed and downloaded for free online. Should a cus-
4 tomer still require the Service to provide a printed or dig-
5 ital copy of the report or document, the charge shall be
6 limited to recovering the Service’s cost of processing, re-
7 producing, and delivering such report or document.

8 SEC. 109. To carry out the responsibilities of the Na-
9 tional Oceanic and Atmospheric Administration (NOAA),
10 the Administrator of NOAA is authorized to: (1) enter
11 into grants and cooperative agreements with; (2) use on
12 a non-reimbursable basis land, services, equipment, per-
13 sonnel, and facilities provided by; and (3) receive and ex-
14 pend funds made available on a consensual basis from: a
15 Federal agency, State or subdivision thereof, local govern-
16 ment, Tribal government, Territory, or possession or any
17 subdivisions thereof: *Provided*, That funds received for
18 permitting and related regulatory activities pursuant to
19 this section shall be deposited under the heading “Na-
20 tional Oceanic and Atmospheric Administration—Oper-
21 ations, Research, and Facilities” and shall remain avail-
22 able until September 30, 2027, for such purposes: *Pro-*
23 *vided further*, That all funds within this section and their
24 corresponding uses are subject to section 505 of this Act.

1 SEC. 110. Amounts provided by this Act or by any
2 prior appropriations Act that remain available for obliga-
3 tion, for necessary expenses of the programs of the Eco-
4 nomics and Statistics Administration of the Department
5 of Commerce, including amounts provided for programs
6 of the Bureau of Economic Analysis and the Bureau of
7 the Census, shall be available for expenses of cooperative
8 agreements with appropriate entities, including any Fed-
9 eral, State, or local governmental unit, or institution of
10 higher education, to aid and promote statistical, research,
11 and methodology activities which further the purposes for
12 which such amounts have been made available.

13 SEC. 111. The Secretary of Commerce, or the des-
14 ignee of the Secretary, may waive up to 50 percent of the
15 cost sharing requirements under section 315, of the Coast-
16 al Zone Management Act of 1972 (16 U.S.C. 1461) as
17 necessary at the request of the grant applicant, for
18 amounts made available under this Act under the heading
19 “Procurement, Acquisition and Construction” under the
20 heading “National Oceanic and Atmospheric Administra-
21 tion”.

22 SEC. 112. Any unobligated balances of expired discre-
23 tionary funds transferred to the Department of Commerce
24 Nonrecurring Expenses Fund, as authorized by section
25 111 of title I of division B of Public Law 116–93, may

1 be obligated only after the Committees on Appropriations
2 of the House of Representatives and the Senate are noti-
3 fied at least 30 days in advance of the planned use of
4 funds.

5 SEC. 113. The Administrator of the National Oceanic
6 and Atmospheric Administration, in consultation with the
7 employees of the National Weather Service and non-gov-
8 ernmental experts in personnel management, may estab-
9 lish an alternative or fixed rate for relocation allowance,
10 including permanent change of station allowance, notwith-
11 standing the provisions of 5 U.S.C. 5724 and the regula-
12 tions prescribed under 5 U.S.C. 5738.

13 SEC. 114. The National Weather Service shall main-
14 tain staffing levels in order to fulfill the mission required
15 under 15 U.S.C. 313 to protect life and property to the
16 maximum extent possible.

17 This title may be cited as the “Department of Com-
18 merce Appropriations Act, 2026”.

1 TITLE II
2 DEPARTMENT OF JUSTICE
3 JUSTICE OPERATIONS, MANAGEMENT, AND
4 ACCOUNTABILITY
5 SALARIES AND EXPENSES

6 For expenses necessary for the operations, manage-
7 ment, and accountability of the Department of Justice,
8 \$140,000,000, of which not to exceed \$4,000,000 shall re-
9 main available until September 30, 2027, and of which
10 not to exceed \$4,000,000 for security and construction of
11 Department of Justice facilities shall remain available
12 until expended.

13 JUSTICE INFORMATION SHARING TECHNOLOGY
14 (INCLUDING TRANSFER OF FUNDS)

15 For necessary expenses for information sharing tech-
16 nology, including planning, development, deployment and
17 departmental direction, \$38,460,000, to remain available
18 until expended: *Provided*, That the Attorney General may
19 transfer up to \$40,000,000 to this account, from funds
20 available to the Department of Justice for information
21 technology, to remain available until expended, for enter-
22 prise-wide information technology initiatives: *Provided fur-*
23 *ther*, That the transfer authority in the preceding proviso
24 is in addition to any other transfer authority contained
25 in this Act: *Provided further*, That any transfer pursuant

1 to the first proviso shall be treated as a reprogramming
2 under section 505 of this Act and shall not be available
3 for obligation or expenditure except in compliance with the
4 procedures set forth in that section.

5 EXECUTIVE OFFICE FOR IMMIGRATION REVIEW
6 (INCLUDING TRANSFER OF FUNDS)

7 For expenses necessary for the administration of im-
8 migration-related activities of the Executive Office for Im-
9 migration Review, \$800,000,000, of which \$10,000,000
10 shall be derived by transfer from the Executive Office for
11 Immigration Review fees deposited in the “Immigration
12 Examinations Fee” account, and of which not less than
13 \$27,500,000 shall be available for services and activities
14 provided by the Legal Orientation Program: *Provided,*
15 That not to exceed \$50,000,000 of the total amount made
16 available under this heading shall remain available until
17 September 30, 2030, for build-out and modifications of
18 courtroom space.

19 OFFICE OF INSPECTOR GENERAL

20 For necessary expenses of the Office of Inspector
21 General, \$139,000,000, including not to exceed \$10,000
22 to meet unforeseen emergencies of a confidential char-
23 acter: *Provided,* That not to exceed \$4,000,000 shall re-
24 main available until September 30, 2027.

1 UNITED STATES PAROLE COMMISSION
2 SALARIES AND EXPENSES

3 For necessary expenses of the United States Parole
4 Commission as authorized, \$13,000,000: *Provided*, That,
5 notwithstanding any other provision of law, upon the expi-
6 ration of a term of office of a Commissioner, the Commis-
7 sioner may continue to act until a successor has been ap-
8 pointed.

9 LEGAL ACTIVITIES
10 SALARIES AND EXPENSES, GENERAL LEGAL ACTIVITIES
11 (INCLUDING TRANSFER OF FUNDS)

12 For expenses necessary for the legal activities of the
13 Department of Justice, not otherwise provided for, includ-
14 ing not to exceed \$20,000 for expenses of collecting evi-
15 dence, to be expended under the direction of, and to be
16 accounted for solely under the certificate of, the Attorney
17 General; the administration of pardon and clemency peti-
18 tions; and rent of private or Government-owned space in
19 the District of Columbia, \$900,000,000, of which not to
20 exceed \$50,000,000 for litigation support contracts and
21 information technology projects, including cybersecurity
22 and hardening of critical networks, shall remain available
23 until expended: *Provided*, That of the total amount appro-
24 priated, not to exceed \$9,000 shall be available to the
25 Criminal Division for official reception and representation

1 expenses: *Provided further*, That notwithstanding section
2 205 of this Act, upon a determination by the Attorney
3 General that emergent circumstances require additional
4 funding for litigation activities of the Civil Division, the
5 Attorney General may transfer such amounts to “Salaries
6 and Expenses, General Legal Activities” from available
7 appropriations for the current fiscal year for the Depart-
8 ment of Justice, as may be necessary to respond to such
9 circumstances: *Provided further*, That any transfer pursu-
10 ant to the preceding proviso shall be treated as a re-
11 programming under section 505 of this Act and shall not
12 be available for obligation or expenditure except in compli-
13 ance with the procedures set forth in that section: *Pro-*
14 *vided further*, That of the amount appropriated, such sums
15 as may be necessary shall be available to the Civil Rights
16 Division for salaries and expenses associated with the elec-
17 tion monitoring program under section 8 of the Voting
18 Rights Act of 1965 (52 U.S.C. 10305) and to reimburse
19 the Office of Personnel Management for such salaries and
20 expenses: *Provided further*, That of the amounts provided
21 under this heading for the election monitoring program,
22 \$3,390,000 shall remain available until expended: *Pro-*
23 *vided further*, That any funds provided under this heading
24 in prior year appropriations Acts that remain available to
25 the Civil Rights Division for salaries and expenses associ-

1 ated with the election monitoring program under section
2 8 of the Voting Rights Act of 1965 (52 U.S.C. 10305)
3 may also be used to carry out any authorized purposes
4 of the Civil Rights Division: *Provided further*, That
5 amounts repurposed by the preceding proviso may not be
6 used to increase the number of permanent positions.

7 In addition, for reimbursement of expenses of the De-
8 partment of Justice associated with processing cases
9 under the National Childhood Vaccine Injury Act of 1986,
10 \$22,700,000, to be appropriated from the Vaccine Injury
11 Compensation Trust Fund and to remain available until
12 expended.

13 SALARIES AND EXPENSES, ANTITRUST DIVISION

14 For expenses necessary for the enforcement of anti-
15 trust and kindred laws, \$245,000,000, to remain available
16 until expended, of which not to exceed \$5,000 shall be
17 available for official reception and representation ex-
18 penses: *Provided*, That notwithstanding any other provi-
19 sion of law, fees collected in fiscal year 2026 for premerger
20 notification filings under the Hart-Scott-Rodino Antitrust
21 Improvements Act of 1976 (15 U.S.C. 18a) shall be re-
22 tained and used for necessary expenses in this appropria-
23 tion and shall remain available until expended: *Provided*
24 *further*, That the sum herein appropriated from the gen-
25 eral fund shall be reduced (1) as such offsetting collections

1 are received during fiscal year 2026 and (2) to the extent
2 that any remaining general fund appropriations can be de-
3 rived from amounts credited to this account as offsetting
4 collections in previous fiscal years that are not otherwise
5 appropriated, so as to result in a final fiscal year 2026
6 appropriation from the general fund estimated at \$0: *Pro-*
7 *vided further*, That, notwithstanding section 605 of the
8 Departments of Commerce, Justice, and State, the Judici-
9 ary, and Related Agencies Appropriations Act, 1990 (15
10 U.S.C. 18a note), none of the funds credited to this ac-
11 count as offsetting collections in previous fiscal years that
12 were unavailable for obligation as of September 30, 2025,
13 shall become available for obligation except as provided in
14 the preceding proviso: *Provided further*, That any
15 premerger notification filing fees received in excess of
16 \$245,000,000 in fiscal year 2026 shall remain available
17 until expended: *Provided further*, That the Attorney Gen-
18 eral shall submit a spending plan to the Committees on
19 Appropriations of the House of Representatives and the
20 Senate for any amounts made available by the preceding
21 proviso and such spending plan shall be treated as a re-
22 programming under section 505 of this Act and shall not
23 be available for obligation or expenditure except in compli-
24 ance with the procedures set forth in that section.

1 SALARIES AND EXPENSES, UNITED STATES ATTORNEYS

2 For necessary expenses of the Offices of the United
3 States Attorneys, including inter-governmental and coop-
4 erative agreements, \$2,621,000,000: *Provided*, That of the
5 total amount appropriated, not to exceed \$19,600 shall be
6 available for official reception and representation ex-
7 penses: *Provided further*, That not to exceed \$40,000,000
8 shall remain available until expended: *Provided further*,
9 That each United States Attorney shall establish or par-
10 ticipate in a task force on human trafficking.

11 UNITED STATES TRUSTEE SYSTEM FUND

12 For necessary expenses of the United States Trustee
13 Program, as authorized, \$205,000,000, to remain avail-
14 able until expended: *Provided*, That, notwithstanding any
15 other provision of law, deposits of discretionary offsetting
16 collections to the United States Trustee System Fund and
17 amounts herein appropriated shall be available in such
18 amounts as may be necessary to pay refunds due deposi-
19 tors: *Provided further*, That, notwithstanding any other
20 provision of law, fees deposited into the Fund as discre-
21 tionary offsetting collections pursuant to section 589a of
22 title 28, United States Code (as limited by section
23 589a(f)(2) of title 28, United States Code), shall be re-
24 tained and used for necessary expenses in this appropria-
25 tion and shall remain available until expended: *Provided*

1 *further*, That to the extent that fees deposited into the
2 Fund as discretionary offsetting collections in fiscal year
3 2026, net of amounts necessary to pay refunds due deposi-
4 tors, exceed \$205,000,000, those excess amounts shall be
5 available in this and future fiscal years only to the extent
6 provided in advance in appropriations Acts: *Provided fur-*
7 *ther*, That the sum herein appropriated from the general
8 fund shall be reduced (1) as such fees are received during
9 fiscal year 2026, net of amounts necessary to pay refunds
10 due depositors, (estimated at \$205,000,000) and (2) to
11 the extent that any remaining general fund appropriations
12 can be derived from amounts deposited in the Fund as
13 discretionary offsetting collections in previous fiscal years
14 that are not otherwise appropriated, so as to result in a
15 final fiscal year 2026 appropriation from the general fund
16 estimated at \$0.

17 SALARIES AND EXPENSES, FOREIGN CLAIMS

18 SETTLEMENT COMMISSION

19 For expenses necessary to carry out the activities of
20 the Foreign Claims Settlement Commission, including
21 services as authorized by section 3109 of title 5, United
22 States Code, \$2,504,000.

23 FEES AND EXPENSES OF WITNESSES

24 For fees and expenses of witnesses, for expenses of
25 contracts for the procurement and supervision of expert

1 witnesses, for private counsel expenses, including ad-
2 vances, and for expenses of foreign counsel, \$320,000,000,
3 to remain available until expended, of which not to exceed
4 \$16,000,000 is for construction of buildings for protected
5 witness safesites; not to exceed \$3,000,000 is for the pur-
6 chase and maintenance of armored and other vehicles for
7 witness security caravans; and not to exceed \$35,000,000
8 is for the purchase, installation, maintenance, and up-
9 grade of secure telecommunications equipment and a se-
10 cure automated information network to store and retrieve
11 the identities and locations of protected witnesses: *Pro-*
12 *vided*, That amounts made available under this heading
13 may not be transferred pursuant to section 205 of this
14 Act.

15 SALARIES AND EXPENSES, COMMUNITY RELATIONS

16 SERVICE

17 (INCLUDING TRANSFER OF FUNDS)

18 For necessary expenses of the Community Relations
19 Service, \$20,000,000: *Provided*, That notwithstanding sec-
20 tion 205 of this Act, upon a determination by the Attorney
21 General that emergent circumstances require additional
22 funding for conflict resolution and violence prevention ac-
23 tivities of the Community Relations Service, the Attorney
24 General may transfer such amounts to the Community Re-
25 lations Service, from available appropriations for the cur-

1 rent fiscal year for the Department of Justice, as may be
2 necessary to respond to such circumstances: *Provided fur-*
3 *ther*, That any transfer pursuant to the preceding proviso
4 shall be treated as a reprogramming under section 505
5 of this Act and shall not be available for obligation or ex-
6 penditure except in compliance with the procedures set
7 forth in that section.

8 ASSETS FORFEITURE FUND

9 For expenses authorized by subparagraphs (B), (F),
10 and (G) of section 524(e)(1) of title 28, United States
11 Code, \$20,514,000, to be derived from the Department
12 of Justice Assets Forfeiture Fund.

13 UNITED STATES MARSHALS SERVICE

14 SALARIES AND EXPENSES

15 For necessary expenses of the United States Mar-
16 shals Service, \$1,702,000,000, of which not to exceed
17 \$20,000 shall be available for official reception and rep-
18 resentation expenses, not to exceed \$8,900 shall be avail-
19 able for INTERPOL Washington official reception and
20 representation expenses, and not to exceed \$25,000,000
21 shall remain available until expended: *Provided*, That the
22 Director of INTERPOL Washington shall concurrently
23 report to the Deputy Attorney General.

1 CONSTRUCTION

2 For construction in space that is controlled, occupied,
3 or utilized by the United States Marshals Service for pris-
4 oner holding and related support, \$8,000,000, to remain
5 available until expended.

6 FEDERAL PRISONER DETENTION

7 For necessary expenses related to United States pris-
8 oners in the custody of the United States Marshals Service
9 as authorized by section 4013 of title 18, United States
10 Code, \$2,236,000,000, to remain available until expended:
11 *Provided*, That not to exceed \$20,000,000 shall be consid-
12 ered “funds appropriated for State and local law enforce-
13 ment assistance” pursuant to section 4013(b) of title 18,
14 United States Code: *Provided further*, That the United
15 States Marshals Service shall be responsible for managing
16 the Justice Prisoner and Air Transportation System.

17 NATIONAL SECURITY DIVISION

18 SALARIES AND EXPENSES

19 (INCLUDING TRANSFER OF FUNDS)

20 For expenses necessary to carry out the activities of
21 the National Security Division, \$117,200,000, of which
22 not to exceed \$5,000,000 for information technology sys-
23 tems shall remain available until expended: *Provided*, That
24 notwithstanding section 205 of this Act, upon a deter-
25 mination by the Attorney General that emergent cir-

1 cumstances require additional funding for the activities of
2 the National Security Division, the Attorney General may
3 transfer such amounts to this heading from available ap-
4 propriations for the current fiscal year for the Department
5 of Justice, as may be necessary to respond to such cir-
6 cumstances: *Provided further*, That any transfer pursuant
7 to the preceding proviso shall be treated as a reprogram-
8 ming under section 505 of this Act and shall not be avail-
9 able for obligation or expenditure except in compliance
10 with the procedures set forth in that section.

11 INTERAGENCY LAW ENFORCEMENT

12 INTERAGENCY CRIME AND DRUG ENFORCEMENT

13 For necessary expenses for the identification, inves-
14 tigation, and prosecution of individuals associated with the
15 most significant drug trafficking organizations,
16 transnational organized crime, and money laundering or-
17 ganizations not otherwise provided for, to include inter-
18 governmental agreements with State and local law en-
19 forcement agencies engaged in the investigation and pros-
20 ecution of individuals involved in transnational organized
21 crime and drug trafficking, \$300,000,000, of which
22 \$50,000,000 shall remain available until expended: *Pro-*
23 *vided*, That any amounts obligated from appropriations
24 under this heading may be used under authorities avail-
25 able to the organizations reimbursed from this appropria-

1 tion: *Provided further*, That any amounts obligated from
2 appropriations under this heading shall only be available
3 for the same purposes for which the amounts were obli-
4 gated in fiscal year 2024.

5 FEDERAL BUREAU OF INVESTIGATION
6 SALARIES AND EXPENSES

7 For necessary expenses of the Federal Bureau of In-
8 vestigation for detection, investigation, and prosecution of
9 crimes against the United States, \$10,609,456,000, of
10 which not to exceed \$216,900,000 shall remain available
11 until expended: *Provided*, That not to exceed \$284,000
12 shall be available for official reception and representation
13 expenses.

14 CONSTRUCTION

15 For necessary expenses, to include the cost of equip-
16 ment, furniture, and information technology requirements,
17 related to construction or acquisition of buildings, facili-
18 ties, and sites by purchase, or as otherwise authorized by
19 law; conversion, modification, and extension of federally
20 owned buildings; preliminary planning and design of
21 projects; and operation and maintenance of secure work
22 environment facilities and secure networking capabilities;
23 \$15,000,000, to remain available until expended.

1 DRUG ENFORCEMENT ADMINISTRATION

2 SALARIES AND EXPENSES

3 For necessary expenses of the Drug Enforcement Ad-
4 ministration, including not to exceed \$70,000 to meet un-
5 foreseen emergencies of a confidential character pursuant
6 to section 530C of title 28, United States Code; and ex-
7 penses for conducting drug education and training pro-
8 grams, including travel and related expenses for partici-
9 pants in such programs and the distribution of items of
10 token value that promote the goals of such programs,
11 \$2,580,340,000, of which not to exceed \$75,000,000 shall
12 remain available until expended and not to exceed \$90,000
13 shall be available for official reception and representation
14 expenses: *Provided*, That, notwithstanding section 3672 of
15 Public Law 106–310, up to \$10,000,000 may be used to
16 reimburse States, units of local government, Indian Tribal
17 Governments, other public entities, and multi-jurisdic-
18 tional or regional consortia thereof for expenses incurred

10 and acquisition of canines for explosives and fire
11 accelerants detection; and for provision of laboratory as-
12 sistance to State and local law enforcement agencies, with
13 or without reimbursement, \$1,585,000,000, of which not
14 to exceed \$36,000 shall be for official reception and rep-
15 resentation expenses, not to exceed \$1,000,000 shall be
16 available for the payment of attorneys' fees as provided

7 SALARIES AND EXPENSES

8 (INCLUDING TRANSFER OF FUNDS)

9 For necessary expenses of the Federal Prison System
10 for the administration, operation, and maintenance of
11 Federal penal and correctional institutions, and for the
12 provision of technical assistance and advice on corrections
13 related issues to foreign governments, \$8,100,000,000:
14 *Provided*, That not less than \$409,483,000 shall be for
15 the programs and activities authorized by the First Step
16 Act of 2018 (Public Law 115–391), of which not less than
17 2 percent shall be transferred to and merged with the ap-
18 propriation for “Research, Evaluation and Statistics” for
19 the National Institute of Justice to carry out evaluations
20 of programs and activities related to the First Step Act
21 of 2018: *Provided further*, That the Attorney General may
22 transfer to the Department of Health and Human Serv-
23 ices such amounts as may be necessary for direct expendi-
24 tures by that Department for medical relief for inmates
25 of Federal penal and correctional institutions: *Provided*

1 *further*, That the Director of the Federal Prison System,
2 where necessary, may enter into contracts with a fiscal
3 agent or fiscal intermediary claims processor to determine
4 the amounts payable to persons who, on behalf of the Fed-
5 eral Prison System, furnish health services to individuals
6 committed to the custody of the Federal Prison System:
7 *Provided further*, That not to exceed \$5,400 shall be avail-
8 able for official reception and representation expenses:
9 *Provided further*, That not to exceed \$50,000,000 shall re-
10 main available until expended for necessary operations:
11 *Provided further*, That, of the amounts provided for con-
12 tract confinement, not to exceed \$20,000,000 shall remain
13 available until expended to make payments in advance for

16 eral Prison System may accept donated property and serv-

24 be necessary in carrying out the program set forth in the
25 budget for the current fiscal year for such corporation.

3 Not to exceed \$2,700,000 of the funds of the Federal
4 Prison Industries, Incorporated, shall be available for its

8 with the corporation's current prescribed accounting sys-
9 tem, and such amounts shall be exclusive of depreciation,
10 payment of claims, and expenditures which such account-

13 shipping expenses, and expenses in connection with acqui-
14 sition, construction, operation, maintenance, improvement,
15 protection, or disposition of facilities and other property

10 and \$2,000,000 is for grants to develop databases
11 on Internet of Things device capabilities and to build
12 and execute training modules for law enforcement;

13 (5) \$19,000,000 for sex offender management
14 assistance, as authorized by the Adam Walsh Act,
15 and related activities, of which \$1,000,000 is for the
16 National Sex Offender Public Website;

17 (6) \$30,000,000 for the Patrick Leahy Bullet-
18 proof Vest Partnership Grant Program, as author-
19 ized by section 2501 of title I of the 1968 Act: *Pro-*
20 *vided*, That \$1,500,000 shall be transferred directly

13 37); the Law Enforcement Mental Health and Wellness

21 ances made available through prior year deobligations

24 under this heading—

1 (1) \$253,093,613 is for grants under section
2 1701 of title I of the 1968 Act (34 U.S.C. 10381)
3 for the hiring and rehiring of additional career law
4 enforcement officers under part Q of such title not-
5 withstanding subsection (i) of such section: *Pro-*
6 *vided*, That, notwithstanding section 1704(c) of such
7 title (34 U.S.C. 10384(c)), funding for hiring or re-
8 hiring a career law enforcement officer may not ex-
9 ceed \$125,000 unless the Director of the Office of
10 Community Oriented Policing Services grants a
11 waiver from this limitation: *Provided further*, That of
12 the amounts appropriated under this paragraph,
13 \$32,000,000 is for improving Tribal law enforce-
14 ment, including hiring, equipment, training, anti-

5 collaboration;

19 table titled “Community Project Funding/Congres-
20 sionally Directed Spending” included for this divi-
21 sion in the explanatory statement described in sec-
22 tion 4 (in the matter preceding division A of this
23 consolidated Act): *Provided*, That such amounts may
24 not be transferred for any other purpose: *Provided*
25 *further*, That grants funded by such amounts shall

1 not be subject to section 1703 of title I of the 1968

3 (8) \$15,000,000 is for activities authorized by

6 GENERAL PROVISIONS—DEPARTMENT OF JUSTICE

7 (INCLUDING TRANSFERS OF FUNDS)

8 SEC. 201. In addition to amounts otherwise made
9 available in this title for official reception and representa-
10 tion expenses, a total of not to exceed \$50,000 from funds
11 appropriated to the Department of Justice in this title
12 shall be available to the Attorney General for official re-
13 ception and representation expenses.

14 SEC. 202. None of the funds appropriated by this
15 title shall be available to pay for an abortion, except where
16 the life of the mother would be endangered if the fetus
17 were carried to term, or in the case of rape or incest: *Pro-*
18 *vided*, That should this prohibition be declared unconstitu-
19 tional by a court of competent jurisdiction, this section
20 shall be null and void.

21 SEC. 203. None of the funds appropriated under this
22 title shall be used to require any person to perform, or
23 facilitate in any way the performance of, any abortion.

24 SEC. 204. Nothing in the preceding section shall re-
25 move the obligation of the Director of the Bureau of Pris-

1 ons to provide escort services necessary for a female in-
2 mate to receive such service outside the Federal facility:
3 *Provided*, That nothing in this section in any way dimin-
4 ishes the effect of section 203 intended to address the phil-
5 osophical beliefs of individual employees of the Bureau of
6 Prisons.

7 SEC. 205. Not to exceed 5 percent of any appropria-
8 tion made available for the current fiscal year for the De-
9 partment of Justice in this Act may be transferred be-
10 tween such appropriations, but no such appropriation, ex-
11 cept as otherwise specifically provided, shall be increased
12 by more than 10 percent by any such transfers: *Provided*,
13 That any transfer pursuant to this section shall be treated
14 as a reprogramming of funds under section 505 of this
15 Act and shall not be available for obligation except in com-
16 pliance with the procedures set forth in that section: *Pro-*
17 *vided further*, That this section shall not apply to the fol-
18 lowing—

19 (1) paragraph 1(O) under the heading “State
20 and Local Law Enforcement Assistance”; and

21 (2) paragraph (7) under the heading “Commu-
22 nity Oriented Policing Services Programs”.

23 SEC. 206. None of the funds made available under
24 this title may be used by the Federal Bureau of Prisons
25 or the United States Marshals Service for the purpose of

1 transporting an individual who is a prisoner pursuant to
2 conviction for crime under State or Federal law and is
3 classified as a maximum or high security prisoner, other
4 than to a prison or other facility certified by the Federal
5 Bureau of Prisons as appropriately secure for housing
6 such a prisoner.

7 SEC. 207. (a) None of the funds appropriated by this
8 Act may be used by Federal prisons to purchase cable tele-
9 vision services, or to rent or purchase audiovisual or elec-
10 tronic media or equipment used primarily for recreational
11 purposes.

12 (b) Subsection (a) does not preclude the rental, main-
13 tenance, or purchase of audiovisual or electronic media or
14 equipment for inmate training, religious, or educational
15 programs.

16 SEC. 208. None of the funds made available under
17 this title shall be obligated or expended for any new or
18 enhanced information technology program having total es-
19 timated development costs in excess of \$100,000,000, un-
20 less the Deputy Attorney General and the investment re-
21 view board certify to the Committees on Appropriations
22 of the House of Representatives and the Senate that the
23 information technology program has appropriate program
24 management controls and contractor oversight mecha-

1 nisms in place, and that the program is compatible with
2 the enterprise architecture of the Department of Justice.

3 SEC. 209. The notification thresholds and procedures
4 set forth in section 505 of this Act shall apply to devi-
5 ations from the amounts designated for specific activities
6 in this Act and in the explanatory statement described in
7 section 4 (in the matter preceding division A of this con-
8 solidated Act), and to any use of deobligated balances of
9 funds provided under this title in previous years.

10 SEC. 210. None of the funds appropriated by this Act
11 may be used to plan for, begin, continue, finish, process,
12 or approve a public-private competition under the Office
13 of Management and Budget Circular A-76 or any suc-
14 cessor administrative regulation, directive, or policy for
15 work performed by employees of the Bureau of Prisons
16 or of Federal Prison Industries, Incorporated.

17 SEC. 211. Notwithstanding any other provision of
18 law, no funds shall be available for the salary, benefits,
19 or expenses of any United States Attorney assigned dual
20 or additional responsibilities by the Attorney General or
21 his designee that exempt that United States Attorney
22 from the residency requirements of section 545 of title 28,
23 United States Code.

24 SEC. 212. At the discretion of the Attorney General,
25 and in addition to any amounts that otherwise may be

1 available (or authorized to be made available) by law, with
2 respect to funds appropriated by this title under the head-
3 ings “Research, Evaluation and Statistics”, “State and
4 Local Law Enforcement Assistance”, and “Juvenile Jus-
5 tice Programs”—

6 (1) up to 2 percent of funds made available to
7 the Office of Justice Programs for grant or reim-
8 bursement programs may be used by such Office to
9 provide training and technical assistance; and

10 (2) up to 2 percent of funds made available for
11 grant or reimbursement programs under such head-
12 ings, except for amounts appropriated specifically for
13 research, evaluation, or statistical programs adminis-
14 tered by the National Institute of Justice and the
15 Bureau of Justice Statistics, shall be transferred to
16 and merged with funds provided to the National In-
17 stitute of Justice and the Bureau of Justice Statis-
18 tics, to be used by them for research, evaluation, or
19 statistical purposes, without regard to the authoriza-
20 tions for such grant or reimbursement programs.

21 This section shall not apply to paragraph 1(O)
22 under the heading “State and Local Law Enforce-
23 ment Assistance”.

24 SEC. 213. Upon request by a grantee for whom the
25 Attorney General has determined there is a fiscal hard-

1 ship, the Attorney General may, with respect to funds ap-
2 propriated in this or any other Act making appropriations
3 for fiscal years 2023 through 2026 for the following pro-
4 grams, waive the following requirements:

5 (1) For the adult and juvenile offender State
6 and local reentry demonstration projects under part
7 FF of title I of the Omnibus Crime Control and
8 Safe Streets Act of 1968 (34 U.S.C. 10631 et seq.),
9 the requirements under section 2976(g)(1) of such
10 part (34 U.S.C. 10631(g)(1)).

11 (2) For grants to protect inmates and safe-
12 guard communities as authorized by section 6 of the
13 Prison Rape Elimination Act of 2003 (34 U.S.C.
14 30305(c)(3)), the requirements of section 6(c)(3) of
15 such Act.

16 SEC. 214. Notwithstanding any other provision of
17 law, section 20109(a) of subtitle A of title II of the Violent
18 Crime Control and Law Enforcement Act of 1994 (34
19 U.S.C. 12109(a)) shall not apply to amounts made avail-
20 able by this or any other Act.

21 SEC. 215. None of the funds made available under
22 this Act, other than for the national instant criminal back-
23 ground check system established under section 103 of the
24 Brady Handgun Violence Prevention Act (34 U.S.C.
25 40901), may be used by a Federal law enforcement officer

1 to facilitate the transfer of an operable firearm to an indi-
2 vidual if the Federal law enforcement officer knows or sus-
3 pects that the individual is an agent of a drug cartel, un-
4 less law enforcement personnel of the United States con-
5 tinuously monitor or control the firearm at all times.

6 SEC. 216. (a) None of the income retained in the De-
7 partment of Justice Working Capital Fund pursuant to
8 title I of Public Law 102–140 (105 Stat. 784; 28 U.S.C.
9 527 note) shall be available for obligation during fiscal
10 year 2026, except up to \$12,000,000 may be obligated for
11 implementation of a unified Department of Justice finan-
12 cial management system.

13 (b) Not to exceed \$30,000,000 of the unobligated bal-
14 ances transferred to the capital account of the Department
15 of Justice Working Capital Fund pursuant to title I of
16 Public Law 102–140 (105 Stat. 784; 28 U.S.C. 527 note)
17 shall be available for obligation in fiscal year 2026, and
18 any use, obligation, transfer, or allocation of such funds
19 shall be treated as a reprogramming of funds under sec-
20 tion 505 of this Act.

21 (c) Not to exceed \$10,000,000 of the excess unobli-
22 gated balances available under section 524(c)(8)(E) of
23 title 28, United States Code, shall be available for obliga-
24 tion during fiscal year 2026, and any use, obligation,

1 transfer or allocation of such funds shall be treated as a
2 reprogramming of funds under section 505 of this Act.

3 SEC. 217. Discretionary funds that are made avail-
4 able in this Act for the Office of Justice Programs may
5 be used to participate in Performance Partnership Pilots
6 authorized under such authorities as have been enacted
7 for Performance Partnership Pilots in appropriations acts
8 in prior fiscal years and the current fiscal year.

9 SEC. 218. The Attorney General shall submit to the
10 Committees on Appropriations of the House of Represent-
11 atives and the Senate quarterly reports on the Crime Vic-
12 tims Fund, the Working Capital Fund, the Three Percent
13 Fund, and the Assets Forfeiture Fund. Such quarterly re-
14 ports shall contain at least the same level of information
15 and detail for each Fund as was provided to the Commit-
16 tees on Appropriations of the House of Representatives
17 and the Senate in fiscal year 2024.

18 SEC. 219. None of the funds made available under
19 this Act may be used to conduct, contract for, or otherwise
20 support, live tissue training, unless the Attorney General
21 issues a written, non-delegable determination that such
22 training is medically necessary and cannot be replicated
23 by alternatives.

24 SEC. 220. None of the funds made available by this
25 Act may be used by the Department of Justice to target

1 or investigate parents who peacefully protest at school
2 board meetings and are not suspected of engaging in un-
3 lawful activity.

4 SEC. 221. None of the funds made available by this
5 Act may be used to investigate or prosecute religious insti-
6 tutions on the basis of their religious beliefs.

7 SEC. 222. Any remaining unobligated balances from
8 amounts originally made available under the heading
9 “Federal Bureau of Investigation—Construction” in the
10 Department of Justice Appropriations Act, 2016 (title II
11 of division B of Public Law 114–113) or in the Depart-
12 ment of Justice Appropriations Act, 2017 (title II of divi-
13 sion B of Public Law 115–31) for the new Federal Bureau
14 of Investigation consolidated headquarters facility in the
15 National Capital Region that were subsequently repro-
16 grammed pursuant to a notification received by the Com-
17 mittees on Appropriations from the Assistant Attorney
18 General for Administration on July 1, 2025, may not be
19 further obligated until the Federal Bureau of Investiga-
20 tion submits to the Committees on Appropriations of the
21 House of Representatives and the Senate the contracted
22 and completed architectural and engineering plan for the
23 Federal Bureau of Investigation’s new headquarters build-
24 ing for review: *Provided*, That classified portions of the

- 1 architectural and engineering plan shall be submitted
- 2 through a classified annex.
- 3 This title may be cited as the “Department of Justice
- 4 Appropriations Act, 2026”.

8 passenger motor vehicles, and services as authorized by
9 section 3109 of title 5, United States Code, not to exceed
10 \$2,250 for official reception and representation expenses,
11 and rental of conference rooms in the District of Colum-
12 bia, \$7,965,000.

13 NATIONAL AERONAUTICS AND SPACE ADMINISTRATION

14 SCIENCE

15 For necessary expenses, not otherwise provided for,
16 in the conduct and support of science research and devel-
17 opment activities, including research, development, oper-
18 ations, support, and services; maintenance and repair, fa-
19 cility planning and design; space flight, spacecraft control,
20 and communications activities; program management; per-
21 sonnel and related costs, including uniforms or allowances
22 therefor, as authorized by sections 5901 and 5902 of title
23 5, United States Code; travel expenses; purchase and hire
24 of passenger motor vehicles; and purchase, lease, charter,
25 maintenance, and operation of mission and administrative

1 aircraft, \$7,250,000,000, to remain available until Sep-
2 tember 30, 2027: *Provided*, That of the amount made
3 available under this heading, the total amount specified
4 in the table under this heading in the explanatory state-
5 ment described in section 4 (in the matter preceding divi-
6 sion A of this Act) shall be for the purposes and in not
7 less than the amount for each such purpose specified in
8 such table.

10 AERONAUTICS

11 For necessary expenses, not otherwise provided for,

17 ment; personnel and related costs, including uniforms or
18 allowances therefor, as authorized by sections 5901 and
19 5902 of title 5, United States Code; travel expenses; pur-
20 chase and hire of passenger motor vehicles; and purchase,
21 lease, charter, maintenance, and operation of mission and
22 administrative aircraft, \$935,000,000, to remain available
23 until September 30, 2027.

25 SPACE TECHNOLOGY

26 For necessary expenses, not otherwise provided for,
27 in the conduct and support of space technology research

1 and development activities, including research, develop-
2 ment, operations, support, and services; maintenance and
3 repair, facility planning and design; space flight, space-

5 management; personnel and related costs, including uni-
6 forms or allowances therefor, as authorized by sections

8 penses; purchase and hire of passenger motor vehicles; and
9 purchase, lease, charter, maintenance, and operation of
10 mission and administrative aircraft, \$920,500,000, to re-

13 For necessary expenses, not otherwise provided for,

15 development activities, including research, development,

18 trol, and communications activities; program manage-
19 ment; personnel and related costs, including uniforms or
20 allowances therefor, as authorized by sections 5901 and
21 5902 of title 5, United States Code; travel expenses; pur-
22 chase and hire of passenger motor vehicles; and purchase,
23 lease, charter, maintenance, and operation of mission and
24 administrative aircraft, \$7,783,000,000, to remain avail-
25 able until September 30, 2027: *Provided*, That the Na-

2 MATHEMATICS ENGAGEMENT

3 For necessary expenses, not otherwise provided for,
4 in the conduct and support of aerospace and aeronautical
5 education research and development activities, including
6 research, development, operations, support, and services;
7 program management; personnel and related costs, includ-
8 ing uniforms or allowances therefor, as authorized by sec-
9 tions 5901 and 5902 of title 5, United States Code; travel
10 expenses; purchase and hire of passenger motor vehicles;
11 and purchase, lease, charter, maintenance, and operation
12 of mission and administrative aircraft, \$143,000,000, to
13 remain available until September 30, 2027: *Provided,*
14 That of the amount made available under this heading,
15 the total amount specified in the table under this heading
16 in the explanatory statement described in section 4 (in the
17 matter preceding division A of this consolidated Act) shall
18 be for the purposes and in not less than the amount for
19 each such purpose specified in such table.

20 SAFETY, SECURITY AND MISSION SERVICES

21 For necessary expenses, not otherwise provided for,
22 in the conduct and support of science, aeronautics, space
23 technology, exploration, space operations and education
24 research and development activities, including research,
25 development, operations, support, and services; mainte-

1 nance and repair, facility planning and design; space
2 flight, spacecraft control, and communications activities;
3 program management; personnel and related costs, includ-
4 ing uniforms or allowances therefor, as authorized by sec-
5 tions 5901 and 5902 of title 5, United States Code; travel
6 expenses; purchase and hire of passenger motor vehicles;
7 not to exceed \$63,000 for official reception and represen-
8 tation expenses; and purchase, lease, charter, mainte-
9 nance, and operation of mission and administrative air-
10 craft, \$3,000,000,000, to remain available until Sep-
11 tember 30, 2027: *Provided*, That if available balances in
12 the “Science, Space, and Technology Education Trust
13 Fund” are not sufficient to provide for the grant disburse-
14 ments required under the third and fourth provisos under
15 such heading in the Department of Housing and Urban
16 Development-Independent Agencies Appropriations Act,

16 ance and restoration, \$185,336,000, to remain available
17 until September 30, 2031: *Provided*, That proceeds from
18 leases deposited into this account shall be available for a

4 For necessary expenses of the Office of Inspector
5 General in carrying out the Inspector General Act of 1978,
6 \$46,500,000, of which \$2,500,000 shall remain available
7 until September 30, 2027.

8 ADMINISTRATIVE PROVISIONS

9 (INCLUDING TRANSFERS OF FUNDS)

10 Funds for any announced prize otherwise authorized
11 shall remain available, without fiscal year limitation, until
12 a prize is claimed or the offer is withdrawn.

13 Not to exceed 10 percent of any appropriation made
14 available for the current fiscal year for the National Aero-
15 nautics and Space Administration in this Act may be
16 transferred between such appropriations, but no such ap-
17 propriation, except as otherwise specifically provided, shall
18 be increased by more than 20 percent by any such trans-
19 fers. Any funds transferred to “Construction and Environ-
20 mental Compliance and Restoration” for construction ac-
21 tivities shall not increase that account by more than 20
22 percent. Balances so transferred shall be merged with and
23 available for the same purposes and the same time period
24 as the appropriations to which transferred. Any transfer

4 Not to exceed 5 percent of any appropriation pro-
5 vided for the National Aeronautics and Space Administra-
6 tion under previous appropriations Acts that remains
7 available for obligation or expenditure in fiscal year 2026
8 may be transferred between such appropriations, but no
9 such appropriation, except as otherwise specifically pro-
10 vided, shall be increased by more than 10 percent by any
11 such transfers. Any transfer pursuant to this provision
12 shall retain its original availability and shall be treated
13 as a reprogramming of funds under section 505 of this
14 Act and shall not be available for obligation except in com-
15 pliance with the procedures set forth in that section.

16 The spending plan required by this Act shall be pro-
17 vided by the National Aeronautics and Space Administra-
18 tion at the theme, program, project, and activity level. The
19 spending plan, as well as any subsequent change of an
20 amount established in that spending plan that meets the
21 notification requirements of section 505 of this Act, shall
22 be treated as a reprogramming under section 505 of this
23 Act and shall not be available for obligation or expenditure
24 except in compliance with the procedures set forth in that
25 section.

1 Not more than 20 percent or \$50,000,000, whichever
2 is less, of the amounts made available in the current-year
3 Construction and Environmental Compliance and Restora-
4 tion (CECR) appropriation may be applied to CECR
5 projects funded under previous years' CECR appropria-
6 tions. Use of current-year funds under this provision shall
7 be treated as a reprogramming of funds under section 505
8 of this Act and shall not be available for obligation except
9 in compliance with the procedures set forth in that section.

10 Of the amounts made available in this Act under the
11 heading "Science, Technology, Engineering, and Mathe-
12 matics Engagement" ("STEM Engagement"), up to
13 \$5,000,000 shall be available to jointly fund, with an addi-
14 tional amount of up to \$1,000,000 each from amounts
15 made available in this Act under the headings "Science",
16 "Aeronautics", "Space Technology", "Exploration", and
17 "Space Operations", projects and activities for engaging
18 students in STEM and increasing STEM research capaci-
19 ties of universities, including Minority Serving Institu-
20 tions.

21 Not to exceed \$38,500,000 made available for the
22 current fiscal year in this Act within "Safety, Security and

13 fiscal year from the General Fund of the Treasury to the
14 National Aeronautics and Space Administration (NASA)
15 by this or any other Act may be transferred (not later
16 than the end of the fifth fiscal year after the last fiscal

8 For necessary expenses in carrying out the National
9 Science Foundation Act of 1950 (42 U.S.C. 1861 et seq.),
10 and Public Law 86–209 (42 U.S.C. 1880 et seq.); services
11 as authorized by section 3109 of title 5, United States
12 Code; maintenance and operation of aircraft and purchase
13 of flight services for research support; acquisition of air-
14 craft; and authorized travel; \$7,176,500,000, to remain
15 available until September 30, 2027: *Provided*, That of the
16 amounts appropriated under this heading, not to exceed
17 \$700,000,000 shall remain available until expended for
18 polar research and operations support, and for reimburse-
19 ment to other Federal agencies for operational and science
20 support and logistical and other related activities for the
21 United States Antarctic program: *Provided further*, That
22 of the amounts in the preceding proviso, not less than
23 \$118,800,000 shall be for U.S. Antarctic Logistical Sup-
24 port: *Provided further*, That receipts for scientific support
25 services and materials furnished by the National Research

1 Centers and other National Science Foundation supported
2 research facilities may be credited to this appropriation.

3 MAJOR RESEARCH EQUIPMENT AND FACILITIES

4 CONSTRUCTION

5 For necessary expenses for the acquisition, construc-
6 tion, commissioning, and upgrading of major research
7 equipment, facilities, and other such capital assets pursu-
8 ant to the National Science Foundation Act of 1950 (42
9 U.S.C. 1861 et seq.), including authorized travel,
10 \$251,000,000, to remain available until expended.

11 STEM EDUCATION

12 For necessary expenses in carrying out science, math-
13 ematics, and engineering education and human resources
14 programs and activities pursuant to the National Science
15 Foundation Act of 1950 (42 U.S.C. 1861 et seq.), includ-
16 ing services as authorized by section 3109 of title 5,
17 United States Code, authorized travel, and rental of con-
18 ference rooms in the District of Columbia, \$938,250,000,
19 to remain available until September 30, 2027: *Provided,*
20 That of the amount made available under this heading,
21 the total amount specified in the table under this heading
22 in the explanatory statement described in section 4 (in the
23 matter preceding division A of this consolidated Act) shall
24 be for the purposes and in not less than the amount for
25 each such purpose specified in such table.

1 AGENCY OPERATIONS AND AWARD MANAGEMENT

2 For agency operations and award management nec-
3 essary in carrying out the National Science Foundation
4 Act of 1950 (42 U.S.C. 1861 et seq.); services authorized
5 by section 3109 of title 5, United States Code; hire of pas-
6 senger motor vehicles; uniforms or allowances therefor, as
7 authorized by sections 5901 and 5902 of title 5, United
8 States Code; rental of conference rooms in the District of
9 Columbia; and reimbursement of the Department of
10 Homeland Security for security guard services;
11 \$355,000,000: *Provided*, That not to exceed \$12,000 is
12 for official reception and representation expenses: *Pro-*
13 *vided further*, That contracts may be entered into under
14 this heading in fiscal year 2026 for maintenance and oper-
15 ation of facilities and for other services to be provided dur-
16 ing the next fiscal year.

17 OFFICE OF THE NATIONAL SCIENCE BOARD

18 For necessary expenses (including payment of sala-
19 ries, authorized travel, hire of passenger motor vehicles,
20 the rental of conference rooms in the District of Columbia,
21 and the employment of experts and consultants under sec-
22 tion 3109 of title 5, United States Code) involved in car-
23 rying out section 4 of the National Science Foundation
24 Act of 1950 (42 U.S.C. 1863) and Public Law 86–209
25 (42 U.S.C. 1880 et seq.), \$5,090,000: *Provided*, That not

1 to exceed \$2,500 shall be available for official reception
2 and representation expenses.

3 OFFICE OF INSPECTOR GENERAL

4 For necessary expenses of the Office of Inspector
5 General as authorized by the Inspector General Act of
6 1978, \$24,160,000, of which \$1,500,000 shall remain
7 available until September 30, 2027.

8 ADMINISTRATIVE PROVISIONS

9 (INCLUDING TRANSFER OF FUNDS)

10 Not to exceed 5 percent of any appropriation made
11 available for the current fiscal year for the National
12 Science Foundation in this Act may be transferred be-
13 tween such appropriations, but no such appropriation shall
14 be increased by more than 10 percent by any such trans-
15 fers. Any transfer pursuant to this paragraph shall be
16 treated as a reprogramming of funds under section 505
17 of this Act and shall not be available for obligation except
18 in compliance with the procedures set forth in that section.

19 The Director of the National Science Foundation
20 (NSF) shall notify the Committees on Appropriations of
21 the House of Representatives and the Senate at least 30
22 days in advance of any planned divestment through trans-
23 fer, decommissioning, termination, or deconstruction of
24 any NSF-owned facilities or any NSF capital assets (in-

1 cluding land, structures, and equipment) valued greater
2 than \$2,500,000.

3 This title may be cited as the “Science Appropria-
4 tions Act, 2026”.

1 TITLE IV
2 RELATED AGENCIES
3 COMMISSION ON CIVIL RIGHTS
4 SALARIES AND EXPENSES

5 For necessary expenses of the Commission on Civil
6 Rights, including hire of passenger motor vehicles,
7 \$14,350,000: *Provided*, That none of the funds appro-
8 priated in this paragraph may be used to employ any indi-
9 viduals under Schedule C of subpart C of part 213 of title
10 5 of the Code of Federal Regulations exclusive of one spe-
11 cial assistant for each Commissioner: *Provided further*,
12 That none of the funds appropriated in this paragraph
13 shall be used to reimburse Commissioners for more than
14 75 billable days, with the exception of the chairperson,
15 who is permitted 125 billable days: *Provided further*, That
16 the Chair may accept and use any gift or donation to carry
17 out the work of the Commission: *Provided further*, That
18 none of the funds appropriated in this paragraph shall be
19 used for any activity or expense that is not explicitly au-
20 thorized by section 3 of the Civil Rights Commission Act
21 of 1983 (42 U.S.C. 1975a): *Provided further*, That not-
22 withstanding the preceding proviso, \$2,000,000 shall be
23 used to separately fund the Commission on the Social Sta-
24 tus of Black Men and Boys.

1 EQUAL EMPLOYMENT OPPORTUNITY COMMISSION

2 SALARIES AND EXPENSES

3 For necessary expenses of the Equal Employment
4 Opportunity Commission as authorized by title VII of the
5 Civil Rights Act of 1964, the Age Discrimination in Em-
6 ployment Act of 1967, the Equal Pay Act of 1963, the
7 Americans with Disabilities Act of 1990, section 501 of
8 the Rehabilitation Act of 1973, the Civil Rights Act of
9 1991, the Genetic Information Nondiscrimination Act
10 (GINA) of 2008 (Public Law 110–233), the ADA Amend-
11 ments Act of 2008 (Public Law 110–325), the Lilly
12 Ledbetter Fair Pay Act of 2009 (Public Law 111–2), and
13 Public Law 117–328, including services as authorized by
14 section 3109 of title 5, United States Code; hire of pas-
15 senger motor vehicles as authorized by section 1343(b) of
16 title 31, United States Code; nonmonetary awards to pri-
17 vate citizens; and up to \$32,500,000 for payments to
18 State and local enforcement agencies for authorized serv-
19 ices to the Commission, \$435,382,000, of which
20 \$2,788,000 shall be for the Office of the Inspector Gen-
21 eral: *Provided*, That the Commission is authorized to make
22 available for official reception and representation expenses
23 not to exceed \$2,250 from available funds: *Provided fur-*
24 *ther*, That the Commission may take no action to imple-
25 ment any workforce repositioning, restructuring, or reor-

1 ganization until such time as the Committees on Appro-
2 priations of the House of Representatives and the Senate
3 have been notified of such proposals, in accordance with
4 the reprogramming requirements of section 505 of this
5 Act: *Provided further*, That the Chair may accept and use
6 any gift or donation to carry out the work of the Commis-
7 sion.

8 INTERNATIONAL TRADE COMMISSION

9 SALARIES AND EXPENSES

10 For necessary expenses of the International Trade
11 Commission, including hire of passenger motor vehicles
12 and services as authorized by section 3109 of title 5,
13 United States Code, and not to exceed \$2,250 for official
14 reception and representation expenses, \$122,000,000, to
15 remain available until expended, of which not less than
16 \$2,096,176 shall be for the Office of Inspector General
17 in carrying out the Inspector General Act of 1978 (5
18 U.S.C. 401 et seq.).

19 LEGAL SERVICES CORPORATION

20 PAYMENT TO THE LEGAL SERVICES CORPORATION

21 For payment to the Legal Services Corporation to
22 carry out the purposes of the Legal Services Corporation
23 Act of 1974, \$540,000,000, of which \$496,300,000 is for
24 basic field programs and required independent audits;
25 \$6,000,000 is for the Office of Inspector General, of which

1 such amounts as may be necessary may be used to conduct
2 additional audits of recipients; \$26,200,000 is for manage-
3 ment and grants oversight; \$4,750,000 is for client self-
4 help and information technology; \$4,750,000 is for a Pro
5 Bono Innovation Fund; and \$2,000,000 is for loan repay-
6 ment assistance: *Provided*, That the budget execution for
7 the payment to the Legal Services Corporation shall be
8 carried out in this fiscal year in the same manner as such
9 budget execution was carried out in fiscal year 2024 and
10 such payment shall be made in full as an annual install-
11 ment paid to the Corporation at the beginning of the fiscal
12 year in such amounts as specified under this heading: *Pro-*
13 *vided further*, That the Legal Services Corporation may
14 continue to provide locality pay to officers and employees
15 at a rate no greater than that provided by the Federal
16 Government to Washington, DC-based employees as au-
17 thorized by section 5304 of title 5, United States Code,
18 notwithstanding section 1005(d) of the Legal Services
19 Corporation Act (42 U.S.C. 2996d(d)): *Provided further*,
20 That the authorities provided in section 205 of this Act
21 shall be applicable to the Legal Services Corporation: *Pro-*
22 *vided further*, That, for the purposes of section 505 of this
23 Act, the Legal Services Corporation shall be considered
24 an agency of the United States Government.

1 ADMINISTRATIVE PROVISIONS—LEGAL SERVICES
2 CORPORATION

3 None of the funds appropriated in this Act to the
4 Legal Services Corporation shall be expended for any pur-
5 pose prohibited or limited by, or contrary to any of the
6 provisions of, sections 501, 502, 503, 504, 505, and 506
7 of Public Law 105–119, and all funds appropriated in this
8 Act to the Legal Services Corporation shall be subject to
9 the same terms and conditions set forth in such sections,
10 except that all references in sections 502 and 503 to 1997
11 and 1998 shall be deemed to refer instead to 2025 and
12 2026, respectively.

13 Section 501 of the Departments of Commerce, Jus-
14 tice, and State, the Judiciary, and Related Agencies Ap-
15 propriations Act, 1998 (Public Law 105–119) is amended
16 by adding the following new subsection at the end:

17 “(d) MODIFIED GOVERNING BODY REQUIREMENT.—
18 For purposes of this Act, section 1007(c) of the Legal
19 Services Corporation Act (42 U.S.C. 2996f(c)) shall be ap-
20 plied by substituting ‘33 percent’ for ‘60 percent’.”

21 Section 502(2) of the Departments of Commerce,
22 Justice, and State, the Judiciary, and Related Agencies
23 Appropriations Act, 1996 (Public Law 104–134) is
24 amended by striking subparagraph (B) in its entirety and
25 replacing it with the following:

1 “(B) is governed by a board of directors or
2 other governing body, 33 percent of which is
3 comprised of attorneys who are members of the
4 bar of a State, as defined in section 1002(8) of
5 the Legal Services Corporation Act (42 U.S.C.
6 2996a(8)), in which the legal assistance is to be
7 provided;”.

8 MARINE MAMMAL COMMISSION
9 SALARIES AND EXPENSES

10 For necessary expenses of the Marine Mammal Com-
11 mission as authorized by title II of the Marine Mammal
12 Protection Act of 1972 (16 U.S.C. 1361 et seq.),
13 \$4,300,000, to remain available until September 30, 2027.

14 OFFICE OF THE UNITED STATES TRADE
15 REPRESENTATIVE
16 SALARIES AND EXPENSES

17 For necessary expenses of the Office of the United
18 States Trade Representative, including the hire of pas-
19 senger motor vehicles and the employment of experts and
20 consultants as authorized by section 3109 of title 5,
21 United States Code, \$65,000,000, of which \$1,000,000
22 shall remain available until expended: *Provided*, That of
23 the total amount made available under this heading, not
24 to exceed \$124,000 shall be available for official reception
25 and representation expenses.

1 TRADE ENFORCEMENT TRUST FUND
2 (INCLUDING TRANSFER OF FUNDS)

3 For activities of the United States Trade Representa-
4 tive authorized by section 611 of the Trade Facilitation
5 and Trade Enforcement Act of 2015 (19 U.S.C. 4405),
6 including transfers, \$23,000,000, to be derived from the
7 Trade Enforcement Trust Fund: *Provided*, That any
8 transfer pursuant to subsection (d)(1) of such section shall
9 be treated as a reprogramming under section 505 of this
10 Act.

11 STATE JUSTICE INSTITUTE
12 SALARIES AND EXPENSES

13 For necessary expenses of the State Justice Institute,
14 as authorized by the State Justice Institute Act of 1984
15 (42 U.S.C. 10701 et seq.) \$7,640,000, of which \$500,000
16 shall remain available until September 30, 2027: *Provided*,
17 That not to exceed \$2,250 shall be available for official
18 reception and representation expenses: *Provided further*,
19 That, for the purposes of section 505 of this Act, the State
20 Justice Institute shall be considered an agency of the
21 United States Government.

1 TITLE V
2 GENERAL PROVISIONS
3 (INCLUDING TRANSFERS AND RESCISSIONS OF FUNDS)

4 SEC. 501. No part of any appropriation contained in
5 this Act shall be used for publicity or propaganda purposes
6 not authorized by the Congress.

7 SEC. 502. No part of any appropriation contained in
8 this Act shall remain available for obligation beyond the
9 current fiscal year unless expressly so provided herein.

10 SEC. 503. The expenditure of any appropriation
11 under this Act for any consulting service through procure-
12 ment contract, pursuant to section 3109 of title 5, United
13 States Code, shall be limited to those contracts where such
14 expenditures are a matter of public record and available
15 for public inspection, except where otherwise provided
16 under existing law, or under existing Executive order
17 issued pursuant to existing law.

18 SEC. 504. If any provision of this Act or the applica-
19 tion of such provision to any person or circumstances shall
20 be held invalid, the remainder of the Act and the applica-
21 tion of each provision to persons or circumstances other
22 than those as to which it is held invalid shall not be af-
23 fected thereby.

24 SEC. 505. (a) None of the funds provided under this
25 Act, or provided under previous appropriations Acts to the

1 agencies funded by this Act that remain available for obli-
2 gation or expenditure in fiscal year 2026, or provided from
3 any accounts in the Treasury of the United States derived
4 by the collection of fees available to the agencies funded
5 by this Act, shall be available for obligation or expenditure
6 through a reprogramming of funds that: (1) creates or ini-
7 tiates a new program, project, or activity; (2) eliminates
8 a program, project, or activity; (3) increases funds or per-
9 sonnel by any means for any project or activity for which
10 funds have been denied or restricted; (4) relocates an of-
11 fice or employees; (5) reorganizes or renames offices, pro-
12 grams, or activities; (6) contracts out or privatizes any
13 functions or activities presently performed by Federal em-
14 ployees; (7) augments existing programs, projects, or ac-
15 tivities in excess of \$500,000 or 5 percent, whichever is
16 less, or reduces by 5 percent funding for any program,
17 project, or activity, or numbers of personnel by 5 percent;
18 (8) results from any general savings, including savings
19 from a reduction in personnel, which would result in a
20 change in existing programs, projects, or activities as ap-
21 proved by Congress; unless the House and Senate Com-
22 mittees on Appropriations are notified 30 days in advance
23 of such reprogramming of funds.

24 SEC. 506. (a) If it has been finally determined by
25 a court or Federal agency that any person intentionally

1 affixed a label bearing a “Made in America” inscription,
2 or any inscription with the same meaning, to any product
3 sold in or shipped to the United States that is not made
4 in the United States, the person shall be ineligible to re-
5 ceive any contract or subcontract made with funds made
6 available in this Act, pursuant to the debarment, suspen-
7 sion, and ineligibility procedures described in sections
8 9.400 through 9.409 of title 48, Code of Federal Regula-
9 tions.

10 (b)(1) To the extent practicable, with respect to au-
11 thorized purchases of promotional items, funds made
12 available by this Act shall be used to purchase items that
13 are manufactured, produced, or assembled in the United
14 States, its territories or possessions.

15 (2) The term “promotional items” has the meaning
16 given the term in OMB Circular A–87, Attachment B,
17 Item (1)(f)(3).

18 SEC. 507. (a) The Departments of Commerce and
19 Justice, the National Science Foundation, and the Na-
20 tional Aeronautics and Space Administration shall provide
21 to the Committees on Appropriations of the House of Rep-
22 resentatives and the Senate a quarterly report on the sta-
23 tus of balances of appropriations at the account level. For
24 unobligated, uncommitted balances and unobligated, com-
25 mitted balances the quarterly reports shall separately

1 identify the amounts attributable to each source year of
2 appropriation from which the balances were derived. For
3 balances that are obligated, but unexpended, the quarterly
4 reports shall separately identify amounts by the year of
5 obligation.

6 (b) The report described in subsection (a) shall be
7 submitted within 30 days of the end of each quarter.

8 (c) If a department or agency is unable to fulfill any
9 aspect of a reporting requirement described in subsection
10 (a) due to a limitation of a current accounting system,
11 the department or agency shall fulfill such aspect to the
12 maximum extent practicable under such accounting sys-
13 tem and shall identify and describe in each quarterly re-
14 port the extent to which such aspect is not fulfilled.

15 SEC. 508. Any costs incurred by a department or
16 agency funded under this Act resulting from, or to pre-
17 vent, personnel actions taken in response to funding re-
18 ductions included in this Act shall be absorbed within the
19 total budgetary resources available to such department or
20 agency: *Provided*, That the authority to transfer funds be-
21 tween appropriations accounts as may be necessary to
22 carry out this section is provided in addition to authorities
23 included elsewhere in this Act: *Provided further*, That use
24 of funds to carry out this section shall be treated as a
25 reprogramming of funds under section 505 of this Act and

1 shall not be available for obligation or expenditure except
2 in compliance with the procedures set forth in that section:
3 *Provided further*, That for the Department of Commerce,
4 this section shall also apply to actions taken for the care
5 and protection of loan collateral or grant property.

6 SEC. 509. None of the funds provided by this Act
7 shall be available to promote the sale or export of tobacco
8 or tobacco products, or to seek the reduction or removal
9 by any foreign country of restrictions on the marketing
10 of tobacco or tobacco products, except for restrictions
11 which are not applied equally to all tobacco or tobacco
12 products of the same type.

13 SEC. 510. Notwithstanding any other provision of
14 law, amounts deposited or available in the Fund estab-
15 lished by section 1402 of chapter XIV of title II of Public
16 Law 98-473 (34 U.S.C. 20101) in any fiscal year in ex-
17 cess of \$1,950,000,000 shall not be available for obligation
18 until the following fiscal year: *Provided*, That notwith-
19 standing section 1402(d) of such Act, of the amounts
20 available from the Fund for obligation: (1) \$10,000,000
21 shall be transferred to the Department of Justice Office
22 of Inspector General and remain available until expended
23 for oversight and auditing purposes associated with this
24 section; and (2) 5 percent shall be available to the Office
25 for Victims of Crime for grants, consistent with the re-

1 requirements of the Victims of Crime Act, to Indian Tribes
2 to improve services for victims of crime.

3 SEC. 511. None of the funds made available to the
4 Department of Justice in this Act may be used to discrimi-
5 nate against or denigrate the religious or moral beliefs of
6 students who participate in programs for which financial
7 assistance is provided from those funds, or of the parents
8 or legal guardians of such students.

9 SEC. 512. None of the funds made available in this
10 Act may be transferred to any department, agency, or in-
11 strumentality of the United States Government, except
12 pursuant to a transfer made by, or transfer authority pro-
13 vided in, this Act or any other appropriations Act.

14 SEC. 513. (a) The Inspectors General of the Depart-
15 ment of Commerce, the Department of Justice, the Na-
16 tional Aeronautics and Space Administration, the Na-
17 tional Science Foundation, and the Legal Services Cor-
18 poration shall conduct audits, pursuant to the Inspector
19 General Act (5 U.S.C. App.), of grants or contracts for
20 which funds are appropriated by this Act, and shall submit
21 reports to Congress on the progress of such audits, which
22 may include preliminary findings and a description of
23 areas of particular interest, within 180 days after initi-
24 ating such an audit and every 180 days thereafter until
25 any such audit is completed.

1 (b) Within 60 days after the date on which an audit
2 described in subsection (a) by an Inspector General is
3 completed, the Secretary, Attorney General, Adminis-
4 trator, Director, or President, as appropriate, shall make
5 the results of the audit available to the public on the Inter-
6 net website maintained by the Department, Administra-
7 tion, Foundation, or Corporation, respectively. The results
8 shall be made available in redacted form to exclude—

9 (1) any matter described in section 552(b) of
10 title 5, United States Code; and

11 (2) sensitive personal information for any indi-
12 vidual, the public access to which could be used to
13 commit identity theft or for other inappropriate or
14 unlawful purposes.

15 (c) Any person awarded a grant or contract funded
16 by amounts appropriated by this Act shall submit a state-
17 ment to the Secretary of Commerce, the Attorney General,
18 the Administrator, Director, or President, as appropriate,
19 certifying that no funds derived from the grant or contract
20 will be made available through a subcontract or in any
21 other manner to another person who has a financial inter-
22 est in the person awarded the grant or contract.

23 (d) The provisions of the preceding subsections of
24 this section shall take effect 30 days after the date on
25 which the Director of the Office of Management and

1 Budget, in consultation with the Director of the Office of
2 Government Ethics, determines that a uniform set of rules
3 and requirements, substantially similar to the require-
4 ments in such subsections, consistently apply under the
5 executive branch ethics program to all Federal depart-
6 ments, agencies, and entities.

7 SEC. 514. (a) None of the funds appropriated or oth-
8 erwise made available under this Act may be used by the
9 Departments of Commerce and Justice, the National Aer-
10 onautics and Space Administration, or the National
11 Science Foundation to acquire a high-impact or moderate-
12 impact information system, as defined for security cat-
13 egorization in the National Institute of Standards and
14 Technology's (NIST) Federal Information Processing
15 Standard Publication 199, "Standards for Security Cat-
16 egorization of Federal Information and Information Sys-
17 tems" unless the agency has—

18 (1) reviewed the supply chain risk for the infor-
19 mation systems against criteria developed by NIST
20 and the Federal Bureau of Investigation (FBI) to
21 inform acquisition decisions for high-impact and
22 moderate-impact information systems within the
23 Federal Government;

24 (2) reviewed the supply chain risk from the pre-
25 sumptive awardee against available and relevant

1 threat information provided by the FBI and other
2 appropriate agencies; and

3 (3) in consultation with the FBI or other ap-
4 propriate Federal entity, conducted an assessment of
5 any risk of cyber-espionage or sabotage associated
6 with the acquisition of such system, including any
7 risk associated with such system being produced,
8 manufactured, or assembled by one or more entities
9 identified by the United States Government as pos-
10 sing a cyber threat, including but not limited to,
11 those that may be owned, directed, or subsidized by
12 the People's Republic of China, the Islamic Republic
13 of Iran, the Democratic People's Republic of Korea,
14 or the Russian Federation.

15 (b) None of the funds appropriated or otherwise
16 made available under this Act may be used to acquire a
17 high-impact or moderate-impact information system re-
18 viewed and assessed under subsection (a) unless the head
19 of the assessing entity described in subsection (a) has—

20 (1) developed, in consultation with NIST, the
21 FBI, and supply chain risk management experts, a
22 mitigation strategy for any identified risks;

23 (2) determined, in consultation with NIST and
24 the FBI, that the acquisition of such system is in
25 the national interest of the United States; and

1 (3) reported that determination to the Commit-
2 tees on Appropriations of the House of Representa-
3 tives and the Senate and the agency Inspector Gen-
4 eral.

5 SEC. 515. None of the funds made available in this
6 Act shall be used in any way whatsoever to support or
7 justify the use of torture by any official or contract em-
8 ployee of the United States Government.

9 SEC. 516. None of the funds made available in this
10 Act may be used to include in any new bilateral or multi-
11 lateral trade agreement the text of—

12 (1) paragraph 2 of article 16.7 of the United
13 States–Singapore Free Trade Agreement;

14 (2) paragraph 4 of article 17.9 of the United
15 States–Australia Free Trade Agreement; or

16 (3) paragraph 4 of article 15.9 of the United
17 States–Morocco Free Trade Agreement.

18 SEC. 517. None of the funds made available in this
19 Act may be used to authorize or issue a national security
20 letter in contravention of any of the following laws author-
21 izing the Federal Bureau of Investigation to issue national
22 security letters: The Right to Financial Privacy Act of
23 1978; The Electronic Communications Privacy Act of
24 1986; The Fair Credit Reporting Act; The National Secu-

1 rity Act of 1947; USA PATRIOT Act; USA FREEDOM
2 Act of 2015; and the laws amended by these Acts.

3 SEC. 518. If at any time during any quarter, the pro-
4 gram manager of a project within the jurisdiction of the
5 Departments of Commerce or Justice, the National Aero-
6 nautics and Space Administration, or the National Science
7 Foundation totaling more than \$75,000,000 has reason-
8 able cause to believe that the total program cost has in-
9 creased by 10 percent or more, the program manager shall
10 immediately inform the respective Secretary, Adminis-
11 trator, or Director. The Secretary, Administrator, or Di-
12 rector shall notify the House and Senate Committees on
13 Appropriations within 30 days in writing of such increase,
14 and shall include in such notice: the date on which such
15 determination was made; a statement of the reasons for
16 such increases; the action taken and proposed to be taken
17 to control future cost growth of the project; changes made
18 in the performance or schedule milestones and the degree
19 to which such changes have contributed to the increase
20 in total program costs or procurement costs; new esti-
21 mates of the total project or procurement costs; and a
22 statement validating that the project's management struc-
23 ture is adequate to control total project or procurement
24 costs.

1 SEC. 519. Funds appropriated by this Act, or made
2 available by the transfer of funds in this Act, for intel-
3 ligence or intelligence related activities are deemed to be
4 specifically authorized by the Congress for purposes of sec-
5 tion 504 of the National Security Act of 1947 (50 U.S.C.
6 3094) during fiscal year 2026 until the enactment of the
7 Intelligence Authorization Act for fiscal year 2026.

8 SEC. 520. None of the funds appropriated or other-
9 wise made available by this Act may be used to enter into
10 a contract in an amount greater than \$5,000,000 or to
11 award a grant in excess of such amount unless the pro-
12 spective contractor or grantee certifies in writing to the
13 agency awarding the contract or grant that, to the best
14 of its knowledge and belief, the contractor or grantee has
15 filed all Federal tax returns required during the three
16 years preceding the certification, has not been convicted
17 of a criminal offense under the Internal Revenue Code of
18 1986, and has not, more than 90 days prior to certifi-
19 cation, been notified of any unpaid Federal tax assessment
20 for which the liability remains unsatisfied, unless the as-
21 sessment is the subject of an installment agreement or
22 offer in compromise that has been approved by the Inter-
23 nal Revenue Service and is not in default, or the assess-
24 ment is the subject of a non-frivolous administrative or
25 judicial proceeding.

1 (RESCISSIONS)

2 SEC. 521. (a) Of the unobligated balances available
3 to the Department of Commerce, the following funds are
4 hereby permanently rescinded, not later than September
5 30, 2026, from the following accounts in the specified
6 amounts—

7 (1) “Economic Development Administration—
8 Economic Development Assistance Programs”,
9 \$60,000,000, only from prior year appropriations
10 that remain available until expended; and

11 (2) “Census Working Capital Fund”,
12 \$15,000,000.

13 (b) Of the unobligated balances from prior year ap-
14 propriations available to the Department of Justice, the
15 following funds are hereby permanently rescinded, not
16 later than September 30, 2026, from the following ac-
17 counts in the specified amounts—

18 (1) “State and Local Law Enforcement Activi-
19 ties—Office on Violence Against Women—Violence
20 Against Women Prevention and Prosecution Pro-
21 grams”, \$36,000,000;

22 (2) “State and Local Law Enforcement Activi-
23 ties—Office of Justice Programs”, \$250,000,000;
24 and

1 (3) “State and Local Law Enforcement Activi-
2 ties—Community Oriented Policing Services”,
3 \$25,000,000.

4 (c) Of the unobligated balances available to the De-
5 partment of Justice, the following funds are hereby per-
6 manently rescinded, not later than September 30, 2026,
7 from the following accounts in the specified amounts—

8 (1) “Working Capital Fund”, \$210,000,000;
9 and

10 (2) “Legal Activities—Assets Forfeiture Fund”,
11 \$113,200,000.

12 (d) The Departments of Commerce and Justice shall
13 submit to the Committees on Appropriations of the House
14 of Representatives and the Senate a report no later than
15 September 1, 2026, specifying the amount of each rescis-
16 sion made pursuant to subsections (a), (b), and (c).

17 (e) The amounts rescinded in subsections (a), (b),
18 and (c) shall not be from amounts that were designated
19 by the Congress as an emergency or disaster relief require-
20 ment pursuant to the concurrent resolution on the budget
21 or the Balanced Budget and Emergency Deficit Control
22 Act of 1985.

23 (f) The amounts rescinded pursuant to subsections
24 (b) and (c) shall not be from—

1 (1) amounts provided under subparagraph (Q)
2 of paragraph (1) under the heading “State and
3 Local Law Enforcement Activities—Office of Justice
4 Programs—State and Local Law Enforcement As-
5 sistance” in title II of division B of Public Law
6 117–103 or Public Law 117–328, or amounts pro-
7 vided under subparagraph (R) of paragraph (1)
8 under the heading “State and Local Law Enforce-
9 ment Activities—Office of Justice Programs—State
10 and Local Law Enforcement Assistance” in title II
11 of division C of Public Law 118–42; or

12 (2) amounts provided under paragraph (7)
13 under the heading “State and Local Law Enforce-
14 ment Activities—Community Oriented Policing Serv-
15 ices—Community Oriented Policing Services Pro-
16 grams” in title II of division B of Public Law 117–
17 103 or Public Law 117–328, or amounts provided
18 under paragraph (7) under the heading “State and
19 Local Law Enforcement Activities—Community Ori-
20 ented Policing Services—Community Oriented Polie-
21 ing Services Programs” in title II of division C of
22 Public Law 118–42.

23 SEC. 522. None of the funds made available in this
24 Act may be used to purchase first class or premium airline

1 travel in contravention of sections 301–10.122 through
2 301–10.124 of title 41 of the Code of Federal Regulations.

3 SEC. 523. None of the funds made available in this
4 Act may be used to send or otherwise pay for the attend-
5 ance of more than 50 employees from a Federal depart-
6 ment or agency, who are stationed in the United States,
7 at any single conference occurring outside the United
8 States unless—

9 (1) such conference is a law enforcement train-
10 ing or operational conference for law enforcement
11 personnel and the majority of Federal employees in
12 attendance are law enforcement personnel stationed
13 outside the United States; or

14 (2) such conference is a scientific conference
15 and the department or agency head determines that
16 such attendance is in the national interest and noti-
17 fies the Committees on Appropriations of the House
18 of Representatives and the Senate within at least 15
19 days of that determination and the basis for that de-
20 termination.

21 SEC. 524. The Director of the Office of Management
22 and Budget shall instruct any department, agency, or in-
23 strumentality of the United States receiving funds appro-
24 priated under this Act to track undisbursed balances in
25 expired grant accounts and include in its annual perform-

1 ance plan and performance and accountability reports the
2 following:

3 (1) Details on future action the department,
4 agency, or instrumentality will take to resolve
5 undisbursed balances in expired grant accounts.

6 (2) The method that the department, agency, or
7 instrumentality uses to track undisbursed balances
8 in expired grant accounts.

9 (3) Identification of undisbursed balances in ex-
10 pired grant accounts that may be returned to the
11 Treasury of the United States.

12 (4) In the preceding 3 fiscal years, details on
13 the total number of expired grant accounts with
14 undisbursed balances (on the first day of each fiscal
15 year) for the department, agency, or instrumentality
16 and the total finances that have not been obligated
17 to a specific project remaining in the accounts.

18 SEC. 525. To the extent practicable, funds made
19 available in this Act should be used to purchase light bulbs
20 that are “Energy Star” qualified or have the “Federal En-
21 ergy Management Program” designation.

22 SEC. 526. (a) None of the funds made available by
23 this Act may be used for the National Aeronautics and
24 Space Administration (NASA) or the Office of Science
25 and Technology Policy (OSTP) to develop, design, plan,

1 promulgate, implement, or execute a bilateral policy, pro-
2 gram, order, or contract of any kind to participate, col-
3 laborate, or coordinate bilaterally in any way with China
4 or any Chinese-owned company unless such activities are
5 specifically authorized by a law enacted after the date of
6 enactment of this Act.

7 (b) None of the funds made available by this Act may
8 be used to effectuate the hosting of official Chinese visitors
9 at facilities belonging to or utilized by NASA.

10 (c) The limitations described in subsections (a) and
11 (b) shall not apply to activities which NASA or OSTP,
12 after consultation with the Federal Bureau of Investiga-
13 tion, have certified—

14 (1) pose no risk of resulting in the transfer of
15 technology, data, or other information with national
16 security or economic security implications to China
17 or a Chinese-owned company; and

18 (2) will not involve knowing interactions with
19 officials who have been determined by the United
20 States to have direct involvement with violations of
21 human rights.

22 (d) Any certification made under subsection (c) shall
23 be submitted to the Committees on Appropriations of the
24 House of Representatives and the Senate, and the Federal
25 Bureau of Investigation, no later than 30 days prior to

1 the activity in question and shall include a description of
2 the purpose of the activity, its agenda, its major partici-
3 pants, and its location and timing.

4 SEC. 527. (a) None of the funds made available in
5 this Act may be used to maintain or establish a computer
6 network unless such network blocks the viewing,
7 downloading, and exchanging of pornography.

8 (b) Nothing in subsection (a) shall limit the use of
9 funds necessary for any Federal, State, Tribal, or local
10 law enforcement agency or any other entity carrying out
11 criminal investigations, prosecution, adjudication, or other
12 law enforcement- or victim assistance-related activity.

13 SEC. 528. The Departments of Commerce and Jus-
14 tice, the National Aeronautics and Space Administration,
15 the National Science Foundation, the Commission on Civil
16 Rights, the Equal Employment Opportunity Commission,
17 the International Trade Commission, the Legal Services
18 Corporation, the Marine Mammal Commission, the Offices
19 of Science and Technology Policy and the United States
20 Trade Representative, and the State Justice Institute
21 shall submit spending plans, signed by the respective de-
22 partment or agency head, to the Committees on Appro-
23 priations of the House of Representatives and the Senate
24 not later than 45 days after the date of enactment of this
25 Act: *Provided*, That the spending plans submitted pursu-

1 ant to this section shall contain at least the same level
2 of detail as the spending plans submitted pursuant to this
3 section in fiscal year 2024.

4 SEC. 529. Notwithstanding any other provision of
5 this Act, none of the funds appropriated or otherwise
6 made available by this Act may be used to pay award or
7 incentive fees for contractor performance that has been
8 judged to be below satisfactory performance or for per-
9 formance that does not meet the basic requirements of a
10 contract.

11 SEC. 530. None of the funds made available by this
12 Act may be used in contravention of section 7606 (“Legit-
13 imacy of Industrial Hemp Research”) of the Agricultural
14 Act of 2014 (Public Law 113–79) by the Department of
15 Justice or the Drug Enforcement Administration.

16 SEC. 531. None of the funds made available under
17 this Act to the Department of Justice may be used, with
18 respect to any of the States of Alabama, Alaska, Arizona,
19 Arkansas, California, Colorado, Connecticut, Delaware,
20 Florida, Georgia, Hawaii, Illinois, Indiana, Iowa, Ken-
21 tucky, Louisiana, Maine, Maryland, Massachusetts, Michi-
22 gan, Minnesota, Mississippi, Missouri, Montana, Nevada,
23 New Hampshire, New Jersey, New Mexico, New York,
24 North Carolina, North Dakota, Ohio, Oklahoma, Oregon,
25 Pennsylvania, Rhode Island, South Carolina, South Da-

1 kota, Tennessee, Texas, Utah, Vermont, Virginia, Wash-
2 ington, West Virginia, Wisconsin, and Wyoming, or with
3 respect to the District of Columbia, the Commonwealth
4 of the Northern Mariana Islands, the United States Virgin
5 Islands, Guam, or Puerto Rico, to prevent any of them
6 from implementing their own laws that authorize the use,
7 distribution, possession, or cultivation of medical mari-
8 juana.

9 SEC. 532. The Department of Commerce, the Na-
10 tional Aeronautics and Space Administration, and the Na-
11 tional Science Foundation shall provide a quarterly report
12 to the Committees on Appropriations of the House of Rep-
13 resentatives and the Senate on any official travel to China
14 by any employee of such Department or agency, including
15 the purpose of such travel.

16 SEC. 533. Of the amounts made available by this Act,
17 not less than 10 percent of each total amount provided,
18 respectively, for Public Works grants authorized by the
19 Public Works and Economic Development Act of 1965 and
20 grants authorized by section 27 of the Stevenson-Wydler
21 Technology Innovation Act of 1980 (15 U.S.C. 3722) shall
22 be allocated for assistance in persistent poverty counties:
23 *Provided*, That for purposes of this section, the term “per-
24 sistent poverty counties” means any county that has had
25 20 percent or more of its population living in poverty over

1 the past 30 years, as measured by the 1993 Small Area
2 Income and Poverty Estimates, the 2000 decennial cen-
3 sus, and the most recent Small Area Income and Poverty
4 Estimates, or any Territory or possession of the United
5 States.

6 SEC. 534. (a) Notwithstanding any other provision
7 of law or treaty, none of the funds appropriated or other-
8 wise made available under this Act or any other Act may
9 be expended or obligated by a department, agency, or in-
10 strumentality of the United States to pay administrative
11 expenses or to compensate an officer or employee of the
12 United States in connection with requiring an export li-
13 cense for the export to Canada of components, parts, ac-
14 cessories or attachments for firearms listed in Category
15 I, section 121.1 of title 22, Code of Federal Regulations
16 (International Trafficking in Arms Regulations (ITAR),
17 part 121, as it existed on April 1, 2005) with a total value
18 not exceeding \$500 wholesale in any transaction, provided
19 that the conditions of subsection (b) of this section are
20 met by the exporting party for such articles.

21 (b) The foregoing exemption from obtaining an ex-
22 port license—

23 (1) does not exempt an exporter from filing any
24 Shipper's Export Declaration or notification letter
25 required by law, or from being otherwise eligible

1 under the laws of the United States to possess, ship,
2 transport, or export the articles enumerated in sub-
3 section (a); and

4 (2) does not permit the export without a license
5 of—

6 (A) fully automatic firearms and compo-
7 nents and parts for such firearms, other than
8 for end use by the Federal Government, or a
9 Provincial or Municipal Government of Canada;

10 (B) barrels, cylinders, receivers (frames) or
11 complete breech mechanisms for any firearm
12 listed in Category I, other than for end use by
13 the Federal Government, or a Provincial or Mu-
14 nicipal Government of Canada; or

15 (C) articles for export from Canada to an-
16 other foreign destination.

17 (c) In accordance with this section, the District Di-
18 rectors of Customs and postmasters shall permit the per-
19 manent or temporary export without a license of any un-
20 classified articles specified in subsection (a) to Canada for
21 end use in Canada or return to the United States, or tem-
22 porary import of Canadian-origin items from Canada for
23 end use in the United States or return to Canada for a
24 Canadian citizen.

1 (d) The President may require export licenses under
2 this section on a temporary basis if the President deter-
3 mines, upon publication first in the Federal Register, that
4 the Government of Canada has implemented or main-
5 tained inadequate import controls for the articles specified
6 in subsection (a), such that a significant diversion of such
7 articles has and continues to take place for use in inter-
8 national terrorism or in the escalation of a conflict in an-
9 other nation. The President shall terminate the require-
10 ments of a license when reasons for the temporary require-
11 ments have ceased.

12 SEC. 535. Notwithstanding any other provision of
13 law, no department, agency, or instrumentality of the
14 United States receiving appropriated funds under this Act
15 or any other Act shall obligate or expend in any way such
16 funds to pay administrative expenses or the compensation
17 of any officer or employee of the United States to deny
18 any application submitted pursuant to 22 U.S.C.
19 2778(b)(1)(B) and qualified pursuant to 27 CFR section
20 478.112 or .113, for a permit to import United States ori-
21 gin “curios or relics” firearms, parts, or ammunition.

22 SEC. 536. None of the funds made available by this
23 Act may be used to pay the salaries or expenses of per-
24 sonnel to deny, or fail to act on, an application for the
25 importation of any model of shotgun if—

1 (1) all other requirements of law with respect to
2 the proposed importation are met; and

3 (2) no application for the importation of such
4 model of shotgun, in the same configuration, had
5 been denied by the Attorney General prior to Janu-
6 ary 1, 2011, on the basis that the shotgun was not
7 particularly suitable for or readily adaptable to
8 sporting purposes.

9 SEC. 537. None of the funds made available by this
10 Act may be obligated or expended to implement the Arms
11 Trade Treaty until the Senate approves a resolution of
12 ratification for the Treaty.

13 SEC. 538. None of the funds appropriated or other-
14 wise made available in this or any other Act may be used
15 to transfer, release, or assist in the transfer or release to
16 or within the United States, its territories, or possessions
17 Khalid Sheikh Mohammed or any other detainee who—

18 (1) is not a United States citizen or a member
19 of the Armed Forces of the United States; and

20 (2) is or was held on or after June 24, 2009,
21 at the United States Naval Station, Guantanamo
22 Bay, Cuba, by the Department of Defense.

23 SEC. 539. (a) None of the funds appropriated or oth-
24 erwise made available in this or any other Act may be used
25 to construct, acquire, or modify any facility in the United

1 States, its territories, or possessions to house any indi-
2 vidual described in subsection (c) for the purposes of de-
3 tention or imprisonment in the custody or under the effec-
4 tive control of the Department of Defense.

5 (b) The prohibition in subsection (a) shall not apply
6 to any modification of facilities at United States Naval
7 Station, Guantanamo Bay, Cuba.

8 (c) An individual described in this subsection is any
9 individual who, as of June 24, 2009, is located at United
10 States Naval Station, Guantanamo Bay, Cuba, and who—

11 (1) is not a citizen of the United States or a
12 member of the Armed Forces of the United States;
13 and

14 (2) is—

15 (A) in the custody or under the effective
16 control of the Department of Defense; or

17 (B) otherwise under detention at United
18 States Naval Station, Guantanamo Bay, Cuba.

19 SEC. 540. Funds made available to the Department
20 of Commerce and the Department of Justice in this Act
21 and any remaining unobligated balances of funds made
22 available to the Department of Commerce and the Depart-
23 ment of Justice in prior year Acts, other than amounts
24 designated by the Congress as being for an emergency re-
25 quirement pursuant to a concurrent resolution on the

1 budget or the Balanced Budget and Emergency Deficit
2 Control Act of 1985 or from amounts made available
3 under the heading “Department of Justice—Legal Activi-
4 ties—Fees and Expenses of Witnesses”, shall be available
5 to provide payments pursuant to section 901(i)(2) of title
6 IX of division J of the Further Consolidated Appropria-
7 tions Act, 2020 (22 U.S.C. 2680b(i)(2)): *Provided*, That
8 payments made pursuant to the matter preceding this pro-
9 viso may not exceed \$5,000,000 for the Department of
10 Commerce and \$10,000,000 for the Department of Jus-
11 tice.

12 SEC. 541. (a)(1) Within 45 days of enactment of this
13 Act, the Secretary of Commerce shall allocate amounts
14 made available from the Creating Helpful Incentives to
15 Produce Semiconductors (CHIPS) for America Fund for
16 fiscal year 2026 pursuant to paragraphs (1) and (2) of
17 section 102(a) of the CHIPS Act of 2022 (division A of
18 Public Law 117–167) not otherwise allocated pursuant to
19 section 546(a)(1)(B) of division C of Public Law 118–42,
20 including the transfer authority in such paragraphs of
21 that section of that Act, to the accounts specified, in the
22 amounts specified, and for the projects and activities spec-
23 ified, in the table titled “Department of Commerce Alloca-
24 tion of National Institute of Standards and Technology
25 Funds: CHIPS Act Fiscal Year 2026” in the explanatory

1 statement described in section 4 (in the matter preceding
2 division A of this consolidated Act).

3 (2) Within 45 days of enactment of this Act, the Di-
4 rector of the National Science Foundation shall allocate
5 amounts made available from the Creating Helpful Incen-
6 tives to Produce Semiconductors (CHIPS) for America
7 Workforce and Education Fund for fiscal year 2026 pur-
8 suant to section 102(d)(1) of the CHIPS Act of 2022 (di-
9 vision A of Public Law 117–167), to the account specified,
10 in the amounts specified, and for the projects and activi-
11 ties specified in the table titled “National Science Founda-
12 tion Allocation of Funds: CHIPS Act Fiscal Year 2026”
13 in the explanatory statement described in section 4 (in the
14 matter preceding division A of this consolidated Act).

15 (b) Neither the President nor his designee may allo-
16 cate any amounts that are made available for any fiscal
17 year under section 102(a)(2)(A) of the CHIPS Act of
18 2022 or under section 102(d)(2) of such Act if there is
19 in effect an Act making or continuing appropriations for
20 part of a fiscal year for the Departments of Commerce
21 and Justice, Science, and Related Agencies: *Provided*,
22 That in any fiscal year, the matter preceding this proviso
23 shall not apply to the allocation, apportionment, or allot-
24 ment of amounts for continuing administration of pro-
25 grams allocated funds from the CHIPS for America Fund,

1 which may be allocated only in amounts that are no more
2 than the allocation for such purposes in subsection (a) of
3 this section.

4 (c) Subject to prior consultation with, and the regular
5 notification procedures of, the Committees on Appropria-
6 tions of the House of Representatives and the Senate, and
7 subject to the terms and conditions in section 505 of this
8 Act—

9 (1) the Secretary of Commerce may reallocate
10 funds allocated to Industrial Technology Services for
11 section 9906 of Public Law 116–283 by subsection
12 (a)(1) of this section; and

13 (2) the Director of the National Science Foun-
14 dation may reallocate funds allocated to the CHIPS
15 for America Workforce and Education Fund by sub-
16 section (a)(2) of this section.

17 (d) Concurrent with the annual budget submission of
18 the President for fiscal year 2027, the Director of the Na-
19 tional Science Foundation, as appropriate, shall submit to
20 the Committees on Appropriations of the House of Rep-
21 resentatives and the Senate proposed allocations by ac-
22 count and by program, project, or activity, with detailed
23 justifications, for amounts made available under section
24 102(d)(2) of the CHIPS Act of 2022 for fiscal year 2027.

1 (e) The Department of Commerce and the National
2 Science Foundation, as appropriate, shall each provide the
3 Committees on Appropriations of the House of Represent-
4 atives and Senate quarterly reports on the status of bal-
5 ances of projects and activities funded by the CHIPS for
6 America Fund for amounts allocated pursuant to sub-
7 section (a)(1) of this section and prior appropriations
8 Acts, the status of balances of projects and activities fund-
9 ed by the Public Wireless Supply Chain Innovation Fund
10 for amounts allocated pursuant to section 543(a)(2) of di-
11 vision B of Public Law 117–328, and the status of bal-
12 ances of projects and activities funded by the CHIPS for
13 America Workforce and Education Fund for amounts allo-
14 cated pursuant to subsection (a)(2) of this section and
15 prior appropriations Acts, including all uncommitted, com-
16 mitted, and unobligated funds.

17 SEC. 542. In making Federal financial assistance, the
18 Department of Commerce, the National Aeronautics and
19 Space Administration, and the National Science Founda-
20 tion shall continue to apply the negotiated indirect cost
21 rates in section 200.414 of title 2, Code of Federal Regu-
22 lations, including with respect to the approval of devi-
23 ations from negotiated indirect cost rates, to the same ex-
24 tent and in the same manner as such negotiated indirect
25 cost rates were applied in fiscal year 2024: *Provided*, That

1 none of the funds appropriated in this or prior Commerce,
2 Justice, Science, and Related Agencies Appropriations
3 Acts, or otherwise made available to the Department of
4 Commerce, the National Aeronautics and Space Adminis-
5 tration, and the National Science Foundation may be used
6 to develop, modify, or implement changes to such fiscal
7 year 2024 negotiated indirect cost rates.

8 SEC. 543. None of the funds made available by this
9 Act may be used to move the Bureau of Alcohol, Tobacco,
10 Firearms and Explosives (ATF) Canine Training Center
11 or the ATF National Canine Division from Front Royal,
12 Virginia, to another location.

13 SEC. 544. (a) Of the amounts made available under
14 the heading “Department of Commerce—National Oce-
15 anic and Atmospheric Administration—Operations, Re-
16 search, and Facilities”, \$507,000,000 shall be derived by
17 transfer from the unobligated balances of amounts pre-
18 viously appropriated under such heading for fiscal year
19 2026 in division J of the Infrastructure Investment and
20 Jobs Act (Public Law 117–58): *Provided*, That amounts
21 derived by transfer pursuant to this subsection shall con-
22 tinue to be treated as amounts specified in section 103(b)
23 of division A of Public Law 118–5.

24 (b) Of the amounts made available under the heading
25 “Department of Commerce—National Telecommuni-

1 cations and Information Administration—Salaries and
2 Expenses”, \$50,000,000 shall be derived by transfer from
3 the unobligated balances of amounts previously appro-
4 priated under the heading “National Telecommunications
5 and Information Administration” in division J of the In-
6 frastructure Investment and Jobs Act (Public Law 117–
7 58), of which \$25,000,000 shall be from amounts
8 repurposed or transferred for salaries and expenses, ad-
9 ministration, and oversight of programs pursuant to sec-
10 tion 542 of the Consolidated Appropriations Act, 2024
11 (Public Law 118–42) and \$25,000,000 shall be from
12 amounts made available under the heading “Middle Mile
13 Deployment”: *Provided*, That amounts derived by transfer
14 pursuant to this subsection shall continue to be treated
15 as amounts specified in section 103(b) of division A of
16 Public Law 118–5.

17 (c) Of the amounts made available under the heading
18 “Department of Commerce—Economic Development Ad-
19 ministration—Economic Development Assistance Pro-
20 grams”, \$16,276,000 shall be derived by transfer from the
21 unobligated balances of amounts previously appropriated
22 under the heading “National Telecommunications and In-
23 formation Administration” in division J of the Infrastruc-
24 ture Investment and Jobs Act (Public Law 117–58) and
25 repurposed or transferred for salaries and expenses, ad-

1 ministration, and oversight of programs pursuant to sec-
2 tion 542 of the Consolidated Appropriations Act, 2024
3 (Public Law 118–42): *Provided*, That amounts derived by
4 transfer pursuant to this subsection shall continue to be
5 treated as amounts specified in section 103(b) of division
6 A of Public Law 118–5.

7 (d) Of the amounts made available under the heading
8 “Department of Commerce—National Oceanic and At-
9 mospheric Administration—Procurement, Acquisition and
10 Construction”, \$44,000,000 shall be derived by transfer
11 from the unobligated balances of the Department of Com-
12 merce Nonrecurring Expenses Fund.

13 This division may be cited as the “Commerce, Jus-
14 tice, Science, and Related Agencies Appropriations Act,
15 2026”.

1 **DIVISION B—ENERGY AND WATER DEVEL-**
2 **OPMENT AND RELATED AGENCIES AP-**
3 **PROPRIATIONS ACT, 2026**

4 TITLE I

5 CORPS OF ENGINEERS—CIVIL

6 DEPARTMENT OF THE ARMY

7 CORPS OF ENGINEERS—CIVIL

8 The following appropriations shall be expended under
9 the direction of the Secretary of the Army and the super-
10 vision of the Chief of Engineers for authorized civil func-
11 tions of the Department of the Army pertaining to river
12 and harbor, flood and storm damage reduction, shore pro-
13 tection, aquatic ecosystem restoration, and related efforts.

14 INVESTIGATIONS

15 For expenses necessary where authorized by law for
16 the collection and study of basic information pertaining
17 to river and harbor, flood and storm damage reduction,
18 shore protection, aquatic ecosystem restoration, and re-
19 lated needs; for surveys and detailed studies, and plans
20 and specifications of proposed river and harbor, flood and
21 storm damage reduction, shore protection, and aquatic
22 ecosystem restoration projects, and related efforts prior to
23 construction; for restudy of authorized projects; and for
24 miscellaneous investigations, and, when authorized by law,
25 surveys and detailed studies, and plans and specifications

1 of projects prior to construction, \$150,384,000, to remain
2 available until expended: *Provided*, That the Secretary
3 shall not deviate from the work plan, once the plan has
4 been submitted to the Committees on Appropriations of
5 both Houses of Congress.

6 CONSTRUCTION

7 For expenses necessary for the construction of river
8 and harbor, flood and storm damage reduction, shore pro-
9 tection, aquatic ecosystem restoration, and related
10 projects authorized by law; for conducting detailed studies,
11 and plans and specifications, of such projects (including
12 those involving participation by States, local governments,
13 or private groups) authorized or made eligible for selection
14 by law (but such detailed studies, and plans and specifica-
15 tions, shall not constitute a commitment of the Govern-
16 ment to construction); \$3,169,966,000, to remain avail-
17 able until expended; of which \$217,983,000, to be derived
18 from the Harbor Maintenance Trust Fund, shall be to
19 cover the Federal share of construction costs for facilities
20 under the Dredged Material Disposal Facilities program;
21 and of which such sums as are necessary to cover 25 per-
22 cent of the costs of construction, replacement, rehabilita-
23 tion, and expansion of inland waterways projects shall be
24 derived from the Inland Waterways Trust Fund, except
25 as otherwise specifically provided for in law: *Provided*,

1 That the Secretary shall not deviate from the work plan,
2 once the plan has been submitted to the Committees on
3 Appropriations of both Houses of Congress.

4 MISSISSIPPI RIVER AND TRIBUTARIES

5 For expenses necessary for flood damage reduction
6 projects and related efforts in the Mississippi River allu-
7 vial valley below Cape Girardeau, Missouri, as authorized
8 by law, \$531,588,000, to remain available until expended,
9 of which \$9,768,000, to be derived from the Harbor Main-
10 tenance Trust Fund, shall be to cover the Federal share
11 of eligible operation and maintenance costs for inland har-
12 bors: *Provided*, That the Secretary shall not deviate from
13 the work plan, once the plan has been submitted to the
14 Committees on Appropriations of both Houses of Con-
15 gress.

16 OPERATION AND MAINTENANCE

17 (INCLUDING TRANSFER OF FUNDS)

18 For expenses necessary for the operation, mainte-
19 nance, and care of existing river and harbor, flood and
20 storm damage reduction, aquatic ecosystem restoration,
21 and related projects authorized by law; providing security
22 for infrastructure owned or operated by the Corps, includ-
23 ing administrative buildings and laboratories; maintaining
24 harbor channels provided by a State, municipality, or
25 other public agency that serve essential navigation needs

1 of general commerce, where authorized by law; surveying
2 and charting northern and northwestern lakes and con-
3 necting waters; clearing and straightening channels; and
4 removing obstructions to navigation, \$6,013,217,000, to
5 remain available until expended, of which \$3,245,249,000,
6 to be derived from the Harbor Maintenance Trust Fund,
7 shall be to cover the Federal share of eligible operations
8 and maintenance costs for coastal harbors and channels,
9 and for inland harbors, of which \$416,760,000 shall be
10 for donor and energy ports as specified in section 102 of
11 the Water Resources Development Act of 2020; of which
12 \$40,000,000, to be derived from the general fund of the
13 Treasury, shall be for the design and construction to re-
14 place Federal dredges, in addition to amounts otherwise
15 made available for such purposes, and shall be transferred
16 to and merged with funds available for such purposes in
17 the revolving fund established by the first section of the
18 Act of July 27, 1953 (33 U.S.C. 576); of which such sums
19 as may be necessary shall be derived from amounts col-
20 lected in this or prior fiscal years under section 210 of
21 the Flood Control Act of 1968 (16 U.S.C. 460d-3) and
22 are not otherwise appropriated shall be for resource pro-
23 tection, research, interpretation, and maintenance activi-
24 ties related to resource protection in the areas at which
25 outdoor recreation is available; of which such sums as be-

1 come available from fees collected under section 217 of
2 Public Law 104–303 shall be used to cover the cost of
3 operation and maintenance of the dredged material dis-
4 posal facilities for which such fees have been collected; and
5 of which \$62,000,000, to be derived from the general fund
6 of the Treasury, shall be to carry out subsection (c) of
7 section 2106 of the Water Resources Reform and Develop-
8 ment Act of 2014 (33 U.S.C. 2238c) and shall be des-
9 ignated as being for such purpose pursuant to paragraph
10 (2) of section 14003 of division B of the Coronavirus Aid,
11 Relief, and Economic Security Act (Public Law 116–136):
12 *Provided*, That funding derived from the Harbor Mainte-
13 nance Trust Fund for donor and energy ports shall be al-
14 located solely in accordance with section 2106 of the
15 Water Resources Reform and Development Act of 2014:
16 *Provided further*, That 1 percent of the total amount of
17 funds provided for each of the programs, projects, or ac-
18 tivities funded under this heading shall not be allocated
19 to a field operating activity prior to the beginning of the
20 fourth quarter of the fiscal year and shall be available for
21 use by the Chief of Engineers to fund such emergency ac-
22 tivities as the Chief of Engineers determines to be nec-
23 essary and appropriate, and that the Chief of Engineers
24 shall allocate during the fourth quarter any remaining
25 funds which have not been used for emergency activities

1 proportionally in accordance with the amounts provided
2 for the programs, projects, or activities: *Provided further*,
3 That the Secretary shall not deviate from the work plan,
4 once the plan has been submitted to the Committees on
5 Appropriations of both Houses of Congress.

6 REGULATORY PROGRAM

7 For expenses necessary for administration of laws
8 pertaining to regulation of navigable waters and wetlands,
9 \$221,000,000, to remain available until September 30,
10 2027.

11 FORMERLY UTILIZED SITES REMEDIAL ACTION PROGRAM

12 For expenses necessary to clean up contamination
13 from sites in the United States resulting from work per-
14 formed as part of the Nation's early atomic energy pro-
15 gram, \$75,000,000, to remain available until expended.

16 FLOOD CONTROL AND COASTAL EMERGENCIES

17 For expenses necessary to prepare for flood, hurri-
18 cane, and other natural disasters and support emergency
19 operations, repairs, and other activities in response to
20 such disasters as authorized by law, \$40,000,000, to re-
21 main available until expended.

22 EXPENSES

23 For expenses necessary for the supervision and gen-
24 eral administration of the civil works program in the head-
25 quarters of the Corps of Engineers and the offices of the

1 Division Engineers; and for costs of management and op-
2 eration of the Humphreys Engineer Center Support Activ-
3 ity, the Institute for Water Resources, the United States
4 Army Engineer Research and Development Center, and
5 the United States Army Corps of Engineers Finance Cen-
6 ter allocable to the civil works program, \$220,000,000, to
7 remain available until September 30, 2027, of which not
8 to exceed \$5,000 may be used for official reception and
9 representation purposes and only during the current fiscal
10 year: *Provided*, That no part of any other appropriation
11 provided in this title shall be available to fund the civil
12 works activities of the Office of the Chief of Engineers
13 or the civil works executive direction and management ac-
14 tivities of the division offices: *Provided further*, That any
15 Flood Control and Coastal Emergencies appropriation
16 may be used to fund the supervision and general adminis-
17 tration of emergency operations, repairs, and other activi-
18 ties in response to any flood, hurricane, or other natural
19 disaster.

20 OFFICE OF THE ASSISTANT SECRETARY OF THE ARMY
21 FOR CIVIL WORKS

22 For the Office of the Assistant Secretary of the Army
23 for Civil Works as authorized by 10 U.S.C. 7016(b)(3),
24 \$7,000,000, to remain available until September 30, 2027:
25 *Provided*, That not more than 75 percent of such amount

1 may be obligated or expended until the Assistant Sec-
2 retary submits to the Committees on Appropriations of
3 both Houses of Congress the report required under section
4 101(d) of this Act and a work plan that allocates at least
5 95 percent of the additional funding provided under each
6 heading in the explanatory statement described in section
7 4 (in the matter preceding division A of this consolidated
8 Act), to specific programs, projects, or activities.

9 WATER INFRASTRUCTURE FINANCE AND INNOVATION

10 PROGRAM ACCOUNT

11 For the cost of direct loans and for the cost of guar-
12 anteed loans, as authorized by the Water Infrastructure
13 Finance and Innovation Act of 2014, \$2,200,000, to re-
14 main available until expended, for safety projects to main-
15 tain, upgrade, and repair dams identified in the National
16 Inventory of Dams with a primary owner type of State,
17 local government, public utility, or private: *Provided*, That
18 any activity that results in a decrease in the hazard or
19 a decrease in the potential consequences of poor perform-
20 ance of a dam structure listed on the National Inventory
21 of Dams with a primary owner type of State, local govern-
22 ment, public utility, or private shall be considered a safety
23 project eligible for funds provided under this heading for
24 that purpose by this or any prior Act: *Provided further*,
25 That any safety project for a dam identified in the Na-

1 tional Inventory of Dams with a primary owner type of
2 State, local government, public utility, or private shall be
3 eligible under section 5026(1)(A) of the Water Resources
4 Reform and Development Act of 2014 (Public Law 113–
5 121) (33 U.S.C. 3905(1)(A)) for funds provided under
6 this heading for that purpose by this or any prior Act:
7 *Provided further*, That no project may be funded with
8 amounts provided under this heading in this or any prior
9 Act for a dam that is identified as jointly owned in the
10 National Inventory of Dams and where one of those joint
11 owners is the Federal Government: *Provided further*, That
12 not later than 90 days following the end of any submittal
13 period occurring before or after the date of enactment of
14 this Act of a solicitation of preliminary applications from
15 prospective borrowers seeking credit assistance of funds
16 made available under this heading by this or any prior
17 Act, the Secretary shall provide to each applicant a written
18 notice to inform the applicant whether the applicant will
19 be invited to apply for credit assistance: *Provided further*,
20 That amounts made available under this heading in this
21 Act shall also be available for projects to construct, main-
22 tain, upgrade, and repair levees and ancillary features
23 with a primary owner type of State, municipal, county,
24 private, or other non-Federal entity: *Provided further*,
25 That not later than 60 days after the date of enactment

1 of this Act, the Secretary shall begin a rulemaking process
2 to establish the process to provide financial assistance for
3 projects to construct, maintain, upgrade, and repair levees
4 and ancillary features with a primary owner type of State,
5 municipal, county, private, or other non-Federal entity:
6 *Provided further*, That no project may be funded with
7 amounts provided under this heading for a levee unless
8 the Secretary has certified in advance, in writing, that the
9 levee is not owned, in whole or in part, by the Federal
10 Government: *Provided further*, That such costs, including
11 the cost of modifying such loans, shall be as defined in
12 section 502 of the Congressional Budget Act of 1974: *Pro-*
13 *vided further*, That these funds are available to subsidize
14 gross obligations for the principal amount of direct loans,
15 including capitalized interest, and total loan principal, in-
16 cluding capitalized interest, any part of which is to be
17 guaranteed, not to exceed \$500,000,000: *Provided further*,
18 That the use of direct loans or loan guarantee authority
19 under this heading for direct loans or commitments to
20 guarantee loans for any project, including any project that
21 is made eligible for funds pursuant to the second proviso
22 under this heading, shall be in accordance with the criteria
23 published in the Federal Register on June 30, 2020 (85
24 FR 39189) pursuant to the fourth proviso under the head-
25 ing “Water Infrastructure Finance and Innovation Pro-

1 gram Account” in division D of the Further Consolidated
2 Appropriations Act, 2020 (Public Law 116–94): *Provided*
3 *further*, That none of the direct loans or loan guarantee
4 authority made available under this heading shall be avail-
5 able for any project unless the Secretary and the Director
6 of the Office of Management and Budget have certified
7 in advance in writing that the direct loan or loan guar-
8 antee, as applicable, and the project comply with the cri-
9 teria referenced in the previous proviso: *Provided further*,
10 That any references to the Environmental Protection
11 Agency (EPA) or the Administrator in the criteria ref-
12 erenced in the previous two provisos shall be deemed to
13 be references to the Army Corps of Engineers or the Sec-
14 retary of the Army, respectively, for purposes of the direct
15 loans or loan guarantee authority made available under
16 this heading: *Provided further*, That for the purposes of
17 carrying out the Congressional Budget Act of 1974, the
18 Director of the Congressional Budget Office may request,
19 and the Secretary shall promptly provide, documentation
20 and information relating to a project identified in a Letter
21 of Interest submitted to the Secretary pursuant to a No-
22 tice of Funding Availability for applications for credit as-
23 sistance under the Water Infrastructure Finance and In-
24 novation Act Program, including with respect to a project

1 that was initiated or completed before the date of enact-
2 ment of this Act.

3 In addition, fees authorized to be collected pursuant
4 to sections 5029 and 5030 of the Water Infrastructure
5 Finance and Innovation Act of 2014 shall be deposited
6 in this account, to remain available until expended.

7 In addition, for administrative expenses to carry out
8 the direct and guaranteed loan programs, notwithstanding
9 section 5033 of the Water Infrastructure Finance and In-
10 novation Act of 2014, \$5,000,000, to remain available
11 until September 30, 2027.

12 GENERAL PROVISIONS—CORPS OF
13 ENGINEERS—CIVIL

14 (INCLUDING TRANSFERS OF FUNDS)

15 SEC. 101. (a) None of the funds provided in title I
16 of this Act, or provided by previous appropriations Acts
17 to the agencies or entities funded in title I of this Act
18 that remain available for obligation or expenditure in fiscal
19 year 2026, shall be available for obligation or expenditure
20 through a reprogramming of funds that:

21 (1) creates or initiates a new program, project,
22 or activity;

23 (2) eliminates a program, project, or activity;

24 (3) increases funds or personnel for any pro-
25 gram, project, or activity for which funds have been

1 denied or restricted by this Act, unless prior ap-
2 proval is received from the Committees on Appro-
3 priations of both Houses of Congress;

4 (4) proposes to use funds directed for a specific
5 activity for a different purpose, unless prior approval
6 is received from the Committees on Appropriations
7 of both Houses of Congress;

8 (5) augments or reduces existing programs,
9 projects, or activities in excess of the amounts con-
10 tained in paragraphs (6) through (10), unless prior
11 approval is received from the Committees on Appro-
12 priations of both Houses of Congress;

13 (6) INVESTIGATIONS.—For a base level over
14 \$100,000, reprogramming of 25 percent of the base
15 amount up to a limit of \$150,000 per project, study
16 or activity is allowed: *Provided*, That for a base level
17 less than \$100,000, the reprogramming limit is
18 \$25,000: *Provided further*, That up to \$25,000 may
19 be reprogrammed into any continuing study or activ-
20 ity that did not receive an appropriation for existing
21 obligations and concomitant administrative expenses;

22 (7) CONSTRUCTION.—For a base level over
23 \$2,000,000, reprogramming of 15 percent of the
24 base amount up to a limit of \$3,000,000 per project,
25 study or activity is allowed: *Provided*, That for a

1 base level less than \$2,000,000, the reprogramming
2 limit is \$300,000: *Provided further*, That up to
3 \$3,000,000 may be reprogrammed for settled con-
4 tractor claims, changed conditions, or real estate de-
5 ficiency judgments: *Provided further*, That up to
6 \$300,000 may be reprogrammed into any continuing
7 study or activity that did not receive an appropria-
8 tion for existing obligations and concomitant admin-
9 istrative expenses;

10 (8) OPERATION AND MAINTENANCE.—Unlim-
11 ited reprogramming authority is granted for the
12 Corps to be able to respond to emergencies: *Pro-*
13 *vided*, That the Chief of Engineers shall notify the
14 Committees on Appropriations of both Houses of
15 Congress of these emergency actions as soon there-
16 after as practicable: *Provided further*, That for a
17 base level over \$1,000,000, reprogramming of 15
18 percent of the base amount up to a limit of
19 \$5,000,000 per project, study, or activity is allowed:
20 *Provided further*, That for a base level less than
21 \$1,000,000, the reprogramming limit is \$150,000:
22 *Provided further*, That \$150,000 may be repro-
23 grammed into any continuing study or activity that
24 did not receive an appropriation;

1 (9) MISSISSIPPI RIVER AND TRIBUTARIES.—
2 The reprogramming guidelines in paragraphs (6),
3 (7), and (8) shall apply to the Investigations, Con-
4 struction, and Operation and Maintenance portions
5 of the Mississippi River and Tributaries Account, re-
6 spectively; and

7 (10) FORMERLY UTILIZED SITES REMEDIAL AC-
8 TION PROGRAM.—Reprogramming of up to 15 per-
9 cent of the base of the receiving project is permitted.

10 (b) DE MINIMUS REPROGRAMMINGS.—In no case
11 should a reprogramming for less than \$50,000 be sub-
12 mitted to the Committees on Appropriations of both
13 Houses of Congress.

14 (c) CONTINUING AUTHORITIES PROGRAM.—Sub-
15 section (a)(1) shall not apply to any project or activity
16 funded under the continuing authorities program.

17 (d) Not later than 60 days after the date of enact-
18 ment of this Act, the Secretary shall submit a report to
19 the Committees on Appropriations of both Houses of Con-
20 gress to establish the baseline for application of re-
21 programming and transfer authorities for the current fis-
22 cal year which shall include:

23 (1) A table for each appropriation with a sepa-
24 rate column to display the President's budget re-
25 quest, adjustments made by Congress, adjustments

1 due to enacted rescissions, if applicable, and the fis-
2 cal year enacted level;

3 (2) A delineation in the table for each appro-
4 priation both by object class and program, project
5 and activity as detailed in the budget appendix for
6 the respective appropriations; and

7 (3) An identification of items of special congres-
8 sional interest.

9 SEC. 102. The Secretary shall allocate funds made
10 available in this Act solely in accordance with the provi-
11 sions of this Act and in the explanatory statement de-
12 scribed in section 4 (in the matter preceding division A
13 of this consolidated Act), including the determination and
14 designation of new starts.

15 SEC. 103. (a) None of the funds made available in
16 this title may be used to award or modify any contract
17 that commits funds beyond the amounts appropriated for
18 that program, project, or activity that remain unobligated,
19 except that such amounts may include any funds that have
20 been made available through reprogramming pursuant to
21 section 101.

22 (b) Subsection (a) shall not apply to projects with
23 awarded integrated design and construction contracts
24 (IDaC) as of the date of enactment of this Act: *Provided*,
25 That the Corps shall modify the existing IDaC contracts

1 for such projects to incorporate the authority provided in
2 33 U.S.C. 621 and DFARS 252.232–7007 pursuant to
3 DFARS 232.703–1(1)(ii)(B) within 60 days of the date
4 of enactment of this Act: *Provided further*, That the Corps
5 shall notify the Committees on Appropriations of both
6 Houses of Congress upon execution of such modifications
7 for each project and upon commencement of work ad-
8 dressed in such modification: *Provided further*, That the
9 Corps shall fully obligate any funds previously designated
10 in Public Law 117–58 or prior appropriations bill as part
11 of the modification, and as required supervision and ad-
12 ministration associated with that modification: *Provided*
13 *further*, That amounts repurposed pursuant to this section
14 shall continue to be treated as amounts specified in section
15 103(b) of division A of Public Law 118–5.

16 SEC. 104. The Secretary of the Army may transfer
17 to the Fish and Wildlife Service, and the Fish and Wildlife
18 Service may accept and expend, up to \$8,733,000 of funds
19 provided in this title under the heading “Operation and
20 Maintenance” to mitigate for fisheries lost due to Corps
21 of Engineers projects.

22 SEC. 105. None of the funds in this Act shall be used
23 for an open lake placement alternative for dredged mate-
24 rial, after evaluating the least costly, environmentally ac-
25 ceptable manner for the disposal or management of

1 dredged material originating from Lake Erie or tributaries
2 thereto, unless it is approved under a State water quality
3 certification pursuant to section 401 of the Federal Water
4 Pollution Control Act (33 U.S.C. 1341): *Provided*, That
5 until an open lake placement alternative for dredged mate-
6 rial is approved under a State water quality certification,
7 the Corps of Engineers shall continue upland placement
8 of such dredged material consistent with the requirements
9 of section 101 of the Water Resources Development Act
10 of 1986 (33 U.S.C. 2211).

11 SEC. 106. Additional funding provided in this Act
12 shall be allocated only to projects determined to be eligible
13 by the Chief of Engineers.

14 SEC. 107. Subject to consultation with the non-Fed-
15 eral sponsor and retaining sufficient amounts for the
16 Corps of Engineers to carry out any of its responsibilities
17 relating to the project and using appropriations made
18 available to the project prior to the enactment of this Act,
19 the Secretary of the Army shall make advance payments
20 to the non-Federal sponsors for their use in completing
21 construction of any project for flood risk management
22 identified in implementation guidance for the Civil Works
23 Public-Private Partnership Pilot Program issued by the
24 Director of Civil Works on January 8, 2019 and that is
25 under construction on the date of enactment of this Act

1 and for which a prior executed Project Partnership Agree-
2 ment, as amended, specifically identifies Federal Work,
3 Non-Federal Work, and a Federal Participation Amount
4 in excess of \$700,000,000: *Provided*, That amounts de-
5 scribed in the matter preceding this proviso shall be cred-
6 ited by the Secretary toward the Federal Participation
7 Amount: *Provided further*, That prior to making any pay-
8 ments authorized in the matter preceding the first proviso,
9 the Secretary and the non-Federal sponsors shall amend
10 the Project Partnership Agreement executed for the
11 project in order to implement any such payments and
12 credits.

13 SEC. 108. None of the funds made available by this
14 Act may be used to carry out any water supply reallocation
15 study under the Wolf Creek Dam, Lake Cumberland, Ken-
16 tucky, project authorized under the Act of July 24, 1946
17 (60 Stat. 636, ch. 595).

18 SEC. 109. Section 225(c)(2)(A)(ii) of the Water Re-
19 sources Development Act of 1992 (33 U.S.C.
20 2328(c)(2)(A)(ii)) is amended by striking “at recreation
21 site at which the fee is collected” and inserting “at any
22 recreation site or facility that is located at the civil works
23 project at which the fee is collected”.

1 TITLE II
2 DEPARTMENT OF THE INTERIOR
3 CENTRAL UTAH PROJECT

4 CENTRAL UTAH PROJECT COMPLETION ACCOUNT

5 For carrying out activities authorized by the Central
6 Utah Project Completion Act, \$23,000,000, to remain
7 available until expended, of which \$4,000,000 shall be de-
8 posited into the Utah Reclamation Mitigation and Con-
9 servation Account for use by the Utah Reclamation Miti-
10 gation and Conservation Commission: *Provided*, That of
11 the amount provided under this heading, \$1,950,000 shall
12 be available until September 30, 2027, for expenses nec-
13 essary in carrying out related responsibilities of the Sec-
14 retary of the Interior: *Provided further*, That for fiscal
15 year 2026, of the amount made available to the Commis-
16 sion under this Act or any other Act, the Commission may
17 use an amount not to exceed \$2,186,000 for administra-
18 tive expenses.

19 BUREAU OF RECLAMATION

20 The following appropriations shall be expended to
21 execute authorized functions of the Bureau of Reclama-
22 tion:

1 WATER AND RELATED RESOURCES
2 (INCLUDING TRANSFERS OF FUNDS)

3 For management, development, and restoration of
4 water and related natural resources and for related activi-
5 ties, including the operation, maintenance, and rehabilita-
6 tion of reclamation and other facilities, participation in
7 fulfilling related Federal responsibilities to Native Ameri-
8 cans, and related grants to, and cooperative and other
9 agreements with, State and local governments, federally
10 recognized Indian Tribes, and others, \$1,465,630,000, to
11 remain available until expended, of which \$23,899,000
12 shall be available for transfer to the Upper Colorado River
13 Basin Fund and \$7,679,000 shall be available for transfer
14 to the Lower Colorado River Basin Development Fund;
15 of which such amounts as may be necessary may be ad-
16 vanced to the Colorado River Dam Fund: *Provided*, That
17 such transfers may be increased or decreased within the
18 overall appropriation under this heading: *Provided further*,
19 That of the total appropriated, the amount for program
20 activities that can be financed by the Reclamation Fund,
21 the Water Storage Enhancement Receipts account estab-
22 lished by section 4011(e) of Public Law 114–322, or the
23 Bureau of Reclamation special fee account established by
24 16 U.S.C. 6806 shall be derived from that Fund or ac-
25 count: *Provided further*, That funds contributed under 43

1 U.S.C. 395 are available until expended for the purposes
2 for which the funds were contributed: *Provided further,*
3 That funds advanced under 43 U.S.C. 397a shall be cred-
4 ited to this account and are available until expended for
5 the same purposes as the sums appropriated under this
6 heading: *Provided further,* That of the amounts made
7 available under this heading, \$3,237,000 shall be depos-
8 ited in the San Gabriel Basin Restoration Fund estab-
9 lished by section 110 of title I of division B of appendix
10 D of Public Law 106–554: *Provided further,* That in ac-
11 cordance with section 4007 of Public Law 114–322 and
12 as recommended by the Secretary in a letter dated Janu-
13 ary 2, 2026, funding provided for such purpose in fiscal
14 year 2025 shall be made available to the Sites Reservoir
15 Project and the B.F. Sisk Dam Raise and Reservoir Ex-
16 pansion Project: *Provided further,* That in accordance with
17 section 4009(a) of Public Law 114–322 and as rec-
18 ommended by the Secretary in a letter dated January 2,
19 2026, funding provided for such purpose in fiscal year
20 2025 and prior fiscal years shall be made available to the
21 Kay Bailey Hutchison Expansion—Concentrate Pipeline
22 Partial Replacement Project and the McAllen Brackish
23 Groundwater Treatment Facility.

1 CENTRAL VALLEY PROJECT RESTORATION FUND

2 For carrying out the programs, projects, plans, habi-
3 tat restoration, improvement, and acquisition provisions of
4 the Central Valley Project Improvement Act, such sums
5 as may be collected in fiscal year 2026 in the Central Val-
6 ley Project Restoration Fund pursuant to sections
7 3407(d), 3404(c)(3), and 3405(f) of Public Law 102–575,
8 to remain available until expended: *Provided*, That the Bu-
9 reau of Reclamation is directed to assess and collect the
10 full amount of the additional mitigation and restoration
11 payments authorized by section 3407(d) of Public Law
12 102–575: *Provided further*, That none of the funds made
13 available under this heading may be used for the acquisi-
14 tion or leasing of water for in-stream purposes if the water
15 is already committed to in-stream purposes by a court
16 adopted decree or order.

17 CALIFORNIA BAY-DELTA RESTORATION

18 (INCLUDING TRANSFERS OF FUNDS)

19 For carrying out activities authorized by the Water
20 Supply, Reliability, and Environmental Improvement Act,
21 consistent with plans to be approved by the Secretary of
22 the Interior, \$32,000,000, to remain available until ex-
23 pended, of which such amounts as may be necessary to
24 carry out such activities may be transferred to appropriate
25 accounts of other participating Federal agencies to carry

1 out authorized purposes: *Provided*, That funds appro-
2 priated herein may be used for the Federal share of the
3 costs of CALFED Program management: *Provided fur-*
4 *ther*, That CALFED implementation shall be carried out
5 in a balanced manner with clear performance measures
6 demonstrating concurrent progress in achieving the goals
7 and objectives of the Program.

8 POLICY AND ADMINISTRATION

9 For expenses necessary for policy, administration,
10 and related functions in the Office of the Commissioner,
11 the Denver office, and offices in the six regions of the Bu-
12 reau of Reclamation, to remain available until September
13 30, 2027, \$64,000,000, to be derived from the Reclama-
14 tion Fund and be nonreimbursable as provided in 43
15 U.S.C. 377, of which not to exceed \$5,000 may be used
16 for official reception and representation expenses: *Pro-*
17 *vided*, That no part of any other appropriation in this Act
18 shall be available for activities or functions budgeted as

3 (A) 15 percent for any program, project or
4 activity for which \$2,000,000 or more is avail-
5 able at the beginning of the fiscal year; or

6 (B) \$400,000 for any program, project or
7 activity for which less than \$2,000,000 is avail-
8 able at the beginning of the fiscal year;

9 (6) transfers more than \$500,000 from either
10 the Facilities Operation, Maintenance, and Rehabili-
11 tation category or the Resources Management and
12 Development category to any program, project, or
13 activity in the other category, unless prior approval
14 is received from the Committees on Appropriations
15 of both Houses of Congress; or

16 (7) transfers, where necessary to discharge legal
17 obligations of the Bureau of Reclamation, more than
18 \$5,000,000 to provide adequate funds for settled
19 contractor claims, increased contractor earnings due
20 to accelerated rates of operations, and real estate de-
21 ficiency judgments, unless prior approval is received
22 from the Committees on Appropriations of both
23 Houses of Congress.

1 (b) Subsection (a)(5) shall not apply to any transfer
2 of funds within the Facilities Operation, Maintenance, and
3 Rehabilitation category.

4 (c) For purposes of this section, the term “transfer”
5 means any movement of funds into or out of a program,
6 project, or activity.

7 (d) Except as provided in subsections (a) and (b), the
8 amounts made available in this title under the heading
9 “Bureau of Reclamation—Water and Related Resources”
10 shall be expended for the programs, projects, and activities
11 specified in the “Final Bill” columns in the “Water and
12 Related Resources” table included under the heading

16 (e) The Bureau of Reclamation shall submit reports
17 on a quarterly basis to the Committees on Appropriations
18 of both Houses of Congress detailing all the funds repro-

20 egories of funding. The first quarterly report shall be sub-
21 mitted not later than 60 days after the date of enactment

8 rying out the purposes of the Department of Energy Orga-
9 nization Act (42 U.S.C. 7101 et seq.), including the acqui-
10 sition or condemnation of any real property or any facility
11 or for plant or facility acquisition, construction, or expan-
12 sion, \$7,375,000,000, to remain available until expended:
13 *Provided*, That of such amount, \$312,818,000 shall be
14 available until September 30, 2027, for program direction.

15 OTHER DEFENSE ACTIVITIES

16 For Department of Energy expenses, including the
17 purchase, construction, and acquisition of plant and cap-
18 ital equipment and other expenses, necessary for atomic
19 energy defense, other defense activities, and classified ac-
20 tivities, in carrying out the purposes of the Department
21 of Energy Organization Act (42 U.S.C. 7101 et seq.), in-
22 cluding the acquisition or condemnation of any real prop-
23 erty or any facility or for plant or facility acquisition, con-
24 struction, or expansion, \$1,170,000,000, to remain avail-
25 able until expended: *Provided*, That of such amount,

1 \$384,404,000 shall be available until September 30, 2027,
2 for program direction.

3 POWER MARKETING ADMINISTRATIONS

4 BONNEVILLE POWER ADMINISTRATION FUND

5 Expenditures from the Bonneville Power Administra-
6 tion Fund, established pursuant to Public Law 93-454,
7 are approved for: the Rocky Reach Kelt Facility, the
8 Colville Acclimation Building Enclosures, the Colville
9 Tribes Resident Fish Hatchery Expansion, the Chief Jo-
10 seph Hatchery Water Quality Project, and the Umatilla
11 Hatchery Facility and Acclimation Facilities: *Provided*,
12 That expenditures are also approved for official reception
13 and representation expenses in an amount not to exceed
14 \$5,000: *Provided further*, That during fiscal year 2026,
15 no new direct loan obligations may be made.

16 OPERATION AND MAINTENANCE, SOUTHEASTERN POWER
17 ADMINISTRATION

18 For expenses necessary for operation and mainte-
19 nance of power transmission facilities and for marketing
20 electric power and energy, including transmission wheeling
21 and ancillary services, pursuant to section 5 of the Flood
22 Control Act of 1944 (16 U.S.C. 825s), as applied to the
23 southeastern power area, \$9,285,000, including official re-
24 ception and representation expenses in an amount not to
25 exceed \$1,500, to remain available until expended: *Pro-*

1 *vided*, That notwithstanding 31 U.S.C. 3302 and section
2 5 of the Flood Control Act of 1944, up to \$9,285,000 col-
3 lected by the Southeastern Power Administration from the
4 sale of power and related services shall be credited to this
5 account as discretionary offsetting collections, to remain
6 available until expended for the sole purpose of funding
7 the annual expenses of the Southeastern Power Adminis-
8 tration: *Provided further*, That the sum herein appro-
9 priated for annual expenses shall be reduced as collections
10 are received during the fiscal year so as to result in a final
11 fiscal year 2026 appropriation estimated at not more than
12 \$0: *Provided further*, That notwithstanding 31 U.S.C.
13 3302, up to \$81,819,000 collected by the Southeastern
14 Power Administration pursuant to the Flood Control Act
15 of 1944 to recover purchase power and wheeling expenses
16 shall be credited to this account as offsetting collections,
17 to remain available until expended for the sole purpose
18 of making purchase power and wheeling expenditures:
19 *Provided further*, That for purposes of this appropriation,
20 annual expenses means expenditures that are generally re-
21 covered in the same year that they are incurred (excluding
22 purchase power and wheeling expenses).

1 OPERATION AND MAINTENANCE, SOUTHWESTERN
2 POWER ADMINISTRATION

3 For expenses necessary for operation and mainte-
4 nance of power transmission facilities and for marketing
5 electric power and energy, for construction and acquisition
6 of transmission lines, substations and appurtenant facili-
7 ties, and for administrative expenses, including official re-
8 ception and representation expenses in an amount not to
9 exceed \$1,500 in carrying out section 5 of the Flood Con-
10 trol Act of 1944 (16 U.S.C. 825s), as applied to the
11 Southwestern Power Administration, \$59,766,000, to re-
12 main available until expended: *Provided*, That notwith-
13 standing 31 U.S.C. 3302 and section 5 of the Flood Con-
14 trol Act of 1944 (16 U.S.C. 825s), up to \$49,366,000 col-
15 lected by the Southwestern Power Administration from
16 the sale of power and related services shall be credited to
17 this account as discretionary offsetting collections, to re-
18 main available until expended, for the sole purpose of
19 funding the annual expenses of the Southwestern Power
20 Administration: *Provided further*, That the sum herein ap-
21 propriated for annual expenses shall be reduced as collec-
22 tions are received during the fiscal year so as to result
23 in a final fiscal year 2026 appropriation estimated at not
24 more than \$10,400,000: *Provided further*, That notwith-
25 standing 31 U.S.C. 3302, up to \$80,000,000 collected by

1 the Southwestern Power Administration pursuant to the
2 Flood Control Act of 1944 to recover purchase power and
3 wheeling expenses shall be credited to this account as off-
4 setting collections, to remain available until expended for
5 the sole purpose of making purchase power and wheeling
6 expenditures: *Provided further*, That for purposes of this
7 appropriation, annual expenses means expenditures that
8 are generally recovered in the same year that they are in-
9 curred (excluding purchase power and wheeling expenses).

10 CONSTRUCTION, REHABILITATION, OPERATION AND
11 MAINTENANCE, WESTERN AREA POWER ADMINIS-
12 TRATION

13 For carrying out the functions authorized by title III,
14 section 302(a)(1)(E) of the Act of August 4, 1977 (42
15 U.S.C. 7152), and other related activities including con-
16 servation and renewable resources programs as author-
17 ized, \$311,035,000, including official reception and rep-
18 resentation expenses in an amount not to exceed \$1,500,
19 to remain available until expended, of which \$311,035,000
20 shall be derived from the Department of the Interior Rec-
21 lamation Fund: *Provided*, That notwithstanding 31 U.S.C.
22 3302, section 5 of the Flood Control Act of 1944 (16
23 U.S.C. 825s), and section 1 of the Interior Department
24 Appropriation Act, 1939 (43 U.S.C. 392a), up to
25 \$247,663,000 collected by the Western Area Power Ad-

1 ministration from the sale of power and related services
2 shall be credited to this account as discretionary offsetting
3 collections, to remain available until expended, for the sole
4 purpose of funding the annual expenses of the Western
5 Area Power Administration: *Provided further*, That the
6 sum herein appropriated for annual expenses shall be re-
7 duced as collections are received during the fiscal year so
8 as to result in a final fiscal year 2026 appropriation esti-
9 mated at not more than \$63,372,000, of which
10 \$63,372,000 is derived from the Reclamation Fund: *Pro-*
11 *vided further*, That notwithstanding 31 U.S.C. 3302, up
12 to \$475,000,000 collected by the Western Area Power Ad-
13 ministration pursuant to the Flood Control Act of 1944
14 and the Reclamation Project Act of 1939 to recover pur-
15 chase power and wheeling expenses shall be credited to
16 this account as offsetting collections, to remain available
17 until expended for the sole purpose of making purchase
18 power and wheeling expenditures: *Provided further*, That
19 for purposes of this appropriation, annual expenses means
20 expenditures that are generally recovered in the same year
21 that they are incurred (excluding purchase power and
22 wheeling expenses).

1 FALCON AND AMISTAD OPERATING AND MAINTENANCE
2 FUND

3 For operation, maintenance, and emergency costs for
4 the hydroelectric facilities at the Falcon and Amistad
5 Dams, \$6,510,000, to remain available until expended,
6 and to be derived from the Falcon and Amistad Operating
7 and Maintenance Fund of the Western Area Power Ad-
8 ministration, as provided in section 2 of the Act of June
9 18, 1954 (68 Stat. 255): *Provided*, That notwithstanding
10 the provisions of that Act and of 31 U.S.C. 3302, up to
11 \$6,282,000 collected by the Western Area Power Adminis-
12 tration from the sale of power and related services from
13 the Falcon and Amistad Dams shall be credited to this
14 account as discretionary offsetting collections, to remain
15 available until expended for the sole purpose of funding
16 the annual expenses of the hydroelectric facilities of these
17 Dams and associated Western Area Power Administration
18 activities: *Provided further*, That the sum herein appro-
19 priated for annual expenses shall be reduced as collections
20 are received during the fiscal year so as to result in a final
21 fiscal year 2026 appropriation estimated at not more than
22 \$228,000: *Provided further*, That for purposes of this ap-
23 propriation, annual expenses means expenditures that are
24 generally recovered in the same year that they are in-
25 curred: *Provided further*, That for fiscal year 2026, the

1 Administrator of the Western Area Power Administration
2 may accept up to \$1,072,000 in funds contributed by
3 United States power customers of the Falcon and Amistad
4 Dams for deposit into the Falcon and Amistad Operating
5 and Maintenance Fund, and such funds shall be available
6 for the purpose for which contributed in like manner as
7 if said sums had been specifically appropriated for such
8 purpose: *Provided further*, That any such funds shall be
9 available without further appropriation and without fiscal
10 year limitation for use by the Commissioner of the United
11 States Section of the International Boundary and Water
12 Commission for the sole purpose of operating, maintain-
13 ing, repairing, rehabilitating, replacing, or upgrading the
14 hydroelectric facilities at these Dams in accordance with
15 agreements reached between the Administrator, Commis-
16 sioner, and the power customers.

17 FEDERAL ENERGY REGULATORY COMMISSION

18 SALARIES AND EXPENSES

19 For expenses necessary for the Federal Energy Regu-
20 latory Commission to carry out the provisions of the De-
21 partment of Energy Organization Act (42 U.S.C. 7101 et
22 seq.), including services as authorized by 5 U.S.C. 3109,
23 official reception and representation expenses not to ex-
24 ceed \$3,000, and the hire of passenger motor vehicles,
25 \$520,000,000, to remain available until expended: *Pro-*

1 *vided*, That notwithstanding any other provision of law,
2 not to exceed \$520,000,000 of revenues from fees and an-
3 nual charges, and other services and collections in fiscal
4 year 2026 shall be retained and used for expenses nec-
5 essary in this account, and shall remain available until ex-
6 pended: *Provided further*, That the sum herein appro-
7 priated from the general fund shall be reduced as revenues
8 are received during fiscal year 2026 so as to result in a
9 final fiscal year 2026 appropriation from the general fund
10 estimated at not more than \$0.

11 GENERAL PROVISIONS—DEPARTMENT OF

12 ENERGY

13 (INCLUDING TRANSFERS OF FUNDS)

14 SEC. 301. (a) No appropriation, funds, or authority
15 made available by this title for the Department of Energy
16 shall be used to initiate or resume any program, project,
17 or activity or to prepare or initiate Requests For Proposals
18 or similar arrangements (including Requests for
19 Quotations, Requests for Information, and Funding Op-
20 portunity Announcements) for a program, project, or ac-
21 tivity if the program, project, or activity has not been
22 funded by Congress.

23 (b)(1) Unless the Secretary of Energy notifies the
24 Committees on Appropriations of both Houses of Congress

1 at least 3 full business days in advance, none of the funds
2 made available in this title may be used to—

3 (A) make a grant allocation or discretionary
4 grant award totaling \$1,000,000 or more;

5 (B) make a discretionary contract award or
6 Other Transaction Agreement totaling \$1,000,000
7 or more, including a contract covered by the Federal
8 Acquisition Regulation;

9 (C) provide nonoperational funding through a
10 competition restricted only to Department of Energy
11 National Laboratories totaling \$1,000,000 or more;

12 (D) provide nonoperational funding directly to a
13 Department of Energy National Laboratory totaling
14 \$25,000,000 or more;

15 (E) issue a letter of intent to make an alloca-
16 tion, award, or Agreement in excess of the limits in
17 subparagraph (A), (B), (C), or (D);

18 (F) announce publicly the intention to make an
19 allocation, award, or Agreement in excess of the lim-
20 its in subparagraph (A), (B), (C), or (D); or

21 (G) issue a letter to terminate an allocation,
22 award, or Agreement in excess of the limits in sub-
23 paragraph (A), (B), (C), or (D).

24 (2) The Secretary of Energy shall submit to the Com-
25 mittees on Appropriations of both Houses of Congress

1 within 15 days of the conclusion of each quarter a report
2 detailing each grant allocation or discretionary grant
3 award totaling less than \$1,000,000 provided during the
4 previous quarter.

5 (3) The notification required by paragraph (1) and
6 the report required by paragraph (2) shall include the re-
7 cipient of the award, the amount of the award, the fiscal
8 year for which the funds for the award were appropriated,
9 the account and program, project, or activity from which
10 the funds are being drawn, the title of the award, and
11 a brief description of the activity for which the award is
12 made.

13 (c) The Department of Energy may not, with respect
14 to any program, project, or activity that uses budget au-
15 thority made available in this title under the heading “De-
16 partment of Energy—Energy Programs”, enter into a
17 multiyear contract, award a multiyear grant, or enter into
18 a multiyear cooperative agreement unless—

19 (1) the contract, grant, or cooperative agree-
20 ment is funded for the full period of performance as
21 anticipated at the time of award; or

22 (2) the contract, grant, or cooperative agree-
23 ment includes a clause conditioning the Federal Gov-
24 ernment’s obligation on the availability of future
25 year budget authority and the Secretary notifies the

1 Committees on Appropriations of both Houses of
2 Congress at least 3 days in advance.

3 (d) Except as provided in subsections (e), (f), and (g),
4 the amounts made available by this title shall be expended
5 as authorized by law for the programs, projects, and ac-
6 tivities, and in the amounts, specified in the “Final Bill”
7 column in the “Department of Energy” table included
8 under the heading “Title III—Department of Energy” in
9 the explanatory statement described in section 4 (in the
10 matter preceding division A of this consolidated Act).

11 (e) The amounts made available by this title may be
12 reprogrammed for any program, project, or activity, and
13 the Department shall notify, and obtain the prior approval
14 of, the Committees on Appropriations of both Houses of
15 Congress at least 30 days prior to the use of any proposed
16 reprogramming that would cause any program, project, or
17 activity funding level to increase or decrease by more than
18 \$5,000,000 or 10 percent, whichever is less, during the
19 time period covered by this Act.

20 (f) None of the funds provided in this title shall be
21 available for obligation or expenditure through a re-
22 programming of funds that—

23 (1) creates, initiates, or eliminates a program,
24 project, or activity;

1 (2) increases funds or personnel for any pro-
2 gram, project, or activity for which funds are denied
3 or restricted by this Act; or

4 (3) reduces funds that are directed to be used
5 for a specific program, project, or activity by this
6 Act.

7 (g)(1) The Secretary of Energy may waive any re-
8 quirement or restriction in this section that applies to the
9 use of funds made available for the Department of Energy
10 if compliance with such requirement or restriction would
11 pose a substantial risk to human health, the environment,
12 welfare, or national security.

13 (2) The Secretary of Energy shall notify the Commit-
14 tees on Appropriations of both Houses of Congress of any
15 waiver under paragraph (1) as soon as practicable, but
16 not later than 3 days after the date of the activity to which
17 a requirement or restriction would otherwise have applied.
18 Such notice shall include an explanation of the substantial
19 risk under paragraph (1) that permitted such waiver.

20 (h) The unexpended balances of prior appropriations
21 provided for activities in this Act may be available to the
22 same appropriation accounts for such activities established
23 pursuant to this title. Available balances may be merged
24 with funds in the applicable established accounts and

1 thereafter may be accounted for as one fund for the same
2 time period as originally enacted.

3 SEC. 302. None of the funds made available in this
4 title shall be used for the construction of facilities classi-
5 fied as high-hazard nuclear facilities under 10 CFR Part
6 830 unless independent oversight is conducted by the Of-
7 fice of Enterprise Assessments to ensure the project is in
8 compliance with nuclear safety requirements.

9 SEC. 303. None of the funds made available in this
10 title may be used to approve critical decision-2 or critical
11 decision-3 under Department of Energy Order 413.3B, or
12 any successive departmental guidance, for construction
13 projects where the total project cost exceeds
14 \$100,000,000, until a separate independent cost estimate
15 has been developed for the project for that critical deci-
16 sion.

17 SEC. 304. None of the funds made available in this
18 title may be used to support a grant allocation award, dis-
19 cretionary grant award, or cooperative agreement that ex-
20 ceeds \$100,000,000 in Federal funding unless the project
21 is carried out through internal independent project man-
22 agement procedures.

23 SEC. 305. No funds shall be transferred directly from
24 “Department of Energy—Power Marketing Administra-
25 tion—Colorado River Basins Power Marketing Fund,

1 Western Area Power Administration” to the general fund
2 of the Treasury in the current fiscal year.

3 SEC. 306. None of the funds made available by this
4 Act may be used to draw down and sell petroleum prod-
5 ucts from the Strategic Petroleum Reserve (1) to any enti-
6 ty that is under the ownership, control, or influence of
7 the Chinese Communist Party; or (2) except on condition
8 that such petroleum products will not be exported to the
9 People’s Republic of China.

10 SEC. 307. (a) None of the funds made available by
11 this Act may be used by the Secretary of Energy to award
12 any grant, contract, cooperative agreement, or loan of
13 \$10,000,000 or greater to an entity of concern as defined
14 in section 10114 of division B of Public Law 117–167.

15 (b) The Secretary shall implement the requirements
16 under subsection (a) using a risk-based approach and ana-
17 lytical tools to aggregate, link, analyze, and maintain in-
18 formation reported by an entity seeking or receiving such
19 funds made available by this Act.

20 (c) This section shall be applied in a manner con-
21 sistent with the obligations of the United States under ap-
22 plicable international agreements.

23 (d) The Secretary shall have the authority to require
24 the submission to the agency, by an entity seeking or re-
25 ceiving such funds made available by this Act, documenta-

1 tion necessary to implement the requirements under sub-
2 section (a).

3 (e) Chapter 35 of title 44, United States Code (com-
4 monly known as the “Paperwork Reduction Act”), shall
5 not apply to the implementation of the requirements under
6 this section.

7 (f) The Secretary and other Federal agencies shall
8 coordinate to share relevant information necessary to im-
9 plement the requirements under subsection (a).

10 SEC. 308. None of the funds appropriated or other-
11 wise made available by this Act may be used to admit any
12 non-U.S. citizen from Russia or China to any nuclear
13 weapons production facility, as such term is defined in sec-
14 tion 4002 of the Atomic Energy Defense Act (50 U.S.C.
15 2501), other than areas accessible to the general public,
16 unless 30 days prior to facility admittance, the Depart-
17 ment of Energy provides notification to the Committees
18 on Appropriations and Armed Services of both Houses of
19 Congress.

20 SEC. 309. Funds made available in this title under
21 the headings “Energy Efficiency and Renewable Energy”,
22 “Electricity”, “Fossil Energy”, “Cybersecurity, Energy
23 Security, and Emergency Response”, and “Science” that
24 are allocated for the purposes of section 9 of the Small
25 Business Act, as amended (15 U.S.C. 638), including for

1 Small Business Innovation Research and Small Business
2 Technology Transfer activities, or for the purposes of sec-
3 tion 1001 of the Energy Policy Act of 2005, as amended
4 (42 U.S.C. 16391), for Technology Commercialization
5 Fund activities, may be reprogrammed within each ac-
6 count without being subject to the restrictions in section
7 301 of this title: *Provided*, That the administration and
8 selection of awards pursuant to such sections will be in
9 coordination with the offices that oversee the appropria-
10 tions accounts to which the relevant funding was originally
11 appropriated.

12 SEC. 310. Section 15(g)(3) of Public Law 85–536
13 (15 U.S.C. 644(g)(3)) is further amended by inserting
14 “and by site support prime contractors at the National
15 Energy Technology Laboratory” following “Department
16 of Energy”.

17 SEC. 311. (a) Of the amounts specified in subsection
18 (d), \$3,100,000,000 shall be transferred to, and merged
19 with, amounts provided in this Act under the heading
20 “Nuclear Energy” that remain available until expended,
21 and in addition to amounts otherwise available, shall only
22 be available for the not more than two competitive awards
23 for Generation 3+ small modular reactor deployment
24 projects described in section 311(a)(1)(A) of division D
25 of the Consolidated Appropriations Act, 2024 (Public Law

1 118–42), the two awards for demonstration projects made
2 prior to the date of enactment of this Act under the Ad-
3 vanced Reactor Demonstration Program, as authorized
4 under section 959A of the Energy Policy Act of 2005 (42
5 U.S.C. 16279a), and Risk Reduction for Future Dem-
6 onstrations, as described under the heading Advanced Re-
7 actor Demonstration Program in the explanatory state-
8 ment accompanying division C of the Further Consoli-
9 dated Appropriations Act, 2020 (Public Law 116–94).

10 (b) Of the amounts specified in subsection (d),
11 \$375,000,000 shall be transferred to, and merged with,
12 amounts provided in this Act under the heading “Grid De-
13 ployment Office” that remain available until expended,
14 and in addition to amounts otherwise available, shall be
15 available for necessary expenses to carry out a program
16 to enhance the domestic supply chain for the manufacture
17 of distribution and power transformers, components, and
18 materials, and electric grid components, including finan-
19 cial assistance, technical assistance, and competitive
20 awards for procurement and acquisition.

21 (c) Of the amounts provided in this title that remain
22 available until expended, the following amounts shall be
23 derived by transfer from the funds specified in subsection
24 (d):

1 (1) \$1,150,000,000 of the amounts provided
2 under the heading “Energy Efficiency and Renew-
3 able Energy”;

4 (2) \$100,000,000 of the amounts provided
5 under the heading “Nuclear Energy”;

6 (3) \$140,000,000 of the amounts provided
7 under the heading “Fossil Energy”;

8 (4) \$150,000,000 of the amounts provided
9 under the heading “Science”; and

10 (5) \$150,000,000 of the amounts provided in
11 the second paragraph under the heading “Title 17
12 Innovative Technology Loan Guarantee Program”.

13 (d) The funds specified in this subsection are the un-
14 obligated balances, as of the date of enactment of this Act,
15 from amounts provided in title III of division J of Public
16 Law 117–58, as follows:

17 (1) \$1,281,141,701 of the amounts made avail-
18 able to carry out section 40323 of division D of Pub-
19 lic Law 117–58;

20 (2) \$1,500,000,000 of the amounts made avail-
21 able to carry out subtitle J of title IX of the Energy
22 Policy Act of 2005;

23 (3) \$1,040,000,000 of the amounts made avail-
24 able to carry out section 969D of the Energy Policy
25 Act of 2005;

1 (4) \$950,000,000 of the amounts made avail-
2 able to carry out subparagraph (B) or subparagraph
3 (C) of section 962(b)(2) of the Energy Policy Act of
4 2005; and

5 (5) \$393,858,299 of the amounts provided
6 under the heading “Energy Programs—Energy Effi-
7 ciency and Renewable Energy”.

8 (e) Not later than 15 days after the date of enact-
9 ment of this Act, the Secretary of the Department of En-
10 ergy shall transmit to the Committees on Appropriations
11 of both Houses of Congress a report that details the
12 amounts repurposed or transferred pursuant to this sec-
13 tion: *Provided*, That such report shall be delineated by
14 both source and destination by Treasury Appropriations
15 Fund Symbol and statutory authority (including by sub-
16 paragraph for funds specified in subsection (d)(4)).

17 (f) Amounts repurposed or transferred pursuant to
18 this section shall continue to be treated as amounts speci-
19 fied in section 103(b) of division A of Public Law 118–
20 5.

21 SEC. 312. Section 4(c)(10)(B) of the Pacific North-
22 west Electric Power Planning and Conservation Act (16
23 U.S.C. 839b(c)(10)(B)) is amended by striking the period
24 at the end and inserting “, adjusted for inflation.”.

1 SEC. 313. In making Federal financial assistance, the
2 Department of Energy shall continue to apply the indirect
3 cost rates, including negotiated indirect cost rates, as de-
4 scribed in section 200.414 of title 2, Code of Federal Reg-
5 ulations, including with respect to the approval of devi-
6 ations from negotiated indirect cost rates, to the same ex-
7 tent and in the same manner as was applied in fiscal year
8 2024: *Provided*, That none of the funds appropriated in
9 this or prior Acts or otherwise made available to the De-
10 partment of Energy may be used to develop, modify, or
11 implement changes to such negotiated indirect cost rates.

3 APPALACHIAN REGIONAL COMMISSION

4 For expenses necessary to carry out the programs au-
5 thorized by the Appalachian Regional Development Act of
6 1965, as amended, and for expenses necessary for the
7 Federal Co-Chairman and the Alternate on the Appa-
8 lachian Regional Commission, for payment of the Federal
9 share of the administrative expenses of the Commission,
10 including services as authorized by 5 U.S.C. 3109, and

12 available until expended.

13 DEFENSE NUCLEAR FACILITIES SAFETY BOARD
14 SALARIES AND EXPENSES

15 For expenses necessary for the Defense Nuclear Fa-
16 cilities Safety Board in carrying out activities authorized
17 by the Atomic Energy Act of 1954, as amended by Public
18 Law 100-456, section 1441, \$42,000,000, to remain
19 available until September 30, 2027, of which not to exceed
20 \$1,000 shall be available for official reception and rep-
21 resentation expenses.

22 DELTA REGIONAL AUTHORITY
23 SALARIES AND EXPENSES

24 For expenses necessary for the Delta Regional Au-
25 thority and to carry out its activities, as authorized by

1 the Delta Regional Authority Act of 2000, notwith-
2 standing sections 382F(d), 382M, and 382N of said Act,
3 \$32,000,000, to remain available until expended.

4 DENALI COMMISSION

5 For expenses necessary for the Denali Commission
6 including the purchase, construction, and acquisition of
7 plant and capital equipment as necessary and other ex-
8 penses, \$18,000,000, to remain available until expended,
9 notwithstanding the limitations contained in section
10 306(g) of the Denali Commission Act of 1998: *Provided*,
11 That funds shall be available for construction projects for
12 which the Denali Commission is the sole or primary fund-
13 ing source in an amount not to exceed 90 percent of total
14 project cost for distressed communities, as defined by such
15 section and by section 701 of appendix D, title VII, Public
16 Law 106–113 (113 Stat. 1501A–280), and for Indian

8 amounts shall be available for administrative expenses,
9 notwithstanding section 15751(b) of title 40, United
10 States Code.

11 NORTHWEST REGIONAL COMMISSION

12 For expenses necessary to establish a Northwest Re-
13 gional Commission located in Washington, Oregon, Idaho,
14 and Montana, \$1,000,000, to remain available until ex-
15 pended: *Provided*, That amounts provided to the North-
16 west Regional Commission shall be used to carry out ac-
17 tivities authorized for other regional Commissions by sub-
18 title V of title 40, United States Code.

19 SOUTHEAST CRESCENT REGIONAL COMMISSION

20 For expenses necessary for the Southeast Crescent
21 Regional Commission in carrying out activities authorized
22 by subtitle V of title 40, United States Code, \$20,000,000,
23 to remain available until expended.

1 SOUTHWEST BORDER REGIONAL COMMISSION

2 For expenses necessary for the Southwest Border Re-
3 gional Commission in carrying out activities authorized by
4 subtitle V of title 40, United States Code, \$5,500,000, to
5 remain available until expended.

6 GREAT LAKES AUTHORITY

7 For expenses necessary for the Great Lakes Author-
8 ity in carrying out activities authorized by subtitle V of
9 title 40, United States Code, \$5,000,000, to remain avail-
10 able until expended.

11 NUCLEAR REGULATORY COMMISSION

12 SALARIES AND EXPENSES

13 For expenses necessary for the Commission in car-
14 rying out the purposes of the Energy Reorganization Act
15 of 1974 and the Atomic Energy Act of 1954,
16 \$952,700,000, including official representation expenses
17 not to exceed \$30,000, to remain available until expended:
18 *Provided*, That of the amount appropriated herein, not
19 more than \$11,494,000 may be made available for sala-
20 ries, travel, and other support costs for the Office of the
21 Commission, to remain available until September 30,
22 2027: *Provided further*, That revenues from licensing fees,
23 inspection services, and other services and collections esti-
24 mated at \$804,509,977 in fiscal year 2026 shall be re-
25 tained and used for necessary salaries and expenses in this

1 account, notwithstanding 31 U.S.C. 3302, and shall re-
2 main available until expended: *Provided further*, That the
3 sum herein appropriated shall be reduced by the amount

8 For expenses necessary for the Office of Inspector
9 General in carrying out the provisions of the Inspector
10 General Act of 1978, \$18,795,000, to remain available
11 until September 30, 2027: *Provided*, That revenues from
12 licensing fees, inspection services, and other services and
13 collections estimated at \$14,885,000 in fiscal year 2026
14 shall be retained and be available until September 30,
15 2027, for necessary salaries and expenses in this account,
16 notwithstanding section 3302 of title 31, United States
17 Code: *Provided further*, That the sum herein appropriated
18 shall be reduced by the amount of revenues received dur-
19 ing fiscal year 2026 so as to result in a final fiscal year
20 2026 appropriation estimated at not more than
21 \$3,910,000: *Provided further*, That of the amounts appro-
22 priated under this heading, \$1,572,000 shall be for In-
23 spector General services for the Defense Nuclear Facilities
24 Safety Board.

1 NUCLEAR WASTE TECHNICAL REVIEW BOARD
2 SALARIES AND EXPENSES

3 For expenses necessary for the Nuclear Waste Tech-
4 nical Review Board, as authorized by Public Law 100-
5 203, section 5051, \$4,000,000, to be derived from the Nu-
6 clear Waste Fund, to remain available until September 30,
7 2027.

8 GENERAL PROVISIONS—INDEPENDENT
9 AGENCIES

10 SEC. 401. The Nuclear Regulatory Commission shall
11 comply with the July 5, 2011, version of Chapter VI of
12 its Internal Commission Procedures when responding to
13 Congressional requests for information, consistent with
14 Department of Justice guidance for all Federal agencies.

15 SEC. 402. (a) The amounts made available by this
16 title for the Nuclear Regulatory Commission may be re-
17 programmed for any program, project, or activity, and the
18 Commission shall notify the Committees on Appropria-
19 tions of both Houses of Congress at least 30 days prior
20 to the use of any proposed reprogramming that would
21 cause any program funding level to increase or decrease
22 by more than \$500,000 or 10 percent, whichever is less,
23 during the time period covered by this Act.

24 (b)(1) The Nuclear Regulatory Commission may
25 waive the notification requirement in subsection (a) if

1 compliance with such requirement would pose a substan-
2 tial risk to human health, the environment, welfare, or na-
3 tional security.

4 (2) The Nuclear Regulatory Commission shall notify
5 the Committees on Appropriations of both Houses of Con-
6 gress of any waiver under paragraph (1) as soon as prac-
7 ticable, but not later than 3 days after the date of the
8 activity to which a requirement or restriction would other-
9 wise have applied. Such notice shall include an explanation
10 of the substantial risk under paragraph (1) that permitted
11 such waiver and shall provide a detailed report to the
12 Committees of such waiver and changes to funding levels
13 to programs, projects, or activities.

14 (c) Except as provided in subsections (a), (b), and
15 (d), the amounts made available by this title for “Nuclear
16 Regulatory Commission—Salaries and Expenses” shall be
17 expended as directed in the explanatory statement de-
18 scribed in section 4 (in the matter preceding division A
19 of this consolidated Act).

20 (d) None of the funds provided for the Nuclear Regu-
21 latory Commission shall be available for obligation or ex-
22 penditure through a reprogramming of funds that in-
23 creases funds or personnel for any program, project, or
24 activity for which funds are denied or restricted by this
25 Act.

1 (e) The Commission shall provide a monthly report
2 to the Committees on Appropriations of both Houses of
3 Congress, which includes the following for each program,
4 project, or activity, including any prior year appropria-
5 tions—

- 6 (1) total budget authority;
- 7 (2) total unobligated balances; and
- 8 (3) total unliquidated obligations.

1 TITLE V
2 GENERAL PROVISIONS
3 (INCLUDING TRANSFER OF FUNDS)

4 SEC. 501. None of the funds appropriated by this Act
5 may be used in any way, directly or indirectly, to influence
6 congressional action on any legislation or appropriation
7 matters pending before Congress, other than to commu-
8 nicate to Members of Congress as described in 18 U.S.C.
9 1913.

10 SEC. 502. (a) None of the funds made available in
11 title III of this Act may be transferred to any department,
12 agency, or instrumentality of the United States Govern-
13 ment, except pursuant to a transfer made by or transfer
14 authority provided in this Act or any other appropriations
15 Act for any fiscal year, transfer authority referenced in
16 the explanatory statement described in section 4 (in the
17 matter preceding division A of this consolidated Act), or
18 any authority whereby a department, agency, or instru-
19 mentality of the United States Government may provide
20 goods or services to another department, agency, or in-
21 strumentality.

22 (b) None of the funds made available for any depart-
23 ment, agency, or instrumentality of the United States
24 Government may be transferred to accounts funded in title
25 III of this Act, except pursuant to a transfer made by or

1 transfer authority provided in this Act or any other appro-
2 priations Act for any fiscal year, transfer authority ref-
3 erenced in the explanatory statement described in section
4 4 (in the matter preceding division A of this consolidated
5 Act), or any authority whereby a department, agency, or
6 instrumentality of the United States Government may
7 provide goods or services to another department, agency,
8 or instrumentality.

9 (c) The head of any relevant department or agency
10 funded in this Act utilizing any transfer authority shall
11 submit to the Committees on Appropriations of both
12 Houses of Congress a semiannual report detailing the
13 transfer authorities, except for any authority whereby a
14 department, agency, or instrumentality of the United
15 States Government may provide goods or services to an-
16 other department, agency, or instrumentality, used in the
17 previous 6 months and in the year-to-date. This report
18 shall include the amounts transferred and the purposes
19 for which they were transferred, and shall not replace or
20 modify existing notification requirements for each author-
21 ity.

22 SEC. 503. (a) None of the funds made available in
23 this Act may be used to maintain or establish a computer
24 network unless such network blocks the viewing,
25 downloading, and exchanging of pornography.

1 (b) Nothing in subsection (a) shall limit the use of
2 funds necessary for any Federal, State, Tribal, or local
3 law enforcement agency or any other entity carrying out
4 criminal investigations, prosecution, or adjudication activi-
5 ties.

6 This division may be cited as the “Energy and Water
7 Development and Related Agencies Appropriations Act,
8 2026”.

3 **AGENCIES APPROPRIATIONS ACT, 2026**

4 TITLE I

5 DEPARTMENT OF THE INTERIOR

6 BUREAU OF LAND MANAGEMENT

7 MANAGEMENT OF LANDS AND RESOURCES

8 For necessary expenses for protection, use, improve-
9 ment, development, disposal, cadastral surveying, classi-
10 fication, acquisition of easements and other interests in
11 lands, and performance of other functions, including main-
12 tenance of facilities, as authorized by law, in the manage-
13 ment of lands and their resources under the jurisdiction
14 of the Bureau of Land Management, including the general
15 administration of the Bureau, and assessment of mineral
16 potential of public lands pursuant to section 1010(a) of
17 Public Law 96–487 (16 U.S.C. 3150(a)), \$1,260,166,000,
18 to remain available until September 30, 2027; of which
19 \$48,560,000 for annual maintenance and deferred mainte-
20 nance programs and \$144,000,000 for the wild horse and
21 burro program, as authorized by Public Law 92–195 (16
22 U.S.C. 1331 et seq.), shall remain available until ex-
23 pended: *Provided*, That amounts in the fee account of the
24 BLM Permit Processing Improvement Fund may be used
25 for any bureau-related expenses associated with the proc-

1 essing of oil and gas applications for permits to drill and
2 related use of authorizations: *Provided further*, That of the
3 amounts made available under this heading, up to
4 \$1,000,000 may be made available for the purposes de-
5 scribed in section 122(e)(1)(A) of division G of Public Law
6 115–31 (43 U.S.C. 1748c(e)(1)(A)): *Provided further*,
7 That of the amounts made available under this heading,
8 not to exceed \$15,000 may be for official reception and
9 representation expenses: *Provided further*, That of the
10 amounts made available under this heading, \$3,246,000
11 is for projects specified for Land Management Priorities
12 in the table titled “Interior and Environment Incorpora-
13 tion of Community Project Funding Items/Congressionally
14 Directed Spending Items” included for this division in the
15 explanatory statement described in section 4 (in the mat-
16 ter preceding division A of this consolidated Act): *Provided*
17 *further*, That of the amounts made available under this
18 heading, up to \$3,000,000 of the amounts made available
19 for Wildlife habitat management shall be available in fiscal
20 year 2026 subject to a match by at least an equal amount
21 by the National Fish and Wildlife Foundation for cost-
22 shared projects supporting conservation of Bureau lands;
23 and such funds shall be advanced to the Foundation as
24 a lump-sum grant without regard to when expenses are
25 incurred.

1 In addition, \$42,696,000 is for Mining Law Adminis-
2 tration program operations, including the cost of admin-
3 istering the mining claim fee program, to remain available
4 until expended, to be reduced by amounts collected by the
5 Bureau and credited to this appropriation from mining
6 claim maintenance fees and location fees that are hereby
7 authorized for fiscal year 2026, so as to result in a final
8 appropriation estimated at not more than \$1,260,166,000,
9 and \$2,000,000, to remain available until expended, from
10 communication site rental fees established by the Bureau
11 for the cost of administering communication site activities.

12 OREGON AND CALIFORNIA GRANT LANDS

13 For expenses necessary for management, protection,
14 and development of resources and for construction, oper-
15 ation, and maintenance of access roads, reforestation, and
16 other improvements on the revested Oregon and California
17 Railroad grant lands, on other Federal lands in the Or-
18 egon and California land-grant counties of Oregon, and
19 on adjacent rights-of-way; and acquisition of lands or in-
20 terests therein, including existing connecting roads on or
21 adjacent to such grant lands; \$115,521,000, to remain
22 available until expended: *Provided*, That the Bureau of
23 Land Management shall maintain the current Western Or-
24 egon Operating Plan and will fully participate in a unified
25 wildfire protection system.

1 RANGE IMPROVEMENTS

2 For rehabilitation, protection, and acquisition of
3 lands and interests therein, and improvement of Federal
4 rangelands pursuant to section 401 of the Federal Land
5 Policy and Management Act of 1976 (43 U.S.C. 1751),
6 notwithstanding any other Act, sums equal to 50 percent
7 of all moneys received during the prior fiscal year under
8 sections 3 and 15 of the Taylor Grazing Act (43 U.S.C.
9 315b, 315m) and the amount designated for range im-
10 provements from grazing fees and mineral leasing receipts
11 from Bankhead-Jones lands transferred to the Depart-
12 ment of the Interior pursuant to law, but not less than
13 \$10,000,000, to remain available until expended: *Pro-*
14 *vided*, That not to exceed \$600,000 shall be available for
15 administrative expenses.

16 SERVICE CHARGES, DEPOSITS, AND FORFEITURES

17 For administrative expenses and other costs related
18 to processing application documents and other authoriza-
19 tions for use and disposal of public lands and resources,
20 for costs of providing copies of official public land docu-
21 ments, for monitoring construction, operation, and termi-
22 nation of facilities in conjunction with use authorizations,
23 and for rehabilitation of damaged property, such amounts
24 as may be collected under Public Law 94–579 (43 U.S.C.
25 1701 et seq.), and under section 28 of the Mineral Leasing

1 Act (30 U.S.C. 185), to remain available until expended:
2 *Provided*, That notwithstanding any provision to the con-
3 trary of section 305(a) of Public Law 94–579 (43 U.S.C.
4 1735(a)), any moneys that have been or will be received
5 pursuant to that section, whether as a result of forfeiture,
6 compromise, or settlement, if not appropriate for refund
7 pursuant to section 305(c) of that Act (43 U.S.C.
8 1735(c)), shall be available and may be expended under
9 the authority of this Act by the Secretary of the Interior
10 to improve, protect, or rehabilitate any public lands ad-
11 ministered through the Bureau of Land Management
12 which have been damaged by the action of a resource de-
13 veloper, purchaser, permittee, or any unauthorized person,
14 without regard to whether all moneys collected from each
15 such action are used on the exact lands damaged which
16 led to the action: *Provided further*, That any such moneys
17 that are in excess of amounts needed to repair damage
18 to the exact land for which funds were collected may be
19 used to repair other damaged public lands.

20 MISCELLANEOUS TRUST FUNDS

21 In addition to amounts authorized to be expended
22 under existing laws, there is hereby appropriated such
23 amounts as may be contributed under section 307 of Pub-
24 lic Law 94–579 (43 U.S.C. 1737), and such amounts as
25 may be advanced for administrative costs, surveys, ap-

1 praisals, and costs of making conveyances of omitted lands
2 under section 211(b) of that Act (43 U.S.C. 1721(b)), to
3 remain available until expended.

4 ADMINISTRATIVE PROVISIONS

5 The Bureau of Land Management may carry out the
6 operations funded under this Act by direct expenditure,
7 contracts, grants, cooperative agreements, and reimburs-
8 able agreements with public and private entities, including
9 with States. Appropriations for the Bureau shall be avail-
10 able for purchase, erection, and dismantlement of tem-
11 porary structures, and alteration and maintenance of nec-
12 essary buildings and appurtenant facilities to which the
13 United States has title; up to \$100,000 for payments, at
14 the discretion of the Secretary, for information or evidence
15 concerning violations of laws administered by the Bureau;
16 miscellaneous and emergency expenses of enforcement ac-
17 tivities authorized or approved by the Secretary and to be
18 accounted for solely on the Secretary's certificate, not to
19 exceed \$10,000: *Provided*, That notwithstanding Public
20 Law 90-620 (44 U.S.C. 501), the Bureau may, under co-
21 operative cost-sharing and partnership arrangements au-
22 thorized by law, procure printing services from cooperators
23 in connection with jointly produced publications for which
24 the cooperators share the cost of printing either in cash
25 or in services, and the Bureau determines the cooperator

1 is capable of meeting accepted quality standards: *Provided*
2 *further*, That projects to be funded pursuant to a written
3 commitment by a State government to provide an identi-
4 fied amount of money in support of the project may be
5 carried out by the Bureau on a reimbursable basis: *Pro-*
6 *vided further*, That the Bureau of Land Management shall
7 maintain staffing levels in order to fulfill the mission re-
8 quired under title 16, title 30, title 43, and title 54, United
9 States Code, including to protect natural and cultural re-
10 sources, provide and maintain appropriate access and
11 recreation for visitors, provide safety precautions for visi-
12 tors and staff, maintain physical and natural infrastruc-
13 ture, provide information and respond to stakeholders and
14 the general public, conduct tribal consultation, provide for
15 administrative support, manage energy and minerals re-
16 sources, and carry out other activities in support of effec-
17 tively managing the National Conservation Lands and
18 other public lands in a timely manner.

19 UNITED STATES FISH AND WILDLIFE SERVICE
20 RESOURCE MANAGEMENT
21 (INCLUDING TRANSFER OF FUNDS)

22 For necessary expenses of the United States Fish and
23 Wildlife Service, as authorized by law, and for scientific
24 and economic studies, general administration, and for the
25 performance of other authorized functions related to such

1 resources, \$1,451,515,000, to remain available until Sep-
2 tember 30, 2027, of which not to exceed \$15,000 may be
3 for official reception and representation expenses: *Pro-*
4 *vided*, That not to exceed \$14,000,000 shall be used for
5 implementing subsections (a), (b), (c), and (e) of section
6 4 of the Endangered Species Act of 1973 (16 U.S.C.
7 1533) (except for processing petitions, developing and
8 issuing proposed and final regulations, and taking any
9 other steps to implement actions described in subsection
10 (c)(2)(A), (c)(2)(B)(i), or (c)(2)(B)(ii) of such section):
11 *Provided further*, That of the amount appropriated under
12 this heading, \$19,115,000, to remain available until Sep-
13 tember 30, 2028, shall be for projects specified for Stew-
14 ardship Priorities in the table titled “Interior and Envi-
15 ronment Incorporation of Community Project Funding
16 Items/Congressionally Directed Spending Items” included
17 for this division in the explanatory statement described in
18 section 4 (in the matter preceding division A of this con-
19 solidated Act): *Provided further*, That amounts in the pre-
20 ceding proviso may be transferred to the appropriate pro-
21 gram, project, or activity under this heading and shall con-
22 tinue to only be available for the purposes and in such
23 amounts as such funds were originally appropriated.

1 CONSTRUCTION

2 For construction, improvement, acquisition, or re-
3 moval of buildings and other facilities required in the con-
4 servation, management, investigation, protection, and uti-
5 lization of fish and wildlife resources, and the acquisition
6 of lands and interests therein; \$14,709,000, to remain
7 available until expended: *Provided*, That of the amounts
8 made available under this heading, \$1,000,000 is for the
9 project specified for Line Item Construction Projects in
10 the table titled “Interior and Environment Incorporation
11 of Community Project Funding Items/Congressionally Di-
12 rected Spending Items” included for this division in the
13 explanatory statement described in section 4 (in the mat-
14 ter preceding division A of this consolidated Act).

15 COOPERATIVE ENDANGERED SPECIES CONSERVATION

16 FUND

17 For expenses necessary to carry out section 6 of the
18 Endangered Species Act of 1973 (16 U.S.C. 1535),
19 \$22,202,000, to remain available until expended, to be de-
20 rived from the Cooperative Endangered Species Conserva-
21 tion Fund.

22 NATIONAL WILDLIFE REFUGE FUND

23 For expenses necessary to implement the Act of Octo-
24 ber 17, 1978 (16 U.S.C. 715s), \$13,228,000.

1 NORTH AMERICAN WETLANDS CONSERVATION FUND

2 For expenses necessary to carry out the provisions
3 of the North American Wetlands Conservation Act (16
4 U.S.C. 4401 et seq.), \$49,000,000, to remain available
5 until expended.

6 NEOTROPICAL MIGRATORY BIRD CONSERVATION

7 For expenses necessary to carry out the Neotropical
8 Migratory Bird Conservation Act (16 U.S.C. 6101 et
9 seq.), \$5,000,000, to remain available until expended.

10 MULTINATIONAL SPECIES CONSERVATION FUND

11 For expenses necessary to carry out the African Ele-
12 phant Conservation Act (16 U.S.C. 4201 et seq.), the
13 Asian Elephant Conservation Act of 1997 (16 U.S.C.
14 4261 et seq.), the Rhinoceros and Tiger Conservation Act
15 of 1994 (16 U.S.C. 5301 et seq.), the Great Ape Con-
16 servation Act of 2000 (16 U.S.C. 6301 et seq.), and the
17 Marine Turtle Conservation Act of 2004 (16 U.S.C. 6601
18 et seq.), \$21,000,000, to remain available until expended.

19 STATE AND TRIBAL WILDLIFE GRANTS

20 For wildlife conservation grants to States and to the
21 District of Columbia, Puerto Rico, Guam, the United
22 States Virgin Islands, the Northern Mariana Islands,
23 American Samoa, and Indian tribes under the provisions
24 of the Fish and Wildlife Act of 1956 and the Fish and
25 Wildlife Coordination Act, for the development and imple-

1 mentation of programs for the benefit of wildlife and their
2 habitat, including species that are not hunted or fished,
3 \$73,812,000, to remain available until expended: *Pro-*
4 *vided*, That of the amount provided herein, \$6,200,000 is
5 for a competitive grant program for Indian tribes not sub-
6 ject to the remaining provisions of this appropriation: *Pro-*
7 *vided further*, That \$7,612,000 is for a competitive grant
8 program to implement approved plans for States, terri-
9 tories, and other jurisdictions and at the discretion of af-
10 fected States, the regional Associations of fish and wildlife
11 agencies, not subject to the remaining provisions of this
12 appropriation: *Provided further*, That the Secretary shall,
13 after deducting \$13,812,000 and administrative expenses,
14 apportion the amount provided herein in the following
15 manner: (1) to the District of Columbia and to the Com-
16 monwealth of Puerto Rico, each a sum equal to not more
17 than one-half of 1 percent thereof; and (2) to Guam,
18 American Samoa, the United States Virgin Islands, and
19 the Commonwealth of the Northern Mariana Islands, each
20 a sum equal to not more than one-fourth of 1 percent
21 thereof: *Provided further*, That the Secretary of the Inte-
22 rior shall apportion the remaining amount in the following
23 manner: (1) one-third of which is based on the ratio to
24 which the land area of such State bears to the total land
25 area of all such States; and (2) two-thirds of which is

1 based on the ratio to which the population of such State
2 bears to the total population of all such States: *Provided*
3 *further*, That the amounts apportioned under this para-
4 graph shall be adjusted equitably so that no State shall
5 be apportioned a sum which is less than 1 percent of the
6 amount available for apportionment under this paragraph
7 for any fiscal year or more than 5 percent of such amount:
8 *Provided further*, That the Federal share of planning
9 grants shall not exceed 75 percent of the total costs of
10 such projects and the Federal share of implementation
11 grants shall not exceed 65 percent of the total costs of
12 such projects: *Provided further*, That the non-Federal
13 share of such projects may not be derived from Federal
14 grant programs: *Provided further*, That any amount ap-
15 portioned in 2026 to any State, territory, or other jurisdic-
16 tion that remains unobligated as of September 30, 2027,
17 shall be reapportioned, together with funds appropriated
18 in 2028, in the manner provided herein.

19 ADMINISTRATIVE PROVISIONS

20 The United States Fish and Wildlife Service may
21 carry out the operations of Service programs by direct ex-
22 penditure, contracts, grants, cooperative agreements and
23 reimbursable agreements with public and private entities.
24 Appropriations and funds available to the United States
25 Fish and Wildlife Service shall be available for repair of

1 damage to public roads within and adjacent to reservation
2 areas caused by operations of the Service; options for the
3 purchase of land at not to exceed one dollar for each op-
4 tion; facilities incident to such public recreational uses on
5 conservation areas as are consistent with their primary
6 purpose; and the maintenance and improvement of aquar-
7 ia, buildings, and other facilities under the jurisdiction of
8 the Service and to which the United States has title, and
9 which are used pursuant to law in connection with man-
10 agement, and investigation of fish and wildlife resources:
11 *Provided*, That notwithstanding 44 U.S.C. 501, the Serv-
12 ice may, under cooperative cost sharing and partnership
13 arrangements authorized by law, procure printing services
14 from cooperators in connection with jointly produced pub-
15 lications for which the cooperators share at least one-half
16 the cost of printing either in cash or services and the Serv-
17 ice determines the cooperator is capable of meeting accept-
18 ed quality standards: *Provided further*, That the Service
19 may accept donated aircraft as replacements for existing
20 aircraft: *Provided further*, That notwithstanding 31 U.S.C.
21 3302, all fees collected for non-toxic shot review and ap-
22 proval shall be deposited under the heading “United
23 States Fish and Wildlife Service—Resource Management”
24 and shall be available to the Secretary, without further
25 appropriation, to be used for expenses of processing of

1 such non-toxic shot type or coating applications and revis-
2 ing regulations as necessary, and shall remain available
3 until expended: *Provided further*, That the United States
4 Fish and Wildlife Service shall maintain staffing levels in
5 order to fulfill the mission required under title 16, title
6 43, and title 54, United States Code, including to protect
7 natural and cultural resources, provide and maintain ap-
8 propriate access and recreation for visitors, provide safety
9 precautions for visitors and staff, maintain physical and
10 natural infrastructure, provide information and respond to
11 stakeholders and the general public, conduct tribal con-
12 sultation, provide for administrative support, enforce Fed-
13 eral wildlife laws, protect species, uphold Acts, treaties,
14 conventions and agreements to conserve, protect, and en-
15 hance fish, wildlife, plants, and their habitats, providing
16 professional expertise to other agencies and international
17 and private partners, and carry out other activities in sup-
18 port of effectively operating the National Fish Hatchery
19 System and National Wildlife Refuge System and carrying
20 out programs administered by the United States Fish and
21 Wildlife Service in a timely manner.

22 NATIONAL PARK SERVICE

23 OPERATION OF THE NATIONAL PARK SYSTEM

24 For expenses necessary for the management, oper-
25 ation, protection, and maintenance of areas and facilities

1 administered by the National Park Service and for the
2 general administration of the National Park Service,
3 \$2,877,195,000, of which \$11,661,000 for planning and
4 interagency coordination in support of Everglades restora-
5 tion and \$148,285,000 for maintenance, repair, or reha-
6 bilitation projects for constructed assets and
7 \$157,950,000 for cyclic maintenance projects for con-
8 structed assets and cultural resources and \$12,500,000
9 for uses authorized by section 101122 of title 54, United
10 States Code shall remain available until September 30,
11 2027, and not to exceed \$15,000 may be for official recep-
12 tion and representative expenses: *Provided*, That funds ap-
13 propriated under this heading in this Act are available for
14 the purposes of section 5 of Public Law 95–348: *Provided*
15 *further*, That notwithstanding section 9 of the 400 Years
16 of African-American History Commission Act (36 U.S.C.
17 note prec. 101; Public Law 115–102), \$3,300,000 of the
18 funds provided under this heading shall be made available
19 for the purposes specified by that Act: *Provided further*,
20 That sections 7(b) and 8 of that Act shall be amended
21 by striking “July 1, 2025” and inserting “July 1, 2027”.

22 In addition, for purposes described in section 2404
23 of Public Law 116–9, an amount equal to the amount de-
24 posited in this fiscal year into the National Park Medical
25 Services Fund established pursuant to such section of

1 such Act, to remain available until expended, shall be de-
2 rived from such Fund.

3 NATIONAL RECREATION AND PRESERVATION

4 For expenses necessary to carry out recreation pro-
5 grams, natural programs, cultural programs, heritage
6 partnership programs, environmental compliance and re-
7 view, international park affairs, and grant administration,
8 not otherwise provided for, \$91,596,000, to remain avail-
9 able until September 30, 2027, of which \$250,000 shall
10 be for projects specified for Statutory and Contractual Aid
11 in the table titled “Interior and Environment Incorpora-
12 tion of Community Project Funding Items/Congressionally
13 Directed Spending Items” included for this division in the
14 explanatory statement described in section 4 (in the mat-
15 ter preceding division A of this consolidated Act).

16 HISTORIC PRESERVATION FUND

17 For expenses necessary in carrying out the National
18 Historic Preservation Act (division A of subtitle III of title
19 54, United States Code), \$205,059,000, to be derived
20 from the Historic Preservation Fund and to remain avail-
21 able until September 30, 2027, of which \$25,500,000 shall
22 be for Save America’s Treasures grants for preservation
23 of nationally significant sites, structures and artifacts as
24 authorized by section 7303 of the Omnibus Public Land
25 Management Act of 2009 (54 U.S.C. 3089): *Provided,*

1 That an individual Save America's Treasures grant shall
2 be matched by non-Federal funds: *Provided further*, That
3 individual projects shall only be eligible for one grant: *Pro-*
4 *vided further*, That all projects to be funded shall be ap-
5 proved by the Secretary of the Interior in consultation
6 with the House and Senate Committees on Appropria-
7 tions: *Provided further*, That of the funds provided for the
8 Historic Preservation Fund, \$1,250,000 is for competitive
9 grants for the survey and nomination of properties to the
10 National Register of Historic Places and as National His-
11 toric Landmarks associated with communities currently
12 under-represented, as determined by the Secretary;
13 \$24,000,000 is for competitive grants to preserve the sites
14 and stories of the African American Civil Rights move-
15 ment; \$5,000,000 is for competitive grants to preserve
16 sites related to the struggle of all people to achieve equal
17 rights in America; \$11,000,000 is for grants to Histori-
18 cally Black Colleges and Universities; \$7,906,000 is for
19 competitive grants for the restoration of historic prop-
20 erties of national, State, and local significance listed on
21 or eligible for inclusion on the National Register of His-
22 toric Places, to be made without imposing the usage or
23 direct grant restrictions of section 101(e)(3) (54 U.S.C.
24 302904) of the National Historic Preservation Act;
25 \$4,907,000 is for a competitive grant program to honor

1 the semiquincentennial anniversary of the United States
2 by restoring and preserving sites and structures listed on
3 the National Register of Historic Places that commemo-
4 rate the founding of the nation; \$62,150,000 is for State
5 Historic Preservation Offices; \$23,750,000 is for Tribal
6 Historic Preservation Offices; and \$15,596,000 is for
7 projects specified for the Historic Preservation Fund in
8 the table titled “Interior and Environment Incorporation
9 of Community Project Funding Items/Congressionally Di-
10 rected Spending Items” included for this division in the
11 explanatory statement described in section 4 (in the mat-
12 ter preceding division A of this consolidated Act): *Provided*
13 *further*, That such competitive grants shall be made with-
14 out imposing the matching requirements in section
15 302902(b)(3) of title 54, United States Code to States and
16 Indian tribes as defined in chapter 3003 of such title, Na-
17 tive Hawaiian organizations, local governments, including
18 Certified Local Governments, and non-profit organiza-
19 tions.

20 CONSTRUCTION

21 For construction, improvements, repair, or replace-
22 ment of physical facilities, and related equipment, and
23 compliance and planning for programs and areas adminis-
24 tered by the National Park Service, \$88,461,000, of which
25 \$3,190,000 is for projects specified for Line item con-

1 struction and maintenance in the table titled “Interior and
2 Environment Incorporation of Community Project Fund-
3 ing Items/Congressionally Directed Spending Items” in-
4 cluded for this division in the explanatory statement de-
5 scribed in section 4 (in the matter preceding division A
6 of this consolidated Act), to remain available until ex-
7 pended: *Provided*, That notwithstanding any other provi-
8 sion of law, for any project initially funded in fiscal year
9 2026 with a future phase indicated in the National Park
10 Service 5–Year Line Item Construction Plan, a single pro-
11 curement may be issued which includes the full scope of
12 the project: *Provided further*, That the solicitation and
13 contract shall contain the clause availability of funds
14 found at 48 CFR 52.232–18: *Provided further*, That Na-
15 tional Park Service Donations, Park Concessions Fran-
16 chise Fees, and Recreation Fees may be made available
17 for the cost of adjustments and changes within the origi-
18 nal scope of effort for projects funded by the National
19 Park Service Construction appropriation: *Provided further*,
20 That the Secretary of the Interior shall consult with the
21 Committees on Appropriations, in accordance with current
22 reprogramming thresholds, prior to making any changes
23 authorized by this section.

3 For the costs of administration of the Land and
4 Water Conservation Fund grants authorized by section

8 under such section, such retained amounts to remain
9 available until expended.

5 SURVEYS, INVESTIGATIONS, AND RESEARCH
6 (INCLUDING TRANSFER OF FUNDS)

7 For expenses necessary for the United States Geo-
8 logical Survey to perform surveys, investigations, and re-
9 search covering topography, geology, hydrology, biology,
10 and the mineral and water resources of the United States,
11 its territories and possessions, and other areas as author-
12 ized by 43 U.S.C. 31, 1332, and 1340; classify lands as
13 to their mineral and water resources; give engineering su-
14 pervision to power permittees and Federal Energy Regu-
15 latory Commission licensees; administer the minerals ex-
16 ploration program (30 U.S.C. 641); conduct inquiries into
17 the economic conditions affecting mining and materials
18 processing industries (30 U.S.C. 3, 21a, and 1603; 50
19 U.S.C. 98g(a)(1)) and related purposes as authorized by
20 law; and to publish and disseminate data relative to the
21 foregoing activities; \$1,420,433,000, to remain available
22 until September 30, 2027; of which \$95,334,000 shall re-
23 main available until expended for satellite operations; and
24 of which \$74,840,000 shall be available until expended for
25 deferred maintenance and capital improvement projects

1 that exceed \$100,000 in cost: *Provided*, That none of the
2 funds provided for the ecosystem research activity shall
3 be used to conduct new surveys on private property, unless
4 specifically authorized in writing by the property owner:
5 *Provided further*, That no part of this appropriation shall
6 be used to pay more than one-half the cost of topographic
7 mapping or water resources data collection and investiga-
8 tions carried on in cooperation with States and municipali-
9 ties: *Provided further*, That of the amount appropriated
10 under this heading, \$2,250,000 shall be for projects speci-
11 fied for Special Initiatives in the table titled “Interior and
12 Environment Incorporation of Community Project Fund-
13 ing Items/Congressionally Directed Spending Items” in-
14 cluded for this division in the explanatory statement de-
15 scribed in section 4 (in the matter preceding division A

1 be considered employees for the purpose of chapters 57
2 and 81 of title 5, United States Code, relating to com-

4 of title 28, United States Code, relating to tort claims,
5 but shall not be considered to be Federal employees for
6 any other purposes.

7 BUREAU OF OCEAN ENERGY MANAGEMENT

8 OCEAN ENERGY MANAGEMENT

9 For expenses necessary for granting and admin-
10 istering leases, easements, rights-of-way, and agreements
11 for use for oil and gas, other minerals, energy, and ma-
12 rine-related purposes on the Outer Continental Shelf and
13 approving operations related thereto, as authorized by law;
14 for environmental studies, as authorized by law; for imple-
15 menting other laws and to the extent provided by Presi-
16 dential or Secretarial delegation; and for matching grants
17 or cooperative agreements, \$191,128,000, of which
18 \$133,128,000 is to remain available until September 30,
19 2027, and of which \$58,000,000 is to remain available
20 until expended: *Provided*, That this total appropriation
21 shall be reduced by amounts collected by the Secretary of
22 the Interior and credited to this appropriation from addi-
23 tions to receipts resulting from increases to lease rental
24 rates in effect on August 5, 1993, and from cost recovery
25 fees from activities conducted by the Bureau of Ocean En-

1 ergy Management pursuant to the Outer Continental Shelf
2 Lands Act, including studies, assessments, analysis, and
3 miscellaneous administrative activities: *Provided further,*
4 That the sum herein appropriated shall be reduced as such
5 collections are received during the fiscal year, so as to re-

8 not to exceed \$3,000 shall be available for reasonable ex-
9 penses related to promoting volunteer beach and marine

13 BUREAU OF SAFETY AND ENVIRONMENTAL
14 ENFORCEMENT
15 OFFSHORE SAFETY AND ENVIRONMENTAL ENFORCEMENT

16 For expenses necessary for the regulation of oper-
17 ations related to leases, easements, rights-of-way, and
18 agreements for use for oil and gas, other minerals, energy,
19 and marine-related purposes on the Outer Continental
20 Shelf, as authorized by law; for enforcing and imple-
21 menting laws and regulations as authorized by law and
22 to the extent provided by Presidential or Secretarial dele-
23 gation; and for matching grants or cooperative agree-
24 ments, \$160,751,000, of which \$128,871,000, including
25 not to exceed \$3,000 for official reception and representa-

1 tion expenses, is to remain available until September 30,
2 2027, and of which \$31,880,000 is to remain available
3 until expended, including \$2,880,000 for offshore decom-
4 missioning activities: *Provided*, That this total appropria-
5 tion shall be reduced by amounts collected by the Sec-
6 retary of the Interior and credited to this appropriation
7 from additions to receipts resulting from increases to lease
8 rental rates in effect on August 5, 1993, and from cost
9 recovery fees from activities conducted by the Bureau of
10 Safety and Environmental Enforcement pursuant to the
11 Outer Continental Shelf Lands Act, including studies, as-

19 available until expended, to be reduced by amounts col-

23 *vided*, That for fiscal year 2026, not less than 50 percent
24 of the inspection fees expended by the Bureau of Safety

12 ability Trust Fund, to remain available until expended.

14 ENFORCEMENT

15 REGULATION AND TECHNOLOGY

16 For necessary expenses to carry out the provisions
17 of the Surface Mining Control and Reclamation Act of
18 1977, Public Law 95–87, \$117,575,000, to remain avail-
19 able until September 30, 2027, of which \$63,700,000 shall
20 be available for State and tribal regulatory grants, and
21 of which not to exceed \$5,000 may be for official reception
22 and representation expenses: *Provided*, That appropria-
23 tions for the Office of Surface Mining Reclamation and
24 Enforcement may provide for the travel and per diem ex-
25 penses of State and tribal personnel attending Office of

1 Surface Mining Reclamation and Enforcement sponsored
2 training.

3 In addition, for costs to review, administer, and en-
4 force permits issued by the Office pursuant to section 507
5 of Public Law 95–87 (30 U.S.C. 1257), \$40,000, to re-
6 main available until expended: *Provided*, That fees as-
7 sessed and collected by the Office pursuant to such section
8 507 shall be credited to this account as discretionary off-
9 setting collections, to remain available until expended:
10 *Provided further*, That the sum herein appropriated from
11 the general fund shall be reduced as collections are re-
12 ceived during the fiscal year, so as to result in a fiscal
13 year 2026 appropriation estimated at not more than
14 \$117,575,000.

15 ABANDONED MINE RECLAMATION FUND

16 For necessary expenses to carry out title IV of the
17 Surface Mining Control and Reclamation Act of 1977,
18 Public Law 95–87, \$32,975,000, to be derived from re-
19 ceipts of the Abandoned Mine Reclamation Fund and to
20 remain available until expended: *Provided*, That pursuant

14 reception and representation expenses.

15 In addition, \$134,000,000, to remain available until
16 expended, for payments to States and federally recognized
17 Indian tribes for reclamation of abandoned mine lands and
18 other related activities in accordance with the terms and
19 conditions described in the explanatory statement de-
20 scribed in section 4 (in the matter preceding division A
21 of this consolidated Act): *Provided*, That such additional
22 amount shall be used for economic and community devel-
23 opment in conjunction with the priorities described in sec-
24 tion 403(a) of the Surface Mining Control and Reclama-
25 tion Act of 1977 (30 U.S.C. 1233(a)): *Provided further*,

1 That of such additional amount, \$88,500,000 shall be dis-
2 tributed in equal amounts to the three Appalachian States
3 with the greatest amount of unfunded needs to meet the
4 priorities described in paragraphs (1) and (2) of such sec-
5 tion, \$33,750,000 shall be distributed in equal amounts
6 to the three Appalachian States with the subsequent
7 greatest amount of unfunded needs to meet such prior-
8 ities, and \$11,750,000 shall be for grants to federally rec-
9 ognized Indian tribes, without regard to their status as
10 certified or uncertified under the Surface Mining Control
11 and Reclamation Act of 1977 (30 U.S.C. 1233(a)), for
12 reclamation of abandoned mine lands and other related
13 activities in accordance with the terms and conditions de-
14 scribed in the explanatory statement described in section
15 4 (in the matter preceding division A of this consolidated
16 Act) and shall be used for economic and community devel-
17 opment in conjunction with the priorities in section 403(a)
18 of the Surface Mining Control and Reclamation Act of
19 1977: *Provided further*, That such payments shall be made
20 to States and federally recognized Indian tribes not later

10 of November 2, 1921 (25 U.S.C. 13) and the Indian Self-
11 Determination and Education Assistance Act of 1975 (25
12 U.S.C. 5301 et seq.), \$1,933,200,000, to remain available
13 until September 30, 2027, except as otherwise provided
14 herein; of which not to exceed \$15,000 may be for official
15 reception and representation expenses; of which not to ex-
16 ceed \$78,494,000 shall be for welfare assistance pay-
17 ments: *Provided*, That in cases of designated Federal dis-
18 asters, the Secretary of the Interior may exceed such cap
19 for welfare payments from the amounts provided herein,
20 to provide for disaster relief to Indian communities af-
21 fected by the disaster: *Provided further*, That federally rec-
22 ognized Indian tribes and tribal organizations of federally
23 recognized Indian tribes may use their tribal priority allo-
24 cations for unmet welfare assistance costs: *Provided fur-*
25 *ther*, That not to exceed \$71,495,000 shall remain avail-
able until expended for housing improvement, road main-

1 tenance, land acquisition, attorney fees, litigation support,
2 land records improvement, hearings and appeals, and the
3 Navajo-Hopi Settlement Program: *Provided further*, That
4 of the amount appropriated under this heading,
5 \$8,491,000 shall be for projects specified for Special Ini-
6 tiatives (CDS) in the table titled “Interior and Environ-
7 ment Incorporation of Community Project Funding Items/
8 Congressionally Directed Spending Items” included for
9 this division in the explanatory statement described in sec-
10 tion 4 (in the matter preceding division A of this consoli-
11 dated Act): *Provided further*, That any forestry funds allo-
12 cated to a federally recognized tribe which remain unobli-
13 gated as of September 30, 2027, may be transferred dur-
14 ing fiscal year 2028 to an Indian forest land assistance
15 account established for the benefit of the holder of the
16 funds within the holder’s trust fund account: *Provided fur-*
17 *ther*, That any such unobligated balances not so trans-
18 ferred shall expire on September 30, 2028: *Provided fur-*
19 *ther*, That in order to enhance the safety of Bureau field
20 employees, the Bureau may use funds to purchase uni-
21 forms or other identifying articles of clothing for per-
22 sonnel: *Provided further*, That not to exceed \$7,096,000
23 of funds made available under this heading may, as need-
24 ed, be transferred to “Office of the Secretary—Depart-
25 mental Operations” for trust, probate, and administrative

1 Irrigation Project may be transferred to the Bureau of
2 Reclamation: *Provided further*, That any funds provided
3 for the Safety of Dams program pursuant to the Indian
4 Dams Safety Act of 1994 (25 U.S.C. 3804), shall be made
5 available on a nonreimbursable basis: *Provided further*,
6 That this appropriation may be reimbursed from the Bu-
7 reau of Trust Funds Administration appropriation for the
8 appropriate share of construction costs for space expan-
9 sion needed in agency offices to meet trust reform imple-
10 mentation: *Provided further*, That of the funds made avail-
11 able under this heading, \$10,000,000 shall be derived
12 from the Indian Irrigation Fund established by section
13 3211 of the WIIN Act (Public Law 114–322): *Provided*
14 *further*, That amounts provided under this heading are
15 made available for the modernization of Federal field com-
16 munication capabilities, in addition to amounts otherwise
17 made available for such purpose.

18 INDIAN LAND AND WATER CLAIM SETTLEMENTS AND

19 MISCELLANEOUS PAYMENTS TO INDIANS

20 For payments and necessary administrative expenses
21 for implementation of Indian land and water claim settle-
22 ments pursuant to Public Laws 99–264, 101–618, and
23 117–349 and for implementation of other land and water
24 rights settlements, \$976,000, to remain available until ex-
25 pended.

1 INDIAN GUARANTEED LOAN PROGRAM ACCOUNT

2 For the cost of guaranteed loans and insured loans,
3 \$13,329,000, to remain available until September 30,
4 2027, of which \$2,125,000 is for administrative expenses,
5 as authorized by the Indian Financing Act of 1974: *Pro-*
6 *vided*, That such costs, including the cost of modifying
7 such loans, shall be as defined in section 502 of the Con-
8 gressional Budget Act of 1974: *Provided further*, That
9 these funds are available to subsidize total loan principal,
10 any part of which is to be guaranteed or insured, not to
11 exceed \$227,318,923.

12 BUREAU OF INDIAN EDUCATION

13 OPERATION OF INDIAN EDUCATION PROGRAMS

14 For expenses necessary for the operation of Indian
15 education programs, as authorized by law, including the
16 Snyder Act of November 2, 1921 (25 U.S.C. 13), the In-
17 dian Self-Determination and Education Assistance Act of
18 1975 (25 U.S.C. 5301 et seq.), the Education Amend-
19 ments of 1978 (25 U.S.C. 2001–2019), and the Tribally
20 Controlled Schools Act of 1988 (25 U.S.C. 2501 et seq.),
21 \$1,131,617,000 to remain available until September 30,
22 2027, except as otherwise provided herein: *Provided*, That
23 federally recognized Indian tribes and tribal organizations
24 of federally recognized Indian tribes may use their tribal
25 priority allocations for unmet welfare assistance costs:

1 *Provided further*, That not to exceed \$833,592,000 for
2 school operations costs of Bureau-funded schools and
3 other education programs shall become available on June
4 1, 2026, and shall remain available until September 30,
5 2027: *Provided further*, That notwithstanding any other
6 provision of law, including but not limited to the Indian
7 Self-Determination Act of 1975 (25 U.S.C. 5301 et seq.)
8 and section 1128 of the Education Amendments of 1978
9 (25 U.S.C. 2008), not to exceed \$95,822,000 within and
10 only from such amounts made available for school oper-
11 ations shall be available for administrative cost grants as-
12 sociated with grants approved prior to June 1, 2026: *Pro-*
13 *vided further*, That in order to enhance the safety of Bu-
14 reau field employees, the Bureau may use funds to pur-
15 chase uniforms or other identifying articles of clothing for
16 personnel.

17 EDUCATION CONSTRUCTION

18 For construction, repair, improvement, and mainte-
19 nance of buildings, utilities, and other facilities necessary
20 for the operation of Indian education programs, including
21 architectural and engineering services by contract; acquisi-
22 tion of lands, and interests in lands; \$234,725,000, to re-
23 main available until expended: *Provided*, That in order to
24 ensure timely completion of construction projects, the Sec-
25 retary of the Interior may assume control of a project and

1 all funds related to the project, if, not later than 18
2 months after the date of the enactment of this Act, any
3 Public Law 100–297 (25 U.S.C. 2501, et seq.) grantee
4 receiving funds appropriated in this Act or in any prior
5 Act, has not completed the planning and design phase of
6 the project and commenced construction.

7 ADMINISTRATIVE PROVISIONS

8 The Bureau of Indian Affairs and the Bureau of In-
9 dian Education may carry out the operation of Indian pro-
10 grams by direct expenditure, contracts, cooperative agree-
11 ments, compacts, and grants, either directly or in coopera-
12 tion with States and other organizations.

13 Notwithstanding Public Law 87–279 (25 U.S.C. 15),
14 the Bureau of Indian Affairs may contract for services in
15 support of the management, operation, and maintenance
16 of the Power Division of the San Carlos Irrigation Project.

17 Notwithstanding any other provision of law, no funds
18 available to the Bureau of Indian Affairs or the Bureau
19 of Indian Education for central office oversight and Exec-
20 utive Direction and Administrative Services (except Exec-
21 utive Direction and Administrative Services funding for
22 Tribal Priority Allocations, regional offices, and facilities
23 operations and maintenance) shall be available for con-
24 tracts, grants, compacts, or cooperative agreements with
25 the Bureau of Indian Affairs or the Bureau of Indian

1 Education under the provisions of the Indian Self-Deter-
2 mination Act or the Tribal Self-Governance Act of 1994
3 (Public Law 103–413).

4 In the event any tribe returns appropriations made
5 available by this Act to the Bureau of Indian Affairs or
6 the Bureau of Indian Education, this action shall not di-
7 minish the Federal Government’s trust responsibility to
8 that tribe, or the government-to-government relationship
9 between the United States and that tribe, or that tribe’s
10 ability to access future appropriations.

11 Notwithstanding any other provision of law, no funds
12 available to the Bureau of Indian Education, other than
13 the amounts provided herein for assistance to public
14 schools under 25 U.S.C. 5342 et seq., shall be available
15 to support the operation of any elementary or secondary
16 school in the State of Alaska.

17 No funds available to the Bureau of Indian Edu-
18 cation shall be used to support expanded grades for any
19 school or dormitory beyond the grade structure in place
20 or approved by the Secretary of the Interior at each school
21 in the Bureau of Indian Education school system as of
22 October 1, 1995, except that the Secretary of the Interior
23 may waive this prohibition to support expansion of up to
24 one additional grade when the Secretary determines such
25 waiver is needed to support accomplishment of the mission

1 of the Bureau of Indian Education, or more than one
2 grade to expand the elementary grade structure for Bu-
3 reau-funded schools with a K–2 grade structure on Octo-
4 ber 1, 1996. Appropriations made available in this or any
5 prior Act for schools funded by the Bureau shall be avail-
6 able, in accordance with the Bureau’s funding formula,
7 only to the schools in the Bureau school system as of Sep-
8 tember 1, 1996, and to any school or school program that
9 was reinstated in fiscal year 2012. Funds made available
10 under this Act may not be used to establish a charter
11 school at a Bureau-funded school (as that term is defined
12 in section 1141 of the Education Amendments of 1978
13 (25 U.S.C. 2021)), except that a charter school that is
14 in existence on the date of the enactment of this Act and
15 that has operated at a Bureau-funded school before Sep-
16 tember 1, 1999, may continue to operate during that pe-
17 riod, but only if the charter school pays to the Bureau
18 a pro rata share of funds to reimburse the Bureau for
19 the use of the real and personal property (including buses
20 and vans), the funds of the charter school are kept sepa-
21 rate and apart from Bureau funds, and the Bureau does
22 not assume any obligation for charter school programs of
23 the State in which the school is located if the charter
24 school loses such funding. Employees of Bureau-funded
25 schools sharing a campus with a charter school and per-

1 forming functions related to the charter school's operation
2 and employees of a charter school shall not be treated as
3 Federal employees for purposes of chapter 171 of title 28,
4 United States Code.

5 Notwithstanding any other provision of law, including
6 section 113 of title I of appendix C of Public Law 106–
7 113, if in fiscal year 2003 or 2004 a grantee received indi-
8 rect and administrative costs pursuant to a distribution
9 formula based on section 5(f) of Public Law 101–301, the
10 Secretary shall continue to distribute indirect and admin-
11 istrative cost funds to such grantee using the section 5(f)
12 distribution formula.

13 Funds available under this Act may not be used to
14 establish satellite locations of schools in the Bureau school
15 system as of September 1, 1996, except that the Secretary
16 may waive this prohibition in order for an Indian tribe
17 to provide language and cultural immersion educational
18 programs for non-public schools located within the juris-
19 dictional area of the tribal government which exclusively
20 serve tribal members, do not include grades beyond those
21 currently served at the existing Bureau-funded school,
22 provide an educational environment with educator pres-
23 ence and academic facilities comparable to the Bureau-
24 funded school, comply with all applicable Tribal, Federal,
25 or State health and safety standards, and the Americans

1 with Disabilities Act, and demonstrate the benefits of es-
2 tablishing operations at a satellite location in lieu of incur-
3 ring extraordinary costs, such as for transportation or
4 other impacts to students such as those caused by busing
5 students extended distances: *Provided*, That no funds
6 available under this Act may be used to fund operations,
7 maintenance, rehabilitation, construction, or other facili-
8 ties-related costs for such assets that are not owned by
9 the Bureau: *Provided further*, That the term “satellite
10 school” means a school location physically separated from
11 the existing Bureau school by more than 50 miles but that
12 forms part of the existing school in all other respects.

13 Funds made available for Tribal Priority Allocations
14 within Operation of Indian Programs and Operation of In-
15 dian Education Programs may be used to execute re-
16 quested adjustments in tribal priority allocations initiated
17 by an Indian tribe.

18 BUREAU OF TRUST FUNDS ADMINISTRATION
19 FEDERAL TRUST PROGRAMS
20 (INCLUDING TRANSFER OF FUNDS)

21 For the operation of trust programs for Indians by
22 direct expenditure, contracts, cooperative agreements,
23 compacts, and grants, \$100,009,000, to remain available
24 until expended, of which not to exceed \$17,152,000 from
25 this or any other Act, may be available for settlement sup-

1 port: *Provided*, That funds for trust management improve-
2 ments and litigation support may, as needed, be trans-
3 ferred to or merged with the Bureau of Indian Affairs,
4 “Operation of Indian Programs” and Bureau of Indian
5 Education, “Operation of Indian Education Programs”
6 accounts; the Office of the Solicitor, “Salaries and Ex-
7 penses” account; and the Office of the Secretary, “Depart-
8 mental Operations” account: *Provided further*, That funds
9 made available through contracts or grants obligated dur-
10 ing fiscal year 2026, as authorized by the Indian Self-De-
11 termination and Education Assistance Act of 1975 (25
12 U.S.C. 5301 et seq.), shall remain available until expended
13 by the contractor or grantee: *Provided further*, That not-
14 withstanding any other provision of law, the Secretary
15 shall not be required to provide a quarterly statement of
16 performance for any Indian trust account that has not had
17 activity for at least 15 months and has a balance of \$15
18 or less: *Provided further*, That the Secretary shall issue
19 an annual account statement and maintain a record of any
20 such accounts and shall permit the balance in each such
21 account to be withdrawn upon the express written request
22 of the account holder: *Provided further*, That not to exceed
23 \$100,000 is available for the Secretary to make payments
24 to correct administrative errors of either disbursements
25 from or deposits to Individual Indian Money or Tribal ac-

1 counts after September 30, 2002: *Provided further*, That
2 erroneous payments that are recovered shall be credited
3 to and remain available in this account for this purpose:
4 *Provided further*, That the Secretary shall not be required
5 to reconcile Special Deposit Accounts with a balance of
6 less than \$500 unless the Bureau of Trust Funds Admin-
7 istration receives proof of ownership from a Special De-
8 posit Accounts claimant: *Provided further*, That notwith-
9 standing section 102 of the American Indian Trust Fund
10 Management Reform Act of 1994 (Public Law 103-412)
11 or any other provision of law, the Secretary may aggregate
12 the trust accounts of individuals whose whereabouts are
13 unknown for a continuous period of at least 5 years and
14 shall not be required to generate periodic statements of
15 performance for the individual accounts: *Provided further*,
16 That with respect to the preceding proviso, the Secretary
17 shall continue to maintain sufficient records to determine
18 the balance of the individual accounts, including any ac-
19 crued interest and income, and such funds shall remain
20 available to the individual account holders.

1 DEPARTMENTAL OFFICES
2 OFFICE OF THE SECRETARY
3 DEPARTMENTAL OPERATIONS
4 (INCLUDING TRANSFER OF FUNDS)

5 For necessary expenses for management of the De-
6 partment of the Interior and for grants and cooperative
7 agreements, as authorized by law, \$131,012,000, to re-
8 main available until September 30, 2027; of which not to
9 exceed \$15,000 may be for official reception and represen-
10 tation expenses; of which up to \$1,000,000 shall be avail-
11 able for workers compensation payments and unemploy-
12 ment compensation payments associated with the orderly
13 closure of the United States Bureau of Mines; and of
14 which \$14,295,000 for Indian land, mineral, and resource
15 valuation activities shall remain available until expended:
16 *Provided*, That funds for Indian land, mineral, and re-
17 source valuation activities may, as needed, be transferred
18 to and merged with the Bureau of Indian Affairs “Oper-
19 ation of Indian Programs” and Bureau of Indian Edu-
20 cation “Operation of Indian Education Programs” ac-
21 counts and the Bureau of Trust Funds Administration
22 “Federal Trust Programs” account: *Provided further*,
23 That funds made available through contracts or grants ob-
24 ligated during fiscal year 2026, as authorized by the In-
25 dian Self-Determination Act of 1975 (25 U.S.C. 5301 et

1 seq.), shall remain available until expended by the con-
2 tractor or grantee.

3 ADMINISTRATIVE PROVISIONS

4 For fiscal year 2026, up to \$550,000 of the payments
5 authorized by chapter 69 of title 31, United States Code,
6 may be retained for administrative expenses of the Pay-
7 ments in Lieu of Taxes Program: *Provided*, That the
8 amounts provided under this Act specifically for the Pay-
9 ments in Lieu of Taxes program are the only amounts
10 available for payments authorized under chapter 69 of
11 title 31, United States Code: *Provided further*, That in the
12 event the sums appropriated for any fiscal year for pay-
13 ments pursuant to this chapter are insufficient to make
14 the full payments authorized by that chapter to all units
15 of local government, then the payment to each local gov-
16 ernment shall be made proportionally: *Provided further*,
17 That the Secretary may make adjustments to payment to
18 individual units of local government to correct for prior
19 overpayments or underpayments: *Provided further*, That
20 no payment shall be made pursuant to that chapter to oth-
21 erwise eligible units of local government if the computed
22 amount of the payment is less than \$100.

1 INSULAR AFFAIRS

2 ASSISTANCE TO TERRITORIES

3 For expenses necessary for assistance to territories
4 under the jurisdiction of the Department of the Interior
5 and other jurisdictions identified in section 104(e) of Pub-
6 lic Law 108–188, \$117,217,000, of which: (1)
7 \$105,395,000 shall remain available until expended for
8 territorial assistance, including general technical assist-
9 ance, maintenance assistance, disaster assistance, coral
10 reef initiative and natural resources activities, and brown
11 tree snake control and research; grants to the judiciary
12 in American Samoa for compensation and expenses, as au-
13 thorized by law (48 U.S.C. 1661(c)); grants to the Govern-
14 ment of American Samoa, in addition to current local rev-
15 enues, for construction and support of governmental func-
16 tions; grants to the Government of the Virgin Islands, as
17 authorized by law; grants to the Government of Guam,
18 as authorized by law; and grants to the Government of
19 the Northern Mariana Islands, as authorized by law (Pub-
20 lic Law 94–241; 90 Stat. 272); and (2) \$11,822,000 shall
21 be available until September 30, 2027, for salaries and
22 expenses of the Office of Insular Affairs: *Provided*, That
23 all financial transactions of the territorial and local gov-
24 ernments herein provided for, including such transactions
25 of all agencies or instrumentalities established or used by

1 such governments, may be audited by the Government Ac-
2 countability Office, at its discretion, in accordance with
3 chapter 35 of title 31, United States Code: *Provided fur-*
4 *ther*, That Northern Mariana Islands Covenant grant
5 funding shall be provided according to those terms of the
6 Agreement of the Special Representatives on Future
7 United States Financial Assistance for the Northern Mar-
8 iana Islands approved by Public Law 104–134: *Provided*
9 *further*, That the funds for the program of operations and
10 maintenance improvement are appropriated to institu-
11 tionalize routine operations and maintenance improvement
12 of capital infrastructure with territorial participation and
13 cost sharing to be determined by the Secretary based on
14 the grantee’s commitment to timely maintenance of its
15 capital assets: *Provided further*, That any appropriation
16 for disaster assistance under this heading in this Act or
17 previous appropriations Acts may be used as non-Federal
18 matching funds for the purpose of hazard mitigation
19 grants provided pursuant to section 404 of the Robert T.
20 Stafford Disaster Relief and Emergency Assistance Act
21 (42 U.S.C. 5170c).

22 COMPACT OF FREE ASSOCIATION

23 For grants and necessary expenses, \$813,000, to re-
24 main available until expended, to support Federal services
25 and programs provided to the Republic of Palau, the Re-

1 public of the Marshall Islands, and the Federated States
2 of Micronesia.

3 ADMINISTRATIVE PROVISIONS

4 (INCLUDING TRANSFER OF FUNDS)

5 At the request of the Governor of Guam, the Sec-
6 retary may transfer discretionary funds or mandatory
7 funds provided under section 104(e) of Public Law 108-
8 188 and Public Law 104-134, that are allocated for
9 Guam, to the Secretary of Agriculture for the subsidy cost
10 of direct or guaranteed loans, plus not to exceed three per-
11 cent of the amount of the subsidy transferred for the cost
12 of loan administration, for the purposes authorized by the
13 Rural Electrification Act of 1936 and section 306(a)(1)
14 of the Consolidated Farm and Rural Development Act for
15 construction and repair projects in Guam, and such funds
16 shall remain available until expended: *Provided*, That such
17 costs, including the cost of modifying such loans, shall be
18 as defined in section 502 of the Congressional Budget Act
19 of 1974: *Provided further*, That such loans or loan guaran-
20 tees may be made without regard to the population of the
21 area, credit elsewhere requirements, and restrictions on
22 the types of eligible entities under the Rural Electrifica-
23 tion Act of 1936 and section 306(a)(1) of the Consolidated
24 Farm and Rural Development Act: *Provided further*, That
25 any funds transferred to the Secretary of Agriculture shall

1 be in addition to funds otherwise made available to make
2 or guarantee loans under such authorities.

3 OFFICE OF THE SOLICITOR

4 SALARIES AND EXPENSES

5 For necessary expenses of the Office of the Solicitor,
6 \$84,181,000, to remain available until September 30,
7 2027.

8 OFFICE OF INSPECTOR GENERAL

9 SALARIES AND EXPENSES

10 For necessary expenses of the Office of Inspector
11 General, \$65,000,000.

12 DEPARTMENT-WIDE PROGRAMS

13 WILDLAND FIRE MANAGEMENT

14 (INCLUDING TRANSFERS OF FUNDS)

15 For necessary expenses for fire preparedness, fire
16 suppression operations, fire science and research, emer-
17 gency rehabilitation, fuels management activities, and
18 rural fire assistance by the Department of the Interior,
19 \$1,147,171,000, of which \$383,657,000 shall remain
20 available until expended, of which not to exceed
21 \$10,000,000 shall be for the renovation or construction
22 of fire facilities: *Provided*, That such funds are also avail-
23 able for repayment of advances to other appropriation ac-
24 counts from which funds were previously transferred for
25 such purposes: *Provided further*, That of the funds pro-

1 vided \$214,450,000 is for fuels management activities:
2 *Provided further*, That of the funds provided, \$10,000,000
3 is for burned area rehabilitation: *Provided further*, That
4 persons hired pursuant to 43 U.S.C. 1469 may be fur-
5 nished subsistence and lodging without cost from funds
6 available from this appropriation: *Provided further*, That
7 notwithstanding 42 U.S.C. 1856d, sums received by a bu-
8 reau or office of the Department of the Interior for fire
9 protection rendered pursuant to 42 U.S.C. 1856 et seq.,
10 protection of United States property, may be credited to
11 the appropriation from which funds were expended to pro-
12 vide that protection, and are available without fiscal year
13 limitation: *Provided further*, That using the amounts des-
14 ignated under this title of this Act, the Secretary of the
15 Interior may enter into procurement contracts, grants, or
16 cooperative agreements, for fuels management activities,
17 and for training and monitoring associated with such fuels
18 management activities on Federal land, or on adjacent
19 non-Federal land for activities that benefit resources on
20 Federal land: *Provided further*, That the costs of imple-
21 menting any cooperative agreement between the Federal
22 Government and any non-Federal entity may be shared,
23 as mutually agreed on by the affected parties: *Provided*
24 *further*, That notwithstanding requirements of the Com-
25 petition in Contracting Act, the Secretary, for purposes

1 of fuels management activities, may obtain maximum
2 practicable competition among: (1) local private, non-
3 profit, or cooperative entities; (2) Youth Conservation
4 Corps crews, Public Lands Corps (Public Law 109–154),
5 or related partnerships with State, local, or nonprofit
6 youth groups; (3) small or micro-businesses; or (4) other
7 entities that will hire or train locally a significant percent-
8 age, defined as 50 percent or more, of the project work-
9 force to complete such contracts: *Provided further*, That
10 in implementing this section, the Secretary shall develop
11 written guidance to field units to ensure accountability
12 and consistent application of the authorities provided here-
13 in: *Provided further*, That funds appropriated under this
14 heading may be used to reimburse the United States Fish
15 and Wildlife Service and the National Marine Fisheries
16 Service for the costs of carrying out their responsibilities
17 under the Endangered Species Act of 1973 (16 U.S.C.
18 1531 et seq.) to consult and conference, as required by
19 section 7 of such Act, in connection with wildland fire
20 management activities: *Provided further*, That the Sec-
21 retary of the Interior may use wildland fire appropriations
22 to enter into leases of real property with local govern-
23 ments, at or below fair market value, to construct capital-
24 ized improvements for fire facilities on such leased prop-
25 erties, including but not limited to fire guard stations, re-

1 tardant stations, and other initial attack and fire support
2 facilities, and to make advance payments for any such
3 lease or for construction activity associated with the lease:
4 *Provided further*, That the Secretary of the Interior and
5 the Secretary of Agriculture may authorize the transfer
6 of funds appropriated for wildland fire management, in
7 an aggregate amount not to exceed \$50,000,000 between
8 the Departments when such transfers would facilitate and
9 expedite wildland fire management programs and projects:
10 *Provided further*, That funds provided for wildfire suppres-
11 sion shall be available for support of Federal emergency
12 response actions: *Provided further*, That funds appro-
13 priated under this heading shall be available for assistance
14 to or through the Department of State in connection with
15 forest and rangeland research, technical information, and
16 assistance in foreign countries, and, with the concurrence
17 of the Secretary of State, shall be available to support for-
18 estry, wildland fire management, and related natural re-
19 source activities outside the United States and its terri-
20 tories and possessions, including technical assistance, edu-
21 cation and training, and cooperation with United States
22 and international organizations: *Provided further*, That of
23 the funds provided under this heading, \$383,657,000 shall
24 be available for wildfire suppression operations, and is pro-
25 vided to meet the terms of section 4004(b)(5)(B) of S.

1 Con. Res. 14 (117th Congress), the concurrent resolution
2 on the budget for fiscal year 2022, and to legislation es-
3 tablishing fiscal year 2026 budget enforcement in the
4 House of Representatives.

5 WILDFIRE SUPPRESSION OPERATIONS RESERVE FUND
6 (INCLUDING TRANSFERS OF FUNDS)

7 In addition to the amounts provided under the head-
8 ing “Department of the Interior—Department-Wide Pro-
9 grams—Wildland Fire Management” for wildfire suppres-
10 sion operations, \$370,000,000, to remain available until
11 transferred, is additional new budget authority as speci-
12 fied for purposes of section 4004(b)(5) of S. Con. Res.
13 14 (117th Congress), the concurrent resolution on the
14 budget for fiscal year 2022, and to legislation establishing
15 fiscal year 2026 budget enforcement in the House of Rep-
16 resentatives: *Provided*, That such amounts may be trans-
17 ferred to and merged with amounts made available under
18 the headings “Department of Agriculture—Forest Serv-
19 ice—Wildland Fire Management” and “Department of the
20 Interior—Department-Wide Programs—Wildland Fire
21 Management” for wildfire suppression operations in the
22 fiscal year in which such amounts are transferred: *Pro-
23 vided further*, That amounts may be transferred to the
24 “Wildland Fire Management” accounts in the Department
25 of Agriculture or the Department of the Interior only upon

1 the notification of the House and Senate Committees on
2 Appropriations that all wildfire suppression operations
3 funds appropriated under that heading in this and prior
4 appropriations Acts to the agency to which the funds will
5 be transferred will be obligated within 30 days: *Provided*
6 *further*, That the transfer authority provided under this
7 heading is in addition to any other transfer authority pro-
8 vided by law: *Provided further*, That, in determining
9 whether all wildfire suppression operations funds appro-
10 priated under the heading “Wildland Fire Management”
11 in this and prior appropriations Acts to either the Depart-
12 ment of Agriculture or the Department of the Interior will
13 be obligated within 30 days pursuant to the preceding pro-
14 viso, any funds transferred or permitted to be transferred
15 pursuant to any other transfer authority provided by law
16 shall be excluded.

17 CENTRAL HAZARDOUS MATERIALS FUND

18 For necessary expenses of the Department of the In-
19 terior and any of its component offices and bureaus for
20 the response action, including associated activities, per-
21 formed pursuant to the Comprehensive Environmental Re-
22 sponse, Compensation, and Liability Act (42 U.S.C. 9601
23 et seq.), \$9,031,000, to remain available until expended.

1 ENERGY COMMUNITY REVITALIZATION PROGRAM
2 (INCLUDING TRANSFERS OF FUNDS)

3 For necessary expenses of the Department of the In-
4 terior to inventory, assess, decommission, reclaim, respond
5 to hazardous substance releases, remediate lands pursuant
6 to section 40704 of Public Law 117–58 (30 U.S.C. 1245),
7 and carry out the purposes of section 349 of the Energy
8 Policy Act of 2005 (42 U.S.C. 15907), as amended,
9 \$4,700,000, to remain available until expended: *Provided*,
10 That such amount shall be in addition to amounts other-
11 wise available for such purposes: *Provided further*, That
12 amounts appropriated under this heading are available for
13 program management and oversight of these activities:
14 *Provided further*, That the Secretary may transfer the
15 funds provided under this heading in this Act to any other
16 account in the Department to carry out such purposes,
17 and may expend such funds directly, or through grants:
18 *Provided further*, That these amounts are not available to
19 fulfill Comprehensive Environmental Response, Com-
20 pensation, and Liability Act (42 U.S.C. 9601 et seq.) obli-
21 gations agreed to in settlement or imposed by a court,
22 whether for payment of funds or for work to be performed.

1 the Secretary of the Interior may assess reasonable
2 charges to State, local, and tribal government employees
3 for training services provided by the National Indian Pro-
4 gram Training Center, other than training related to Pub-
5 lic Law 93–638: *Provided further*, That the Secretary may
6 lease or otherwise provide space and related facilities,
7 equipment, or professional services of the National Indian
8 Program Training Center to State, local and tribal govern-
9 ment employees or persons or organizations engaged in
10 cultural, educational, or recreational activities (as defined
11 in section 3306(a) of title 40, United States Code) at the
12 prevailing rate for similar space, facilities, equipment, or
13 services in the vicinity of the National Indian Program
14 Training Center: *Provided further*, That all funds received
15 pursuant to the two preceding provisos shall be credited
16 to this account, shall be available until expended, and shall
17 be used by the Secretary for necessary expenses of the
18 National Indian Program Training Center: *Provided fur-*
19 *ther*, That the Secretary may enter into grants and cooper-
20 ative agreements to support the Office of Natural Re-
21 source Revenue’s collection and disbursement of royalties,
22 fees, and other mineral revenue proceeds, as authorized
23 by law.

1 ADMINISTRATIVE PROVISION

2 There is hereby authorized for acquisition from avail-
3 able resources within the Working Capital Fund, aircraft
4 which may be obtained by donation, purchase, or through
5 available excess surplus property: *Provided*, That existing
6 aircraft being replaced may be sold, with proceeds derived
7 or trade-in value used to offset the purchase price for the
8 replacement aircraft.

9 OFFICE OF NATURAL RESOURCES REVENUE

10 For necessary expenses for management of the collec-
11 tion and disbursement of royalties, fees, and other mineral
12 revenue proceeds, and for grants and cooperative agree-
13 ments, as authorized by law, \$159,850,000, to remain
14 available until September 30, 2027; of which \$55,916,000
15 shall remain available until expended for the purpose of
16 mineral revenue management activities: *Provided*, That
17 notwithstanding any other provision of law, \$50,000 shall
18 be available for refunds of overpayments in connection
19 with certain Indian leases in which the Secretary of the
20 Interior concurred with the claimed refund due, to pay
21 amounts owed to Indian allottees or tribes, or to correct
22 prior unrecoverable erroneous payments.

1 GENERAL PROVISIONS, DEPARTMENT OF THE INTERIOR
2 (INCLUDING TRANSFERS OF FUNDS)

3 EMERGENCY TRANSFER AUTHORITY—INTRA-BUREAU

4 SEC. 101. Appropriations made in this title shall be
5 available for expenditure or transfer (within each bureau
6 or office), with the approval of the Secretary of the Inte-
7 rior, for the emergency reconstruction, replacement, or re-
8 pair of aircraft, buildings, utilities, or other facilities or
9 equipment damaged or destroyed by fire, flood, storm, or
10 other unavoidable causes: *Provided*, That no funds shall
11 be made available under this authority until funds specifi-
12 cally made available to the Department of the Interior for
13 emergencies shall have been exhausted: *Provided further*,
14 That all funds used pursuant to this section must be re-
15 plenished by a supplemental appropriation, which must be
16 requested as promptly as possible.

17 EMERGENCY TRANSFER AUTHORITY—DEPARTMENT-WIDE

18 SEC. 102. The Secretary of the Interior may author-
19 ize the expenditure or transfer of any no year appropria-
20 tion in this title, in addition to the amounts included in
21 the budget programs of the several agencies, for the sup-
22 pression or emergency prevention of wildland fires on or
23 threatening lands under the jurisdiction of the Depart-
24 ment of the Interior; for the emergency rehabilitation of
25 burned-over lands under its jurisdiction; for emergency ac-

1 tions related to potential or actual earthquakes, floods,
2 volcanoes, storms, or other unavoidable causes; for contin-
3 gency planning subsequent to actual oil spills; for response
4 and natural resource damage assessment activities related
5 to actual oil spills or releases of hazardous substances into
6 the environment; for the prevention, suppression, and con-
7 trol of actual or potential grasshopper and Mormon cricket
8 outbreaks on lands under the jurisdiction of the Secretary,
9 pursuant to the authority in section 417(b) of Public Law
10 106–224 (7 U.S.C. 7717(b)); for emergency reclamation
11 projects under section 410 of Public Law 95–87; and shall
12 transfer, from any no year funds available to the Office
13 of Surface Mining Reclamation and Enforcement, such
14 funds as may be necessary to permit assumption of regu-
15 latory authority in the event a primacy State is not car-
16 rying out the regulatory provisions of the Surface Mining
17 Act: *Provided*, That appropriations made in this title for
18 wildland fire operations shall be available for the payment
19 of obligations incurred during the preceding fiscal year,
20 and for reimbursement to other Federal agencies for de-
21 struction of vehicles, aircraft, or other equipment in con-
22 nection with their use for wildland fire operations, with
23 such reimbursement to be credited to appropriations cur-
24 rently available at the time of receipt thereof: *Provided*
25 *further*, That for wildland fire operations, no funds shall

1 be made available under this authority until the Secretary
2 determines that funds appropriated for “wildland fire sup-
3 pression” shall be exhausted within 30 days: *Provided fur-*
4 *ther*, That all funds used pursuant to this section must
5 be replenished by a supplemental appropriation, which
6 must be requested as promptly as possible: *Provided fur-*
7 *ther*, That such replenishment funds shall be used to reim-
8 burse, on a pro rata basis, accounts from which emergency
9 funds were transferred.

10 AUTHORIZED USE OF FUNDS

11 SEC. 103. Appropriations made to the Department
12 of the Interior in this title shall be available for services
13 as authorized by section 3109 of title 5, United States
14 Code, when authorized by the Secretary of the Interior,
15 in total amount not to exceed \$500,000; purchase and re-
16 placement of motor vehicles, including specially equipped
17 law enforcement vehicles; hire, maintenance, and oper-
18 ation of aircraft; hire of passenger motor vehicles; pur-
19 chase of reprints; payment for telephone service in private
20 residences in the field, when authorized under regulations
21 approved by the Secretary; and the payment of dues, when
22 authorized by the Secretary, for library membership in so-
23 cieties or associations which issue publications to members
24 only or at a price to members lower than to subscribers
25 who are not members.

1 AUTHORIZED USE OF FUNDS, INDIAN TRUST

2 MANAGEMENT

3 SEC. 104. Appropriations made in this Act under the
4 headings Bureau of Indian Affairs and Bureau of Indian
5 Education, and Bureau of Trust Funds Administration
6 and any unobligated balances from prior appropriations
7 Acts made under the same headings shall be available for
8 expenditure or transfer for Indian trust management and
9 reform activities. Total funding for settlement support ac-
10 tivities shall not exceed amounts specifically designated in
11 this Act for such purpose. The Secretary shall notify the
12 House and Senate Committees on Appropriations within
13 60 days of the expenditure or transfer of any funds under
14 this section, including the amount expended or transferred
15 and how the funds will be used.

16 REDISTRIBUTION OF FUNDS, BUREAU OF INDIAN

17 AFFAIRS

18 SEC. 105. Notwithstanding any other provision of
19 law, the Secretary of the Interior is authorized to redis-
20 tribute any Tribal Priority Allocation funds, including
21 tribal base funds, to alleviate tribal funding inequities by
22 transferring funds to address identified, unmet needs,
23 dual enrollment, overlapping service areas or inaccurate
24 distribution methodologies. No tribe shall receive a reduc-
25 tion in Tribal Priority Allocation funds of more than 10

1 percent in fiscal year 2026. Under circumstances of dual
2 enrollment, overlapping service areas or inaccurate dis-
3 tribution methodologies, the 10 percent limitation does not
4 apply.

5 ELLIS, GOVERNORS, AND LIBERTY ISLANDS

6 SEC. 106. Notwithstanding any other provision of
7 law, the Secretary of the Interior is authorized to acquire
8 lands, waters, or interests therein, including the use of all
9 or part of any pier, dock, or landing within the State of
10 New York and the State of New Jersey, for the purpose
11 of operating and maintaining facilities in the support of
12 transportation and accommodation of visitors to Ellis,
13 Governors, and Liberty Islands, and of other program and
14 administrative activities, by donation or with appropriated
15 funds, including franchise fees (and other monetary con-
16 sideration), or by exchange; and the Secretary is author-
17 ized to negotiate and enter into leases, subleases, conces-
18 sion contracts, or other agreements for the use of such
19 facilities on such terms and conditions as the Secretary
20 may determine reasonable: *Provided*, That for purposes of
21 54 U.S.C. 200306(a), such lands, waters, or interests ac-
22 quired under this heading shall be considered to be within
23 the exterior boundary of a System unit authorized or es-
24 tablished.

1 OUTER CONTINENTAL SHELF INSPECTION FEES

2 SEC. 107. (a) In fiscal year 2026, the Secretary of
3 the Interior shall collect a nonrefundable inspection fee,
4 which shall be deposited in the “Offshore Safety and Envi-
5 ronmental Enforcement” account, from the designated op-
6 erator for facilities subject to inspection under 43 U.S.C.
7 1348(c).

8 (b) Annual fees shall be collected for facilities that
9 are above the waterline, excluding drilling rigs, and are
10 in place at the start of the fiscal year. Fees for fiscal year
11 2026 shall be—

12 (1) \$10,500 for facilities with no wells, but with
13 processing equipment or gathering lines;

14 (2) \$17,000 for facilities with 1 to 10 wells,
15 with any combination of active or inactive wells; and

16 (3) \$31,500 for facilities with more than 10
17 wells, with any combination of active or inactive
18 wells.

19 (c) Fees for drilling rigs shall be assessed for all in-
20 spections completed in fiscal year 2026. Fees for fiscal
21 year 2026 shall be—

22 (1) \$30,500 per inspection for rigs operating in
23 water depths of 500 feet or more; and

24 (2) \$16,700 per inspection for rigs operating in
25 water depths of less than 500 feet.

1 (d) Fees for inspection of well operations conducted
2 via non-rig units as outlined in title 30 CFR 250 subparts
3 D, E, F, and Q shall be assessed for all inspections com-
4 pleted in fiscal year 2026. Fees for fiscal year 2026 shall
5 be—

6 (1) \$13,260 per inspection for non-rig units op-
7 erating in water depths of 2,500 feet or more;

8 (2) \$11,530 per inspection for non-rig units op-
9 erating in water depths between 500 and 2,499 feet;
10 and

11 (3) \$4,470 per inspection for non-rig units op-
12 erating in water depths of less than 500 feet.

13 (e) The Secretary shall bill designated operators
14 under subsection (b) quarterly, with payment required
15 within 30 days of billing. The Secretary shall bill des-
16 igned operators under subsection (c) within 30 days of
17 the end of the month in which the inspection occurred,
18 with payment required within 30 days of billing. The Sec-
19 retary shall bill designated operators under subsection (d)
20 with payment required by the end of the following quarter.

21 CONTRACTS AND AGREEMENTS FOR WILD HORSE AND

22 BURRO HOLDING FACILITIES

23 SEC. 108. Notwithstanding any other provision of
24 this Act, the Secretary of the Interior may enter into
25 multiyear cooperative agreements with nonprofit organiza-

1 such entities, except that total obligations at the end of
2 the fiscal year shall not exceed total budgetary resources
3 available at the end of the fiscal year.

4 DEPARTMENT OF THE INTERIOR EXPERIENCED SERVICES
5 PROGRAM

6 SEC. 111. (a) Notwithstanding any other provision
7 of law relating to Federal grants and cooperative agree-
8 ments, the Secretary of the Interior is authorized to make
9 grants to, or enter into cooperative agreements with, pri-
10 vate nonprofit organizations designated by the Secretary
11 of Labor under title V of the Older Americans Act of 1965
12 to utilize the talents of older Americans in programs au-
13 thorized by other provisions of law administered by the
14 Secretary and consistent with such provisions of law.

15 (b) Prior to awarding any grant or agreement under
16 subsection (a), the Secretary shall ensure that the agree-
17 ment would not—

18 (1) result in the displacement of individuals
19 currently employed by the Department, including
20 partial displacement through reduction of non-over-
21 time hours, wages, or employment benefits;

22 (2) result in the use of an individual under the
23 Department of the Interior Experienced Services
24 Program for a job or function in a case in which a
25 Federal employee is in a layoff status from the same

1 or substantially equivalent job within the Depart-
2 ment; or

3 (3) affect existing contracts for services.

4 OBLIGATION OF FUNDS

5 SEC. 112. Amounts appropriated by this Act to the
6 Department of the Interior shall be available for obligation
7 and expenditure not later than 60 days after the date of
8 enactment of this Act.

9 SEPARATION OF ACCOUNTS

10 SEC. 113. The Secretary of the Interior, in order to
11 implement an orderly transition to separate accounts of
12 the Bureau of Indian Affairs and the Bureau of Indian
13 Education, may transfer funds among and between the
14 successor offices and bureaus affected by the reorganiza-
15 tion only in conformance with the reprogramming guide-
16 lines described in this Act.

17 PAYMENTS IN LIEU OF TAXES (PILT)

18 SEC. 114. Section 6906 of title 31, United States
19 Code, shall be applied by substituting “fiscal year 2026”
20 for “fiscal year 2019”.

21 DISCLOSURE OF DEPARTURE OR ALTERNATE PROCEDURE

22 APPROVAL

23 SEC. 115. (a) Subject to subsection (b), in any case
24 in which the Bureau of Safety and Environmental En-
25 forcement or the Bureau of Ocean Energy Management

1 prescribes or approves any departure or use of alternate
2 procedure or equipment, in regards to a plan or permit,
3 under 30 CFR 585.103; 30 CFR 550.141; 30 CFR
4 550.142; 30 CFR 250.141; or 30 CFR 250.142, the head
5 of such bureau shall post a description of such departure
6 or alternate procedure or equipment use approval on such
7 bureau's publicly available website not more than 15 busi-
8 ness days after such issuance.

9 (b) The head of each bureau may exclude confidential
10 business information.

11 LONG BRIDGE PROJECT

12 SEC. 116. (a) AUTHORIZATION OF CONVEYANCE.—
13 Hereafter, until the expiration of authority pursuant to
14 subsection (e), on request by the State of Virginia or the
15 District of Columbia for the purpose of the construction
16 of rail and other infrastructure relating to the Long
17 Bridge Project, the Secretary of the Interior may convey
18 to the State or the District of Columbia, as applicable,
19 all right, title, and interest of the United States in and
20 to any portion of the approximately 4.4 acres of National
21 Park Service land depicted as “Permanent Impact to NPS
22 Land” on the Map dated May 15, 2020, that is identified
23 by the State or the District of Columbia.

24 (b) TERMS AND CONDITIONS.—Such conveyance of
25 the National Park Service land under subsection (a) shall

1 be subject to any terms and conditions that the Secretary
2 may require. If such conveyed land is no longer being used
3 for the purposes specified in this section, the lands or in-
4 terests therein shall revert to the National Park Service
5 after they have been restored or remediated to the satis-
6 faction of the Secretary.

7 (c) CORRECTIONS.—The Secretary and the State or
8 the District of Columbia, as applicable, by mutual agree-
9 ment, may—

10 (1) make minor boundary adjustments to the
11 National Park Service land to be conveyed to the
12 State or the District of Columbia under subsection
13 (a); and

14 (2) correct any minor errors in the Map re-
15 ferred to in subsection (a).

16 (d) DEFINITIONS.—For purposes of this section:

17 (1) LONG BRIDGE PROJECT.—The term “Long
18 Bridge Project” means the rail project, as identified
19 by the Federal Railroad Administration, from
20 Rosslyn (RO) Interlocking in Arlington, Virginia, to
21 L’Enfant (LE) Interlocking in Washington, DC,
22 which includes a bicycle and pedestrian bridge.

23 (2) SECRETARY.—The term “Secretary” means
24 the Secretary of the Interior, acting through the Di-
25 rector of the National Park Service.

1 (3) STATE.—The term “State” means the State
2 of Virginia.

3 (e) TERMINATION OF AUTHORITY.—The authority
4 provided by this section shall expire once the conveyance
5 described in subsection (a) has been completed.

6 INTERAGENCY MOTOR POOL

7 SEC. 117. Notwithstanding any other provision of law
8 or Federal regulation, federally recognized Indian tribes
9 or authorized tribal organizations that receive Tribally-
10 Controlled School Grants pursuant to Public Law 100-
11 297 may obtain interagency motor vehicles and related
12 services for performance of any activities carried out
13 under such grants to the same extent as if they were con-
14 tracting under the Indian Self-Determination and Edu-
15 cation Assistance Act.

16 APPRAISER PAY AUTHORITY

17 SEC. 118. For fiscal year 2026, funds made available
18 in this or any other Act or otherwise made available to
19 the Department of the Interior for the Appraisal and
20 Valuation Services Office may be used by the Secretary
21 of the Interior to establish higher minimum rates of basic
22 pay for employees of the Department of the Interior in
23 the Appraiser (GS-1171) job series at grades 11 through
24 15 carrying out appraisals of real property and appraisal
25 reviews conducted in support of the Department’s realty

1 programs at rates no greater than 15 percent above the
2 minimum rates of basic pay normally scheduled, and such
3 higher rates shall be consistent with subsections (e)
4 through (h) of section 5305 of title 5, United States Code.

5 SAGE-GROUSE

6 SEC. 119. None of the funds made available by this
7 or any other Act may be used by the Secretary of the Inte-
8 rior to write or issue pursuant to section 4 of the Endan-
9 gered Species Act of 1973 (16 U.S.C. 1533)—

10 (1) a proposed rule for greater sage-grouse
11 (*Centrocercus urophasianus*);

12 (2) a proposed rule for the Columbia basin dis-
13 tinct population segment of greater sage-grouse.

14 STATE CONSERVATION GRANTS

15 SEC. 120. For expenses necessary to carry out section
16 200305 of title 54, United States Code, the National Park
17 Service may retain up to 7 percent of the State Conserva-
18 tion Grants program to provide to States, the District of
19 Columbia, and insular areas, as matching grants to sup-
20 port state program administrative costs.

21 HISTORIC PRESERVATION FUND DEPOSITS

22 SEC. 121. Section 303102 of title 54, United States
23 Code, shall be applied by substituting “fiscal year 2026”
24 for “fiscal year 2023”.

1 INTERIOR AUTHORITY FOR OPERATING EFFICIENCIES

2 SEC. 122. (a) In fiscal years 2026 and 2027, the Sec-
3 retary of the Interior may authorize and execute agree-
4 ments to achieve operating efficiencies among and between
5 two or more component bureaus and offices through the
6 following activities:

7 (1) co-locating in offices and facilities leased or
8 owned by any such component and sharing related
9 utilities and equipment;

10 (2) detailing or assigning staff on a non-reim-
11 bursable basis for up to 5 business days; and

12 (3) sharing staff and equipment necessary to
13 meet mission requirements.

14 (b) The authority provided by subsection (a) is to
15 support areas of mission alignment between and among
16 component bureaus and offices or where geographic prox-
17 imity allows for efficiencies.

18 (c) Bureaus and offices entering into agreements au-
19 thorized under subsections (a)(1) and (a)(3) shall bear
20 costs for such agreements in a manner that reflects their
21 approximate benefit and share of total costs, which may
22 or may not include indirect costs.

23 (d) In furtherance of the requirement in subsection
24 (c), the Secretary of the Interior may make transfers of
25 funds in advance or on a reimbursable basis.

1 EMERGENCY LAW ENFORCEMENT CEILING

2 SEC. 123. Section 103101 of title 54, United States
3 Code, is amended in subsection (c)(1) by striking
4 “\$250,000” and inserting “\$500,000”.

5 CONTRIBUTION AUTHORITY EXTENSION

6 SEC. 124. Section 113 of division G of Public Law
7 113–76, as amended by Public Law 116–6, is further
8 amended by striking “2024” and inserting “2030”.

9 LIMITATION

10 SEC. 125. If requested by the claimant of any mining
11 claim located within the area covered by Public Land
12 Order 7921, the Bureau of Land Management shall
13 prioritize completion of a validity determination for such
14 claim. The Bureau of Land Management shall strive to
15 complete any such validity determination not later than
16 3 years of receipt of the request.

17 RENEWAL

18 SEC. 126. The first section of Public Law 99–338
19 (100 Stat. 641) is amended—

20 (1) by striking “3 renewals” and inserting “7
21 renewals”; and

22 (2) by striking “of Southern California Edison
23 Company”.

1 FIELD UNIT LOCAL HIRING

2 SEC. 127. The Secretary of the Interior may recruit
3 and directly appoint qualified individuals into the competi-
4 tive service who are certified as maintaining a permanent
5 and exclusive residence in the vicinity of a field unit, into

13 section 5033 of the Water Infrastructure Finance and In-
14 novation Act of 2014, \$7,640,000, to remain available
15 until September 30, 2027.

16 ADMINISTRATIVE PROVISIONS—ENVIRONMENTAL
17 PROTECTION AGENCY
18 (INCLUDING TRANSFERS OF FUNDS)

19 For fiscal year 2026, notwithstanding 31 U.S.C.
20 6303(1) and 6305(1), the Administrator of the Environ-
21 mental Protection Agency, in carrying out the Agency's
22 function to implement directly Federal environmental pro-
23 grams required or authorized by law in the absence of an
24 acceptable tribal program, may award cooperative agree-
25 ments to federally recognized Indian tribes or Intertribal

1 consortia, if authorized by their member tribes, to assist
2 the Administrator in implementing Federal environmental
3 programs for Indian tribes required or authorized by law,
4 except that no such cooperative agreements may be award-
5 ed from funds designated for State financial assistance
6 agreements.

7 The Administrator of the Environmental Protection
8 Agency is authorized to collect and obligate pesticide reg-
9 istration service fees in accordance with section 33 of the
10 Federal Insecticide, Fungicide, and Rodenticide Act (7
11 U.S.C. 136w-8), to remain available until expended.

12 Notwithstanding section 33(d)(2) of the Federal In-
13 secticide, Fungicide, and Rodenticide Act (FIFRA) (7
14 U.S.C. 136w-8(d)(2)), the Administrator of the Environ-
15 mental Protection Agency may assess fees under section
16 33 of FIFRA (7 U.S.C. 136w-8) for fiscal year 2026.

17 The Administrator of the Environmental Protection
18 Agency is authorized to collect and obligate fees in accord-
19 ance with section 3024 of the Solid Waste Disposal Act
20 (42 U.S.C. 6939g) for fiscal year 2026, to remain avail-
21 able until expended.

22 The Administrator is authorized to transfer up to
23 \$369,000,000 of the funds appropriated for the Great
24 Lakes Restoration Initiative under the heading “Environ-
25 mental Programs and Management” to the head of any

1 Federal department or agency, with the concurrence of
2 such head, to carry out activities that would support the
3 Great Lakes Restoration Initiative and Great Lakes
4 Water Quality Agreement programs, projects, or activities;
5 to enter into an interagency agreement with the head of
6 such Federal department or agency to carry out these ac-
7 tivities; and to make grants to governmental entities, non-
8 profit organizations, institutions, and individuals for plan-
9 ning, research, monitoring, outreach, and implementation
10 in furtherance of the Great Lakes Restoration Initiative
11 and the Great Lakes Water Quality Agreement.

12 The Science and Technology, Environmental Pro-
13 grams and Management, Office of Inspector General, Haz-
14 ardous Substance Superfund, and Leaking Underground
15 Storage Tank Trust Fund Program Accounts, are avail-
16 able for the construction, alteration, repair, rehabilitation,
17 and renovation of facilities, provided that the cost does
18 not exceed \$300,000 per project.

19 For fiscal year 2026, and notwithstanding section
20 518(f) of the Federal Water Pollution Control Act (33
21 U.S.C. 1377(f)), the Administrator is authorized to use
22 the amounts appropriated for any fiscal year under section
23 319 of the Act to make grants to Indian tribes pursuant
24 to sections 319(h) and 518(e) of that Act.

1 The Administrator is authorized to use the amounts
2 appropriated under the heading “Environmental Pro-
3 grams and Management” for fiscal year 2026 to provide
4 grants to implement the Southeast New England Water-
5 shed Restoration Program.

6 Notwithstanding the limitations on amounts in sec-
7 tion 320(i)(2)(B) of the Federal Water Pollution Control
8 Act, not less than \$2,500,000 of the funds made available
9 under this title for the National Estuary Program shall
10 be for making competitive awards described in section
11 320(g)(4).

12 For fiscal year 2026, the Office of Chemical Safety
13 and Pollution Prevention and the Office of Water may,
14 using funds appropriated under the headings “Environ-
15 mental Programs and Management” and “Science and
16 Technology”, contract directly with individuals or indi-
17 rectly with institutions or nonprofit organizations, without
18 regard to 41 U.S.C. 5, for the temporary or intermittent
19 personal services of students or recent graduates, who
20 shall be considered employees for the purposes of chapters
21 57 and 81 of title 5, United States Code, relating to com-
22 pensation for travel and work injuries, and chapter 171
23 of title 28, United States Code, relating to tort claims,
24 but shall not be considered to be Federal employees for
25 any other purpose: *Provided*, That amounts used for this

1 purpose by the Office of Chemical Safety and Pollution
2 Prevention and the Office of Water collectively may not
3 exceed \$2,000,000.

4 In this fiscal year and each fiscal year through 2031,
5 the Administrator may, after consultation with the Office
6 of Personnel Management, employ up to 100 persons at
7 any one time at the Environmental Protection Agency pur-
8 suant to the authority provided in 42 U.S.C. 209.

9 The Environmental Protection Agency shall maintain
10 staffing levels in order to fulfill the mission and statutory
11 obligations of the agency, including Section 2(f) of the En-
12 vironmental Research, Development, and Demonstration
13 Authorization Act of 1981 (42 U.S.C. 4363).

14 The Environmental Protection agency shall provide
15 the Committees on Appropriations of the House of Rep-
16 resentatives and Senate with copies of any available De-
17 partment of Treasury quarterly certification of trust fund
18 receipts collected from section 13601 of Public Law 117-
19 169 and section 80201 of Public Law 117-58, an annual
20 operating plan for such receipts showing amounts allo-
21 cated by program area and program project, and quarterly
22 reports for such receipts of obligated balances by program
23 area and program project.

6 For necessary expenses of the Office of the Under
7 Secretary for Natural Resources and Environment,
8 \$780,000: *Provided*, That funds made available by this
9 Act to any agency in the Natural Resources and Environ-
10 ment mission area for salaries and expenses are available
11 to fund up to one administrative support staff for the of-
12 fice.

13 FOREST SERVICE
14 FOREST SERVICE OPERATIONS
15 (INCLUDING TRANSFERS OF FUNDS)

16 For necessary expenses of the Forest Service, not
17 otherwise provided for, \$1,090,600,000, of which
18 \$944,114,000 shall remain available through September
19 30, 2029: *Provided*, That a portion of the funds made
20 available under this heading shall be for the base salary
21 and expenses of employees in the Chief's Office, the Work
22 Environment and Performance Office, the Business Oper-
23 ations Deputy Area, and the Chief Financial Officer's Of-
24 fice to carry out administrative and general management
25 support functions: *Provided further*, That funds provided

1 under this heading shall be available for the costs of facil-
2 ity maintenance, repairs, and leases for buildings and sites
3 where these administrative, general management and
4 other Forest Service support functions take place; the
5 costs of all utility and telecommunication expenses of the
6 Forest Service, as well as business services; and, for infor-
7 mation technology, including cybersecurity requirements:
8 *Provided further*, That funds provided under this heading
9 may be used for necessary expenses to carry out adminis-
10 trative and general management support functions of the
11 Forest Service not otherwise provided for and necessary
12 for its operation.

13 FOREST AND RANGELAND RESEARCH

14 For necessary expenses of forest and rangeland re-
15 search as authorized by law, \$308,697,000, to remain
16 available through September 30, 2029: *Provided*, That of
17 the funds provided, \$32,197,000 is for the forest inventory
18 and analysis program: *Provided further*, That all authori-
19 ties for the use of funds, including the use of contracts,
20 grants, and cooperative agreements, available to execute
21 amounts made available under this heading, are also avail-
22 able in the utilization of funds for Fire Science Research.

23 STATE, PRIVATE, AND TRIBAL FORESTRY

24 For necessary expenses of cooperating with and pro-
25 viding technical and financial assistance to States, terri-

1 tories, possessions, tribes, and others, and for forest
2 health management, including for invasive plants, and
3 conducting an international program and trade compliance
4 activities as authorized, \$310,594,000, to remain available
5 through September 30, 2029, as authorized by law, of
6 which \$18,094,000 shall be for projects specified for For-
7 est Resource Information and Analysis in the table titled
8 “Interior and Environment Incorporation of Community
9 Project Funding Items/Congressionally Directed Spending
10 Items” included for this division in the explanatory state-
11 ment described in section 4 (in the matter preceding divi-
12 sion A of this consolidated Act).

13 NATIONAL FOREST SYSTEM

14 For necessary expenses of the Forest Service, not
15 otherwise provided for, for management, protection, im-
16 provement, and utilization of the National Forest System,
17 and for hazardous fuels management on or adjacent to
18 such lands, \$1,857,843,000, to remain available through
19 September 30, 2029: *Provided*, That of the funds pro-
20 vided, \$31,000,000 shall be deposited in the Collaborative
21 Forest Landscape Restoration Fund for ecological restora-
22 tion treatments as authorized by 16 U.S.C. 7303(f): *Pro-*
23 *vided further*, That for the funds provided in the preceding
24 proviso, section 4003(d)(3)(A) of the Omnibus Public
25 Land Management Act of 2009 (16 U.S.C.

1 7303(d)(3)(A)) shall be applied by substituting “20” for
2 “10” and section 4003(d)(3)(B) of the Omnibus Public
3 Land Management Act of 2009 (16 U.S.C.
4 7303(d)(3)(B)) shall be applied by substituting “4” for
5 “2”: *Provided further*, That of the funds provided,
6 \$39,000,000 shall be for forest products: *Provided further*,
7 That of the funds provided, \$176,850,000 shall be for haz-
8 ardous fuels management activities, of which not to exceed
9 \$30,000,000 may be used to make grants, using any au-
10 thorities available to the Forest Service under the “State,
11 Private, and Tribal Forestry” appropriation, for the pur-
12 pose of creating incentives for increased use of biomass

5 part of the transportation system; and for maintenance
6 of forest roads and trails by the Forest Service as author-
7 ized by 16 U.S.C. 532–538 and 23 U.S.C. 101 and 205:
8 *Provided*, That \$6,000,000 shall be for activities author-
9 ized by 16 U.S.C. 538(a): *Provided further*, That
10 \$20,850,000 shall be for projects specified for Construc-
11 tion Projects in the table titled “Interior and Environment
12 Incorporation of Community Project Funding Items/Con-
13 gressionally Directed Spending Items” included for this
14 division in the explanatory statement described in section
15 4 (in the matter preceding division A of this consolidated
16 Act): *Provided further*, That funds becoming available in
17 fiscal year 2026 under the Act of March 4, 1913 (16
18 U.S.C. 501) shall be transferred to the General Fund of
19 the Treasury and shall not be available for transfer or obli-
20 gation for any other purpose unless the funds are appro-
21 priated.

11 For necessary expenses of the Forest Service to man-
12 age Federal lands in Alaska for subsistence uses under
13 title VIII of the Alaska National Interest Lands Conserva-
14 tion Act (16 U.S.C. 3111 et seq.), \$1,099,000, to remain
15 available through September 30, 2029.

16 WILDLAND FIRE MANAGEMENT
17 (INCLUDING TRANSFERS OF FUNDS)

18 For necessary expenses for forest fire presuppression
19 activities on National Forest System lands, for emergency
20 wildland fire suppression on or adjacent to such lands or
21 other lands under fire protection agreement, and for emer-
22 gency rehabilitation of burned-over National Forest Sys-
23 tem lands and water, \$2,426,111,000, to remain available
24 until expended: *Provided*, That such funds, including un-
25 obligated balances under this heading, are available for re-

1 payment of advances from other appropriations accounts
2 previously transferred for such purposes: *Provided further,*
3 That any unobligated funds appropriated in a previous fis-
4 cal year for hazardous fuels management may be trans-
5 ferred to the “National Forest System” account: *Provided*
6 *further,* That such funds shall be available to reimburse
7 State and other cooperating entities for services provided
8 in response to wildfire and other emergencies or disasters

6 ations, \$2,480,000,000, to remain available until trans-
7 ferred, is additional new budget authority as specified for
8 purposes of section 4004(b)(5) of S. Con. Res. 14 (117th
9 Congress), the concurrent resolution on the budget for fis-
10 cal year 2022, and to legislation establishing fiscal year
11 2026 budget enforcement in the House of Representatives:
12 *Provided*, That such amounts may be transferred to and
13 merged with amounts made available under the headings
14 “Department of the Interior—Department-Wide Pro-
15 grams—Wildland Fire Management” and “Department of
16 Agriculture—Forest Service—Wildland Fire Manage-
17 ment” for wildfire suppression operations in the fiscal year
18 in which such amounts are transferred: *Provided further*,
19 That amounts may be transferred to the “Wildland Fire
20 Management” accounts in the Department of the Interior
21 or the Department of Agriculture only upon the notifica-
22 tion of the House and Senate Committees on Appropria-
23 tions that all wildfire suppression operations funds appro-
24 priated under that heading in this and prior appropria-
25 tions Acts to the agency to which the funds will be trans-

1 ferred will be obligated within 30 days: *Provided further*,
2 That the transfer authority provided under this heading
3 is in addition to any other transfer authority provided by
4 law: *Provided further*, That, in determining whether all
5 wildfire suppression operations funds appropriated under
6 the heading “Wildland Fire Management” in this and
7 prior appropriations Acts to either the Department of Ag-
8 riculture or the Department of the Interior will be obli-
9 gated within 30 days pursuant to the preceding proviso,
10 any funds transferred or permitted to be transferred pur-
11 suant to any other transfer authority provided by law shall
12 be excluded.

13 COMMUNICATIONS SITE ADMINISTRATION

14 (INCLUDING TRANSFER OF FUNDS)

15 Amounts collected in this fiscal year pursuant to sec-
16 tion 8705(f)(2) of the Agriculture Improvement Act of
17 2018 (Public Law 115–334), shall be deposited in the spe-
18 cial account established by section 8705(f)(1) of such Act,
19 shall be available to cover the costs described in subsection
20 (c)(3) of such section of such Act, and shall remain avail-
21 able until expended: *Provided*, That such amounts shall
22 be transferred to the “National Forest System” account.

1 ADMINISTRATIVE PROVISIONS—FOREST SERVICE

2 (INCLUDING TRANSFERS OF FUNDS)

3 Appropriations to the Forest Service for the current
4 fiscal year shall be available for: (1) purchase of passenger
5 motor vehicles; acquisition of passenger motor vehicles
6 from excess sources, and hire of such vehicles; purchase,
7 lease, operation, maintenance, and acquisition of aircraft
8 to maintain the operable fleet for use in Forest Service
9 wildland fire programs and other Forest Service programs;
10 notwithstanding other provisions of law, existing aircraft
11 being replaced may be sold, with proceeds derived or
12 trade-in value used to offset the purchase price for the
13 replacement aircraft; (2) services pursuant to 7 U.S.C.
14 2225, and not to exceed \$100,000 for employment under
15 5 U.S.C. 3109; (3) purchase, erection, and alteration of
16 buildings and other public improvements (7 U.S.C. 2250);
17 (4) acquisition of land, waters, and interests therein pur-
18 suant to 7 U.S.C. 428a; (5) for expenses pursuant to the
19 Volunteers in the National Forest Act of 1972 (16 U.S.C.
20 558a, 558d, and 558a note); (6) the cost of uniforms as
21 authorized by 5 U.S.C. 5901–5902; and (7) for debt col-
22 lection contracts in accordance with 31 U.S.C. 3718(c).

23 Funds made available to the Forest Service in this
24 Act may be transferred between accounts affected by the
25 Forest Service budget restructure outlined in section 435

1 of division D of the Further Consolidated Appropriations
2 Act, 2020 (Public Law 116–94): *Provided*, That any
3 transfer of funds pursuant to this paragraph shall not in-
4 crease or decrease the funds appropriated to any account
5 in this fiscal year by more than ten percent: *Provided fur-*
6 *ther*, That such transfer authority is in addition to any
7 other transfer authority provided by law.

8 Any appropriations or funds available to the Forest
9 Service may be transferred to the Wildland Fire Manage-
10 ment appropriation for forest firefighting, emergency re-
11 habilitation of burned-over or damaged lands or waters
12 under its jurisdiction, and fire preparedness due to severe
13 burning conditions upon the Secretary of Agriculture’s no-
14 tification of the House and Senate Committees on Appro-
15 priations that all fire suppression funds appropriated
16 under the heading “Wildland Fire Management” will be
17 obligated within 30 days: *Provided*, That all funds used
18 pursuant to this paragraph must be replenished by a sup-
19 plemental appropriation which must be requested as
20 promptly as possible.

21 Not more than \$50,000,000 of funds appropriated to
22 the Forest Service shall be available for expenditure or
23 transfer to the Department of the Interior for wildland
24 fire management, hazardous fuels management, and State

1 fire assistance when such transfers would facilitate and
2 expedite wildland fire management programs and projects.

3 Notwithstanding any other provision of this Act, the
4 Forest Service may transfer unobligated balances of dis-
5 cretionary funds appropriated to the Forest Service by
6 this Act to or within the National Forest System Account,
7 or reprogram funds to be used for the purposes of haz-
8 ardous fuels management and urgent rehabilitation of
9 burned-over National Forest System lands and water: *Pro-*
10 *vided*, That such transferred funds shall remain available
11 through September 30, 2029: *Provided further*, That none
12 of the funds transferred pursuant to this paragraph shall
13 be available for obligation without written notification to
14 and the prior approval of the Committees on Appropria-
15 tions of both Houses of Congress.

16 Funds appropriated to the Forest Service shall be
17 available for assistance to or through the U.S. Department
18 of State and other Federal agencies in connection with for-
19 est and rangeland research, technical information, and as-
20 sistance in foreign countries, and shall be available to sup-
21 port forestry and related natural resource activities out-
22 side the United States and its territories and possessions,
23 including technical assistance, education and training, and
24 cooperation with United States government, private sec-
25 tor, and international organizations: *Provided*, That

1 amounts made available for International Programs and
2 Trade may utilize all authorities related to forestry, re-
3 search, and cooperative assistance regardless of program
4 designations.

5 Funds appropriated to the Forest Service shall be
6 available to enter into a cooperative agreement with the
7 section 509(a)(3) Supporting Organization, “Forest Serv-
8 ice International Foundation” to assist the Foundation in
9 meeting administrative, project, and other expenses, and
10 may provide the Foundation’s use of Forest Service per-
11 sonnel and facilities.

12 Funds appropriated to the Forest Service shall be
13 available for expenditure or transfer to the Department
14 of the Interior, Bureau of Land Management, for removal,
15 preparation, and adoption of excess wild horses and burros
16 from National Forest System lands, and for the perform-
17 ance of cadastral surveys to designate the boundaries of
18 such lands.

19 None of the funds made available to the Forest Serv-
20 ice in this Act or any other Act with respect to any fiscal
21 year shall be subject to transfer under the provisions of
22 section 702(b) of the Department of Agriculture Organic
23 Act of 1944 (7 U.S.C. 2257), section 442 of Public Law
24 106–224 (7 U.S.C. 7772), or section 10417(b) of Public
25 Law 107–171 (7 U.S.C. 8316(b)).

1 Not more than \$82,000,000 of funds available to the
2 Forest Service shall be transferred to the Working Capital
3 Fund of the Department of Agriculture and not more than
4 \$14,500,000 of funds available to the Forest Service shall
5 be transferred to the Department of Agriculture for De-
6 partment Reimbursable Programs, commonly referred to
7 as Greenbook charges: *Provided*, That nothing in this
8 paragraph shall prohibit or limit the use of reimbursable
9 agreements requested by the Forest Service in order to
10 obtain information technology services, including tele-
11 communications and system modifications or enhance-
12 ments, from the Working Capital Fund of the Department
13 of Agriculture.

14 Of the funds available to the Forest Service, up to
15 \$5,000,000 shall be available for priority projects within
16 the scope of the approved budget, which shall be carried
17 out by the Youth Conservation Corps and shall be carried
18 out under the authority of the Public Lands Corps Act
19 of 1993 (16 U.S.C. 1721 et seq.).

20 Of the funds available to the Forest Service, \$4,000
21 is available to the Chief of the Forest Service for official
22 reception and representation expenses.

23 Pursuant to sections 405(b) and 410(b) of Public
24 Law 101-593, of the funds available to the Forest Service,
25 up to \$3,000,000 may be advanced in a lump sum to the

1 National Forest Foundation to aid conservation partner-
2 ship projects in support of the Forest Service mission,
3 without regard to when the Foundation incurs expenses,
4 for projects on or benefitting National Forest System
5 lands or related to Forest Service programs: *Provided*,
6 That of the Federal funds made available to the Founda-
7 tion, no more than \$300,000 shall be available for admin-
8 istrative expenses: *Provided further*, That the Foundation
9 shall obtain, by the end of the period of Federal financial
10 assistance, private contributions to match funds made
11 available by the Forest Service on at least a one-for-one
12 basis: *Provided further*, That the Foundation may transfer
13 Federal funds to a Federal or a non-Federal recipient for
14 a project at the same rate that the recipient has obtained
15 the non-Federal matching funds.

16 Pursuant to section 2(b)(2) of Public Law 98-244,
17 up to \$3,000,000 of the funds available to the Forest
18 Service may be advanced to the National Fish and Wildlife
19 Foundation in a lump sum to aid cost-share conservation
20 projects, without regard to when expenses are incurred,
21 on or benefitting National Forest System lands or related
22 to Forest Service programs: *Provided*, That such funds
23 shall be matched on at least a one-for-one basis by the
24 Foundation or its sub-recipients: *Provided further*, That
25 the Foundation may transfer Federal funds to a Federal

1 or non-Federal recipient for a project at the same rate
2 that the recipient has obtained the non-Federal matching
3 funds.

4 Any amounts made available to the Forest Service
5 in this fiscal year, including available collections, may be
6 used by the Secretary of Agriculture, acting through the
7 Chief of the Forest Service, to enter into Federal financial
8 assistance grants and cooperative agreements to support
9 forest or grassland collaboratives in the accomplishment
10 of activities benefitting both the public and the National
11 Forest System, Federal lands and adjacent non-Federal
12 lands. Eligible activities are those that will improve or en-
13 hance Federal investments, resources, or lands, including
14 for collaborative and collaboration-based activities, includ-
15 ing but not limited to facilitation, planning, and imple-
16 menting projects, technical assistance, administrative
17 functions, operational support, participant costs, and
18 other capacity support needs, as identified by the Forest
19 Service. Eligible recipients are Indian tribal entities (de-
20 fined at 25 U.S.C. 5304(e)), state government, local gov-
21 ernments, private and nonprofit entities, for-profit organi-
22 zations, and educational institutions. The Secretary of Ag-
23 riculture, acting through the Chief of the Forest Service,
24 may enter into such cooperative agreements notwith-
25 standing chapter 63 of title 31 when the Secretary deter-

1 mines that the public interest will be benefited and that
2 there exists a mutual interest other than monetary consid-
3 erations. Transactions subject to Title 2 of the Code of
4 Federal Regulations shall be publicly advertised and re-
5 quire competition when required by such Title 2. For those
6 transactions not subject to Title 2 of the Code of Federal
7 Regulations, the agency may require public advertising
8 and competition when deemed appropriate. The term “for-
9 est and grassland collaboratives” means groups of individ-
10 uals or entities with diverse interests participating in a
11 cooperative process to share knowledge, ideas, and re-
12 sources about the protection, restoration, or enhancement
13 of natural and other resources on Federal and adjacent
14 non-Federal lands, the improvement or maintenance of
15 public access to Federal lands, or the reduction of risk
16 to such lands caused by natural disasters.

17 The 19th unnumbered paragraph under the heading
18 “Administrative Provisions, Forest Service” in title III of
19 Public Law 109–54 is amended in the first sentence by
20 inserting “and future Acts” after “funds available to the
21 Forest Service in this Act” and by striking “prior to the
22 date of enactment of this Act”.

23 Funds appropriated to the Forest Service shall be
24 available for interactions with and providing technical as-

1 sistance to rural communities and natural resource-based
2 businesses for sustainable rural development purposes.

3 Funds appropriated to the Forest Service shall be
4 available for payments to counties within the Columbia
5 River Gorge National Scenic Area, pursuant to section
6 14(c)(1) and (2), and section 16(a)(2) of Public Law 99–
7 663.

8 Any funds appropriated to the Forest Service may
9 be used to meet the non-Federal share requirement in sec-
10 tion 502(c) of the Older Americans Act of 1965 (42
11 U.S.C. 3056(c)(2)).

12 The Forest Service shall not assess funds for the pur-
13 pose of performing fire, administrative, and other facilities
14 maintenance and decommissioning.

15 Notwithstanding any other provision of law, of any
16 appropriations or funds available to the Forest Service,
17 not to exceed \$500,000 may be used to reimburse the Of-
18 fice of the General Counsel (OGC), Department of Agri-
19 culture, for travel and related expenses incurred as a re-
20 sult of OGC assistance or participation requested by the
21 Forest Service at meetings, training sessions, management
22 reviews, land purchase negotiations, and similar matters
23 unrelated to civil litigation: *Provided*, That future budget
24 justifications for both the Forest Service and the Depart-

1 ment of Agriculture should clearly display the sums pre-
2 viously transferred and the sums requested for transfer.

3 An eligible individual who is employed in any project
4 funded under title V of the Older Americans Act of 1965
5 (42 U.S.C. 3056 et seq.) and administered by the Forest
6 Service shall be considered to be a Federal employee for
7 purposes of chapter 171 of title 28, United States Code.

8 The Forest Service may employ or contract with an
9 individual who is enrolled in a training program at a long-
10 standing Civilian Conservation Center (as defined in sec-
11 tion 147(d) of the Workforce Innovation and Opportunity
12 Act (29 U.S.C. 3197(d))) at regular rates of pay for nec-
13 essary hours of work on National Forest System lands.

14 Funds appropriated to the Forest Service shall be
15 available to pay, from a single account, the base salary
16 and expenses of employees who carry out functions funded
17 by other accounts for Enterprise Program, Geospatial
18 Technology and Applications Center, National Applica-
19 tions Liaison Office, Job Corps, and National Technology
20 and Development Program.

21 The Forest Service shall maintain staffing levels in
22 order to fulfill the mission required under title 7, title 16,
23 title 30, title 43, and title 54, United States Code, includ-
24 ing to protect natural and cultural resources, provide and
25 maintain appropriate access and recreation for visitors,

1 provide safety precautions for visitors and staff, maintain
2 physical and natural infrastructure, provide information
3 and respond to stakeholders and the general public, con-
4 duct tribal consultation, provide for administrative sup-
5 port, administer forestry assistance programs, provide
6 technical assistance to states, tribes and private land-
7 owners, manage energy and minerals resources, and carry
8 out other activities in support of effectively operating the
9 National Forest System and carrying out programs ad-
10 ministered by the Forest Service in a timely manner.

13 INDIAN HEALTH SERVICE

14 INDIAN HEALTH SERVICES

15 For expenses necessary to carry out the Act of Au-
16 gust 5, 1954 (68 Stat. 674), the Indian Self-Determina-
17 tion and Education Assistance Act, the Indian Health
18 Care Improvement Act, and titles II and III of the Public
19 Health Service Act with respect to the Indian Health Serv-
20 ice, \$66,993,000, to remain available until September 30,
21 2027, except as otherwise provided herein, which shall be
22 in addition to funds previously appropriated under this
23 heading that became available on October 1, 2025; in ad-
24 dition, \$264,702,000, to remain available until September
25 30, 2027, for the Electronic Health Record System and

1 the Indian Healthcare Improvement Fund, of which
2 \$74,138,000 is for the Indian Health Care Improvement
3 Fund and may be used, as needed, to carry out activities
4 typically funded under the Indian Health Facilities ac-
5 count; and, in addition, \$4,789,731,000, which shall be-
6 come available on October 1, 2026, and remain available
7 through September 30, 2028, except as otherwise provided
8 herein; together with payments received during the fiscal
9 year pursuant to sections 231(b) and 233 of the Public
10 Health Service Act (42 U.S.C. 238(b) and 238b), for serv-
11 ices furnished by the Indian Health Service: *Provided*,
12 That funds made available to tribes and tribal organiza-
13 tions through contracts, grant agreements, or any other
14 agreements or compacts authorized by the Indian Self-De-
15 termination and Education Assistance Act of 1975 (25
16 U.S.C. 5301 et seq.), shall be deemed to be obligated at
17 the time of the grant or contract award and thereafter
18 shall remain available to the tribe or tribal organization
19 without fiscal year limitation: *Provided further*, That from
20 the amounts that become available on October 1, 2026,
21 \$2,500,000 shall be available for grants or contracts with
22 public or private institutions to provide alcohol or drug
23 treatment services to Indians, including alcohol detoxifica-
24 tion services: *Provided further*, That from the amounts
25 that become available on October 1, 2026, \$996,755,000

1 shall remain available until expended for Purchased/Re-
2 ferred Care: *Provided further*, That of the total amount
3 specified in the preceding proviso for Purchased/Referred
4 Care, \$54,000,000 shall be for the Indian Catastrophic
5 Health Emergency Fund: *Provided further*, That from the
6 amounts that become available on October 1, 2026, up to
7 \$53,000,000 shall remain available until expended for im-
8 plementation of the loan repayment program under section
9 108 of the Indian Health Care Improvement Act: *Provided*
10 *further*, That from the amounts that become available on
11 October 1, 2026, \$58,000,000, to remain available until
12 expended, shall be for costs related to or resulting from
13 accreditation emergencies, including supplementing activi-
14 ties funded under the heading “Indian Health Facilities”,
15 of which up to \$4,000,000 may be used to supplement
16 amounts otherwise available for Purchased/Referred Care:
17 *Provided further*, That the amounts collected by the Fed-
18 eral Government as authorized by sections 104 and 108
19 of the Indian Health Care Improvement Act (25 U.S.C.
20 1613a and 1616a) during the preceding fiscal year for
21 breach of contracts shall be deposited in the Fund author-
22 ized by section 108A of that Act (25 U.S.C. 1616a–1) and
23 shall remain available until expended and, notwithstanding
24 section 108A(c) of that Act (25 U.S.C. 1616a–1(c)), funds
25 shall be available to make new awards under the loan re-

1 payment and scholarship programs under sections 104
2 and 108 of that Act (25 U.S.C. 1613a and 1616a): *Pro-*
3 *vided further*, That the amounts made available within this
4 account for the Substance Abuse and Suicide Prevention
5 Program, for Opioid Prevention, Treatment and Recovery
6 Services, for the Domestic Violence Prevention Program,
7 for the Zero Suicide Initiative, for the housing subsidy au-
8 thority for civilian employees, for Aftercare Pilot Pro-
9 grams at Youth Regional Treatment Centers, for trans-
10 formation and modernization costs of the Indian Health
11 Service Electronic Health Record system, for national
12 quality and oversight activities, to improve collections from
13 public and private insurance at Indian Health Service and
14 tribally operated facilities, for an initiative to treat or re-
15 duce the transmission of HIV and HCV, for a maternal
16 health initiative, for the Telebehaviorial Health Center of
17 Excellence, for Alzheimer's activities, for Village Built
18 Clinics, for a produce prescription pilot, and for accredita-
19 tion emergencies shall be allocated at the discretion of the
20 Director of the Indian Health Service and shall remain
21 available until expended: *Provided further*, That funds pro-
22 vided in this Act may be used for annual contracts and
23 grants that fall within 2 fiscal years, provided the total
24 obligation is recorded in the year the funds are appro-
25 priated: *Provided further*, That the amounts collected by

1 the Secretary of Health and Human Services under the
2 authority of title IV of the Indian Health Care Improve-
3 ment Act (25 U.S.C. 1613) shall remain available until
4 expended for the purpose of achieving compliance with the
5 applicable conditions and requirements of titles XVIII and
6 XIX of the Social Security Act, except for those related
7 to the planning, design, or construction of new facilities:
8 *Provided further*, That funding contained herein for schol-
9 arship programs under the Indian Health Care Improve-
10 ment Act (25 U.S.C. 1613) shall remain available until
11 expended: *Provided further*, That amounts received by
12 tribes and tribal organizations under title IV of the Indian
13 Health Care Improvement Act shall be reported and ac-
14 counted for and available to the receiving tribes and tribal
15 organizations until expended: *Provided further*, That the
16 Bureau of Indian Affairs may collect from the Indian
17 Health Service, and from tribes and tribal organizations
18 operating health facilities pursuant to Public Law 93-638,
19 such individually identifiable health information relating
20 to disabled children as may be necessary for the purpose
21 of carrying out its functions under the Individuals with
22 Disabilities Education Act (20 U.S.C. 1400 et seq.): *Pro-*
23 *vided further*, That none of the funds provided that become
24 available on October 1, 2026, may be used for implemen-
25 tation of the Electronic Health Record System or the In-

1 dian Health Care Improvement Fund: *Provided further*,
2 That none of the funds appropriated by this Act, or any
3 other Act, to the Indian Health Service for the Electronic
4 Health Record system shall be available for obligation or
5 expenditure for the selection or implementation of a new
6 Information Technology infrastructure system, unless the
7 Committees on Appropriations of the House of Represent-
8 atives and the Senate are consulted 90 days in advance
9 of such obligation.

10 CONTRACT SUPPORT COSTS

11 For payments to tribes and tribal organizations for
12 contract support costs associated with Indian Self-Deter-
13 mination and Education Assistance Act agreements with
14 the Indian Health Service for fiscal year 2026, such sums
15 as may be necessary: *Provided*, That notwithstanding any
16 other provision of law, no amounts made available under
17 this heading shall be available for transfer to another
18 budget account: *Provided further*, That amounts obligated
19 but not expended by a tribe or tribal organization for con-
20 tract support costs for such agreements for the current
21 fiscal year shall be applied to contract support costs due
22 for such agreements for subsequent fiscal years.

23 PAYMENTS FOR TRIBAL LEASES

24 For payments to tribes and tribal organizations for
25 leases pursuant to section 105(l) of the Indian Self-Deter-

1 mination and Education Assistance Act (25 U.S.C.
2 5324(l)) for fiscal year 2026, such sums as may be nec-
3 essary, which shall be available for obligation through Sep-
4 tember 30, 2027: *Provided*, That notwithstanding any
5 other provision of law, no amounts made available under
6 this heading shall be available for transfer to another
7 budget account.

8 INDIAN HEALTH FACILITIES

9 For construction, repair, maintenance, demolition,
10 improvement, and equipment of health and related auxil-
11 iary facilities, including quarters for personnel; prepara-
12 tion of plans, specifications, and drawings; acquisition of
13 sites, purchase and erection of modular buildings, and
14 purchases of trailers; and for provision of domestic and
15 community sanitation facilities for Indians, as authorized
16 by section 7 of the Act of August 5, 1954 (42 U.S.C.
17 2004a), the Indian Self-Determination Act, and the In-
18 dian Health Care Improvement Act, and for expenses nec-
19 essary to carry out such Acts and titles II and III of the
20 Public Health Service Act with respect to environmental
21 health and facilities support activities of the Indian Health
22 Service, \$5,826,000, to remain available until expended,
23 which shall be in addition to funds previously appropriated
24 under this heading that became available on October 1,
25 2025; in addition, \$292,622,000, to remain available until

1 expended, for Sanitation Facilities Construction and
2 Health Care Facilities Construction; and, in addition,
3 \$516,600,000, which shall become available on October 1,
4 2026, and remain available until expended: *Provided*, That
5 notwithstanding any other provision of law, funds appro-
6 priated for the planning, design, construction, renovation,
7 or expansion of health facilities for the benefit of an In-
8 dian tribe or tribes may be used to purchase land on which
9 such facilities will be located: *Provided further*, That not
10 to exceed \$500,000 may be used for fiscal year 2027 by
11 the Indian Health Service to purchase TRANSAM equip-
12 ment from the Department of Defense for distribution to
13 the Indian Health Service and tribal facilities: *Provided*
14 *further*, That none of the funds provided that become
15 available on October 1, 2026, may be used for Health Care
16 Facilities Construction or for Sanitation Facilities Con-
17 struction: *Provided further*, That of the amount appro-
18 priated under this heading for fiscal year 2026 for Sanita-
19 tion Facilities Construction, \$17,039,000 shall be for
20 projects specified for Sanitation Facilities Construction
21 (CDS) in the table titled “Interior and Environment In-
22 corporation of Community Project Funding Items/Con-
23 gressionally Directed Spending Items” included for this
24 division in the explanatory statement described in section
25 4 (in the matter preceding division A of this consolidated

1 Act): *Provided further*, That none of the funds appro-
2 priated to the Indian Health Service may be used for sani-
3 tation facilities construction for new homes funded with
4 grants by the housing programs of the United States De-
5 partment of Housing and Urban Development.

6 ADMINISTRATIVE PROVISIONS—INDIAN HEALTH SERVICE

7 Appropriations provided in this Act to the Indian
8 Health Service shall be available for services as authorized
9 by 5 U.S.C. 3109 at rates not to exceed the per diem rate
10 equivalent to the maximum rate payable for senior-level
11 positions under 5 U.S.C. 5376; hire of passenger motor
12 vehicles and aircraft; purchase of medical equipment; pur-
13 chase of reprints; purchase, renovation, and erection of
14 modular buildings and renovation of existing facilities;
15 payments for telephone service in private residences in the
16 field, when authorized under regulations approved by the
17 Secretary of Health and Human Services; uniforms, or al-
18 lowances therefor as authorized by 5 U.S.C. 5901–5902;
19 and for expenses of attendance at meetings that relate to
20 the functions or activities of the Indian Health Service:
21 *Provided*, That in accordance with the provisions of the
22 Indian Health Care Improvement Act, non-Indian patients
23 may be extended health care at all tribally administered
24 or Indian Health Service facilities, subject to charges, and
25 the proceeds along with funds recovered under the Federal

1 Medical Care Recovery Act (42 U.S.C. 2651–2653) shall
2 be credited to the account of the facility providing the
3 service and shall be available without fiscal year limitation:
4 *Provided further*, That notwithstanding any other law or
5 regulation, funds transferred from the Department of
6 Housing and Urban Development to the Indian Health
7 Service shall be administered under Public Law 86–121,
8 the Indian Sanitation Facilities Act and Public Law 93–
9 638: *Provided further*, That funds appropriated to the In-
10 dian Health Service in this Act, except those used for ad-
11 ministrative and program direction purposes, shall not be
12 subject to limitations directed at curtailing Federal travel
13 and transportation: *Provided further*, That none of the
14 funds made available to the Indian Health Service in this
15 Act shall be used for any assessments or charges by the
16 Department of Health and Human Services unless such
17 assessments or charges are identified in the budget jus-
18 tification and provided in this Act, or approved by the
19 House and Senate Committees on Appropriations through
20 the reprogramming process: *Provided further*, That not-
21 withstanding any other provision of law, funds previously
22 or herein made available to a tribe or tribal organization
23 through a contract, grant, or agreement authorized by
24 title I or title V of the Indian Self-Determination and
25 Education Assistance Act of 1975 (25 U.S.C. 5301 et

1 seq.), may be deobligated and reobligated to a self-deter-
2 mination contract under title I, or a self-governance agree-
3 ment under title V of such Act and thereafter shall remain
4 available to the tribe or tribal organization without fiscal
5 year limitation: *Provided further*, That none of the funds
6 made available to the Indian Health Service in this Act
7 shall be used to implement the final rule published in the
8 Federal Register on September 16, 1987, by the Depart-
9 ment of Health and Human Services, relating to the eligi-
10 bility for the health care services of the Indian Health
11 Service until the Indian Health Service has submitted a
12 budget request reflecting the increased costs associated
13 with the proposed final rule, and such request has been
14 included in an appropriations Act and enacted into law:
15 *Provided further*, That with respect to functions trans-
16 ferred by the Indian Health Service to tribes or tribal or-
17 ganizations, the Indian Health Service is authorized to
18 provide goods and services to those entities on a reimburs-
19 able basis, including payments in advance with subsequent
20 adjustment, and the reimbursements received therefrom,
21 along with the funds received from those entities pursuant
22 to the Indian Self-Determination Act, may be credited to
23 the same or subsequent appropriation account from which
24 the funds were originally derived, with such amounts to
25 remain available until expended: *Provided further*, That re-

1 imbursements for training, technical assistance, or serv-
2 ices provided by the Indian Health Service will contain
3 total costs, including direct, administrative, and overhead
4 costs associated with the provision of goods, services, or
5 technical assistance: *Provided further*, That the Indian
6 Health Service may provide to civilian medical personnel
7 serving in hospitals operated by the Indian Health Service
8 housing allowances equivalent to those that would be pro-
9 vided to members of the Commissioned Corps of the
10 United States Public Health Service serving in similar po-
11 sitions at such hospitals: *Provided further*, That the appro-
12 priation structure for the Indian Health Service may not
13 be altered without advance notification to the House and
14 Senate Committees on Appropriations.

18 For necessary expenses for the National Institute of
19 Environmental Health Sciences in carrying out activities
20 set forth in section 311(a) of the Comprehensive Environ-
21 mental Response, Compensation, and Liability Act of
22 1980 (42 U.S.C. 9660(a)) and section 126(g) of the
23 Superfund Amendments and Reauthorization Act of 1986,
24 \$77,100,000.

1 OTHER RELATED AGENCIES
2 EXECUTIVE OFFICE OF THE PRESIDENT
3 COUNCIL ON ENVIRONMENTAL QUALITY AND OFFICE OF
4 ENVIRONMENTAL QUALITY

5 For necessary expenses to continue functions as-
6 signed to the Council on Environmental Quality and Office
7 of Environmental Quality pursuant to the National Envi-
8 ronmental Policy Act of 1969, the Environmental Quality
9 Improvement Act of 1970, and Reorganization Plan No.
10 1 of 1977, and not to exceed \$750 for official reception
11 and representation expenses, \$4,629,000: *Provided*, That
12 notwithstanding section 202 of the National Environ-
13 mental Policy Act of 1970, the Council shall consist of
14 one member, appointed by the President, by and with the
15 advice and consent of the Senate, serving as chairman and

23 space, and for services authorized by 5 U.S.C. 3109 but
24 at rates for individuals not to exceed the per diem equiva-
25 lent to the maximum rate payable for senior level positions

1 under 5 U.S.C. 5376, \$14,000,000: *Provided*, That the
2 Chemical Safety and Hazard Investigation Board (Board)
3 shall have not more than three career Senior Executive
4 Service positions: *Provided further*, That notwithstanding
5 any other provision of law, the individual appointed to the
6 position of Inspector General of the Environmental Pro-
7 tection Agency (EPA) shall, by virtue of such appoint-
8 ment, also hold the position of Inspector General of the
9 Board: *Provided further*, That notwithstanding any other

22 available on July 1, 2026, and shall remain available until
23 September 30, 2027.

1 SMITHSONIAN INSTITUTION

2 SALARIES AND EXPENSES

3 For necessary expenses of the Smithsonian Institu-
4 tion, as authorized by law, including research in the fields
5 of art, science, and history; development, preservation, and
6 documentation of the National Collections; presentation of
7 public exhibits and performances; collection, preparation,
8 dissemination, and exchange of information and publica-
9 tions; conduct of education, training, and museum assist-
10 ance programs; maintenance, alteration, operation, lease
11 agreements of no more than 30 years, and protection of
12 buildings, facilities, and approaches; not to exceed
13 \$100,000 for services as authorized by 5 U.S.C. 3109; and
14 purchase, rental, repair, and cleaning of uniforms for em-
15 ployees, \$928,500,000, to remain available until Sep-
16 tember 30, 2027, except as otherwise provided herein; of
17 which not to exceed \$27,000,000 for the instrumentation
18 program, collections acquisition, exhibition reinstallation,
19 Smithsonian American Women's History Museum, Na-
20 tional Museum of the American Latino, and the repatri-
21 ation of skeletal remains program shall remain available
22 until expended; and including such funds as may be nec-
23 essary to support American overseas research centers:
24 *Provided*, That funds appropriated herein are available for
25 advance payments to independent contractors performing

1 research services or participating in official Smithsonian
2 presentations: *Provided further*, That the Smithsonian In-
3 stitution may expend Federal appropriations designated in
4 this Act for lease or rent payments, as rent payable to
5 the Smithsonian Institution, and such rent payments may
6 be deposited into the general trust funds of the Institution
7 to be available as trust funds for expenses associated with
8 the purchase of a portion of the building at 600 Maryland
9 Avenue, SW, Washington, DC, to the extent that federally
10 supported activities will be housed there: *Provided further*,
11 That the use of such amounts in the general trust funds
12 of the Institution for such purpose shall not be construed
13 as Federal debt service for, a Federal guarantee of, a
14 transfer of risk to, or an obligation of the Federal Govern-
15 ment: *Provided further*, That no appropriated funds may
16 be used directly to service debt which is incurred to fi-
17 nance the costs of acquiring a portion of the building at

10 For necessary expenses of repair, revitalization, and
11 alteration of facilities owned or occupied by the Smithso-
12 nian Institution, by contract or otherwise, as authorized
13 by section 2 of the Act of August 22, 1949 (63 Stat. 623),
14 and for construction, including necessary personnel,
15 \$152,000,000, to remain available until expended, of
16 which not to exceed \$10,000 shall be for services as au-
17 thorized by 5 U.S.C. 3109.

18 NATIONAL GALLERY OF ART

19 SALARIES AND EXPENSES

20 For the upkeep and operations of the National Gal-
21 lery of Art, the protection and care of the works of art
22 therein, and administrative expenses incident thereto, as
23 authorized by the Act of March 24, 1937 (50 Stat. 51),
24 as amended by the public resolution of April 13, 1939
25 (Public Resolution 9, 76th Congress), including services

1 as authorized by 5 U.S.C. 3109; payment in advance when
2 authorized by the treasurer of the Gallery for membership
3 in library, museum, and art associations or societies whose
4 publications or services are available to members only, or
5 to members at a price lower than to the general public;
6 purchase, repair, and cleaning of uniforms for guards, and
7 uniforms, or allowances therefor, for other employees as
8 authorized by law (5 U.S.C. 5901–5902); purchase or
9 rental of devices and services for protecting buildings and
10 contents thereof, and maintenance, alteration, improve-
11 ment, and repair of buildings, approaches, and grounds;
12 and purchase of services for restoration and repair of
13 works of art for the National Gallery of Art by contracts
14 made, without advertising, with individuals, firms, or or-
15 ganizations at such rates or prices and under such terms
16 and conditions as the Gallery may deem proper,
17 \$185,000,000, to remain available until September 30,
18 2027, of which not to exceed \$3,893,000 for the special
19 exhibition program shall remain available until expended.

20 REPAIR, RESTORATION AND RENOVATION OF BUILDINGS

21 For necessary expenses of repair, restoration, and
22 renovation of buildings, grounds and facilities owned or
23 occupied by the National Gallery of Art, by contract or
24 otherwise, for operating lease agreements of no more than
25 10 years, that address space needs created by the ongoing

1 renovations in the Master Facilities Plan, as authorized,
2 \$19,000,000, to remain available until expended: *Pro-*
3 *vided*, That funds made available in prior Acts under this
4 heading for the design and construction of an off-site art
5 storage facility in partnership with the Smithsonian Insti-
6 tution may be used for the repair, restoration, and renova-
7 tion of other National Gallery of Art buildings, grounds,
8 and facilities: *Provided further*, That contracts awarded
9 for environmental systems, protection systems, and exte-
10 rior repair or renovation of buildings of the National Gal-
11 lery of Art may be negotiated with selected contractors
12 and awarded on the basis of contractor qualifications as
13 well as price.

14 JOHN F. KENNEDY CENTER FOR THE PERFORMING
15 ARTS
16 OPERATIONS AND MAINTENANCE

17 For necessary expenses for the operation, mainte-
18 nance, and security of the John F. Kennedy Center for
19 the Performing Arts, including rent of temporary office
20 space in the District of Columbia during renovations of
21 such Center, \$32,340,000, to remain available until Sep-
22 tember 30, 2027.

23 CAPITAL REPAIR AND RESTORATION

24 For necessary expenses for capital repair and restora-
25 tion of the existing features of the building and site of

1 the John F. Kennedy Center for the Performing Arts,
2 \$4,860,000, to remain available until expended.

3 WOODROW WILSON INTERNATIONAL CENTER FOR
4 SCHOLARS
5 SALARIES AND EXPENSES

6 For expenses necessary in carrying out the provisions
7 of the Woodrow Wilson Memorial Act of 1968 (82 Stat.
8 1356) including hire of passenger vehicles and services as
9 authorized by 5 U.S.C. 3109, \$5,000,000, to remain avail-
10 able until September 30, 2027.

11 NATIONAL FOUNDATION ON THE ARTS AND THE
12 HUMANITIES
13 NATIONAL ENDOWMENT FOR THE ARTS
14 GRANTS AND ADMINISTRATION

15 For necessary expenses to carry out the National
16 Foundation on the Arts and the Humanities Act of 1965,
17 \$207,000,000 shall be available to the National Endow-
18 ment for the Arts for the support of projects and produc-
19 tions in the arts, including arts education and public out-
20 reach activities, through assistance to organizations and
21 individuals pursuant to section 5 of the Act, for program
22 support, and for administering the functions of the Act,
23 to remain available until expended.

1 NATIONAL ENDOWMENT FOR THE HUMANITIES

2 GRANTS AND ADMINISTRATION

3 For necessary expenses to carry out the National
4 Foundation on the Arts and the Humanities Act of 1965,
5 \$207,000,000, to remain available until expended, of
6 which \$192,000,000 shall be available for support of ac-
7 tivities in the humanities, pursuant to section 7(c) of the
8 Act and for administering the functions of the Act; and
9 \$15,000,000 shall be available to carry out the matching
10 grants program pursuant to section 10(a)(2) of the Act,
11 including \$13,000,000 for the purposes of section 7(h):
12 *Provided*, That appropriations for carrying out section
13 10(a)(2) shall be available for obligation only in such
14 amounts as may be equal to the total amounts of gifts,
15 bequests, devises of money, and other property accepted
16 by the chairman or by grantees of the National Endow-
17 ment for the Humanities under the provisions of sections
18 11(a)(2)(B) and 11(a)(3)(B) during the current and pre-
19 ceding fiscal years for which equal amounts have not pre-
20 viously been appropriated.

21 ADMINISTRATIVE PROVISIONS

22 None of the funds appropriated to the National
23 Foundation on the Arts and the Humanities may be used
24 to process any grant or contract documents which do not
25 include the text of 18 U.S.C. 1913: *Provided*, That none

1 of the funds appropriated to the National Foundation on
2 the Arts and the Humanities may be used for official re-
3 ception and representation expenses: *Provided further,*
4 That funds from nonappropriated sources may be used as
5 necessary for official reception and representation ex-
6 penses: *Provided further,* That the Chairperson of the Na-
7 tional Endowment for the Arts may approve grants of up
8 to \$10,000, if in the aggregate the amount of such grants
9 does not exceed 5 percent of the sums appropriated for
10 grantmaking purposes per year: *Provided further,* That
11 such small grant actions are taken pursuant to the terms
12 of an expressed and direct delegation of authority from
13 the National Council on the Arts to the Chairperson.

14 COMMISSION OF FINE ARTS

15 SALARIES AND EXPENSES

16 For expenses of the Commission of Fine Arts under
17 chapter 91 of title 40, United States Code, \$3,641,000:
18 *Provided,* That the Commission is authorized to charge
19 fees to cover the full costs of its publications, and such
20 fees shall be credited to this account as an offsetting col-
21 lection, to remain available until expended without further
22 appropriation: *Provided further,* That the Commission is
23 authorized to accept gifts, including objects, papers, art-
24 work, drawings and artifacts, that pertain to the history
25 and design of the Nation's Capital or the history and ac-

1 tivities of the Commission of Fine Arts, for the purpose
2 of artistic display, study, or education: *Provided further*,
3 That one-tenth of 1 percent of the funds provided under
4 this heading may be used for official reception and rep-
5 resentation expenses.

6 NATIONAL CAPITAL ARTS AND CULTURAL AFFAIRS

7 For necessary expenses as authorized by Public Law
8 99–190 (20 U.S.C. 956a), \$5,000,000.

9 ADVISORY COUNCIL ON HISTORIC PRESERVATION

10 SALARIES AND EXPENSES

11 For necessary expenses of the Advisory Council on
12 Historic Preservation (Public Law 89–665), \$8,285,000.

13 NATIONAL CAPITAL PLANNING COMMISSION

14 SALARIES AND EXPENSES

15 For necessary expenses of the National Capital Plan-
16 ning Commission under chapter 87 of title 40, United
17 States Code, including services as authorized by 5 U.S.C.
18 3109, \$8,750,000: *Provided*, That one-quarter of 1 per-
19 cent of the funds provided under this heading may be used
20 for official reception and representational expenses associ-
21 ated with hosting international visitors engaged in the
22 planning and physical development of world capitals.

1 TITLE IV
2 GENERAL PROVISIONS
3 (INCLUDING TRANSFERS OF FUNDS)
4 RESTRICTION ON USE OF FUNDS

5 SEC. 401. No part of any appropriation contained in
6 this Act shall be available for any activity or the publica-
7 tion or distribution of literature that in any way tends to
8 promote public support or opposition to any legislative
9 proposal on which Congressional action is not complete
10 other than to communicate to Members of Congress as
11 described in 18 U.S.C. 1913.

12 OBLIGATION OF APPROPRIATIONS

13 SEC. 402. No part of any appropriation contained in
14 this Act shall remain available for obligation beyond the
15 current fiscal year unless expressly so provided herein.

16 DISCLOSURE OF ADMINISTRATIVE EXPENSES

17 SEC. 403. The amount and basis of estimated over-
18 head charges, deductions, reserves, or holdbacks, including
19 working capital fund charges, from programs, projects, ac-
20 tivities and subactivities to support government-wide, de-
21 partmental, agency, or bureau administrative functions or
22 headquarters, regional, or central operations shall be pre-
23 sented in annual budget justifications and subject to ap-
24 proval by the Committees on Appropriations of the House
25 of Representatives and the Senate. Changes to such esti-

1 mates shall be presented to the Committees on Appropria-
2 tions for approval.

3 MINING APPLICATIONS

4 SEC. 404. (a) LIMITATION OF FUNDS.—None of the
5 funds appropriated or otherwise made available pursuant
6 to this Act shall be obligated or expended to accept or
7 process applications for a patent for any mining or mill
8 site claim located under the general mining laws.

9 (b) EXCEPTIONS.—Subsection (a) shall not apply if
10 the Secretary of the Interior determines that, for the claim
11 concerned: (1) a patent application was filed with the Sec-
12 retary on or before September 30, 1994; and (2) all re-
13 quirements established under sections 2325 and 2326 of
14 the Revised Statutes (30 U.S.C. 29 and 30) for vein or
15 lode claims, sections 2329, 2330, 2331, and 2333 of the
16 Revised Statutes (30 U.S.C. 35, 36, and 37) for placer
17 claims, and section 2337 of the Revised Statutes (30
18 U.S.C. 42) for mill site claims, as the case may be, were
19 fully complied with by the applicant by that date.

20 (c) REPORT.—On September 30, 2027, the Secretary
21 of the Interior shall file with the House and Senate Com-
22 mittees on Appropriations and the Committee on Natural
23 Resources of the House and the Committee on Energy and
24 Natural Resources of the Senate a report on actions taken
25 by the Department under the plan submitted pursuant to

1 section 314(c) of the Department of the Interior and Re-
2 lated Agencies Appropriations Act, 1997 (Public Law
3 104–208).

4 (d) MINERAL EXAMINATIONS.—In order to process
5 patent applications in a timely and responsible manner,
6 upon the request of a patent applicant, the Secretary of
7 the Interior shall allow the applicant to fund a qualified
8 third-party contractor to be selected by the Director of the
9 Bureau of Land Management to conduct a mineral exam-
10 ination of the mining claims or mill sites contained in a
11 patent application as set forth in subsection (b). The Bu-
12 reau of Land Management shall have the sole responsi-
13 bility to choose and pay the third-party contractor in ac-
14 cordance with the standard procedures employed by the
15 Bureau of Land Management in the retention of third-
16 party contractors.

17 CONTRACT SUPPORT COSTS, PRIOR YEAR LIMITATION

18 SEC. 405. Sections 405 and 406 of division F of the
19 Consolidated and Further Continuing Appropriations Act,
20 2015 (Public Law 113–235) shall continue in effect in fis-
21 cal year 2026.

22 CONTRACT SUPPORT COSTS, FISCAL YEAR 2026

23 LIMITATION

24 SEC. 406. Amounts provided by this Act for fiscal
25 year 2026 under the headings “Department of Health and

1 Human Services, Indian Health Service, Contract Support
2 Costs” and “Department of the Interior, Bureau of Indian
3 Affairs and Bureau of Indian Education, Contract Sup-
4 port Costs” are the only amounts available for contract
5 support costs arising out of self-determination or self-gov-
6 ernance contracts, grants, compacts, or annual funding
7 agreements for fiscal year 2026 with the Bureau of Indian
8 Affairs, Bureau of Indian Education, and the Indian
9 Health Service: *Provided*, That such amounts provided by
10 this Act are not available for payment of claims for con-
11 tract support costs for prior years, or for repayments of
12 payments for settlements or judgments awarding contract
13 support costs for prior years.

14 FOREST MANAGEMENT PLANS

15 SEC. 407. The Secretary of Agriculture shall not be
16 considered to be in violation of section 6(f)(5)(A) of the
17 Forest and Rangeland Renewable Resources Planning Act
18 of 1974 (16 U.S.C. 1604(f)(5)(A)) solely because more
19 than 15 years have passed without revision of the plan
20 for a unit of the National Forest System. Nothing in this
21 section exempts the Secretary from any other requirement
22 of the Forest and Rangeland Renewable Resources Plan-
23 ning Act (16 U.S.C. 1600 et seq.) or any other law: *Pro-*
24 *vided*, That if the Secretary is not acting expeditiously and
25 in good faith, within the funding available, to revise a plan

1 for a unit of the National Forest System, this section shall
2 be void with respect to such plan and a court of proper
3 jurisdiction may order completion of the plan on an accel-
4 erated basis.

5 PROHIBITION WITHIN NATIONAL MONUMENTS

6 SEC. 408. No funds provided in this Act may be ex-
7 pended to conduct preleasing, leasing and related activities
8 under either the Mineral Leasing Act (30 U.S.C. 181 et
9 seq.) or the Outer Continental Shelf Lands Act (43 U.S.C.
10 1331 et seq.) within the boundaries of a National Monu-
11 ment established pursuant to the Act of June 8, 1906 (16
12 U.S.C. 431 et seq.) as such boundary existed on January
13 20, 2001, except where such activities are allowed under
14 the Presidential proclamation establishing such monu-
15 ment.

16 LIMITATION ON TAKINGS

17 SEC. 409. Unless otherwise provided herein, no funds
18 appropriated in this Act for the acquisition of lands or
19 interests in lands may be expended for the filing of dec-
20 larations of taking or complaints in condemnation without
21 the advance notification and approval of the House and
22 Senate Committees on Appropriations: *Provided*, That this
23 provision shall not apply to funds appropriated to imple-
24 ment the Everglades National Park Protection and Ex-
25 pansion Act of 1989, or to funds appropriated for Federal

1 assistance to the State of Florida to acquire lands for Ev-
2 erglades restoration purposes.

3 PROHIBITION ON NO-BID CONTRACTS

4 SEC. 410. None of the funds appropriated or other-
5 wise made available by this Act to executive branch agen-
6 cies may be used to enter into any Federal contract unless
7 such contract is entered into in accordance with the re-
8 quirements of Chapter 33 of title 41, United States Code,
9 or Chapter 137 of title 10, United States Code, and the
10 Federal Acquisition Regulation, unless—

11 (1) Federal law specifically authorizes a con-
12 tract to be entered into without regard for these re-
13 quirements, including formula grants for States, or
14 federally recognized Indian tribes;

15 (2) such contract is authorized by the Indian
16 Self-Determination and Education Assistance Act
17 (Public Law 93–638, 25 U.S.C. 5301 et seq.) or by
18 any other Federal laws that specifically authorize a
19 contract within an Indian tribe as defined in section
20 4(e) of that Act (25 U.S.C. 5304(e)); or

21 (3) such contract was awarded prior to the date
22 of enactment of this Act.

23 POSTING OF REPORTS

24 SEC. 411. (a) Any agency receiving funds made avail-
25 able in this Act, shall, subject to subsections (b) and (c),

1 post on the public website of that agency any report re-
2 quired to be submitted by the Congress in this or any
3 other Act, upon the determination by the head of the agen-
4 cy that it shall serve the national interest.

5 (b) Subsection (a) shall not apply to a report if—

6 (1) the public posting of the report com-
7 promises national security; or

8 (2) the report contains proprietary information.

9 (c) The head of the agency posting such report shall
10 do so only after such report has been made available to
11 the requesting Committee or Committees of Congress for
12 no less than 45 days.

13 NATIONAL ENDOWMENT FOR THE ARTS GRANT

14 GUIDELINES

15 SEC. 412. Of the funds provided to the National En-
16 dowment for the Arts—

17 (1) The Chairperson shall only award a grant
18 to an individual if such grant is awarded to such in-
19 dividual for a literature fellowship, National Herit-
20 age Fellowship, or American Jazz Masters Fellow-
21 ship.

22 (2) The Chairperson shall establish procedures
23 to ensure that no funding provided through a grant,
24 except a grant made to a State or local arts agency,
25 or regional group, may be used to make a grant to

1 any other organization or individual to conduct ac-
2 tivity independent of the direct grant recipient.
3 Nothing in this subsection shall prohibit payments
4 made in exchange for goods and services.

5 (3) No grant shall be used for seasonal support
6 to a group, unless the application is specific to the
7 contents of the season, including identified programs
8 or projects.

9 NATIONAL ENDOWMENT FOR THE ARTS PROGRAM

10 PRIORITIES

11 SEC. 413. (a) In providing services or awarding fi-
12 nancial assistance under the National Foundation on the
13 Arts and the Humanities Act of 1965 from funds appro-
14 priated under this Act, the Chairperson of the National
15 Endowment for the Arts shall ensure that priority is given
16 to providing services or awarding financial assistance for
17 projects, productions, workshops, or programs that serve
18 underserved populations.

19 (b) In this section:

20 (1) The term “underserved population” means
21 a population of individuals, including urban minori-
22 ties, who have historically been outside the purview
23 of arts and humanities programs due to factors such
24 as a high incidence of income below the poverty line
25 or to geographic isolation.

1 (2) The term “poverty line” means the poverty
2 line (as defined by the Office of Management and
3 Budget, and revised annually in accordance with sec-
4 tion 673(2) of the Community Services Block Grant
5 Act (42 U.S.C. 9902(2))) applicable to a family of
6 the size involved.

7 (c) In providing services and awarding financial as-
8 sistance under the National Foundation on the Arts and
9 Humanities Act of 1965 with funds appropriated by this
10 Act, the Chairperson of the National Endowment for the
11 Arts shall ensure that priority is given to providing serv-
12 ices or awarding financial assistance for projects, produc-
13 tions, workshops, or programs that will encourage public
14 knowledge, education, understanding, and appreciation of
15 the arts.

16 (d) With funds appropriated by this Act to carry out
17 section 5 of the National Foundation on the Arts and Hu-
18 manities Act of 1965—

19 (1) the Chairperson shall establish a grant cat-
20 egory for projects, productions, workshops, or pro-
21 grams that are of national impact or availability or
22 are able to tour several States;

23 (2) the Chairperson shall not make grants ex-
24 ceeding 15 percent, in the aggregate, of such funds

1 to any single State, excluding grants made under the
2 authority of paragraph (1);

3 (3) the Chairperson shall report to the Con-
4 gress annually and by State, on grants awarded by
5 the Chairperson in each grant category under sec-
6 tion 5 of such Act; and

7 (4) the Chairperson shall encourage the use of
8 grants to improve and support community-based
9 music performance and education.

10 STATUS OF BALANCES OF APPROPRIATIONS

11 SEC. 414. The Department of the Interior, the Envi-
12 ronmental Protection Agency, the Forest Service, and the
13 Indian Health Service shall provide the Committees on
14 Appropriations of the House of Representatives and Sen-
15 ate quarterly reports on the status of balances of appro-
16 priations including all uncommitted, committed, and unob-
17 ligated funds in each program and activity within 60 days
18 of enactment of this Act.

19 EXTENSION OF GRAZING PERMITS

20 SEC. 415. The terms and conditions of section 325
21 of Public Law 108–108 (117 Stat. 1307), regarding graz-
22 ing permits issued by the Forest Service on any lands not
23 subject to administration under section 402 of the Federal
24 Lands Policy and Management Act (43 U.S.C. 1752),
25 shall remain in effect for fiscal year 2026.

1 horse or burro (as defined in section 2 of Public Law 92–
2 195 (commonly known as the “Wild Free-Roaming Horses
3 and Burros Act”) (16 U.S.C. 1332)).

4 (d) A Federal, State, or local government agency re-
5 ceiving an excess wild horse or burro pursuant to sub-
6 section (a) shall not—

7 (1) destroy the horse or burro in a manner that
8 results in the destruction of the horse or burro into
9 a commercial product;

10 (2) sell or otherwise transfer the horse or burro
11 in a manner that results in the destruction of the
12 horse or burro for processing into a commercial
13 product; or

14 (3) euthanize the horse or burro, except on the
15 recommendation of a licensed veterinarian in a case
16 of severe injury, illness, or advanced age.

17 (e) Amounts appropriated by this Act shall not be
18 available for—

19 (1) the destruction of any healthy, unadopted,
20 and wild horse or burro under the jurisdiction of the
21 Secretary concerned (including a contractor); or

22 (2) the sale of a wild horse or burro that results
23 in the destruction of the wild horse or burro for
24 processing into a commercial product.

1 FOREST SERVICE FACILITY REALIGNMENT AND
2 ENHANCEMENT AUTHORIZATION EXTENSION

3 SEC. 418. Section 503(f) of Public Law 109–54 (16
4 U.S.C. 580d note) shall be applied by substituting “Sep-
5 tember 30, 2026” for “September 30, 2019”.

6 USE OF AMERICAN IRON AND STEEL

7 SEC. 419. (a)(1) None of the funds made available
8 by a State water pollution control revolving fund as au-
9 thorized by section 1452 of the Safe Drinking Water Act
10 (42 U.S.C. 300j–12) shall be used for a project for the
11 construction, alteration, maintenance, or repair of a public
12 water system or treatment works unless all of the iron and
13 steel products used in the project are produced in the
14 United States.

15 (2) In this section, the term “iron and steel” products
16 means the following products made primarily of iron or
17 steel: lined or unlined pipes and fittings, manhole covers
18 and other municipal castings, hydrants, tanks, flanges,
19 pipe clamps and restraints, valves, structural steel, rein-
20 forced precast concrete, and construction materials.

21 (b) Subsection (a) shall not apply in any case or cat-
22 egory of cases in which the Administrator of the Environ-
23 mental Protection Agency (in this section referred to as
24 the “Administrator”) finds that—

1 (1) applying subsection (a) would be incon-
2 sistent with the public interest;

3 (2) iron and steel products are not produced in
4 the United States in sufficient and reasonably avail-
5 able quantities and of a satisfactory quality; or

6 (3) inclusion of iron and steel products pro-
7 duced in the United States will increase the cost of
8 the overall project by more than 25 percent.

9 (c) If the Administrator receives a request for a waiv-
10 er under this section, the Administrator shall make avail-
11 able to the public on an informal basis a copy of the re-
12 quest and information available to the Administrator con-
13 cerning the request, and shall allow for informal public
14 input on the request for at least 15 days prior to making
15 a finding based on the request. The Administrator shall
16 make the request and accompanying information available
17 by electronic means, including on the official public Inter-
18 net Web site of the Environmental Protection Agency.

19 (d) This section shall be applied in a manner con-
20 sistent with United States obligations under international
21 agreements.

22 (e) The Administrator may retain up to 0.25 percent
23 of the funds appropriated in this Act for the Clean and
24 Drinking Water State Revolving Funds for carrying out

1 the provisions described in subsection (a)(1) for manage-
2 ment and oversight of the requirements of this section.

3 LOCAL COOPERATOR TRAINING AGREEMENTS AND TRANS-
4 FERS OF EXCESS EQUIPMENT AND SUPPLIES FOR
5 WILDFIRES

6 SEC. 420. The Secretary of the Interior is authorized
7 to enter into grants and cooperative agreements with vol-
8 unteer fire departments, rural fire departments, rangeland
9 fire protection associations, and similar organizations to
10 provide for wildland fire training and equipment, including
11 supplies and communication devices. Notwithstanding sec-
12 tion 121(c) of title 40, United States Code, or section 521
13 of title 40, United States Code, the Secretary is further
14 authorized to transfer title to excess Department of the
15 Interior firefighting equipment no longer needed to carry
16 out the functions of the Department's wildland fire man-
17 agement program to such organizations.

18 REPROGRAMMING GUIDELINES

19 SEC. 421. None of the funds made available in this
20 Act, in this and prior fiscal years, may be reprogrammed
21 without the advance notification and approval of the
22 House and Senate Committees on Appropriations in ac-
23 cordance with the reprogramming procedures contained in
24 the explanatory statement described in section 4 (in the
25 matter preceding division A of this consolidated Act).

1 LOCAL CONTRACTORS

2 SEC. 422. Section 412 of division E of Public Law
3 112–74 shall be applied by substituting “fiscal year 2026”
4 for “fiscal year 2019”.

5 INTERPRETIVE ASSOCIATION AUTHORIZATION EXTENSION

6 SEC. 423. Section 426 of division G of Public Law
7 113–76 (16 U.S.C. 565a–1 note) shall be applied by sub-
8 stituting “September 30, 2026” for “September 30,
9 2019”.

10 FOREST BOTANICAL PRODUCTS FEE COLLECTION

11 AUTHORIZATION EXTENSION

12 SEC. 424. Section 339 of the Department of the Inte-
13 rior and Related Agencies Appropriations Act, 2000 (as
14 enacted into law by Public Law 106–113; 16 U.S.C. 528
15 note), as amended by section 335(6) of Public Law 108–
16 108 and section 432 of Public Law 113–76, shall be ap-
17 plied by substituting “fiscal year 2026” for “fiscal year
18 2019”.

19 CHACO CANYON

20 SEC. 425. None of the funds made available by this
21 Act may be used to accept a nomination for oil and gas
22 leasing under 43 CFR 3120.3 et seq., or to offer for oil
23 and gas leasing, any Federal lands within the withdrawal
24 area identified on the map of the Chaco Culture National
25 Historical Park prepared by the Bureau of Land Manage-

1 ment and dated April 2, 2019, prior to the completion of
2 the cultural resources investigation identified in the ex-
3 planatory statement described in section 4 in the matter
4 preceding division A of the Consolidated Appropriations
5 Act, 2021 (Public Law 116–260).

6 TRIBAL LEASES

7 SEC. 426. (a) Notwithstanding any other provision
8 of law, in the case of any lease under section 105(l) of
9 the Indian Self-Determination and Education Assistance
10 Act (25 U.S.C. 5324(l)), the initial lease term shall com-
11 mence no earlier than the date of receipt of the lease pro-
12 posal.

13 (b) The Secretaries of the Interior and Health and
14 Human Services shall, jointly or separately, during fiscal
15 year 2026 consult with tribes and tribal organizations
16 through public solicitation and other means regarding the
17 requirements for leases under section 105(l) of the Indian
18 Self-Determination and Education Assistance Act (25
19 U.S.C. 5324(l)) on how to implement a consistent and
20 transparent process for the payment of such leases.

21 FOREST ECOSYSTEM HEALTH AND RECOVERY FUND

22 SEC. 427. The authority provided under the heading
23 “Forest Ecosystem Health and Recovery Fund” in title
24 I of Public Law 111–88, as amended by section 117 of
25 division F of Public Law 113–235, shall be applied by sub-

1 stituting “fiscal year 2026” for “fiscal year 2020” each
2 place it appears.

3 ALLOCATION OF PROJECTS, LAND AND WATER

4 CONSERVATION FUND

5 SEC. 428. (a)(1) Within 45 days of enactment of this
6 Act, the Secretary of the Interior and the Secretary of Ag-
7 riculture, as appropriate, shall allocate amounts made
8 available for expenditure from the Land and Water Con-
9 servation Fund for fiscal year 2026 pursuant to subsection
10 (a) of section 200303 of title 54, United States Code, to
11 the agencies and accounts specified, for the projects speci-
12 fied under the accounts titled “Land Acquisition Projects”
13 and “Forest Legacy Projects” in the Forest Service, and
14 in the amounts specified in the table titled “Allocation of
15 Funds: Land and Water Conservation Fund Fiscal Year
16 2026” in the explanatory statement described in section
17 4 (in the matter preceding division A of this consolidated
18 Act): *Provided*, That the matter preceding this proviso
19 shall not apply to amounts in any account titled “Land
20 Acquisition Projects” in the Bureau of Land Management,
21 United States Fish and Wildlife Service, or National Park
22 Service in such table.

23 (2)(A) Within 30 days of enactment of this Act, the
24 Secretary of the Interior shall provide to the House and
25 Senate Committees on Appropriations project lists with

1 project data sheets as described in subsection (c)(4), which
2 shall include a sufficient number of projects to total the
3 amounts for the account titled “Land Acquisition
4 Projects” for each of the Bureau of Land Management,
5 United States Fish and Wildlife Service, and National
6 Park Service, as specified in the table titled “Allocation
7 of Funds: Land and Water Conservation Fund Fiscal
8 Year 2026” in the explanatory statement described in sec-
9 tion 4 (in the matter preceding division A of this consoli-
10 dated Act): *Provided*, That on the date on which the Sec-
11 retary of the Interior provides to the Committees on Ap-
12 propriations such project lists with such project data
13 sheets, the Secretary of the Interior shall provide to the
14 Committees on Appropriations lists of supplementary allo-
15 cations for Federal land acquisition projects for each of
16 the Bureau of Land Management, United States Fish and
17 Wildlife Service, and National Park Service that are
18 prioritized and detailed by account, program, and project,
19 and that total no less than half the full amount allocated
20 to each such account for that land management Agency
21 in the table titled “Allocation of Funds: Land and Water
22 Conservation Fund Fiscal Year 2026” in the explanatory
23 statement described in section 4 (in the matter preceding
24 division A of this consolidated Act): *Provided further*, That

1 expenditure of funds under this paragraph is a reprogram-
2 ming and shall be subject to section 421 of this Act.

3 (B) Within 45 days of the date on which a re-
4 programming is approved pursuant to the last proviso in
5 subparagraph (A), the Secretary of the Interior shall allo-
6 cate amounts made available for expenditure from the
7 Land and Water Conservation Fund for fiscal year 2026
8 pursuant to subsection (a) of section 200303 of title 54,
9 United States Code, to the account titled “Land Acquisi-
10 tion Projects” for each of the Bureau of Land Manage-
11 ment, United States Fish and Wildlife Service, and Na-
12 tional Park Service, as applicable, in the amounts specified
13 in the table titled “Allocation of Funds: Land and Water
14 Conservation Fund Fiscal Year 2026” in the explanatory
15 statement described in section 4 (in the matter preceding
16 division A of this consolidated Act) and for the projects
17 included in the project lists approved by the Committees
18 on Appropriations in accordance with subparagraph (A).

19 (3) If any portion of a project specified under the
20 accounts titled “Land Acquisition Projects” and “Forest
21 Legacy Projects” in the Forest Service in the table titled
22 “Allocation of Funds: Land and Water Conservation Fund
23 Fiscal Year 2026” in the explanatory statement described
24 in section 4 (in the matter preceding division A of this
25 consolidated Act) or for the projects included in the

1 project lists approved by the Committees on Appropria-
2 tions in accordance with subsection (a)(2)(A) is intended
3 to be carried out within the Federal land unit or project
4 boundary as specified in such table (or any prior allocation
5 table incorporated by reference into a prior Act, as appli-
6 cable) or project list but outside the specific tracts for the
7 project described in the corresponding project data sheet
8 submitted to the Committees on Appropriations required
9 by section 200303(c)(1) of title 54, United States Code,
10 or paragraph (2), not later than 30 days before the date
11 on which the Secretary of the Interior or the Secretary
12 of Agriculture expends amounts on the project, the Sec-
13 retary of the Interior or the Secretary of Agriculture, as
14 appropriate, shall provide written notice to the House and
15 Senate Committees on Appropriations of such expendi-
16 ture.

17 (b) Neither the President nor his designee may allo-
18 cate any amounts that are made available for any fiscal
19 year under subsection (a) of section 200303 of title 54,
20 United States Code, other than in amounts and for
21 projects and activities that are allocated by subsection
22 (a)(1) or in accordance with subsection (a)(2) of this sec-
23 tion: *Provided*, That in any fiscal year, the matter pre-
24 ceding this proviso shall not apply to the allocation of
25 amounts for continuing administration of programs allo-

1 cated funds from the Land and Water Conservation Fund,
2 which may be allocated only in amounts that are no more
3 than the allocation for such purposes in subsections (a)(1)
4 and (a)(2) of this section.

5 (c)(1) Concurrent with the annual budget submission
6 of the President for fiscal year 2027, the Secretary of Ag-
7 riculture shall submit to the Committees on Appropria-
8 tions a list of supplementary allocations for Federal land
9 acquisition and Forest Legacy Projects at the Forest Serv-
10 ice that are in addition to the “Submission of Cost Esti-
11 mates” required by section 200303(c)(1) of title 54,
12 United States Code, that are prioritized and detailed by
13 account, program, and project, and that total no less than
14 half the full amount allocated to each such account for
15 the Forest Service under the allocations submitted under
16 section 200303(c)(1) of title 54, United States Code: *Pro-*
17 *vided*, That in the event amounts allocated by this Act
18 or any prior Act pursuant to subsection (a) of section
19 200303 of title 54, United States Code, are no longer
20 needed because a project has been completed or can no
21 longer be executed, such amounts must be clearly identi-
22 fied if proposed for reallocation in the annual budget sub-
23 mission.

24 (2) Concurrent with the annual budget submission of
25 the President for fiscal year 2027, the Secretary of the

1 Interior shall submit to the Committees on Appropriations
2 a list of supplementary allocations for Federal land acqui-
3 sition projects at the National Park Service, the United
4 States Fish and Wildlife Service, and the Bureau of Land
5 Management that are in addition to the “Submission of
6 Cost Estimates” required by section 200303(c)(1) of title
7 54, United States Code, that are prioritized and detailed
8 by account, program, and project, and that total the full
9 amount allocated to each such account for that land man-
10 agement Agency in the table titled “Allocation of Funds:
11 Land and Water Conservation Fund Fiscal Year 2026”
12 in the explanatory statement described in section 4 (in the
13 matter preceding division A of this consolidated Act): *Pro-*
14 *vided*, That in the event amounts allocated by this Act
15 or any prior Act pursuant to subsection (a) of section
16 200303 of title 54, United States Code, are no longer
17 needed because a project has been completed or can no
18 longer be executed, such amounts must be clearly identi-
19 fied if proposed for reallocation in the annual budget sub-
20 mission.

21 (3) The Federal land acquisition and Forest Legacy
22 projects in the “Submission of Cost Estimates” required
23 by section 200303(c)(1) of title 54, United States Code,
24 in the project lists provided under subsection (a)(2), in
25 the list of supplementary allocations provided under sub-

1 section (a)(2), and on the lists of supplementary alloca-
2 tions required by paragraphs (1) and (2) shall be com-
3 prised only of projects for which a willing seller has been
4 identified and for which an appraisal or market research
5 has been initiated.

6 (4) Concurrent with the annual budget submission of
7 the President for fiscal year 2027, the Secretary of the
8 Interior and the Secretary of Agriculture shall each sub-
9 mit to the Committees on Appropriations project data
10 sheets in the same format and containing the same level
11 of detailed information that is found on such sheets in
12 the Budget Justifications annually submitted by the Sec-
13 retary of the Interior with the President's Budget for the
14 projects in the "Submission of Cost Estimates" required
15 by section 200303(c)(1) of title 54, United States Code,
16 and in the same format and containing the same level of
17 detailed information that is found on such sheets sub-
18 mitted to the Committees on Appropriations pursuant to
19 section 427 of division D of the Further Consolidated Ap-
20 propriations Act, 2020 (Public Law 116-94) for the list
21 of supplementary allocations required by paragraphs (1)
22 and (2).

23 (5) The Secretary of the Interior and the Secretary
24 of Agriculture shall provide to the Committees on Appro-
25 priations quarterly reports on the status of balances of

1 projects and activities funded by the National Parks and
2 Public Land Legacy Restoration Fund and the Land and
3 Water Conservation Fund, and the status of balances of
4 projects and activities funded by the Land and Water Con-
5 servation Fund for amounts allocated pursuant to sub-
6 section (a)(2) of this section, including all uncommitted,
7 committed, and unobligated funds.

8 (d) Within 45 days of enactment of this Act, the Sec-
9 retary of the Interior and the Secretary of Agriculture,
10 as appropriate, shall allocate amounts made available for
11 expenditure from the Land and Water Conservation Fund
12 for fiscal year 2025 pursuant to subsection (a) of section
13 200303 of title 54, United States Code, to the agencies
14 and accounts specified, for the projects specified, under
15 the accounts specified, and in the amounts specified in the
16 table titled “Allocation of Funds: Land and Water Con-
17 servation Fund Fiscal Year 2025 Revisions” in the ex-
18 planatory statement described in section 4 (in the matter
19 preceding division A of this consolidated Act).

20 (e)(1) Within 30 days of enactment of this Act, the
21 Secretary of the Interior and the Secretary of Agriculture
22 shall provide to the House and Senate Committees on Ap-
23 propriations project lists with project data sheets, which
24 shall include a sufficient number of projects to total the
25 amounts for the account titled “National Parks and Public

1 Land Legacy Restoration Fund” for each of the Bureau
2 of Land Management, United States Fish and Wildlife
3 Service, National Park Service, Bureau of Indian Edu-
4 cation, and U.S. Forest Service: *Provided*, That expendi-
5 ture of funds under this paragraph is a reprogramming
6 and shall be subject to section 421 of this Act.

7 (2) Within 45 days of the date on which a reprogram-
8 ming is approved pursuant to the last proviso in subpara-
9 graph (1), the Secretary of the Interior and the Secretary
10 of Agriculture shall allocate amounts made available for
11 expenditure from the National Parks and Public Land
12 Legacy Restoration Fund for fiscal year 2026 pursuant
13 to subsection (c) of 200402 of title 54, United States
14 Code, to the account titled “National Parks and Public
15 Land Legacy Restoration Fund” for each of the Bureau
16 of Land Management, United States Fish and Wildlife
17 Service, National Park Service, Bureau of Indian Edu-
18 cation, and U.S. Forest Service as applicable, in the
19 amounts specified and for the projects included in the
20 project lists approved by the Committees on Appropria-
21 tions in accordance with subparagraph (1).

22 POLICIES RELATING TO BIOMASS ENERGY

23 SEC. 429. To support the key role that forests in the
24 United States can play in addressing the energy needs of
25 the United States, the Secretary of Energy, the Secretary

1 of Agriculture, and the Administrator of the Environ-
2 mental Protection Agency shall, consistent with their mis-
3 sions, jointly—

4 (1) ensure that Federal policy relating to forest
5 bioenergy—

6 (A) is consistent across all Federal depart-
7 ments and agencies; and

8 (B) recognizes the full benefits of the use
9 of forest biomass for energy, conservation, and
10 responsible forest management; and

11 (2) establish clear and simple policies for the
12 use of forest biomass as an energy solution, includ-
13 ing policies that—

14 (A) reflect the carbon neutrality of forest
15 bioenergy and recognize biomass as a renewable
16 energy source, provided the use of forest bio-
17 mass for energy production does not cause con-
18 version of forests to non-forest use;

19 (B) encourage private investment through-
20 out the forest biomass supply chain, including
21 in—

22 (i) working forests;

23 (ii) harvesting operations;

24 (iii) forest improvement operations;

25 (iv) forest bioenergy production;

- 1 (v) wood products manufacturing; or
2 (vi) paper manufacturing;
3 (C) encourage forest management to im-
4 prove forest health; and
5 (D) recognize State initiatives to produce
6 and use forest biomass.

7 SMALL REMOTE INCINERATORS

8 SEC. 430. None of the funds made available in this
9 Act may be used to implement or enforce the regulation
10 issued on March 21, 2011 at 40 CFR part 60 subparts
11 CCCC and DDDD with respect to units in the State of
12 Alaska that are defined as “small, remote incinerator”
13 units in those regulations and, until a subsequent regula-
14 tion is issued, the Administrator shall implement the law
15 and regulations in effect prior to such date.

16 TIMBER SALE REQUIREMENTS

17 SEC. 431. No timber sale in Alaska’s Region 10 shall
18 be advertised if the indicated rate is deficit (defined as
19 the value of the timber is not sufficient to cover all logging
20 and stumpage costs and provide a normal profit and risk
21 allowance under the Forest Service’s appraisal process)
22 when appraised using a residual value appraisal. The west-
23 ern red cedar timber from those sales which is surplus
24 to the needs of the domestic processors in Alaska, shall
25 be made available to domestic processors in the contiguous

1 48 United States at prevailing domestic prices. All addi-
2 tional western red cedar volume not sold to Alaska or con-
3 tiguous 48 United States domestic processors may be ex-
4 ported to foreign markets at the election of the timber sale
5 holder. All Alaska yellow cedar may be sold at prevailing
6 export prices at the election of the timber sale holder.

7 TRANSFER AUTHORITY TO FEDERAL HIGHWAY
8 ADMINISTRATION FOR THE NATIONAL PARKS AND PUBLIC
9 LAND LEGACY RESTORATION FUND

10 SEC. 432. Funds made available or allocated in this
11 Act to the Department of the Interior or the Department
12 of Agriculture that are subject to the allocations and limi-
13 tations in 54 U.S.C. 200402(e) and prohibitions in 54
14 U.S.C. 200402(f) may be further allocated or reallocated
15 to the Federal Highway Administration for transportation
16 projects of the covered agencies defined in 54 U.S.C.
17 200401(2).

18 PROHIBITION ON USE OF FUNDS

19 SEC. 433. Notwithstanding any other provision of
20 law, none of the funds made available in this Act or any
21 other Act may be used to promulgate or implement any
22 regulation requiring the issuance of permits under title V
23 of the Clean Air Act (42 U.S.C. 7661 et seq.) for carbon
24 dioxide, nitrous oxide, water vapor, or methane emissions

1 resulting from biological processes associated with live-
2 stock production.

3 GREENHOUSE GAS REPORTING RESTRICTIONS

4 SEC. 434. Notwithstanding any other provision of
5 law, none of the funds made available in this or any other
6 Act may be used to implement any provision in a rule,
7 if that provision requires mandatory reporting of green-
8 house gas emissions from manure management systems.

9 FUNDING PROHIBITION

10 SEC. 435. None of the funds made available by this
11 or any other Act may be used to regulate the lead content
12 of ammunition, ammunition components, or fishing tackle
13 under the Toxic Substances Control Act (15 U.S.C. 2601
14 et seq.) or any other law.

15 FIREFIGHTER PAY CAP

16 SEC. 436. (a) Section 1701 of division B of the Ex-
17 tending Government Funding and Delivering Emergency
18 Assistance Act (5 U.S.C. 5547 note), as amended by Pub-
19 lic Law 117–103, is further amended in subsection (a)(1),
20 by striking the last sentence and inserting “Any Services
21 during a given calendar year that generate payments pay-
22 able in the subsequent calendar year shall be disregarded
23 in applying this subsection”.

24 (b) The waivers of premium and overtime pay author-
25 ized in subsections (a) through (c) of section 1701 of divi-

1 sion B of the Extending Government Funding and Deliv-
2 ering Emergency Assistance Act (5 U.S.C. 5547 note), as
3 amended by Public Law 117–103, shall be applied in fiscal
4 year 2026.

5 ALASKA NATIVE REGIONAL HEALTH ENTITIES

6 AUTHORIZATION EXTENSION

7 SEC. 437. Section 424(a) of title IV of division G of
8 the Consolidated Appropriations Act, 2014 (Public Law
9 113–76) shall be applied by substituting “October 1,
10 2026” for “December 24, 2022”.

11 LAVA RIDGE WIND PROJECT

12 SEC. 438. (a) None of the funds made available by
13 this Act may be obligated or expended for the purpose of
14 granting, issuing, or renewing a right-of-way under section
15 501 of the Federal Land Policy and Management Act of
16 1976 (43 U.S.C. 1761) for the Lava Ridge Wind Project,
17 unless or until the Secretary of the Interior, acting
18 through the Bureau of Land Management, has analyzed,
19 in consultation with local elected officials and stake-
20 holders, action alternatives designed to reduce impacts to
21 wildlife, cultural resources, transportation, hunting, wet-
22 lands and the connected surface and ground waters. The
23 Secretary shall complete such consultations, and seek
24 feedback regarding action alternatives, not later than Sep-
25 tember 30, 2026, and no funds made available in this Act

1 shall be used for granting, issuing, or renewing a right-
2 of-way under section 501 of the Federal Land Policy and
3 Management Act of 1976 (43 U.S.C. 1761) for the Lava
4 Ridge Wind Project while such consultations and efforts
5 are ongoing.

6 (b) Prior to granting, issuing, or renewing a right-
7 of-way under section 501 of the Federal Land Policy and
8 Management Act of 1976 (43 U.S.C. 1761) for the Lava
9 Ridge Wind Project, the Secretary shall periodically report
10 to the House and Senate Committees on Appropriations
11 on the status of consultations required under subsection
12 (a) and, once such consultations are complete, provide a
13 briefing to the Committees on the action alternatives and
14 the feedback of local elected officials and stakeholders.

15 WILDFIRE SUPPRESSION FUNDING AND FOREST

16 MANAGEMENT ACT

17 SEC. 439. Section 104 of the Wildfire Suppression
18 Funding and Forest Management Activities Act (division
19 O of Public Law 115–141) is amended—

20 (1) in subsection (a), by striking “90” and in-
21 serting “180”; and

22 (2) in paragraph (4) of subsection (b), by in-
23 serting the following before the semi-colon: “, and
24 shall include an accounting of any spending in the
25 first two quarters of the succeeding fiscal year that

1 is attributable to suppression operations in the fiscal
2 year for which the report was prepared”.

3 FIVE YEAR CONSTRUCTION PLAN

4 SEC. 440. The Department of the Interior and the
5 Forest Service are directed to maintain updated 5-year de-
6 ferred maintenance plans that, to the extent practicable,
7 include a list of all outstanding deferred maintenance
8 needs, and to provide them to the Committee on a quar-
9 terly basis.

10 QUARTERLY DISASTER ESTIMATES

11 SEC. 441. The Department of the Interior, the
12 United States Forest Service, and the Environmental Pro-
13 tection agency shall provide quarterly estimates to the
14 Committees on Appropriations of the House of Represent-
15 atives and the Senate within 30 days of a quarter closing
16 detailing the costs to repair, restore, or otherwise reme-
17 diate damages to Federal lands and infrastructure caused
18 by disasters and, for the Environmental Protection Agen-
19 cy, the costs to repair and improve the resiliency of drink-
20 ing water and wastewater infrastructure damaged in
21 states, territories, and on tribal lands.

22 AMERICAN WOMEN’S HISTORY MUSEUM AND NATIONAL
23 MUSEUM OF THE AMERICAN LATINO

24 SEC. 442. None of the funds made available by this
25 or any other Act may be used to close, halt development

1 of, merge with or transfer to another function or program,
2 reduce funding, or otherwise diminish the operations of
3 the Smithsonian American Women's History Museum or
4 the National Museum of the American Latino established
5 by Public Law 116–260 on December 27, 2020.

6 PROGRAM FUNDING INCORPORATED BY REFERENCE

7 SEC. 443. Amounts provided in this Act shall be allo-
8 cated in the amounts specified for the programs, projects
9 and activities specified in the tables in the explanatory
10 statement described in section 4 (in the matter preceding
11 division A of this consolidated Act) titled:

12 (1) Program Funding for Management of
13 Lands and Resources;

14 (2) Program Funding for Resource Manage-
15 ment;

16 (3) Program Funding for Operation of the Na-
17 tional Park System;

18 (4) Program Funding for National Recreation
19 and Preservation;

20 (5) Program Funding for National Heritage
21 Areas;

22 (6) Program Funding for Surveys, Investiga-
23 tions, and Research;

24 (7) Program Funding for Operation of Indian
25 Programs;

1 (8) Program Funding for Science and Tech-
2 nology Programs;

3 (9) Program Funding for Environmental Pro-
4 grams and Management;

5 (10) Program Funding for National Estuary
6 Program;

7 (11) Program Funding for Forest and Range-
8 land Research;

9 (12) Program Funding for State, Private, and
10 Tribal Forestry; and

11 (13) Program Funding for National Forest
12 System.

13 REPURPOSING

14 SEC. 444. (a) Of the amounts made available under
15 the heading “Department of the Interior—Departmental
16 Offices—Department-Wide Programs—Wildland Fire
17 Management”, \$763,514,000 shall be derived by transfer
18 from the unobligated balances of amounts previously ap-
19 propriated in division J of the Infrastructure Investment
20 and Jobs Act (Public Law 117–58) as follows: (1)
21 \$125,000,000 from the unobligated balances under the
22 heading “Environmental Protection Agency—State and
23 Tribal Assistance Grants” from amounts that will become
24 available for fiscal year 2026 in paragraph (3); (2)
25 \$353,514,000 from the unobligated balances under the

1 heading “Department of the Interior—Office of Surface
2 Mining Reclamation and Enforcement—Abandoned Mine
3 Reclamation Fund”; (3) \$285,000,000 from the unobli-
4 gated balances under the heading “Department of the In-
5 terior—Methane Reduction Infrastructure”: *Provided*,
6 That amounts derived by transfer pursuant to this sub-
7 section shall continue to be treated as amounts specified
8 in section 103(b) of division A of Public Law 118–5: *Pro-*
9 *vided further*, That amounts derived by transfer pursuant
10 to this subsection shall not be available for wildfire sup-
11 pression operations.

12 (b) Of the amounts made available under the heading
13 “Department of the Interior—Departmental Offices—Of-
14 fice of Inspector General”, \$65,000,000 shall be derived
15 by transfer from the unobligated balances of amounts pre-
16 viously appropriated in division J of the Infrastructure In-
17 vestment and Jobs Act (Public Law 117–58), including
18 amounts that will become available for fiscal year 2026,
19 that have been or will be transferred to the Office of In-
20 spector General of the Department of the Interior for
21 oversight of funding provided to the Department of the
22 Interior in title VI of division J of that Act: *Provided*,
23 That amounts derived by transfer pursuant to this sub-
24 section shall continue to be treated as amounts specified
25 in section 103(b) of division A of Public Law 118–5.

1 (c) Of the amounts made available under the heading
2 “Department of Agriculture—Forest Service—Forest
3 Service Operations”, \$146,486,000 shall be derived by
4 transfer from the unobligated balances of amounts pre-
5 viously appropriated under the heading “Department of
6 the Interior—Office of Surface Mining Reclamation and
7 Enforcement—Abandoned Mine Reclamation Fund” in di-
8 vision J of the Infrastructure Investment and Jobs Act
9 (Public Law 117–58): *Provided*, That amounts derived by
10 transfer pursuant to this subsection shall continue to be
11 treated as amounts specified in section 103(b) of division
12 A of Public Law 118–5.

13 BUREAU OF LAND MANAGEMENT ACTIONS REGARDING
14 GRAZING ON PUBLIC LANDS

15 SEC. 445. Paragraph (1) of section 122(a) of division
16 E of Public Law 112–74 (125 Stat. 1013) is amended
17 by striking “through 2024.” in the first sentence and in-
18 serting “through 2027,”.

19 TECHNICAL CORRECTIONS

20 SEC. 446. The contents in the “Senate” sub column
21 of the “Requestor(s)” column in the table titled “Commu-
22 nity Project Funding/Congressional Directed Spending”
23 under the heading “Disclosure of Earmarks and Congres-
24 sionally Directed Spending Items” in the explanatory
25 statement for the Agriculture, Rural Development, Food

1 and Drug Administration, and Related Agency Appropria-
2 tions Act, 2026 (division B of Public Law 119–37) de-
